

1 Roman invasion

In this unit you will:

explore how and why the Romans invaded new lands





1.1 Army and empire

The strength of the Roman army allowed the Roman Empire to expand and conquer new lands. The Roman soldiers were better trained and had better weapons than the tribes they fought against. When the Romans defeated a tribe, they added the tribe's land to the Roman Empire. Which lands did the Romans conquer? How was the Roman army organised? What special weapons did the Roman army use?

The Roman Empire

The Roman Empire was one of the largest empires the world had ever known. The capital city Rome, in Italy, was the largest city in the world for 500 years between 100 BCE and 400 CE. In total, the Romans ruled over an estimated 50–90 million people, which was about 25 per cent of the world's population. Many modern countries and territories were included in the Roman Empire: much of Europe, including most of Britain (Scotland was not included), France, Germany, Italy, Spain, Portugal, Austria, Switzerland, Belgium, Greece, Hungary, Ukraine; the coastal area of northern Africa ground the Mediterranean Sea (such as Libya, Tunisia, Algeria, Morocco, Egypt); the Balkans (such as Albania, Bosnia, Slovenia, Croatia, Bulgaria) and parts of the Middle East (such as Syria, Lebanon, Iraq, Jordan).

How the Roman army was organised

There were about 300 000 soldiers in the Roman army. The soldiers were divided into groups called legions.

A legion contained about 5000 soldiers. The legions were split into groups of 80 and each group was called a century. The man in charge of a century was called a centurion. The century was then split into ten groups of eight soldiers, who shared a tent together.



In battle, the Romans protected themselves by grouping together and holding their shields above their heads. This was called the 'testudo' – a Latin word for 'tortoise'.

Did you know?

A Roman soldier marched so much that he wore out three pairs of boots each year!


How did the soldiers fight?

The soldiers fought in a tightly packed group. They marched slowly towards the enemy, holding their shields in front of them for protection. When the enemy threw rocks or spears at them, they lifted their shields above their heads for protection. When they got near to the enemy, the soldiers threw their spears, took out their swords and ran at the enemy. They sometimes used cavalry (soldiers on horses) to hunt down enemy soldiers who ran away.

What special weapons did the Romans use?

The Roman army sometimes had to conquer a town surrounded by a strong stone wall or a well-defended fortress.

Then the army used larger weapons such as the ballista, the battering ram and the onager.

1.2 The Romans invade

About 2000 years ago, tribes of people known as Celts ruled Britain. Then the Romans decided to invade Britain. The Romans had already captured vast areas of land around the Mediterranean Sea, Western Europe and parts of the Middle East. Why did the Romans invade Britain? Did they conquer the whole country? How successful were the Celts when fighting the Romans?


In Roman times, the area of Britain now known as Scotland was called Caledonia, and the people were known as the Caledonians. The Romans never defeated these fierce warrior tribes.




The Romans built Hadrian's Wall across England to keep watch and help defend against attacks.



Tribes hiding in the forests and hills fought fiercely against the Romans for many years. The Romans built many forts in these areas and placed large groups of soldiers where some of the fiercest tribes lived.



The southern part of Britain was the most peaceful. Over time, the Celts and the Romans mixed more and more.



There are many men, buildings and herds of animals. There is much wood. The money is bronze or gold.

Why did the Romans invade Britain?

The Roman emperor at the time of the invasion was called Claudius. He wanted to show that he was a strong leader. He was unhappy that some of the Celts had been helping tribes in France fight against the Romans. The Romans were also looking for resources such as land, iron, lead, zinc, copper, silver and gold. When the Romans conquered new lands they gained control of all the goods and resources. The Romans then bought and sold the resources or took them back to Italy. For example, the Romans got olive oil, honey, pottery, marble and horses from Greece. They got corn, dates and figs from Egypt and perfumes, spices and jewels from the Middle East.

The invasion

The Romans invaded Britain in 43 ce. They landed on the south coast and fought many battles with different tribes of Celts. The Romans pushed the Celts back and captured the south of England within four years. In the north of England and in Wales there were thick forests and hills where the Celts could hide. It took the Romans another 30 years to conquer these parts.

Did you know?

The invasion of 43 cE was the third time the Romans invaded Britain. The first time, the Romans left because their ships were ruined in a storm. In the second invasion, the Romans beat many of the British tribes. However, the Romans eventually left Britain when the tribes promised to pay money to Rome each year.

The Celts fight back

Some Celts accepted Roman rule, but others still fought to try to make the Romans leave. In 60 CE, Queen Boudicca of the Celtic Iceni tribe gathered a huge army and burned several Roman towns in the south of England, including London, while the main part of the Roman army was in Wales. The Roman army quickly returned and attacked Boudicca's army. The Romans were outnumbered, but they were better organised and better equipped. Both sides lost many soldiers, but the Romans eventually won.


1.3 Roman settlers

There were 50 000 Roman soldiers in Britain – about 15 per cent of the whole Roman army. The soldiers lived in forts. The forts were spaced with one day's march between them. Between the forts, the Romans built roads so they could travel quickly across the country. How did Britain become more peaceful? What impact did the Romans make on Britain? What was it like in Roman Britain?

The Celts are defeated

Some Celtic tribes made peace with the Romans immediately. They agreed to obey Roman laws and pay taxes. Other tribes fought against the Romans and were defeated many times.

Many tribes refused to join together with other tribes to make themselves stronger. So the Romans were able to attack individual tribes and beat them one by one. Over time, the country became more peaceful as the Romans defeated more and more tribes and made peace with other tribes.

The Romans build towns

The Romans built towns in every country they conquered. Roman towns were all laid out in the same way. They were protected by tall, thick walls and had straight streets laid out in a grid pattern. There were houses, shops, markets, meeting places, workshops, offices and temples.

The Romans tried to make their towns as healthy as possible. Pipes and aqueducts brought fresh, clean water from rivers and lakes. Drains carried away dirty water. Most towns had at least one bathhouse where people could go to wash, take exercise and meet friends.

Roman Britain

Over time, many tribes who lived far away from the Roman towns moved to be near the towns. They felt safer near the towns. The towns were built on flat land that was good for farming. Farmers sold crops and cattle to the Romans. There was plenty of work for people, either on the farms or building houses and roads for the Romans. Local rulers who supported the Romans prospered. They made money by trading in wool, gold, silver, lead and pottery. They often adopted Roman customs and dress. Slowly, the British and Roman cultures began to mix. The British people began to live like the Romans and the Romans adopted local traditions.

Did you know?

The Romans built excellent roads. They built their roads as straight as possible so that soldiers and goods could move quickly from place to place.

Challenge

The Romans built aqueducts to bring fresh water into towns from a river or lake. The Romans built aqueducts in many of the countries they conquered. Some of these aqueducts still survive today. Find out about the nearest surviving aqueduct to the place where you live. Write a brief fact file about it and include some images.

1.4 Life in the Roman army

The strength of the Roman army was one of the main reasons why the Roman Empire became so large and powerful. It was the largest army in the world at this time. Roman soldiers were highly trained, well organised and had the best weapons and equipment. Who was in the Roman army? What uniforms did the soldiers wear? What was their training like?

Who could be a soldier?

Only men were allowed in the Roman army. There were two main types of Roman soldiers: legionaries and auxiliaries.

The best soldiers were called legionaries.

A legionary had to be a Roman citizen, which meant he had to own property or farms.

A legionary had to be tall, fit, literate and over 17 years of age. Legionaries stayed in the army for at least 20 years.

The emperor was the first to give them more money and permission to wear gold rings and to live with their wives.

This was in 197 ce.

This was written by Herodian, a writer in Roman times. Before 197 ce, only the most important leaders in the army were allowed to marry.

armour auxiliary legionary literate pension The other type of soldier was called an auxiliary. An auxiliary was not a Roman citizen. Auxiliaries were recruited from tribes that had been conquered by the Romans. An auxiliary was not paid as much as a legionary and had to serve in the army for at least 25 years. Auxiliaries did many of the most dangerous jobs. For example, when the Roman army went into battle, auxiliaries fought in the front lines.

What uniforms did the soldiers wear?


A Roman soldier's uniform and equipment were designed to protect his body and help him to survive for long periods of time on military campaigns.

Did you know?

After a legionary had completed 20 years in the army he was allowed to retire. Retired legionaries received a pension or a large area of land. Some retired soldiers lived together in towns called colonia.

Fitness and fighting

Roman soldiers were very fit. They could march 32 kilometres in five hours, wearing all their armour and carrying their weapons and equipment. They practised sword-fighting and javelin-throwing every day. The soldiers could all cook, swim, sail boats and build bridges. Discipline was very strict in the Roman army. Soldiers could be executed if they failed to follow orders.





What was a villa?

'Villa' is a Latin word. It means a large house in the country surrounded by its own grounds and other buildings.





Most villas had under-floor heating. The floor was raised up by pillars of stone or bricks and a small fire was lit to allow warm air to circulate.

Be a good historian

Good historians know that archeology is very important to help us understand the past. Archeology is the study of things that people made, used and left behind. The aim of archeology is to understand what people of the past were like and how they lived. People who study archeology are called archeologists.

Who lived in villas?

As the countries in the Roman Empire became more peaceful under Roman rule, some important and wealthy Romans decided to move out of the towns and build villas nearby. Soon there were hundreds of villas all over the Roman Empire, surrounded by farmland and workshops for iron-making and pottery. The villas were luxurious. The owners lived in the main building of a villa and the slaves and farm workers, who helped run the estate, lived in one of the smaller buildings.



Villas were decorated with beautiful wall paintings and mosaics like this one.

Villas were built by the wealthier Romans outside the main towns. Most people lived in smaller houses or apartments in towns. Find out about the different types of home inside Roman towns. What did they look like? How many rooms did they have? How big were they?

1.6 The end of the Roman Empire

The Roman Empire grew for several hundred years. At the peak of their power, the Romans ruled between 50 and 90 million people across Europe, North Africa and the Middle East. The Roman army was the most powerful in the world and Rome had grown from a small town into an enormous and wealthy capital city. What happened to the Roman Empire? When and why did it decline?

The empire is attacked

Many tribes from northern and central Europe attacked towns in the empire. The Romans called these people barbarians because the Romans



thought they were uncivilised. There were so many attacks that the Roman army could not defend all the towns.

Money


The empire was running out of money. Some emperors had wasted money on expensive parties and building projects. The Roman leaders had to raise taxes to pay for the army. This caused many people to rebel.

A slow decline

The Roman Empire continued to grow until the time of Emperor Hadrian (117–138 cE). Hadrian decided the empire was too big to rule properly. He thought there was too much land for the Roman governors and the army to control and manage. From this time, the Roman Empire began to decline. The decline happened over a long period of time. Here are some of the reasons why the Roman Empire began to fail.

Poor leadership

The emperors were not always chosen because they were the best leaders. They sometimes bribed people to get the job. There were many arguments between important



Romans. From 192 ce to 313 ce the Romans had over 40 different emperors. Many were assassinated.

Did you know?

Britain was part of the Western Roman Empire. For many years, tribes attacked Britain. At first, more Roman soldiers were sent to defend Britain but eventually, in 410 cE, the Romans left. The Roman soldiers and leaders who ruled Britain were needed to defend other parts of the empire.

The empire was too big

The empire became so large it was difficult to control. In 285 CE, the Emperor



Diocletian divided the empire into two parts, the Eastern Roman Empire and the Western Roman Empire. He believed that the empire would be easier to control if there were two emperors ruling separate parts of the empire. The Western part had its capital in Rome, the Eastern part had Byzantium as its capital (now Istanbul). There were many disagreements and wars because of this split.

The fall of Rome

In 410 ce, a tribe of Goths attacked Rome (in the western part of the empire). They killed many Romans, destroyed buildings and stole treasures. In 476 ce, a tribal leader named Odoacer took control of Rome. He forced the last emperor of the Western Roman Empire (Romulus Augustulus) to step down as leader. This was the end of the Western Roman Empire. The Eastern Roman Empire continued for hundreds more years, but gradually got smaller and smaller.

Be a good historian

Good historians know that there is rarely only one reason why something happens: there are often a number of different reasons. You might think some reasons are more important than others. A good historian always explains and justifies their ideas.

The Roman army became weaker

As the empire grew, it needed more soldiers.
There were not enough Romans to join the army, so more non-Romans were recruited. Many of these new soldiers were from the tribes in countries that the Romans had conquered – Gauls from France, Goths from Germany and Thracians from south-east Europe. These soldiers were not committed to the empire and did not always follow instructions properly in battle.





2 The Anglo-Saxons

In about 410 CE, the Romans left Britain. They went back to Italy to defend parts of the Roman Empire nearer Rome. The British people no longer had the Roman army to defend them from invaders. It did not take long for new tribes to **invade** Britain. These tribes became known as Anglo-Saxons.

2.1 Who were the Anglo-Saxons?

The Anglo-Saxons were a mix of tribes from northern Germany, Denmark and the Netherlands. They crossed to Britain in large rowing boats. After the Romans left Britain, the Anglo-Saxons started to arrive. Some Anglo-Saxons immediately lived peacefully, but most fought with the British (known as Britons) for the land. When the Anglo-Saxons captured the land (which they usually did) they brought their families from their homeland. Who were the Anglo-Saxons invade and settle?



The Anglo-Saxons were a mix of three main tribes from northern Europe – the Angles, the Saxons and the Jutes. The Angles and the Saxons were the largest of the three attacking tribes, so we call them Anglo-Saxons. From 360 cE, even before the Romans left Britain, Anglo-Saxons **raided** the coast of Britain.

They attacked villages and Roman villas and

tried to steal gold, jewellery and animals. The Romans usually beat the Anglo-Saxons away quickly. When the Romans eventually left Britain, the Anglo-Saxons did not just raid the country and then return across the sea to their homelands. The Anglo-Saxons decided to settle in Britain instead.



An Anglo-Saxon warrior

The Anglo-Saxons were fierce warriors. Each soldier was armed with a battle-axe, a sword and a spear. The soldier carried a round shield and wore a metal helmet and a type of body armour called chain mail.

Did you know?

The Anglo-Saxons never conquered the whole of Britain. They never conquered Scotland, Wales or Cornwall.

Why did the Anglo-Saxons decide to settle?

There are two reasons why the Anglo-Saxons decided to settle in Britain.

Many Anglo-Saxons wanted to find new farmland. The climate was better in Britain. Also, their homelands often flooded, so it was difficult to grow crops.


Tribes of Picts and Scots attacked from the north (we call this Scotland today). Other British tribes invited the Anglo-Saxons to Britain to help defend homes and farms against the Picts and the Scots. The Anglo-Saxons did not leave: they settled in Britain instead.

Where did the Anglo-Saxons settle?

There were many battles between
Anglo-Saxons and Britons. Over time, the
Anglo-Saxons took control of most of Britain
(see the map on page 20). Some of the Britons
who were defeated in battle became the
slaves of the Anglo-Saxons. Sometimes the
Britons and the Anglo-Saxons settled down
together and lived peacefully.

2.2 Who ruled the Anglo-Saxons?


The Anglo-Saxons did not have a single leader or emperor.
There were many Anglo-Saxon tribes and each tribe had its own leader. Each tribe controlled a different part of Britain.
The strongest and most successful tribal leaders were known as cyning. This was the Anglo-Saxon word for king. Each tribal 'king' ruled over a kingdom. Where were the main Anglo-Saxon kingdoms? How did a king rule his tribe? What different roles did people have in an Anglo-Saxon tribe?

Anglo-Saxon kings

Anglo-Saxon tribes were often at war with each other. They attacked each other because they wanted to gain more wealth and take valuable farmland. Sometimes a king who had conquered the land of several other kings called himself 'bretwalda', which meant 'ruler of Britain'.

Anglo-Saxon kingdoms

By about 600 cE, there were five main Anglo-Saxon **kingdoms**. Each kingdom had its own ruler. The map shows all these kingdoms.




The main Anglo-Saxon kingdoms

The king lived in a large wooden house, called a hall, where he held meetings. The king lived with his family and some of his most loyal warriors. Every farmer on the king's land gave him a share of the food they grew. The king also took land and treasures from other kings if he beat them in battle. Kings wore fine clothes, jewels and a crown.



Ordinary Anglo-Saxon villagers were called ceorls (pronounced 'churls'). They were farmers and skilled craftsmen, such as clothweavers, pottery-makers or metal-workers. They lived in small, wooden huts. Ceorls had to fight for their king in return for the land he allowed them to live on.

Some slaves were captured in battles with other tribes. Other slaves were criminals or were born into slave families. Slaves wore poorquality clothes and were forced to work for their whole life. They slept in a barn with the animals.

Ruling a kingdom

If you were an Anglo-Saxon leader or king, life was difficult. People expected you to lead warriors in battle and protect your tribe's land from your rivals. Sometimes people in your kingdom tried to kill you because they wanted your power and riches.

The thanes were the king's advisors. They travelled around the kingdom with the king and helped him to rule his people and organise his soldiers. The thanes owned large halls in the villages. They stayed in these halls when they visited the villages. They made sure that the villagers followed the king's laws. The thanes owned expensive jewellery and wore fine clothes.

Did you know?

Each king had a council of advisors to help him. This council of advisors was called the witan.



Women had different roles from men. A king or thane's wife stayed at home, weaving cloth, sewing and looking after the children. Poorer women worked on the farms with the men. They also cooked, cared for children and made clothes.

2.3a What was life like in an Anglo-Saxon village?

The Anglo-Saxons built their own villages. They did not live in the stone houses and towns left by the Romans. They looked for land that was good for farming and near to a water supply, such as a river. Sometimes they cleared an area of forest to build their homes and farms. They used the wood from trees to build huts and fences to protect their cattle from wild animals such as wolves and foxes. They hoped the fences would also protect them from enemy attack. What was life like in an Anglo-Saxon village? How big were the villages? What was it like inside people's homes?




Did you know?

The Anglo-Saxons gave England its name. 'Angle-land' (which later became England) means 'land of the Angles'. Scotland was also named after a tribe – the Scotti tribe.

Owning land

Most Anglo-Saxons were farmers. The ordinary villagers (called ceorls) owned enough land to grow their own food and keep some animals. They had some land next to their homes to grow vegetables and more land in some of the large fields that surrounded the village.

Homes and halls

The villages varied in size. Some contained just a few houses, but others had as many as 50 homes. The king's chief advisor (called a thane) lived in the largest house, which was called a hall. Thanes had slaves who farmed their land for them. The king owned a hall in some of the larger villages. He travelled from one village to the next. The villagers had to provide him with food.



What about the children?

Ordinary Anglo-Saxon boys learned, from a very young age, all the skills they needed to be both a farmer and a warrior. They learned how to hunt and fish, plant crops and use swords, axes and spears. They had to behave like adults from about the age of 10. Like Anglo-Saxon women, girls had a different role from boys. Their mothers taught them how to cook, mend clothes, look after younger children and collect water and firewood.

A hole in the roof let the smoke out. Thatched straw roof People ate a thick soup called pottage every day. It contained vegetables such as peas, beans, onions and cabbages. Sometimes it also contained meat. Wood for the fire Villagers collected water for washing and cooking from a river or well.

Did you know?

The Romans lived in Britain before the Anglo-Saxons. The Romans built their homes with stone and had glass windows and under-floor heating. The Anglo-Saxons did not understand the Roman ways and did not like to live in the old, abandoned Roman towns. Sometimes, the Anglo-Saxons took some stone from old Roman towns and used it for their own buildings.

2.4 What were the achievements of the Anglo-Saxons?

When the Anglo-Saxons first began to settle in Britain, there were many different kingdoms that fought against each other. Over time, some kingdoms defeated others and took their land. By the 800s CE, there were three main Anglo-Saxon kingdoms: one in the north, one in the middle and one in the south. By now, Anglo-Saxon culture and society had become more advanced. What were the achievements of the Anglo-Saxons?

Making coins

When the Anglo-Saxons first came to Britain, they did not use coins. Most people used barter, which means that they exchanged goods. During the 8th century CE (the 700s), coins were used widely in Europe, for example in France. Soon, Anglo-Saxons

began to produce their own coins to make trading easier. Coins with an image of the king showed how important and wealthy the king was.

Anglo-Saxon crafts

The Anglo-Saxons were highly skilled craftspeople. Archeologists have found dice and board games made from bone, pottery, glass and stone. They have also found a musical instrument called a lyre (similar to a small harp). Anglo-Saxon metal-workers made iron tools, pots and swords. Woodworkers made wooden bowls, furniture, farming equipment and wheels.

Anglo-Saxon jewellers made beautiful belt buckles, brooches, necklaces, purses and ornaments.
The jewellers used gold, silver, glass and precious stones from abroad. This shows that the

Anglo-Saxons traded with other countries.

Educated Anglo-Saxons communicated with people in other European countries. For example, letters survive that were sent between Anglo-Saxon King Offa of Mercia and Emperor Charlemagne, who ruled over parts of France, Italy and Germany.



The Anglo-Saxons loved to create poems, songs and stories. They gathered together in halls to sing songs and hear poems such as *Beowulf*, the story of a heroic warrior who fights to save his people.

Buildings

At first the Anglo-Saxons avoided Roman towns and built their own villages instead, using wood. Over time, the Anglo-Saxons began to reuse the stone from Roman towns, villas and roads. Some Anglo-Saxon villages became important trading centres and began to grow. The Anglo-Saxons built ports on the south and east coasts of England. These quickly grew into busy centres of trade – local people and merchants bought and sold goods from all over Europe.

By 1000 CE, there were about 15 towns in Britain with more than 1000 people living in them. Eight of these towns had more than 3000 people living in them.



This Anglo-Saxon building from the 8th century ce was made from stone and still survives today.

2.5 Viking invasions

From about 800 ce, 400 years after the Anglo-Saxons invaded Britain, the country was under attack from tribes from Denmark, Norway and Sweden. These tribes were made up of fierce fighters, usually known as Vikings but sometimes called Norsemen (meaning men from the north). Why did the Vikings attack? How did they get to Britain? Did the Anglo-Saxons fight back?

Viking raids



The first recorded Viking attack on Britain was in 789 ce. This was the start of a long, violent struggle between the Anglo-Saxons and the Vikings. At first, the Vikings raided Britain. They travelled over the North Sea in longboats and stole valuable treasures, such as gold, jewels and books. They also took food, cattle, clothes and tools.

The Vikings could use their long, flat, narrow boats in both deep and shallow water. These boats could cross vast oceans and also travel close to the shore or along a river so Viking warriors could jump straight off the boats and fight.

Viking settlers

In 865 ce, an army of Vikings arrived in Britain. This time they wanted to conquer land and settle in Britain, not just raid the country and return to their homelands. The Vikings had many reasons for choosing Britain as a place to settle. Their land at home in Denmark, Norway and Sweden was not very good for growing crops or keeping animals. This meant that, as the population grew, there was not enough food. The Vikings were searching for better, more fertile land for their farms.



During their raids, the Vikings had learned that Britain contained treasures that could make them rich.

The struggle for power


There were many battles between the Anglo-Saxons and the Vikings. Gradually, the Vikings conquered more and more land, taking control of most of the large Anglo-Saxon kingdoms. By 874 CE, only the Anglo-Saxon kingdom of Wessex in the south-west of England was not controlled by the Vikings. This area of England was ruled by King Alfred the Great. He beat the Vikings in battle but was unable to drive them completely out of the country.

Eventually, after many more years of fighting, King Alfred and the Vikings made a peace agreement. They decided to split the country into two – the Anglo-Saxon lands were in the west and the Viking lands were in the east. The area that the Vikings controlled was called the Danelaw.

At first the two sides continued to argue and fight, but gradually the Anglo-Saxons and Vikings became neighbours in Britain and there were many years of peace. By the mid-1000s CE, the country was united under one king, Edward. Edward's father had been an Anglo-Saxon king and his mother had once been married to a Viking king.

Did you know?

The Vikings were great travellers and traders.
They sailed all over Europe and the Atlantic
Ocean in their longboats. The objects found at
Sutton Hoo show that the Anglo-Saxons also
traded with many distant lands. There were coins
from France, bowls from Egypt, cloth from Syria
and silver dishes from the Mediterranean.







3.1 Who were the Maya?

The first Mayan tribes were huntergatherers. This means that they moved around from place to place gathering food (such as fruit, seeds and nuts) and hunting animals for meat. Gradually, the Maya learned how to grow crops such as corn (which they called maize), squash and beans. This changed how the Maya lived. Why and how did knowledge of growing crops change Mayan civilisation?

Farming techniques

The Maya learned how to clear large areas of jungle to create fields to grow crops. They used tools made from stone, bone and wood. When they had removed most of the trees, they set fire to the remaining plants. They used the ash from these fires as a fertiliser that added nutrients to the earth. The ash helped the Maya to grow crops successfully. The Maya dug canals through the fields so they could water their crops.

Where the land was very wet, the Maya built raised platforms on which they grew crops. In mountainous areas, they used stepped farming, which means that they built terraces up the hillside. The terraces stopped the soil slipping downhill and provided a firm, flat base for the crops to grow.

A wide variety of food

Maize was a very important food for the Maya. They made corn flour from maize and used it to make bread. The most common type of bread was very thick and flat, known as a tortilla. The Maya also made porridge from maize. Mayan farmers grew many other crops, including sweet potatoes, tomatoes, avocados and chilli peppers. The Maya kept bees for honey and grew cotton to make clothes. They caught fish in the rivers and hunted wild turkeys and deer. The Maya used cacao beans to make a bitter chocolate drink, sometimes spiced with chilli.



Stepped farming using terraces helped the Maya to farm in mountainous regions.

Did you know?

Water was important for growing crops and for drinking. Where water was hard to find, the Maya collected rainwater and stored it in tanks and reservoirs.

The Maya used a flat, stone table known as a metate to grind corn into flour. They used the flour to make bread.

Settling down

Once the Maya began to farm, groups of people were able to settle in villages. The Maya were successful farmers so there was plenty of food and the population in these villages began to grow. Over time, cities started to develop.



3.2 What were Mayan cities like?

The Maya never had one emperor ruling over them or just one central capital city. Instead, there were many independent areas, each controlled by a different king. These were called city-states. The city-state was the total area ruled by a king. The king and his advisors and all the important buildings were located in the main city, usually close to the centre of the city-state. How many city-states were there? What were Mayan cities like? How were the cities set out?

Mayan civilisation

There were many different **city-states**, but all the Maya spoke the same language – Mayan. At least 6 million people still speak Mayan today. People in all the city-states worshipped in the same way and followed similar laws. They planned their cities in the same way, with all the important buildings in the centre and the ordinary homes and farms on the edges. All the Maya dressed in a similar way and shared the same calendar.




Rival city-states

For many years, historians thought the Maya were peaceful. However, archeologists discovered wall paintings, statues and carvings that recorded wars between rival city-states. Sometimes one city-state became very powerful and gained control of some of the smaller city-states. But no state managed to control the whole Mayan civilisation.

Did you know?

The Maya built their spectacular buildings without metal tools, the wheel or large animals (such as the donkey, ox or elephant) to help them.

3.3 Who ruled the Maya?

Each Mayan city-state had its own king.
When a king died, his son or other closest
relative became the next king. Who helped
the king rule? What were the different levels
in Mayan society? How do we know so
much about the Mayan kings?

The king and his family

Each city-state had a ruling family. The king, his wives and children were at the top of Mayan **society**. They lived a life of luxury in large palaces in the centre of the city. People believed that members of the royal family were more important than anyone else and thought the royal family could protect them. The king performed special ceremonies to protect his city and bring good fortune.

There was only one way for a new ruling family to take over a city-state. This happened when the ruling family in another city-state challenged and defeated the king's family. Fights and wars between city-states were common. In times of war, the king led his army into battle.

Helping the king

A group of men known as the nobles helped the king to rule. The nobles were generals and other officials. They were usually members of the king's family.

Mayan nobles spent a lot of time on their appearance. They wore brightly coloured clothes and painted their bodies. They wore lots of necklaces, hair bands, bangles and enormous earrings.



This painted pottery figure shows a Mayan noble.

They also wore huge hats – the taller the better! The hats were usually decorated with long feathers from the quetzal bird, which had tail feathers up to 1 metre long.

Some women played an important role in Mayan society. The wives and mothers of kings sometimes held positions of influence. At a lower level than the nobles were the craftspeople, architects and merchants. This group could become wealthy, but they were not allowed to become nobles, unless the king invited them. They could not even dress like a noble. At the next level were the farmers, who lived outside the city centre on their farms. At the lowest level were the slaves. Most slaves were captured in wars from other city-states. Some people became slaves as a punishment for a crime. Slaves did much of the building work and had no rights or privileges.

How do we know about Mayan people?

We know a lot about the rulers of the larger city-states because the Maya recorded the kings' reigns. Information about the kings was painted onto pottery or carved in wood or stone.



Stone columns known as stelae were carved out of limestone. The stelae recorded the actions and achievements of the kings.

Did you know?

The organisation of society was very strict. It was very difficult to move from a position within society. If a person's father was a farmer or a merchant, then that person became a farmer or a merchant. People could not marry outside their social class.

Crime and punishment

Laws were similar across all the city-states. If a person broke a law, a judge listened to the evidence and decided whether the person was guilty or not. The punishments varied. A thief might become a slave of the victim for a short while. The punishment for damaging someone else's property was to pay for the damage or become a slave. Murder was rare. The punishment for murder was execution or the family of the victim might decide to take the murderer's land instead.

3.4 Mayan merchants

There were many city-states. Each city-state traded with others. The large trading network was very important for the city-states. Why was trading so important? What goods did the Maya trade? How did the merchants travel?

Why did the city-states trade?

The city-states had most – but not all – of the goods they needed. Each city-state had to trade with other city-states to get the goods it needed. Different city-states had different resources to trade.

 City-states near the coast had plenty of fish and salt. Salt was important for preserving food. But the coastal city-states had poor farmland so they traded their fish and salt for maize and other vegetables.



This jade jewellery set was found in the jungle city-state of Calakmul, Mexico, and is from 600–900 ce. Jade was popular in all the city-states.

- Material for making tools and for building, such as flint and limestone, was available in the city-states in the lowland areas. The lowland city-states traded building materials for shrimp, lobsters and crabs from the coastal city-states or for valuable stones from the highlands. Jade and obsidian (a type of glass found in volcanic areas) were highly prized.
- The city-states in the tropical areas traded skins from jungle animals, feathers, wood and cacao beans for the goods they needed.

Jade or chocolate money

The Maya did not use coins or notes to buy and sell. The merchants agreed between themselves how much of their goods they would swap for something they wanted. This is called bartering. Sometimes merchants carried jade or cacao beans with them to swap for goods because these resources were so valuable.

Merchants

The people who travelled around the region trading goods were known as merchants. Merchants were well respected and many lived very comfortable lives. They did not use donkeys or elephants to help them transport goods. They used people from their own city-state or slaves. The city-states were linked by well-built roads. Sometimes the merchants used rivers or sailed in the sea, close to the shore so they did not get lost.



This picture shows a merchant and craftsmen trading stone axes and hammers. Can you also see the men carrying goods to the next city-state, the women putting maize into pots and the farmers in the fields?

The merchants also used canoes made from hollowed-out tree trunks. These boats were up to 15 metres long, 2.5 metres wide and powered by 25 rowers.

Did you know?

Sometimes a merchant arrived in a city-state with a wide variety of goods to trade – fine pottery, stone axes, textiles, feathers, gold, jade, honey, animal skins, vegetable dyes, herbal medicines, bags of salt, paper (produced from fig-tree bark), jewellery and furniture.

Feathers were important and valuable to the Maya. Feathers were one of the most popular items that Mayan merchants traded. Find out the different types of bird that were the source of the feathers. How did the Maya use the feathers?

3.5a What achievements are the Maya known for?

The Maya are well known for their great stone cities in the jungle and their huge pyramids. They were also very advanced in their use of mathematics and writing. The Maya studied the movements of the stars and planets and created an accurate calendar. What was Mayan writing like? Why were the Maya so interested in astronomy? What art did they create?

Great artists

The Maya were very artistic.
They created beautiful vases and bowls out of clay and made jewellery and small statues in jade, stone, gold, silver, wood and bone.

The Maya did not use metal tools. They used tools made from hard stone. They carved stelae (see page 43), which told stories of their kings, and they painted pictures on palace walls.

Weavers created colourful fabrics using dyed cotton. The bright material was usually made into clothing, but it was sometimes used as wall hangings to decorate people's homes.

Mayan mathematics

Mayan mathematics was very advanced. Our number system is based on the number 10, but the Maya based their system on the number 20. It is believed that this was because humans have 20 fingers and toes. The Maya used just three symbols to show numbers: a dot (for '1'), a line (for '5') and a seashell (for zero). The Maya were one of the first groups of people to use the number zero. With their number system they could add and subtract, record large numbers and accurately keep track of dates.



Mayan writing

The Maya created a written language, known as hieroglyphics (or glyphs). The glyphs were pictures that represented words, sounds and objects. The Maya used glyphs to record important events and stories about their leaders. They carved the glyphs onto stone columns or the walls of stone buildings. They also created books using paper made from tree bark. A book was called a codex. The plural of codex is 'codices'.

The land that the Maya occupied is made up of rainforests, mountains and coasts. The mountain areas are the highlands and the areas nearer to sea level are the lowlands.

3.5b What achievements are the Maya known for?

Serious sports

The Maya played a type of football called pok-a-tok. Two teams played against each other in a large ball court with sloping sides and areas for spectators. Without using hands, each team tried to keep a hard rubber ball in the air and get it through stone rings on the side of the court. People probably played pok-a-tok for fun, but some experts believe it was also a way of settling conflicts. They think that sometimes members of the losing team were executed.

Studying the stars


The Maya were very interested in astronomy. They used observatories to watch the movements of the sun, planets and stars. They predicted eclipses and solstices. There are two solstices in the year: the longest day and the shortest day. The Maya used their observations to create three different calendars. They used one calendar to record all history over a long period of time and another calendar to plan special ceremonies. For farming, they used a calendar of 365 days, like the one we use today.

Did you know?

The Maya believed that crossed eyes were a sign of beauty. They dangled objects in front of a newborn baby's eyes, until the baby's eyes were completely (and permanently) crossed.

The Maya used their knowledge of astronomy when planning their buildings. The pyramid at Chichen Itza has 365 steps. Some Mayan buildings have windows for viewing the movement of the planet Venus. Mayan generals believed that it was good luck to fight battles when Venus was in a certain position in the sky.

What happened to the Maya?

Mayan civilisation was at its peak from about 250 ce to 900 ce. However, after 900 ce the Maya abandoned many of the cities in the rainforests. Experts are not sure why this happened. Here are some theories:

- Some experts believe that the cities grew so big that they used up all the farmland. As a result, the cities could not grow enough food so there were many famines.
- Other experts think that there were so many violent wars between the city-states that some large groups of Maya were wiped out. Other Maya might have run away from the rainforests and moved to places where they felt safer.

The rainforest cities were abandoned after 900 cE, but many other city-states continued for hundreds of years. Then, in about 1500 cE, Spanish invaders began to conquer the Mayan city-states. Many Maya died fighting against the Spanish. Others died because they caught diseases that the Spanish brought with them. Eventually, the Spanish conquered all the city-states. However, the descendants of the Maya continue to live in the area today.





4.1a On the road

The invention of the wheel changed how people travelled. The wheel made it much easier to transport people and goods further and faster. When was the wheel invented? How did people move heavy objects before the invention of the wheel? How has technology changed the way in which we use the wheel?

Before the wheel

Before the **invention** of the wheel, people either walked everywhere or rode on an animal. Some people used a horse, camel or donkey to carry goods to market. When things were too heavy for a human or an animal to carry, people used rollers or a sledge.


Sometimes a team of people worked together to carry a heavy load.

Using roads

The first roads linked villages and towns.

People travelled along the roads to visit
markets and to trade goods. The roads began
as simple dirt tracks that people created by
travelling to and from places along the same
route. The roads often followed rivers or valleys.

The first roads were mainly used for trade and were called trade routes. Some of the earliest long-distance trade routes over land date from about 1500 BCE in Western Asia, the Mediterranean, China and India. Traders transported goods such as silk and spices from one place to another. Some of the best roads of the ancient world were built by the Romans. The Romans built a network of roads so the Roman army could march quickly from one part of the empire to another. Merchants also used these roads. By 300 CE, the road network of the Roman Empire reached from Italy to France, Britain and the eastern Mediterranean region.



Roman roads were so well built that some still survive today. Others have been renovated, using the same route as the Roman road.

The invention of the wheel

No-one knows who invented the wheel, but experts think that the first wheels were made about 5000 years ago. The oldest known wheel was from Mesopotamia, which is the name of an ancient region covering modern-day Iraq, Kuwait and the eastern parts of Syria. Some experts think that the Mesopotamian people invented the wheel - and news of the invention spread very quickly along trade routes. Other experts believe that the wheel developed in separate parts of the world at about the same time. The first wheels were made from wood. The wheel changed the way in which people travelled. People could travel much faster and large carts with wheels could carry heavy loads over long distances.

Challenge

Did you know?

People in many countries have used strong animals, such as donkeys, camels and horses, for transport for thousands of years. However, the Maya did not use animals to transport the materials they needed to build their cities. Instead, they either used slaves or employed people from their own cities. The Maya did not use the wheel either.

Be a good historian


Good historians know that change can happen very quickly, but it can also happen very slowly. For example, for many thousands of years a cart or coach, pulled by an animal, was the quickest way to travel. The invention of rail, air and motor transport greatly increased the speed of travel.

4.1b On the road

As the world population grew, the number of towns and villages increased. As a result, the number of roads that linked these places also increased. Advances were made in bridge-building and road-making techniques, so the quality of roads in many countries slowly improved. However, most people still travelled around on foot or used strong animals to pull goods and people in coaches and carts.

Getting faster

There have been many different uses of the horse and cart all over the world. For example, armies used fast, light, two-wheeled chariots in battle and to transport soldiers quickly from one place to another. As roads continued to improve, horse-drawn coaches became a popular way to transport goods quickly. In Britain, the quickest way to transport goods was by stagecoach. A stagecoach was a large, light, horse-drawn coach that travelled regularly over a fixed route carrying passengers and goods.

The first cars

The first car that could move using its own power was built in France in 1769. It was powered by a steam engine and could travel at about 7 kilometres per hour. In 1837, the first electric car was built. It was powered by batteries.

At this time, a new fuel was made from oil, called petrol. Inventors began to build engines that were powered by burning petrol. These new engines were called internal combustion engines.

In 1885, a German man named Karl Benz decided to put one of the new engines on a three-wheeled vehicle he had made in Mannheim, Germany. This is known as the first motor car. It had a tiny engine at the back and could travel at about 12 kilometres per hour. It has the same type of engine we still have in most of our cars today.

Motor cars

Motor cars soon became more and more popular. Lots of companies all over the world began making cars – for example, Peugeot in France (1891), Fiat in Italy (1899), Dodge and Cadillac in the United States (1902), Rolls-Royce in Britain (1906) and Audi in Germany (1909).

These car manufacturers were later joined by BMW in Germany (1916), Toyota in Japan (1937), Ferrari in Italy (1939) and Hyundai in South Korea (1967).

Factories and cars

In 1908, Ford Motor Company in the United States began making one of the most famous cars ever made – the Model T. The Model T was the first car made in large numbers in a factory on an assembly line. The car was cheap and easy to drive. Over 15 million Model Ts were sold between 1908 and 1927, making it one of the best-selling cars in history. At the peak of production, Ford produced about 10 000 Model Ts every day. It was such a well-built car that some Model T cars still survive.

Today, most cars are made on an assembly line in the same way as the Model T.

Modern motors

In recent years, some cars have been criticised for the amount of pollution they put into the environment. Many car-makers have started to introduce more 'environmentally friendly' versions of their cars known as hybrids. Most hybrid cars have an electric motor for short journeys and a petrol engine for longer journeys.

Other motorised vehicles

Manufacturers also started fitting engines to carts and carriages. These vehicles eventually became the trucks, lorries, buses and coaches that transport goods and people on today's roads.

4.2 Water transport

From the earliest times, people have used boats to travel. They used boats to catch fish, trade goods and explore the places where they lived. How were the first boats made? How have different people used boats? How have boats changed over time?

The first boats

People have been travelling on water for tens of thousands of years. The first boats were simple rafts made from tree logs tied together, and dugout (canoes) made from hollowed-out tree trunks. The oldest boat ever found in the world is a dugout. It was made some time between 8200 and 7600 BC.




The oldest boat ever found. It was found in the Netherlands in 1955. It measures 298 centimetres long and 44 centimetres wide.

People in different parts of the world used different types of boat. A coracle is a light, round boat made by sewing animal skins over a wooden frame. Coracles were popular in India, Vietnam, Iraq and Tibet. In parts of the Middle East, northern Africa and South America, reed boats were common. Reeds are a type of long grass found near rivers.

Reed boats were made by tying reeds together. A 7000-year-old reed boat was found in Kuwait in 2002.





Sail boats

Experts think that people began to use the power of the wind to push their boats over long distances about 6000 years ago in Mesopotamia (modern-day Iraq, Kuwait and the eastern parts of Syria). Sails were made from cloth or strips of thin wood. The sails were hung from a pole (called a mast) to catch the wind. Merchants used some of the earliest known sail boats on the Nile, Euphrates and Tigris rivers more than 5000 years ago.

Using boats for war

Boats have also been used in wars. The Romans and the Vikings, for example, used ships to transport soldiers and goods from one place to another. In the 14th century, warships were fitted with large guns, called cannons, to fire at enemy ships in an attempt to sink them. Today, warships can carry fighter planes and attack helicopters.

Explorers and trade

Explorers sailed ships all over the world looking for new land. As the explorers found new lands, more merchants began to trade for goods from these countries. Over time, all sorts of goods produced in foreign lands began to appear in countries thousands of miles away. For example, trading ships brought tea from China, sugar from the Caribbean, and spices and cotton from India to Britain. Today, huge container ships carry cargo in big metal boxes and ferry ships carry foot passengers, cars and trucks from one port to another.

Canal transport

People built a canal to transport goods from one place to another when there was no nearby river and the road system was not good enough. One of the oldest and longest canals in the world is the Grand Canal of China, which dates back to the 5th century BCE. The Suez Canal, which opened in 1869, connects the Mediterranean Sea to the Red Sea through the Isthmus of Suez in Egypt. It is 193.3 kilometres long and is used by about 17000 ships a year.

Did you know?

On the River Nile, the wind always blows from north to south and the current always flows from south to north. So the sail could only be used when sailing in one direction. When travelling against the wind, the boat had to be rowed.



4.3 Rail transport

After the invention of the wheel, people made carts and carriages that were pulled by horses or donkeys. Over time, these wagons and carriages were pulled by animals on tracks or rails. The tracks allowed the wagons to move more quickly than on ordinary roads. These tracks were sometimes called railways. Who was the first person to use an engine on a railway? How did railways develop? Why are modern railways so important?

Steam power

In 1804, Englishman Richard Trevithick attached a steam engine to a carriage that ran along a track. His locomotive, as it was called, pulled wagons that carried iron. Soon, other people began to use locomotives to transport heavy goods such as coal and iron. In 1808, Trevithick began charging passengers to travel on a wagon pulled by one of his locomotives.

Passenger locomotives

The world's first passenger railway opened in Britain in 1825. It ran a distance of 40 kilometres between two towns in the north of England. Soon there was a network of railways all over Britain. From the 1830s, railways started to spread throughout the world.

Be a good historian

Good historians are able to identify the consequences of an event, invention or development. Rail transport is a good example of how an invention and its further developments have had a major impact.

Did you know?

The long trains that carry goods are called freight trains. The longest freight train ran in Australia in 2001. It was 7 kilometres long and had 682 wagons full of iron ore.

Impact of the locomotive

Locomotives and their railways changed the ways in which people lived and worked. People could work in the city but live in the country because the trains could transport thousands of people every day.

People and goods could be transported further and faster than ever before. Merchants and businesses used the railways to transport fresh food long distances quickly. A growing railway network created jobs, and also made towns, cities and countries much more connected with each other. For example, the Trans-Siberian Railway in Russia is over 9289 kilometres long and connects Moscow with the far east of Russia, Mongolia, China and North Korea.

Railway development meant that letters and newspapers could be delivered much more quickly so news spread faster. High-speed travel meant that sports clubs could now play teams from other places. In Britain, for example, a journey between London and Edinburgh took two weeks by road in 1745. By 1901, people could make the same journey in nine hours by rail.

New locomotive power

By the 1950s, diesel engines were used more than steam engines in many countries. Diesel engines were easier to drive, quieter and cheaper to run than steam engines.

Some of the fastest locomotives today are powered by electricity. The fastest speed ever reached by an electric train was 574 kilometres per hour in France in 2007. In recent years, there has been an increase in the number of locomotives powered by magnets, particularly in Japan, Korea and China. They are called Maglevs and can travel at high speeds.

4.4 Up in the air

It is difficult to think of our world without air travel. Airplanes are a common sight in our skies. Every day thousands of airplanes carry people and cargo all over the world. How long have people been able to fly in machines in the sky? Who built the first airplane? How is air travel used today?

The first flights

In September 1783, French brothers Joseph and Étienne Montgolfier built a large balloon from cloth and paper. They lit a fire underneath the balloon that heated the air inside it. Hot air is lighter than cold air, so the balloon rose up from the ground. The first hot air balloon carried a sheep, a rooster and a duck for a mile. All the animals landed safely. A few months later, on 21 November, the brothers used their balloon to carry two men for five miles over Paris. It was a 25-minute flight. They were the first people ever to fly.

The first airplane

After the Montgolfier brothers, many other people experimented with flight. In 1852, airships were invented. The first airship was a balloon with a steam engine and propellers attached to steer the airship. In 1891, the first glider that could travel long distances and carry people was created.



Then, on 17 December 1903, American brothers Orville and Wilbur Wright made the first engine-powered flight in an airplane. The flight lasted 12 seconds and covered a distance of 37 metres. By 1905, the brothers had made over 150 flights, some lasting nearly 40 minutes.

The development of air travel

During World War One (1914–18) airplanes were fitted with guns and bombs. After the war, airplanes were used to deliver goods from one place to another. In the 1920s, larger airplanes were built that could carry many passengers. These large airplanes are called airliners. Over time, airliners became bigger and could carry more and more passengers over greater distances.

Air travel today

Today, air travel is one of the most popular ways to travel over long distances. The largest airliner is the Airbus A380-800, which can carry up to 853 people on two passenger floors. The Boeing 787-8 Dreamliner can fly up to 13000 kilometres non-stop without refuelling. Huge airplanes, called cargo planes, transport perishable goods such as fruit, vegetables and flowers to markets thousands of miles away from where they are produced.

Challenge

Most airplanes today are powered by jet engines. Find out how about the history and development of the jet engine. Who invented the first jet engine? In what airplane was it first used? How does a jet engine works? Write a report about how a jet engine lifts an airplane into the sky.

4.5 Transport in the future

The ways in which we travel and transport goods are always changing. There are many new ideas and inventions in transport and travel. Recent developments include cars that can park themselves and goods that are delivered to your home by drone. What are the latest ideas and inventions in transport? Why has transport changed in recent years? How might transport develop in the future?

Space transport

Space transport is one of the newest types of transport. In 1961, Russian Yuri Gagarin became the first human in space when he orbited the Earth once during a 108-minute flight. In 1969, Americans Neil Armstrong and Buzz Aldrin became the first people to walk on the moon. In 1981, the Space Shuttle was launched. It was the first spaceship that could be reused many times. In 1998, the International Space Station (ISS) was put into orbit around the Earth.

Did you know?

Driverless cars have been developed. These cars can drive safely behind other vehicles, detect buildings, stop suddenly for other cars and change speed.

The ISS is used as a research laboratory in which crew members conduct scientific experiments. Since 2000, permanent crews have been living and working on the ISS. The astronauts travel between Earth and the ISS in spacecraft. Space flight companies are now planning to offer tourist flights into space.

Environmentally friendly travel

Most cars, buses and trucks have engines that burn fuel made from oil. Some experts believe that the world's supply of fossil fuels (such as oil) is in short supply. Also, burning fossil fuels in engines releases polluting gases into the atmosphere, which has caused a number of serious environmental problems. As a result, engineers and designers are improving engines so they burn less fuel and developing new types of fuel and transport.

 Alternative fuel vehicles use energy that does not come from oil. For example, engines have been developed that use propane or vegetable oil.

- Walking and cycling not only protect the environment, but also get you fit.
- Using public transport (trains and buses) means there are fewer cars on the road, which in turn means less pollution.
- 'Smart cars' are becoming popular. Carmakers, including BMW and Nissan, are producing more electric smart cars fitted with many different types of technology to help the driver and to conserve energy.
 Smart cars use no petrol and operate for 130–160 kilometres per charge.

Good historians know that, at any one time, some things are changing and some things are staying the same. Some changes happen quickly, triggered by new discoveries or changes in technology. Other changes happen slowly, especially if things have been done the same way for thousands of years.
