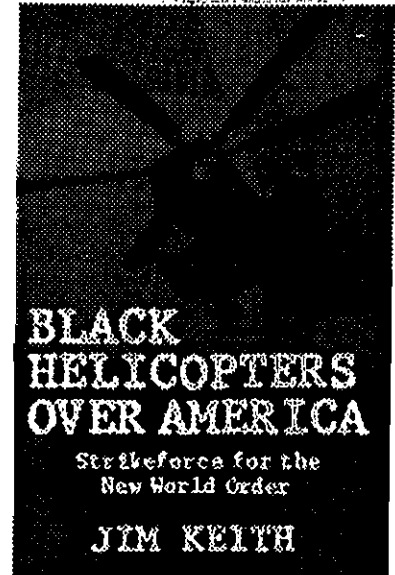

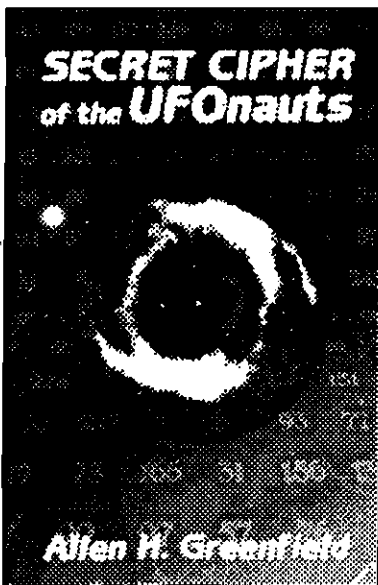

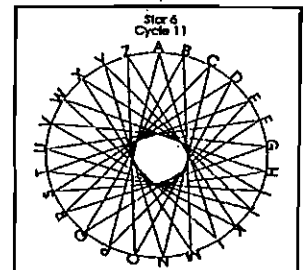

# Who's behind the Gas Japanese Attacks?

Last year, the United States almost went to war with North Korea. What does Japan have to do with the US going to war in Korea? On June 10, 1994, North Korea threatened Japan with chemical weapons, and specifically nerve gas attacks, if it allowed the US to use Japan's islands as bases. On March 20, 1995, in the heart of the Tokyo subway system, they may have made good on their threat.

The North Koreans want the US to stay out of Japan and the military base of Kadena on Okinawa, where we could launch and fuel B52s. Guam is currently the only base in the Pacific with B52s, and it is a long hard trek to Korea for strikes. The added distance would add great monetary and human costs to US strikes on the Korean mainland. Without good bases, tactical strikes would be limited to rocket attacks and other South Korea-based attacks, which could be overrun or destroyed more easily.

North Korea's threatening behavior was alleviated when it signed a treaty with the US. As a part of that treaty, in order to obtain the release of US military personnel held prisoner when their helicopter was shot down over NK, the US sent NK a great deal of oil in October of 1994. As a result, the helicopter pilots were returned (one alive and one body) in January of 1995. Ironically, the helicopter had crashed near a chemical weapons storage area, and some believe that it was going in to extract a defector or an agent.

A recent article in the *Army Times* says NK is now practicing its biggest land and air ops in memory. With winter weather, roads to the south are impassable. However, the spring or summer, when roads are passable, would be the ideal time to

move. It was for just that reason that NK attacked South Korea in June of 1950. At any rate, we may expect to see action in Korea again within the year.

## Happy Anniversary?

The gas attacks were likely a "trial run" by NK, to show the Japanese government that they are serious about their chemical attack threats. Another reason for the attacks may be that NK has announced that they plan to unify North and South Korea during 1995, which marks the 50th anniversary of their liberation from Japan after WWII. Was the Japanese subway gas attack, which killed 12 people and sickened 5500, another way to "celebrate" the defeat of their former oppressor? Indeed, Japanese officials are deeply afraid of ethnic Koreans in Japan causing disruptive and terrorist attacks and have instigated various investigations into the backgrounds and activities of these people.

Whatever the motive, the subway attack was clearly expected:

- The *Orange County Register* newspaper reported that before the gas attack, the price of stock for companies that manufactured gas masks sky-rocketed. An investigation by Japanese officials claims there was no insider trading.

- Sales of gas masks were ten times normal in the two weeks before the gas attack. Most of those buying masks were government employees.

- One day before the attack the civil police

asked their military to give them special chemical warfare training.

- The Japanese government sent in a decontaminating unit immediately after the gas attacks, before they could have known what needed to be decontaminated.

- The first emergency medical technicians on the scene were wearing gas masks, which is not SOP (Standard Operating Procedure.) They were also carrying atropine, which is the antidote for nerve gas.

#### Who's In Charge Here?

Officially, the attacks were the work of a cult known (in English) as Aum Supreme Truth. [Yes, yet another evil and crazy doomsday religious cult has emerged to threaten democracy.—ed.] However, the attacks were done with military precision. Three to five people attacked six different trains in a 43 minute period. While that might be difficult for amateur cult members, NK has a Special Forces group trained for chemical warfare and as terrorist shock troops. In fact, since 1983, NK has used such forces to bomb airlines, kidnap various government officials, and run various other terrorist attacks.

Aum Supreme Truth (Aum Shinri Kyo) is headed by Shoko Asahara, and his influence is felt throughout the world. The cult's claimed involvement in the situation has contradictory aspects. The cult is not just in Japan. There are 30,000 members in Russia and just 10,000 in Japan. It is not known how many members in Japan are ethnic Koreans, or if the cult is active in North Korea.

A mark against the cult-as-instigator theory is that they did not attack Russia. There are many more members in Russia, and it would have been easy to mask the attack as Chechan terrorism, which the Russians are expecting. If the official explanation for the attacks (the cult's general "terror and doomsday" philosophy) were true, it would seem that Russia would have also been a target.

After the attacks, 2500 police descended on the cult's compound and found a chemical lab and supplies. However, only four people were arrested during the raid, and none of those initial arrests had anything to do with chemicals or the gas attacks. They were for kidnapping and keeping people imprisoned illegally.

Another problem with the theory that the cult was the agent of the attacks is that the police found no gas masks, no chemical suits, and no atropine antidote injectors on the scene. Which means that, if they were making the nerve gas, they were either incredibly capable or incredibly stupid.

Also, the cult's seemingly ludicrous claims that they used the chemicals for electronic circuitry boards and pottery *actually has some validity*, as some of the chemicals found are used for cleaning circuit boards and other for dyes in porcelain.

#### Yankee Go Home

Two days before the gas attacks, a co-author of this article alerted the *Los Angeles Times* to be on the lookout

for anti-American public relations attacks taking place in Japan, and especially anything relating to airplanes. That was because the North Koreans want to incite Japanese public opinion against having US military airpower in their country. A few days after the gas attack, the TV show *Nightline* showed Japanese officials seizing copies of cult magazines, which they had published, but not yet distributed. Those

magazines showed US C130 planes and had a story about them spraying nerve gas over Japan. Now, the cult leaders are claiming the US was responsible for the attack. These actions fit quite nicely with the North Korean aim to get the US out of Japan.

Whether or not the cult was involved in the attacks, North Korea is the likely instigator. The gas was highly diluted, and the number of deaths was relatively small. It would have been very easy to kill thousands had that been the goal. Since the gas attack

was almost directly under the Japanese Parliament building, the North Korean's likely aim was not mass murder, but rather to scare the Japanese government.

The gas attacks brought the message home: North Korea means business, and if there is a war between the US and NK, Japan had better pick sides very carefully.

# Shoko Speaks

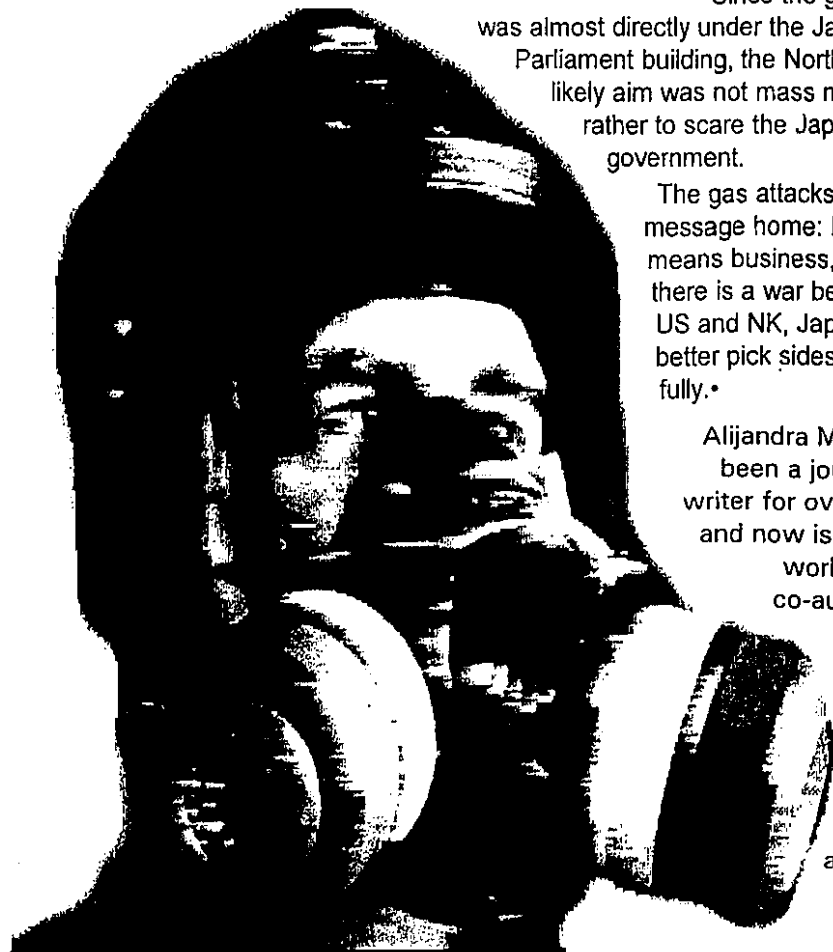
*The following are excerpts from a transcript of a video message taped for the Japanese TV network NHK by Shoko Asahara on March 24, 1995. Officials allege that Asahara and his followers are behind the Japanese subway gassings of March 20.*

Due to the media reports and police announcements, you may be thinking that Aum Shinrikyo actually produced sarin and carried out the attacks in the subway. Before I touch upon this incident, I must explain how this situation came about. Without this knowledge, you won't be able to understand these media reports.

First of all, my body is very weak now. I'm affected by Q-fever rickettsia, which is also affecting about 50% of the 1,700 monks and nuns—my disciples who have renounced their secular lives. Rickettsia is an extremely harmful virus, as harmful as any pestilence, and it has been sprayed on us repeatedly. Poisonous gases like sarin and yperite were also sprayed. Although antibiotics are helping us to sustain our lives, we are in a very critical condition. For this reason I appeared in public only a few times after May 1994. We repeatedly announced these incidents to news agencies, but the media never raised the issue.

We act on the basis of prophecies. In 1997 and 1998 most of Japan's large cities will suffer major damage in a war between the US and Japan. Then the Japanese economy will collapse. Japanese assets will be lost...

From the beginning, our activities have been legal. However, many incidents hampered our efforts. For example, the



media and the National Public Safety Commission prevented us from making necessary purchases. They also pressured suppliers to stop exporting their commodities to us. As a result we were forced to produce everything on our own for 1,700 monks and nuns. Several hundred different chemicals were necessary for this purpose.

For example, several newspapers wrote yesterday about the potassium cyanide found in Aum's complex. The chemical is used for gilding—plating Buddhist statues. Yet it is an extremely poisonous compound. Ordinarily, if a person possessed such a poison, the police would naturally suspect him of planning a murder. However, these industrial chemicals are bought and sold by the ton. Thousands of tons of these chemicals are used in Japan annually. Without them, we actually could not live or engage in our religious activities. This is because it is hard for Aum Shinrikyo to buy things.

Now let me talk about the main topic. The media report that the police found three chemicals near the Satyan No. 6 building, in which the police say I reside. These chemicals are phosphorus trichloride, sodium fluoride, and isopropyl alcohol. The police say they found them there, and it is probably true. However, you should understand the following.

Since last year some magazines have been spreading rumors about Aum Shinrikyo producing sarin. We deny their accusations. So why did the police find these chemicals in warehouses near the Satyan No. 6 building, which they say is my residence? This clearly indicates that Aum Shinrikyo had no idea they were related to the production of sarin.

Why is this so? Aum Shinrikyo sells a variety of products so that monks and nuns can live in the order. For example, we have become the first or second largest seller of DOS/V personal computers in Japan. Sodium fluoride is a raw material for ceramic coatings. We have made plans to start selling chinaware in 1995 or 1996, which is made with sodium fluoride. The goal of this project was to offer cheap but beautiful chinaware to many people through mass production.

We purchased phosphorus trichloride for two reasons. The first was to study its properties as a plasticizer in the production of plastic goods. Our 1,700 monks and nuns currently use plastic containers. We had also expected to sell our plastic products in the future. The second reason

was that we need phosphorus trichloride to produce fertilizer and other agricultural chemicals for hydroponics. This would be used in the event Japan suffered major damage.

What about isopropyl alcohol? According to scientists, the production of sarin requires isopropyl alcohol. But you can easily obtain it by going to a drug store. Like ethanol, it is widely used as a disinfectant.

Therefore, even though a large quantity of sodium fluoride was found, it is only a material for ceramic coatings. Even though phosphorus trichloride was found, it is only used as a plasticizer in the production of plastic products. The buildings of Aum Shinrikyo throughout Japan occupy a total area four times larger than Korakuen Baseball Stadium. Phosphorus trichloride was used in the fireproof structure of our buildings. We were also planning to use it for fertilizer and other agricultural chemicals in hydroponics. Lastly, we needed a large amount of isopropyl alcohol because there are more injuries as the number of monks and nuns grows.

How could the police conclude that Aum was preparing to murder people simply from the discovery of these three chemicals? If their argument is correct, then semiconductor and solvent manufacturers who use phosphorus trichloride must also be guilty of conspiring to murder.

I must explain the cause of this incident. As I've mentioned earlier, we've been suffering from Q-fever rickettsia. Before this incident we suffered from sarin and yperite poisoning. Who sprayed these poisons? Clearly, it is the US military because over ten US Air Force jets flew in formation over Aum's buildings, and we detected these poisons in the air immediately after their flight. Therefore, if we ever attempt to fight anyone, we must fight the US military.

However, we do not want to fight. There were 2,500 policemen mobilized in this investigation. Yet we did not use any violence to resist them. This is because we love freedom and peace...

From the way I see the media working now, I feel that this may not be revealed. But the truth is the truth. I hope you conduct yourselves courageously in your reporting.

## **Update:**

Japan experienced at least one other serious chemical gas attack after the March 20 incident. Also, on April 22, the top scientist (and presumably a key witness) of Aum Supreme Truth was fatally stabbed as police and reporters looked on. The killing occurred as Hideo Murai, 36, head of the sect's "Science and Technology Ministry" was returning to its Tokyo headquarters. The assailant, Hiroyuki Jo, 29, called himself a "right wing extremist." Perhaps more significant is the fact that he is a North Korean living in Japan.

# A Tour of Tijuana Cancer Clinics

In a most unlikely, hissing-of-summer-lawns Los Angeles neighborhood we found the "Queen of Alternative Cancer Networking," Lorraine Rosenthal, at home. We had called ahead (213-663-7801) and made an appointment to meet Lorraine and review her materials on Tijuana cancer clinics. The Cancer Control Society's book corner was full of extraordinary titles on the non-toxic, holistic prevention, control and "cure" of cancer. As we sat on the sofa to partake of this alternative education, as well as the apricot kernels (natural laetrile) on the coffee table, the books began to pile around us and the hands of the clock spun around. At the end of the day, we walked out of the Cancer Control Society with an armload of books that would prepare us for our Tijuana cancer clinics tour.

With Lorraine's assistance, we had our tour somewhat planned, but with

prior knowledge of Mexico's hellish roads, and little knowledge of its language, how would we get around? We'd already been advised by our U.S. car rental agency that the rental was not allowed to cross the border.

The Cancer Control Society's listing of Tijuana cancer clinics also contains contacts for hotels, insurance coordinators, and a list of patients who have agreed to discuss their alternative cancer experience over the phone. We called the Days Inn at Chula Vista, just ten minutes from the Mexican border, for information. We were advised that people staying at the hotel as patients or potential patients of the Mexican clinics enjoy a special rate at the hotel (\$35 per night), and that a personal driver was available for day trips into Mexico! Two problems were solved with one phone call. We headed for Chula Vista.

The next morning, Friday, we were up and ready when our professional driver, Roberto Rodriguez, arrived on time for our first day trip. He explained

that his services were available for all Tijuana and Las Playas (the Beach) cancer patients who wish to be driven back and forth across the border each day. He is also available for those patients who feel well enough for an afternoon sight-seeing drive. His

charge is \$20 per day, per person (roundtrip), no matter how long your day happens to be. Roberto's van is new, clean and well maintained and he is an excellent driver. He is expertly bilingual, having grown up in Los Angeles, and he is a polite and charming Christian man. You will be in good hands should you choose to call Roberto (619-686-7251 or 011-526-623-9303). In addition to Roberto's private transportation service, most clinics have a free shuttle service daily from all American hotels near the border, and will also pick you up at the airport in San Diego upon your arrival.

If you have a relative or friend in the San Diego area, the cost of your treatment in Mexico would be significantly reduced. However, we personally inspected the rooms at most of the clinics and found them to be quite comfortable and clean. Although they are comparatively smaller than American hospitals, all Tijuana clinics have fully-equipped surgical facilities and professional medical staff. The costs vary from \$3000 to \$9000 for the

## Glossary

*Listed below are definitions of some of the terminology used by practitioners of alternative cancer therapies. Although this list does not encompass every therapy in use at present, it is representative of those treatments specifically mentioned by doctors interviewed at the clinics visited, or detailed in their literature.*

**ACCELERATED-CHARGE NEUTRALIZATION (ACN):** This treatment is a specialty of the American Biologics Hospital. The theory behind ACN is that cancer cells fool the immune system by carrying a negative electrical charge. The cancer cells are given a positive charge through the application of a current carrying platinum wire inserted directly into the tumor. This causes the immune system to recognize the cancerous cells as foreign and to respond accordingly.

**ACUPUNCTURE:** Practiced for centuries in Asia and now

gaining increased recognition in the West, this ancient science has been a successful treatment for a wide variety of ailments. Treatment is based upon the theory that the body contains energy pathways, called meridians, which connect the inner organs to acupoints located just under the skin. When disease occurs in an organ, the energy flow is disrupted. Hair thin needles inserted at the proper acupoints serve to either draw needed energy to, or divert excess energy from the affected organ.

**AMINO ACID THERAPY:** Infusion of amino protein compounds for the restoration of cells, mainly through diet.

**ANTIOXIDANTS:** Vitamins such as E, A and C which protect cells against harmful free radicals, which are molecules routinely produced by the body through oxygen contact. These free radicals are known to damage the body's DNA structure, thus creating mutated (cancerous) cells.

**BETA CAROTENE:** A derivative of vitamin A. It is now widely accepted as a cancer preventative.

**BIOLOGICALS (BIOLOGIC THERAPIES):** Any therapy which



entire length of stay, and the average length of stay is three weeks. We believe that your bill for cancer treatment in the U.S. would easily be quadruple the amount. Payment is up-front; usually credit cards are accepted. Most clinics have insurance coordinators to help you file the necessary paperwork for insurance reimbursement. To our surprise, we learned that some of the treatments are covered by private insurance, and that your insurance contact may not be aware of which treatments are covered. (Call International Health Care Resources at 619-575-7684 for information). Organized Tijuana Cancer Clinic Tours are available by calling 619-585-3926 or 209-529-4697.

At the end of your clinic stay, you will be sent home with oral supplements, including Laetrile, which are all legal to take across the border as long as you have a prescription in hand. You will be asked to visit the clinic once a year for continuing treatment and detoxification, and to renew your prescription for Laetrile. You will remain on Laetrile supplements for the rest of your life, which are legal to obtain through the mail from various sources. If you are thinking of purchasing a barrel of apricot kernels in order to cure cancer, don't bother. You must have the required 9 grams of pure Amygdalin per day for the cancer battle, which would require eating literally pounds of apricot kernels each day. (However, apricot kernels should be part of a cancer prevention diet and are available from

Health World at 800-282-2873).

One of the most important things we learned in our personal cancer clinics tour is that the non-toxic Tijuana protocols are "for life." This means that for quality of life you must change your lifestyle and take active control of your

body on a day to day basis. Patients who have been "cured" and go off their holistic regimen usually wake up one day to find that their cancer has metastasized: "traveled" to another locale in the body. One of the most important books we picked up from the Cancer Control Society was **Third Opinion** by

John M. Fink (Avery, \$14.95). This international directory to alternative therapy centers for the treatment and prevention of cancer and other degenerative diseases is a must-have for cancer victims and their families. Information for the glossary of alternative cancer treatments section of this article comes from **Third Opinion** and from **Options: The Alternative Cancer Therapy Book** by Richard Walters (Avery, \$13.95).

This article is dedicated to the memory of our fathers, who died of cancer in 1994 before we knew what could have been done about it. We took this trip to give others the information and courage to go with their gut feeling. Please make our trip worthwhile. Don't be afraid. Mexico is beautiful and so are the people. Go! Have a nice trip!

Located at 1571 Edmundo O'Gorman in Tijuana, our first clinic stop afforded us the opportunity to meet in person with the two head doctors. Dr. Castillo Ramos and his young assistant Dr. Alvarez explained the importance of understanding that patients are very

employs biological substances or non-toxic pharmacological agents.

**CHELATION THERAPY (EDTA):** Pronounced kee-lay'-tion, consists of a solution used to cleanse the body of heavy metals such as lead, cadmium and arsenic; metals which restrict the flow of blood to the vital organs. This solution contains EDTA, (Ethylenediamine Tetraacetic Acid), the large molecules of which are used to bond to and to flush out the smaller mineral molecules.

**COFFEE ENEMA:** Used to stimulate the liver in order to help rid it of toxins.

**DMSO (DIMETHYL SULFOXIDE):** Used as a vehicle to facilitate the penetration of anti-cancer drugs into a tumor.

**ENZYME THERAPY:** Enzymes are the catalysts of life. They are essential in helping the body to repair tissue damage caused by degenerative diseases. Enzymes are destroyed at 115 degrees Fahrenheit. Thus the best source of enzymes is uncooked food. Barring this source, the body is forced to produce enzymes on its own, taxing the body's energy supply.

**GERSON THERAPY:** Vigorous detoxification combined with positive nutrition aimed at restoring the body's natural immunity and healing power.

**HOXSEY THERAPY:** A nutritive anti-cancer therapy. Originally offered by Harry Hoxsey of Dallas during the 1950's. Forced to close by the "authorities" in 1960, his long-time chief nurse, Mildred Nelson, R.N, brought the highly successful treatment to Tijuana in 1963 where it has since been practiced at the Bio-Medical Center.

**HYDRAZINE SULPHATE:** An inexpensive anti-cancer agent used in the treatment of Cachexia, or "wasting away" syndrome.

**HYDROGEN PEROXIDE:** In injectable form, it is used to destroy bacteria and viruses, oxidize toxins and stimulate the immune system.

**HYDROTHERAPY:** Used to remove bodily toxins and stimulate the nervous system. Treatments include steam baths, whirlpool baths, etc.

**IMMUNOTHERAPY:** Any therapy designed to increase the

rarely permanently "cured" of cancer. Dr. Alvarez took time to explain that the secret to control of cancer lies in the changing of lifestyle and habits, which begins with the spiritual and holistic mindset at the Tijuana clinics. Half the battle is to strengthen the immune system so that the body fights the disease with its own built-in defenses. Many patients who come to the clinic after being bombarded with the toxic chemotherapy killer drug are starting off with a compromised or depressed immune response. Dr. Alvarez added that in some cancers, chemotherapy seems to help, such as in the acute phase of leukemia.

The prescribed stay at the Stella Maris Clinic is 21 days. The daily regimen consists of an intravenous treatment called a "cocktail" which you will receive for five hours each morning, weekdays only. The Stella Maris cocktail is a saline solution consisting of 9 grams (500 mgs) of Amygdalin (B-17, Laetrile), 10 cc of DMSO, and megavitamins, including ascorbic acid (Vitamin C). Also important in the Stella Maris clinic regimen are: beta carotene, proteolytic enzymes, chelation, emulsified Vitamin A and other immunostimulants, high levels of Zinc, prostglandin (an enzyme which reduces inflammation) and a strict vegetarian diet. Animal protein is discouraged in Mexican cancer clinics and makes much sense. You will also undergo strenuous detoxification rituals, and you will be put on a serious nutritional program designed to

detoxify and strengthen your immune system.

The doctors at Stella Maris have never seen a toxic or allergic reaction to the medication used. The cost for treatment at Stella Maris runs from \$2800 to \$3300 per week, depending on the type of cancer you have. Surgery is not included in this fee, and is

used only when necessary. The doctors explained that tumors, including brain tumors, do not as a rule entirely disappear; scar tissue will usually remain. Whereas American protocols recommend surgery to insure that the scar tissue is benign, the attitude at Stella Maris is to leave well enough alone. The aim is to reduce the tumor

without surgery. Dr. Alvarez stated that surgery should be performed only on life-threatening tumors which are causing major obstructions.

About 10-15% of the patients treated at Stella Maris have lung cancer. Although all the data needed for a proper scientific study is not yet available, new protocols using natural herbs in the treatment of lung cancer at Stella Maris look extremely hopeful. Dr. Alvarez claimed that the average life extension for lung cancer treatment at Stella Maris is about 2.5 years, as opposed to a few months with American protocols. We all know how quickly lung cancer claims its victims in the U.S.

On a happier note, we were told that the first encouraging sign reported by prostate cancer patients within three days of receiving the intravenous "cocktail" treatment is a reduction in frequency of urination. This translates to freedom for men who had previously been unable to travel any distance from toilet facilities! Dr. Alvarez stressed that it is important to solve the immediate discomfort or pain so that the patient is encouraged and begins to have a more positive attitude toward his or her own role in the healing process. In contrast, toxic medicines used (and lately over-used at Dana Farber) in America cause patients to feel much, much worse before they feel better, if

body's immune system.

**LAETRILE (AMYGDALIN) (B17):** Either through injection or as a dietary factor, Laetrile acts as an enzyme which strips the outer shell from cancer cells. Working along with the body's own natural defenses, the trace amount of cyanide contained within the Laetrile acts to destroy the cancerous cells.

**MAGNETIC FIELD THERAPY:** An as yet unproven therapy involving the placement of magnets at tumor sites. However, some patients have reported positive results.

**MASSAGE THERAPY:** Used as a method of detoxification, usually in conjunction with therapeutic sweating, diet, etc.

**NATUROPATHY:** Natural healing through the use of diet, detoxification and exercise.

**NEIHANS LIVE CELL THERAPY:** The injection of animal fetal or embryonic cells into the body. Used to stimulate the immune system, regenerate tissue and balance hormones.

**OZONE THERAPY:** Used to fight infection and destroy bacteria. Medical ozone is created by causing pure oxygen to become electrically charged. The ozone can then be delivered to a specific

target through a variety of methods, including injection.

**POLYPEPTIDES:** Amino acid chains.

**SHARK CARTILAGE:** An anti-cancer immunostimulant. It acts by restricting the blood flow at tumor sites, effectively starving the cancer cells.

**STAPHAGE-LYSATE:** A nonspecific bacterial vaccine used in the treatment of diseases such as cancer, multiple sclerosis and herpes, among others. Relatively inexpensive and almost totally non-toxic. It can be inhaled, injected or taken orally.

**THYMUS EXTRACT THERAPY:** Used to boost the recipient's production of tumosterone, a steroid created in the thymus gland and lymphatic system. Tumosterone helps in the prevention of genetic defects.

**WARBURG THERAPY:** See ozone therapy.

**714X THERAPY:** A camphor based compound developed by Gaston Naessens which acts as an immunity booster.

American Biologics is located at 15 Azucenas Street, Tijuana, off Agua Caliente Boulevard and is headed by Rodrigo Rodriguez, M.D. This clinic has inpatient and outpatient facilities, offering private and semiprivate rooms, and complete state of the art diagnostic laboratory screening, blood analysis, x-rays, and CAT scan facilities. Standard orthodox therapies are also available and integrated when jointly agreed upon by the patient and medical staff.

The treatment at American Biologics is eclectic, offering metabolic therapies along with therapeutic nutrition, tumor blockers, butyrate complex and staphage-lysate, laetrile, megavitamins, minerals, herbal nonsurgical tumor removal, experimental vaccines and biologicals, chelation therapy, and detoxification.

The length of treatment varies from one to three weeks. The cost of live cell therapy is \$2,700 for five days. This fee includes your room. A ten day program is available for \$4,300. Live cell therapy injections are \$200 per dosage. American Biologics treats all degenerative conditions including all cancers, lupus, multiple sclerosis and emphysema.

The Centro Bio Medico is the only clinic in Mexico which exclusively offers the Hoxsey therapy. This beautiful hospital sits up on a hill with a large balcony overlooking the colorful city of Tijuana. Once the spacious, castle-like home of a "drug kingpin" busted by the Mexican authorities, this seizure of personal property has at least been put to humanitarian use. The front courtyard is home to a round aviary full of chirping tweeties.

The Hoxsey clinic in Tijuana was founded by Harry Hoxsey in 1963. The Hoxsey therapy dates back to 1840 when it cured a horse of a cancerous sore on its leg. The formula was passed down through the Hoxsey family and has been used internally and externally on humans for more than fifty years. This is an outpatient clinic only; transportation from your American hotel is provided by the clinic. Length of treatment is one full day, but can continue for up to three days, with follow-up visits three to six months later.

The Hoxsey treatment has achieved best results with lymphomas, melanoma, and skin cancers, and is also recommended for Candida albicans

and Epstein Barr virus. All patients are routinely tested for Candida albicans. The Hoxsey treatment consists of a vitamin and nutritional program, along with immune stimulation and other specific treatments for viruses. The liquid tonic which is used for internal cancers is made from potassium iodide, licorice, red clover, cascara, burdock root, barberis root, poke root, and stillinga root. In addition, a salve and powder are used on external

cancers. The \$3,500 charge for therapy will cover you for life, should you need to return for additional treatment.

The Sierra Clinic, located at 30003 Gobernador Logo, Suite 202 in Tijuana, is an outpatient clinic operated by Dr. G.J. Palafox, who has been practicing in Tijuana for more than 23 years. The Sierra Clinic offers a unique Uniquad approach to the treatment of cancer. The Sierra Clinic doctors have searched out and tested for compatibility what they feel are the four best protocols worldwide. The Uniquad approach borrows from: (1) a Russian therapy called Immunex, a polypeptide

treatment which rapidly decreases pain; (2) the Hoxsey treatment (explained earlier); (3) the R.S.S. immune system booster, also developed in Russia and especially effective for breast and ovarian cancers, and (4) Dr. Palafox's personal treatment which he has used for over ten years. The treatments are non-toxic and are said to have no side effects. After treatment, the patient is given instructions to help maintain the immune system at optimum levels. The Hoxsey treatment is taken home for use after the three week program. An easy, not too restrictive diet is

followed.

The Sierra Clinic offers a homeopathic detoxification program, chelation, amino acid supplementation, thymus extract therapy and daily injections of vitamins and minerals. Also offered is the Niehans live cell therapy developed for relieving symptoms of senility, at an additional cost. The length of treatment is three weeks (18 days) and it is recommended that

patients stay in nearby San Ysidro where transportation across the border will be arranged. The cost of treatment is \$4,500, which includes six months of home maintenance.

### **Day Two: Las Playas-At the Beach**

The second day of the cancer clinics tour was a Saturday. Although all of the clinics were opened and there was lots of activity, the doctors in charge were off duty and unavailable for questions. However, we found the staff at most of the hospitals to be very congenial and, even though we had not called ahead, they happily showed us the facilities.

#### **Immune Therapy Clinic Paseo Ensenada #9 Playas de Tijuana (619) 428-2211 (24-hours)**

A quick ten minute ride from the border along the main route to Rosarito, on the way to the beach, take a left onto Paseo Ensenada and you will arrive at the Immune Therapy clinic. In our attempts to locate this clinic, we discovered that the phone number in our basic resource guide, **Third Opinion**, was incorrect, but we did manage to find the clinic.

Established by cancer patients, the Immune Therapy Clinic offers metabolic and nutritional immune system stimulation therapies from around the world. This clinic is outpatient only, however, complete arrangements will be made for travel and accommodations at a nearby hotel, plus follow-up after your return home. The length of stay varies between three to eight weeks, depending upon the patient's condition and type of cancer. The Immune Therapy Clinic treats all types of cancer, including prostate, breast, lung, brain, colon, lymphoma, and mesothelioma, specializing in metastatic cancers. The clinic also treats osteoporosis. The cost of the immune system stimulation is \$5,200 for the first four weeks.

#### **Hospital Ernesto Contreras**

1 Paseo de Tijuana Playas de Tijuana, Encinada (800) 700-1850

The four-story, 50-bed Contreras clinic is probably the most impressive cancer ward in Mexico, and is certainly the largest. Nicknamed the "Oasis of Hope," this beautiful hospital is run by Dr. Ernesto Contreras and his two

sons who are medical doctors and cancer specialists. It has a church on its grounds, and is located near the ocean and the bull ring in the picturesque village of Encinada. The first thing you notice when you walk into the front door is the wonderful aroma wafting out of the cafeteria, where the people in the village are welcome to purchase a delicious and wholesome lunch, and many of them do! As a matter of fact, our driver, Roberto, bought us lunch at the Hospital Contreras, and it was delicious!

The floors are noticeably shiny, almost like a porcelain plate. The walls and floors are a very soothing deep pink color. There are thirteen large rooms with two beds in each room. For a 21-day stay, the cost ranges between \$5000 to \$6000 depending on the type of treatment which is decided upon by doctor and patient. The Contreras Hospital treats all cancers and most degenerative diseases, such as arthritis, multiple sclerosis and lupus. The therapy used is metabolic, using Amygdalin (laetrile), enzymes, and megadoses of vitamins A and C; Alivett therapy, using the original Greek formula; Warburg therapy; 714X therapy developed by Dr. Gaston Naessens of Canada; live cell therapy; shark cartilage; and vitamin and mineral megadoses along with detoxification and immuno-modulators. The special diet at the Contreras Hospital is mainly vegetarian; and psychological and spiritual counseling is available. Dr. Contreras Sr. conducts bible studies himself.

Treatment consists of a four-hour intravenous treatment every morning, after which you are free to roam the beach or go shopping as your health begins to improve. The staff at Contreras reported that patients begin to feel much better after just 3 or 4 days of treatment, as opposed to chemotherapy's violent nausea, hair loss and sapping of strength. The Contreras staff echoed the attitude of everyone we had met on our two-day tour, that it is not necessary to feel sick before you begin to feel better! You can start to feel better right away!

You will need to return for check-ups after three months, six months,

and one year. After that, your return visits will be annual. But you won't mind, because the Hospital Contreras, unlike American hospitals, is a beautiful place to get well.

### **Gerson Therapy**

#### **Hospital De Baja Centro Hospitalario del Pacifico (CHIPSA) #449 Nubes Street, Playas de Tijuana**

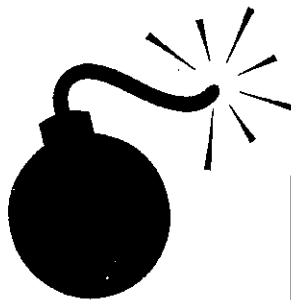
Charlotte Gerson teaches the therapy that her father, Max Gerson, M.D., founded in Germany and New York. The staff consists of seven medical doctors and a full nursing staff. Patients and companions may stay in private rooms with private bath. The Hospital de Baja is a modern, multi-level hospital with 48 inpatient beds. The Gerson therapy requires a great deal of work to maintain, but is well known for its ability to treat otherwise "incurable" degenerative diseases. It is recommended for patients who have not "poisoned" their bodies with other treatments beforehand.

For absolute recovery, strict compliance with the Gerson diet is recommended for at least one and a half years. It is unwise to begin the Gerson treatment unless one is committed to following through for at least that length of time. All types of cancer respond to Gerson Therapy, in particular, metastasized melanoma, lung cancers, bladder and kidney cancers, lymphoma, and pancreas and liver cancers. Improvements with Gerson therapy are often quick and dramatic. The center also treats other degenerative diseases such as multiple sclerosis, diabetes, arthritis.

The Gerson treatment involves an intensive detoxification and nutrition program. Freshly pressed juices made from raw, organic green vegetables, carrots and apples must be taken at hourly intervals besides three meals a day consisting of organically grown foods low in protein, salt and fat. In addition, the Gerson regimen consists of coffee enemas, dietary supplements of potassium iodide, enzymes, thyroid, iodine, niacin, and crude liver extract, and Vitamin B12 injections. The Gerson Institute also uses ozone therapy, intravenous potassium, laetrile, and clay baths.

**D**oes meat consumption cause cancer, heart disease, arthritis and other health problems, including an Alzheimer's-like brain disorder? The medical establishment knows more than they are telling.

The U.S. government and major medical associations claim that meat is nutritious. It's no secret that the United States Department of Agriculture sets the nutrition guidelines for the nation, such as the "food pyramid," which leads people to consume several servings of meat and dairy products daily. The USDA also regulates meat inspection and uses tax dollars to promote meat and milk consumption. Taxpayers subsidize meat, yet the public has been warned in countless news reports that meat consumption at least plays a role in the development of diseases like colon cancer.

The key to avoiding disease, claim "health experts," is to consume meat in "moderation"—a nebulous term that might be interpreted as four ounces of meat per day by one person, and meat at each meal by another. How much meat consumption leads to the development of disease? How much meat consumption is safe? Are the people who set health policy and those who disseminate government-certified nutrition information deliberately trying to confuse the public? Is meat good for

human beings or isn't it? If it is a factor in cancer—why the luke-warm warning? Wouldn't it be more appropriate to state that meat-eating is a health risk, rather than recommend a "moderate" amount of a potentially killer substance in the diet?

Dietitians and physicians quoted in mainstream women's magazines, television lifestyle programs, and newspaper food sections claim that "meat is not a risky substance" and that no food is "good" or "bad." These are leading sources of health information for millions of Americans, and home to advertisers peddling bacon, cheese, antacids and hemorrhoid preparations. It's not far-fetched to assume that if all the facts about meat, such as the sample listed below, were revealed to the public, many more people would consider or choose vegetarianism.

#### Food Facts

- Some cattle slaughtered for human consumption have been fed the remains of other animals. Evidence exists that turning "cows into cannibals" is detrimental to the health of the animals and the people who consume them. An unknown number of cattle have developed a transmissible spongiform encephalopathy-like agent. In Europe a TSE agent or "Mad Cow Disease" infected as many as 80,000 cattle. In the U.S., some health experts are concerned that Creutzfeldt-Jacob Disease (CJD), which can be latent for 10-30 years, has infected human beings. The disease manifests in Alzheimer's Disease-like symptoms. In one city, of 54 autopsied dementia patients, 5.5% had died of CJD. (1)

- Meat-eaters may have a 1 in 30 chance of developing "hamburger disease." As much as 3.5% of ground beef may contain the microbe E. coli, which causes the disease. Spread primarily through improperly cooked ground beef, "hamburger disease" killed 4 children and made hundreds of other people sick after they consumed burgers from a fast-food restaurant. Some of the individuals infected did not eat the burgers. Hamburger disease is communicable, easily spread by feces, unwashed hands or soiled underwear—particularly dangerous in places like daycare and senior centers where children and elders, two of the groups most physiologically vulnerable to hamburger disease, gather. "Our government has known about this deadly disease for over a decade and has done nothing," said Jeremy Rifkin, in **Beyond Beef**. (2)

- The government has proposed irradiating beef as a solution to the E. coli tragedy. Food activists say meat contamination is a result of the number of animals slaughtered each year in high-speed processing plants. There are more animals slaughtered annually for the dinner table in the U.S. (more than 6 billion) than the total number of humans living on the planet. Some scientists contend that among other dangers, irradiation drastically alters the chemical composition of substances such as protein and carbohydrates and increases the level of carcinogens in certain foods. (3)

- The consumption of animal fat can increase the production of hormones in the human body. In women, estrogen and prolactin stimulate the growth of tissue in the uterus and breast. In men, androgens stimulate growth in the prostate. People with elevated hormone levels have higher rates of cancer. (4)

- Chronic inflammatory conditions may be affected by animal product consumption. Studies have shown that people who consume animal products produce antibodies against the animal protein. Removing animal products from the diet has, for some people, relieved inflamed arthritic joints as well as alleviated eczema, swollen bronchial tubes (asthma) and uterine cramps (or PMS). (5)



- Lymphoma, or cancer of the lymph nodes, is common in chickens and believed to be transmitted by virus. Evidence links the virus with lymph node cancer in humans. Chicken farmers have a higher rate of the disease than any other occupation, and animal experimenters who use chickens have developed the disease. (6)

- Vegetarians have twice the amount of "T" cells, and other natural killer-cell activities (which destroy cancer cells) than meat-eaters. In fact, there are substances in plants that boost the immune system. In addition, a study showed the survival rate of people with AIDS who have Kaposi's syndrome improved with a macrobiotic diet. (7)

- Pesticides concentrate in the fatty tissues of animals. People who eat animal products consume much larger amounts of pesticides (more than a dozen times more) than those who don't. (8)

- A six month investigation of seafood revealed that almost half the samples of fish examined were infected with fecal matter. (9)

- As many as a third of chicken carcasses are contaminated with salmonella. A quarter or more of salmonella varieties are not affected by antibiotics. Many cases of the flu are undiagnosed cases of salmonella, and in some cases it can cause serious illness and death. (10)

Is meat the culprit in diseases like cancer? Plenty of evidence strongly suggests that animal products have a deleterious effect on the human body and, conversely, that plants contain substances to prevent and in some cases reverse disease. As people languish and die from painful wasting diseases, reams of medical journals, filled with credible studies linking animal products with illness and plant-based diets with good health, lie unread on bookshelves in physicians' offices and public libraries. Virtually hidden from public view, this potentially life-saving data has been available for decades to anyone who knows where to look and how to decipher medical jargon.

Today, it's not necessary to dig into medical journals. A half dozen books by physicians contain basic information proving that meat-eating, even in moderation, is tied to health risks. Nevertheless, "meat in moderation" gurus continue singing the same tune.

U.S. taxpayers subsidize other products linked to health risks, but at least the Surgeon General's warnings appear on cigarette packages and in ads. As the information and online explosion give the public greater access to facts about diet and diseases like cancer, consumers could soon demand that meat packages bear similar labels. If government health authorities and the popular press stressed the facts listed here, the majority of Americans would then have sufficient information to decide which foods are "good" and which are potentially very "bad." But that assumes government officials and the medical establishment place human health above all corporate interests.

Health organizations, pharmaceutical companies, and industries such as petroleum, chemical pesticide and animal feed producers profit from America's huge appetite for meat and milk and related health problems like obesity, coronary disease and high blood cholesterol count.

Vital information sometimes seeps into the mainstream, such as the China Study, often referred to as the "grand prix" of epidemiology which made the front page of the *New York Times*. Led by biochemist T. Colin Campbell, the massive study dispelled dozens of myths including the long-held concept that meat is necessary in the diet for iron. Campbell, who earlier examined the relationship between diet and cancer for the federal government, told the press that human beings are a "vegetarian species." The story made a splash worldwide but has since been buried beneath the avalanche of studies, from those focused on the "cancer gene" to stories claiming that fat intake is not

related to breast cancer.

Food facts have become more available through alternative magazines, books, and from volunteers working on issues such as environmentalism, vegetarianism, world hunger, animal rights, macrobiotics and natural health. But the flow of alternative information can also be blocked. For instance, two states have already passed laws making it illegal to say or write anything bad or "unproven" about fruits and vegetables. This means unless the government or another establishment authority agrees that a pesticide sprayed on fruit can cause cancer, the information might not get reported.

Could similar restrictions soon be applied to meat and milk? If enacted, such laws could effectively curtail much of the work of vegetarian organizations, animal rights and environmental groups, food irradiation activists and those opposed to the bovine growth hormone and genetic engineering of fruits and vegetables. Is it coincidental that such Draconian laws—similar to those used in the last century to stop anti-slavery newspapers from reaching Southern states—are reemerging just as the public is becoming more vocal about food issues?

Greater details about meat-eating and health are available to anyone with enough time, and let's say paranoia, to investigate just what the government and esteemed health organizations know about what is (and isn't) in meat and why a meat-free diet is a major factor in the prevention of many diseases. Is there a conspiracy to keep Americans addicted to a diet that progressive health professionals contend puts people in the hospital, while keeping the medical and meat industry coffers full? Or, are the high priests of nutrition in denial about the effects which hamburgers and chicken breasts can have on human beings, including their loved ones and themselves? Whichever answer one prefers, this fact is clear: we can't leave our health in the hands of bureaucrats and industries whose interest in what's placed on our dinner table is purely financial, not beneficial.

## Duran Video a Fake?

• A dramatic and widely-shown video, which purports to show alleged White House shooter Alberto Francisco Duran, may in fact be a fake. Researcher Charles Zeps has compared the tape with an earlier tape shot by NBC news from a passing car, and the two simply don't match up. The NBC tape shows a man in a trench coat, his back to the camera, walking up to the White House fence. Then, the sound of gunfire is heard, as the man holds his position. Two other men are standing approximately 3 meters from the shooter, one to his left and one to his right. Unlike the brief and rather bland NBC video, "Video 2" is a dramatic and up-close production which shows the armed "Duran" apparently firing his weapon and dancing leftward toward the videographer. A man approaching from the left pushes a stroller with a young child. Zeps notes that the child, with a semiautomatic weapon firing just feet away, never appears startled and in fact does not move in any discernible way. Just before the stroller scene, an older man is seen walking calmly towards "Duran." As the older man rotates his head towards the video camera, he is clearly grinning or laughing. In addition, Zeps notes that the cameraman would have had to be over 9 ft tall to have the particular point-of-view of the footage, unlike the car-level NBC tape. Finally, there is the "Magic Stroller." In the beginning of the video, the man with the stroller is going past "Duran" However, this same man and stroller are again seen approaching from the left as the two "heroes" are shown jumping "Duran" in the final scene. "Video 2," supposedly shot by a Brazilian tourist who later died due to

## Kill Spree Connection

• Two infamous cases of mass murder appear to have an unusual and disturbing link. In July of 1984, James Oliver Huberty opened fire with an automatic rifle at a crowded McDonald's restaurant in San Ysidro, California, killing 21 and wounding 19. He was killed by a police sharpshooter. In January of 1989, Patrick E. Purdy attacked the children of the Cleveland Elementary School with an automatic rifle, killing five children and wounding 30 before committing suicide. The city medical examiner found that Huberty's hair contained an extremely high level of manganese, as well as high levels of lead and cadmium. Likewise, a postmortem mineral analysis on Purdy's hair revealed an unusually high amount of manganese. Both killers were welders, working at jobs where they frequently handled manganese, lead, cadmium, and iron. Preliminary studies have shown that many violent offenders have high levels of such substances, or have exceptionally low levels of essential nutrients. In addition, researchers have shown that a number of poisonous metals accu-

## Second Gunman Arrested

• Are assassination conspiracies really so unthinkable in American politics? If one takes an international perspective, it is actually the "lone nut" theories which deserve our skepticism. Case in point: The 1994 assassination of Mexico's leading presidential candidate, Luis Donaldo Colosio. On February 25, 1995, Mexican federal agents arrested a member of Colosio's security detail and charged him as the second gunman in the shooting. In addition, authorities disclosed that evidence in the crime had been tampered with. Within weeks, investigators were linking the assassination to the brother of former Mexican president Carlos Salinas de Gortari. Gortari's government, in power at the time of the assassination, had claimed that the candidate was the victim of a lone, deranged assassin. (*New York Times*)

## "Little Wacos"

• The tragic April, 1995 Oklahoma bombing and alleged motivation behind it focused renewed attention on the federal atrocities at Waco and Ruby Ridge, Idaho. But David Koresh and Randy Weaver are just two among many victims of Uncle Sam's increasingly tyrannical rampages. In October 1992, the DEA and several LA Sheriff's Deputies paid a nighttime visit to Californian Donald Scott, a law-abiding citizen. Bursting into the house while he was asleep, a deputy sheriff shot Mr. Scott and killed him. No illegal drugs were found. A year earlier, in September, 1991, some 60 agents from the DEA, the Bureau of Alcohol, Tobacco and Firearms (ATF), the National Guard and the U.S. Forest Service arrived in the living rooms of Mrs. Sina Brush and two neighbors in New Mexico just after dawn. Mrs. Brush and her daughter were handcuffed in their underwear and forced to kneel while the American Gestapo searched the house for drugs. No drugs were found. Last summer, the ATF paid a visit to Harry and Theresa Lumplugh in Pennsylvania. The ATF apparently required 15 to 20 armed and masked men to handle the couple, whom they forced to open safes and hand over private papers while held at the point of a machine gun. One heartless agent kicked the Lumplugh's pet cat to death. In Ohio, the ATF raided the house of businessman and part-time police officer Louie Katona III, pushing his pregnant wife against a wall and causing her to miscarry. Nothing illegal was found. In no case did any of the victims violate any law. In the Scott case, the Ventura County District Attorney's office found that the raid was in part motivated by the desire of the Sheriff's Office to seize Mr. Scott's ranch under federal asset-forfeiture laws. The National Academy of Sciences recently estimated that 15% of the American people are presently afflicted with allergies to one or more chemical products. The study pointed out that we are exposed to more toxic chemicals while inside our homes than when we go out. The chemicals which are found in every home include benzene, which causes leukemia; common moth spray and mothballs containing paradichlorobenzene, which forms an invisible but damaging gas in some thirty million American homes; lindane, a common pesticide; and chlor-dane, used for termite control. Chloroform compounds are much more common in homes than is popularly realized. The EPA has found that chloroform levels inside of homes was five times greater than outside. Persons taking hot shower baths inside a closed shower curtain are unaware that they are inhaling substantial amounts of chloroform from the steam. Heating the water releases the chlorine in the heavily chlorinated water, which then emerges as a gas while the hot water comes from the nozzle. A daily shower is guaranteed to give you a chloroform high.

The daily ingestion of minute portions of any or all of these household chemicals contributes to the development of cancers, as they are sufficiently toxic to become carcinogenic in daily contact. However, Dr. A. Samuel Epstein, a noted cancer authority from the University of Illinois, states that "Food is the single most important route of exposure for humans to synthetic chemicals." Jim Sibbinson estimated that the average American ingests some nine pounds of chemicals in foodstuffs each year, meaning chemicals so toxic that a fraction of an ounce can cause serious illness or death. These chemicals are put into our food chain as additives, preservatives, dyes, bleaches, emulsifiers, flavors, alkalizers, moisteners, anti-caking and anti-foaming agents, conditioners, hydrogenators, thickeners, sweeteners, maturers, fortifiers, and other agents.

Most Americans are not aware that of the more than five thousand chemical additives in the foods which they eat every day, about one-third are known to be harmless, another third are described by the Food and Drug Administration as "gras," an acronym for "generally recognized as safe," and the other third, almost 2,000 chemicals have never been adequately tested for possible harmful results.

The Delaney Committee, which conducted Hearings from 1950 to 1952, listed 704 chemical additives, of which only 428

were known to be safe. The other 276, which continued to be used without any proof that they were safe, meant that the food processors were playing Russian roulette with the American consumer. Even so, it was another six years before the Delaney Amendment became law, requiring testing of these additives. The catch is that most additives are only tested for toxicity, not for their propensity to cause cancer.

Coumarin, which was a key ingredient of imitation vanilla flavoring, had been in continuous use for seventy-five years before it was found to produce serious liver damage in laboratory animals. An artificial sweetening agent, dulcin, was used as a sugar substitute for fifty years before it was found to produce cancers in test animals. Butter yellow was found to cause cancer

of the liver, that is, AB and OB Yellow. Mineral oil, the famous

Rockefeller cancer cure of the mid-1800s, which is now used in many salad dressings, was found to prevent the absorption by

the body of vitamins and other nutritional needs.

The 1938 Food and Drug Cosmetics Act certified nineteen dyes for use in foods. Since then, three have been decertified, leaving sixteen for use in foods.

The label "certified" simply means that it is pure—it offers no clue as to its possible effects on the human system. Dr. Arthur A. Nelson reported that FDA tests in 1957 reported that ten of the thirteen certified dyes then in use had produced cancers when injected under the skin of rats.

Science writer Earl Ubell estimated that humans would get twice as much of these dyes by mouth as the rats had injected under their skin. The oil-soluble colors were so poisonous that the rats died before the scientist could see whether any cancer had developed. The food industry used thousands of pounds of Orange No. 2 until 1956, when it was found to induce intestinal polyps and cancer in test animals.

Emanuel Kaplan and Ferdinand A. Dorff, researchers with the Baltimore Health Department, presented a report, "Exotic Chemicals in Food," which was presented at a meeting of FDA officials in the 1950s. We quote,

"Let us consider the chemical treatment of the various ingredients used in bakery practice. The flour is derived from seeds probably treated for plant disease protection with organic mercurials or similar agents, and the seeds are planted on soil influenced by fertilizers. Selenium (an extremely poisonous mineral substance) may be extracted from the soil. In milling, flour is treated with improvers, oxidizing agents such as persulfate, bromate, iodate and

nitrogen trichloride, which affect protease activity and gluten properties.

"Bleaching agents such as oxides of nitrogen, chlorine and benzoyl peroxide convert the yellow carotenoid pigment to colorless compounds because of alleged consumer desire for white bread. Vitamins and minerals are added in compulsory 'enrichment.' Mineral salts may be added to stabilize gas-retaining properties of flour gluten. Cyanide or chlorinated organic compounds may be employed in fumigation of the resulting flour in storage...Mold inhibitors such as calcium propionate may be employed and the final product may be contaminated on the store shelf with insecticidal powders such as sodium fluoride."

It is estimated that almost half of the American population, more than 100 million citizens, now suffer from some form of chronic illness, of which 25 million are allergic disorders. These allergies are increasingly found to be caused by exposure to or ingestion of some chemical substance.

Twenty million Americans have nervous disorders; 10 million have stomach ulcers; 700,000 suffer from cancer, and lesser numbers suffer from such diseases as lupus and muscular dystrophy. In 1917-18, of the draftees for World War I, 21.3% were rejected and 9.9% placed in "limited service" because of various handicaps. In the Korean War period, from 1947-1955, 52% of the draftees were rejected for physical and mental defects, a 21% increase since World War I, despite the great "advances" which the United States had supposedly made in nutrition, medical care, meals for school children, and other marks of progress. These figures also do not take into account that standards for World War I draftees were much higher than in World War II. In 1955, 25% of all draftees from New York City, aged from 21 to 26, were turned down for heart ailments. Of some 200 Americans killed in Korea, and autopsied, 80% were found to have advanced stages of heart disease. Dr. Jolliffe reported to Congress in 1955 that, "Whereas coronary heart disease was a rarity prior to 1920, it has now become the #1 cause of death in the 45 to 64 year old age group as well as after 65." How much of this was due to the increase in the use of chlorinated water supplies after World War I, Dr. Jolliffe does not say. Although specialists know that the ingestion of chlorine is a primary factor in the formation of arteriosclerotic plaques on the walls of arteries, no studies have been commissioned to determine the use of chlorine as a factor in the increase of deaths from heart failure. Dr. Mendelsohn has noted, fluoridation of water is one of the Four Holy Waters of the Church of Modern Medicine. Scientists dare not tamper with what is essentially a religious and emotional conviction.

Dr. Mendelsohn also points out the possible contradictions in the American Medical Association's frequent admonitions to get your daily supply of the Big Four for adequate nutrition, that is, vegetables and fruits, grains, meats and dairy products. Dr. Mendelsohn points out that many groups cannot tolerate cow's milk because of enzymatic deficiencies. Some studies show that 75% of the world's peoples are lactose intolerant, and cannot

digest cow's milk.

One of the post World War II epidemics was the worldwide reaction to the extensive use of DDT, even though DDT had come into being as the supposed guardian against epidemics during the war. Its use had been advertised as the miracle pesticide which would prevent outbreaks of various diseases in the war-ravaged nations of the world. However, DDT was eventually found to be a cumulative poison in the human system, much like sodium fluoride. Not only were considerable concentrations of DDT being accumulated in man's fatty tissues, but he also was consuming additional amounts in every forkful of food that he ate. Nobel Prize winner Dr. Otto Warburg heralded the dangers of DDT when he warned that any poison which interferes with the respiration of the cells causes irreparable damage and pro-

duces degenerative diseases such as cancer. Despite such warnings, from 1947 to 1956, the annual production of DDT quadrupled to an annual total of more than five hundred million pounds. DDT has since been banned, but the residues remain. Even after the ban, Monsanto continued to make huge profits from the sale of DDT by exporting it to other countries...

Despite the well publicized dangers of chemical food additives and other nutritional problems, the principal charitable

health foundations have for years strongly opposed any linkage of diet, nutrition and health. This program was originally laid down for them many years ago by the famous quack, Morris Fishbein, and the American Medical Association. They have religiously followed these precepts in the ensuing decades. AMA officials testified before a Senate Committee that there is no proof that diet is related to disease, adding the warning that changing American eating habits might lead to "economic dislocation." The Arthritis Foundation assures its place in the sun by regular reiterations of its claims that arthritis is incurable, although this has never prevented the foundation from annual fundraising drives to collect money for a "cure." This foundation denounces any food supplements or health detoxification programs to cleanse the system, leaving this to the province of individualistic health care practitioners in California. The foundation also opposes the following of rotary diets which could uncover food allergies in arthritis patients. In 1985, the Arthritis Foundation collected \$36.2 million, as one of a small group of "monopoly-disease" groups which have established their claim to a particular disease, a feature which is very attractive to the Medical Monopoly which

approves their positions. Its sister foundations, National Multiple Sclerosis, United Cerebral Palsy, and the Lupus Foundation are equally protective towards their stakes in the "Monopoly diseases," which the Super Rich have staked out as well-defined and unchallengeable claims. Reports of cures of arthritis by abstaining from such acid-producing foods as beef, chocolate and milk, while routine, are totally denied by the Arthritis Foundation. One San Francisco doctor published his findings after curing the most advanced cases of rheumatoid arthritis by banning all fruits, meats, wheat and dairy products, a rigorous regimen which those patients willing to abide by it found to produce total relief. The American Cancer Society also routinely branded all metabolic-nutritional approaches to cancer treatment as "anecdotal links to cancer prevention" which constitute "quackery." In 1984, faced by a growing tide of publicity about the efficacy of diet and nutrition in many cancer cases, the American Cancer Society did a reluctant flipflop, offering the cautious assertion that diet and vitamins might offer some slight benefit. ACS continued to ignore the facts showing that the record of increase in the use of food additives paralleled the annual increase in the cancer toll. From 1940 to 1977, the American intake of food colorings and additives increased tenfold, while the per capita consumption of fruits and vegetables declined. *Later studies have shown an inverse association between the daily intake of green or yellow vegetables and the mortality rates from cancer.* Studies of victims of prostate cancer, now epidemic among American men, showed a high intake of fats, milk, meats and coffee. It was recommended that baked goods should be avoided, whether because of additives or the danger of aluminum compounds was not stated.

There has also been a fivefold increase in the intake of fried food in the United States, most of which has come through the "fast food" outlets. The use of fats in these outlets, with little supervision and inadequately trained personnel, means that deep frying fats are reused over long periods of time. These reused fats have been proved to be mutagenic in laboratory tests, and are listed as potentially carcinogenic by researchers.

The *Washington Post*, January 23, 1988, noted that of 60,000 chemicals now in general use, only 2% have been tested for toxicity. *Many Americans can testify about the drastic effects of many chemicals, especially pesticides.* Colman McCarthy recently complained in his *Post* column that "The environmental war against bugs escalates as a war against people." The widespread use of such chemicals as sevin, malathion, and surban on private lawns, golf courses and public parks has resulted in a number of deaths, with an unknown number whose cause was never recorded. One man in a Washington suburb walked across a recently sprayed golf course, went home and died. He had absorbed a lethal amount of pesticide through his lowcut ankle socks. A cardiovascular surgeon who has treated 17,000 patients in the last twelve years at his Environmental Health Center in Dallas estimates that between ten and twenty per cent of the American population is being seriously harmed by chemicals. Thousands of school children sit in classrooms for six hours a day breathing in residues of asbestos, formaldehyde and other chemicals, which the school officials have no idea are present.

The list of poisons encountered in every day life is a long one. For years, people died suddenly from inhaling the fumes of a common cleaning agent, carbon tetrachloride, but it took years

before it was finally withdrawn from general sale. Recent reports found that 35% of all chickens in grocery store meat boxes contain significant amounts of salmonella, a notorious cause of gastric illness and death. For years, oranges had been gussied up for public sale by coating them with biphenyl, the chemical which is used in the embalming process in mortuaries. One of the world's most widely consumed foodstuffs is pasta, the Italian word for paste. In fact, pasta, or spaghetti, is ground wheat which is mixed with water to form a paste. In libraries, it is known as library paste. Millions of people eat this congealed paste every day. Macaroni, another common food, is dehydrated concentrated starch. Milk is the most mucous-forming part of the average American diet; drinking milk causes the system to become clogged, resulting in colds, which often develop into flu, asthma or pneumonia. Some 75% of the world's population is unable to digest cow's milk, a fact which has never discouraged dairy companies from advertising that "Milk Is Good For You."

**S**oft drinks contain large amounts of the chemical citric acid, which acts to increase the acidity level of the entire body. The results are frequently manifested as mouth cankers and duodenal ulcers. Caramel, also widely used, is prepared from ammonia; its ingestion causes mental disorders in children. Cola drinks, from a derivative of cocaine, increase heart action, cause irritability of the nerves and resultant insomnia, and can cause paralysis of the heart. Beer contains gypsum, which is better known as plaster of paris. Hops in beer cause a hypnotic effect and can cause delirium tremens.

Widely used food additives, colors and seasonings include cochineal, used to produce a bright red color. It is made from the bodies of dried lice. Food colors have been the subjects of warnings for many years; Arthur Kallet in 1933 published findings that the widely used colors Violet 1 and Citrus Red 2 (used for coloring oranges) were definitely carcinogenic. A few years ago, a number of health cure products featuring hexochlorophene, a highly recommended antiseptic substance, were hastily withdrawn from the market. It was found that phiso hex, a product then used daily in every hospital in the United States, had caused death when rubbed on the skin of babies. Phiso hex was also featured in feminine hygiene sprays, Dial soap, shampoos, toothpaste, and many feminine cosmetics; all of these products contained dangerous concentrations of hexachlorophene. Not only was it manufactured from the same chemical as DOW's deadly weedkillers, 2,4,5T and 2,4D; it is also closely related to the deadly dioxin, which has been much in the news. It was only after many years of health care use that products containing hexachlorophene were found to produce dangerous reactions in babies washed or rubbed with any products containing it, although the relationship with the deadly dioxin was only made public much later. Even with this revelation, it required a ten year struggle to get the highly profitable hexachlorophene products off the market.

Recommendations for better nutrition include eating starches with fats or green vegetables; eating fruits alone; and seasoning with herbs. The effect of herbs is that they work electrically on the system, meaning that they work quickly, and that they cause "miraculous" changes. *The admonitions to drink cow's milk forbear from explaining that cow's milk is a substance far removed in nature from human mother's milk. It contains 300% more casein, because it is designed by nature for a calf which can*

increase its gross weight from one to two hundred pounds in six to eight weeks; no human grows at such a fast rate.

Alfalfa is a highly recommended substance by many nutritionists because of its structure; its chlorophyll molecule is a web of carbon and hydrogen, nitrogen and oxygen atoms grouped around a single atom of magnesium; this is similar to the structure of hemoglobin, the red corpuscle, except that the atoms are grouped around a single atom of iron instead of magnesium. A recommended treatment for kidney stones is lemon juice in a glass of water, or a combination of carrot and beet juice. The present writer has obtained quick relief and shrinking of a kidney stone in the ureter by drinking quantities of cranberry juice. These juices apparently begin to dissolve the stone, which then passes without effort. The stone is usually an oxide, an accumulation of minerals or oxides which forms a hard stone.

The surplus of elements left over from the manufacture of atomic bombs now threatens us with another "magical" process, the process of preserving food by irradiating it. Cobalt 60, one of these atomic bomb leftovers, is now being offered to food irradiators for \$100,000 per kilo. Should the food irradiation program fall through, this byproduct of atomic bombs will have to be disposed of by the manufacturer at great expense. It is a repetition of the dilemmas which brought us such public "boons" as chlorination of water after World War I and nitrate fertilizers after World War II.

The first commercial use of food irradiation took place in occupied West Germany in 1957, where it was used experimentally to sterilize spices used in the manufacture of sausages. The results were so disturbing that the West German government was forced to ban it in 1958. At the same time, the Soviet Union had begun to use irradiation to inhibit the sprouting of potatoes in storage; in 1959, the Soviets used it for the disinfection of grain. Canada, which is heavily influenced by pro-Soviet representatives in its government, began to use irradiation on potatoes in 1960. The U.S. Food and Drug Cosmetic Act of 1958 took up the use of irradiation, defining it as an "additive," which brought it under their control. In 1963, the FDA gave permission for the use of irradiation to sterilize canned bacon; this permission was rescinded in 1968.

In 1968, the Rockefeller Monopoly moved to back the food irradiation process on a national level. The Coalition for Food Irradiation was formed by some of the nation's biggest food companies; ALPO, Beatrice, Campbell Soup, Del Monte, Gaines Foods, General Foods, Hormel, Heinz, Hershey, Gerber, MARS, Stouffer and Welch. Joining them in the coalition were the chemical companies, W. R. Grace, DuPont and Rockwell International. The Coalition began the tried and true technique of staging well-planned and expensive "conferences" at prominent universities, at which only the advocates for their plan would be heard. One of these conferences backfired. The planned irradiation conference at Johns Hopkins University Center for Radiation Education and Research was scheduled in August 1987. Prospec-

five attendees were disturbed to find that the list of scheduled speakers was heavily stacked in favor of food irradiation. Of the twenty listed speakers, nineteen were known proponents of irradiation. The sole critic of food irradiation, Rep. Douglas Bosco, of California, pulled out when he realized that he was being set up. It would be publicized that although critics of food irradiation had been given a place at the conference, the conclusions would be totally in favor of irradiation.

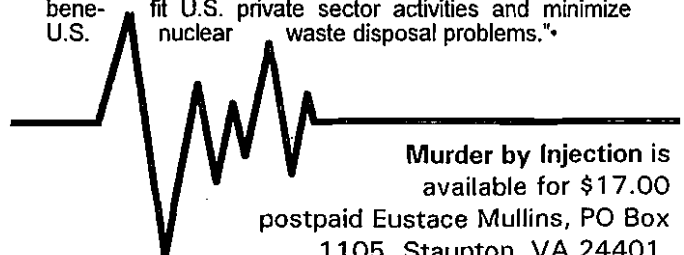
The United States Army has spent some \$50 million on food irradiation since the 1950s, but most of the results have been flawed. Maine has outlawed the sale of irradiated food. Milwaukee forbade the building of an irradiation plant, and public opposition also forced Radiation Technology to abandon a plant in Elizabeth, New Jersey. In 1987, the European Parliament voted against irradiation in the European Community "on precautionary grounds." The Canadian parliament then decided against using irradiation for wheat. Meanwhile, Abbott Laboratories and Baxter Travenol, leading pharmaceutical manufacturers, have licensed Gamma Irradiation Facilities to DOW Corning, General Electric, General Foods, IBM, IRT Corporation, Merck, RCA and Rockwell International.

After the Canadian Parliament recommended against using irradiation for wheat, Hon. Jake Epp, Canadian Minister of Health and Welfare, announced that irradiation of the food supply would be permitted. This announcement, which Epp made on September 10, 1987, astounded many Canadians. It came after the recommendation against it by the Canadian Parliament, as well as after the condemnation of food irradiation by London's Food Commission in Eng-

land. Here again, the desperation of the Chemical Trust leads it to imperil the health of a nation. There are many available records of tests indicating the dangers of irradiated foods. Consumption of irradiated rice has been linked with the development of pituitary, thyroid, heart and lung disturbances, and with the development of tumors. Children and test animals fed irradiated wheat developed increased polyphoidy (an abnormality of the chromosomes).

In *East/West* magazine, Feb. 1988, a quote from an unclassified document from the Department of State on food irradiation is quite revealing:

"The Administration and Congress are interested in promoting the use of U.S. exclusive technology using cesium 137 isotope for the benefit of man. U.S. nuclear waste processing currently is producing the cesium isotope which Dept. of Energy would like to be used for beneficial purposes. Promulgation of cesium technology would benefit U.S. private sector activities and minimize U.S. nuclear waste disposal problems."

**A** year and a half ago, in the middle of a presentation I was giving at the Metropolitan University in Cupey, Puerto Rico, a young man showed me four photographs which left me deeply impressed. They depicted the strange corpse, in a variety of poses, of a creature which had obviously been dead for a long time.

# An Alien Corpse in Puerto Rico?

Intrigued by the snapshots, I asked the young man about their origin, since the visible details were reminiscent of the alleged extraterrestrial humanoids known as "Greys" in the world of UFO investigation—small beings with a maximum height of 3 to 4 feet, large heads, and wide, dark, slanted eyes. The eyesockets were similar, but this being's eyes were submerged within them. The corpse barely had a nose, only nasal orifices and a lipless mouth with no visible teeth.

Other details in the photos reminded me of other descriptions given of the "Greys," such as the extremely slender and long arms. The mysterious corpse's hands had only four fingers with a membrane between them, the digits ended in sharp little nails. The young man pointed out that a person known to me had given him the photos, and proceeded to hand me copies of them. Armed with this information, I set out to investigate the matter.

I contacted the person who had supplied the photos, and he told me an incredible story. According to him, the snapshots were of an alleged extraterrestrial slain by a relative of his around 1980-81. This relative was a cattleman in the northern part of the island who had lost a sizeable number of heads of cattle in a bizarre manner, mutilated in an indescribable fashion (since 1975, a considerable number of animal mutilations have taken place). He decided to keep a vigil along with two friends, all of them armed with 30/30 rifles, in an effort to discover who or what was responsible.

One night, four small, strange creatures, similar to the one in the photo, appeared out of a mountain stream. The cattleman and his friends saw the creatures enter a stable and remove a small heifer by levitation. The heifer was rigid and floated between and above the four creatures, who moved with a wobbling gait. Still unable to believe what he was seeing, the cattleman fired upon the creatures several times, striking one of them which fell to the ground emitting weird shrieks. The heifer fell to the ground simultaneously while the beings tried to succor

their fallen companion, writhing in pain and struggling to get up.

The cattleman and his friends fired again, prompting the creatures to flee and desert the wounded one. Upon noticing that the wounded being was trying to get up, the cattleman shot it in the neck. The group moved closer to look at the creature, which still writhed on the ground, and one of

the cattleman's friends gave it a strong blow on the head with a piece of wood, crushing its skull and finally killing it. One of the friends took off his jacket immediately after and wrapped the creature in it, taking it to the cattleman's residence where it was stored at first in formaldehyde and later frozen for ten years. It was only shown on certain occasions, as the cattleman was fearful that the U.S. authorities would learn about his concealed item, and take action against him to cover up such a piece of evidence.

On one of the few occasions in which his relative thawed out the corpse, he allowed the individual I was speaking with to take several

color photos of it, which he kept in his possession. The reader must understand that if this story should turn out to be true, it represents a milestone in UFO research not only in Puerto Rico, but around the world. I asked him to arrange an interview with the cattleman on many occasions, but my requests were always met with hesitation on his part, assuring me that his relative "was scared."

I explained to Alfredo Zayas—for that was his name—that I was aware of another story concerning the origin of the corpse, but he insisted that his relative's account was indeed true, and he refused to arrange an interview once more, making several excuses. Although the body in the photos resembled that of an alleged "Grey," I didn't believe him, on account of the story that follows.

#### **Previous Contact with the Case**

In fact, before speaking with this person, I recalled having been shown a similar photo, but with a different detail: the corpse was contained within an elongated, transparent glass receptacle. This was in the summer of 1980, during a conversation with two friends, Pablo Soto and Jason Díaz, from Salinas, P.R., on UFO incidents which had taken place in the region around that time. They showed me an interesting black and white photo in which the same corpse could be seen—but inside the container.

They stated that it was the corpse of an extraterrestrial which had been slain by a youth at a hill behind Camp Santiago, in Salinas, in 1980. According to this version, the youth ran into several little men while taking a walk through the hills. The little men tried to seize him, and in fright, he reached for a piece of wood on the ground and clobbered one of them, shattering its skull. Immediately after, while the other little men fled the scene,

the youth took the tiny corpse and abandoned the area. Upon reaching his home, he placed it in a container filled with alcohol, transporting it later to a friend, who placed it in a container of formaldehyde.

Pablo and Jason gave me the photo as a gift, and we later paid a visit to an individual who—they said—had the preserved corpse in his possession. We went to a neighborhood in the "Las 80s" sector of Salinas, and the individual in question, Mr. Calixto Pérez, a professional chemist, substantiated the story, but denied having the corpse. My friends assured me that he indeed had it, but was fearful of the authorities.



There was no way of seeing the "extraterrestrial" corpse, a fact I found suspicious. It could easily be the corpse of a small Titi monkey, for which reason I put the matter aside until recently, when I saw the new photos, which were in full color. I researched the matter for a year, and recently, a merchant from the city of Cayey told me about a friend of his who is a resident of Salinas, Mr. Rafael Baerga who, years ago, had shown him a series of photographs of the corpse of an alleged alien slain in that town. Surprised, I showed him the photos in my possession and he said that they were the very same, but that there

were many more! Armed with Baerga's name and phone number, I contacted him two months later by phone, and he stated that he indeed had 22 photographs of Salinas' dead alien! We arranged an interview at his home to discuss the matter, and met a few days later.

He disclosed that the incident involving the "little man's" death was true and that he'd learned of the affair in 1981 from a woman, Mrs. Ada Zayas, who had discussed the subject at his place of business. She alleged that her husband, a Salinas police officer, had in his possession the body of dead extraterrestrial which he'd confiscated from a local youth.

Intrigued, Baerga asked her if she could bring him the container with the little creature so he could see it, and she obliged. Later on, she returned with the container and to everyone's surprise, it held a strange little creature that could not have measured more than 12 inches in height when alive. It had a very large skull, which had been crushed by a massive blow to the head, and its description was the one mentioned earlier.

He requested Mrs. Zayas' permission to remove the corpse from its container and placed it on a desk, taking over 22 color photos from every angle and placing the corpse in a number of postures. Baerga explained that the story he learned both from Mrs. Zayas as well as from "Chino," the young man who killed the creature, was that while "Chino" was looking for archaeological artifacts in an area of the mountains behind the Santiago Military Camp in Salinas, he suddenly became aware of several tiny creatures, some 12 to 14 inches tall, who tried to grab him by the legs. Terrified, he picked up a piece of wood from the ground and killed one of them by striking its head. The others fled quickly and vanished. Scared, "Chino" picked up the creature's body and took it home, where he placed it in a jar filled with alcohol, and took the corpse to the aforementioned chemist, who placed it in a container of formaldehyde.

According to Baerga, both he and the others present agreed that the corpse was neither a human fetus nor

an ape. It was something entirely different with a human shape [having a head, torso, arms, legs, etc.] but clearly nonhuman. He also pointed out that the creature's skin had a strange color, and was extremely resistant. The old Channel 11 TV station was notified, but before network personnel could arrive to do a report on the discovery, police officer Osvaldo Santiago, Mrs. Zayas' husband, arrived on the scene, demanding the return of the corpse, which was part of an investigation.

Later on, Calixto Perez turned up at Mr. Baerga's establishment, angrily demanding that the jar with the being be turned over to him, since he was going to write a book about the discovery. He also demanded that Baerga turn over the photos he'd taken of the corpse. After consulting with a judge, Baerga gave him a few prints of the photos, although he was under no obligation to do so, while retaining other prints for himself.

Baerga's photos, which were in color and clearer, enabled me to see that the corpse in the container was certainly not that of an ordinary fetus...nor that of anything known: The head is too large for the being's body, which also had excessively long arms that ended in four-fingered hands joined by a membrane (palmate) and tipped with sharp little fingernails. The eyesockets were very large and almond-shaped, and the face's bone structure, while somewhat similar, was unlike a human face. It lacked defined ears, only auditive orifices with a little piece of flesh stuck to the skull behind the hole.

Upon locating Mrs. Ada Zayas, she stated that her then husband, Salinas police officer Osvaldo Santiago, had died two years after the "little man" incident, attacked by thugs in Salinas. She added: "...he turned up one day with the container that held the creature, and explained that a kid had called him at the station to register a complaint about something he had in his house, in the Las 80s sector. He went to investigate and the kid told him that he had run into "those things" in the hills behind Camp Santiago, and that he'd killed one of them high in the hills. The fellow also explained that he'd brought "the thing" home, but that

at night, both he and his sister heard strange noises outside, as if someone were trying to break into the house, and they were convinced that someone or "something" had come after the little corpse. They got scared and called the police. That's when my husband went, found the situation curious, confiscated the container from the kid, and took it back to the station to investigate."

Mrs. Zayas stressed that as far as she and her husband (who had experience in dealing with aborted fetus cases) were concerned, the thing was not a human fetus. It gave her the impression of being an adult figure, but only 12 inches tall. Later on, the chemist went to the police station and demanded that Santiago turn over the container with the creature, alleging that it was his property, and Santiago turned it over.

Days later, Officer Santiago told Mrs. Zayas not to discuss the matter anymore: higher-ups in the police force had told him to leave the matter alone, as upper echelons were taking care of the situation, apparently at the military level, "...and that they [the military] would deal with the matter from that point onward."

### **Back Where We Started**

Faced with all the aforementioned details, I tried to locate Calixto Pérez once more, whom I'd visited with Pablo and Jason in 1980. Thanks to a confidant in Salinas, I was recently able to contact him, and he confirmed the story of the young man and the beings in the mountains: "That took place in an area known as La Explanada (The Esplanade) near the "Tetas de Cayey," close to some caves that exist up there..." And he added something else:

"I had the jar with the little man in my house for a while and I can tell you it was no fetus. I was fed up with seeing baby fetuses in different stages of development while at the University of Puerto Rico, and that did not resemble a baby in the least. No, sir."

"It's skin was glossy, coarse, and with a tone like our own, but mixed with clear greenish shades, and let me make clear that it wasn't as a result of the formaldehyde. It's skin was indeed that shade. It had only four fingers and very long arms. It wasn't human. I think it was something extraterrestrial."

"Its skull, its head, was too big



for the body, which was flimsy, and its eyes were too big. It had no nose to speak of, only the two nasal orifices, and I can say that it wasn't because it was decomposing and its nose fell off—it simply had no nose."

Calixto had the mysterious corpse in his house for a while, planning to write a book on the discovery and other strange incidents that had taken place in the area, but was threatened by neighbors when it was learned that he was the one who had the being. In one instance, a black Chevrolet pulled up at his house, driven by a tall, thin, mulatto-like individual, who told him: "I've been told that you deal with flying objects. Be very careful with that."

"The tone in which he said that led me to interpret that my life was in danger. He tried to pursue the conversation, but I remained silent. He got back in his car and left. Some time later, the photos and the container with the creature disappeared from the place in which I'd concealed them. Maybe someone I'd taken into my confidence broke into the house and retrieved the evidence...either that, or it was the authorities."

On account of the threats and the twist taken by the entire affair, Pérez, frightened and concerned with the risk to his safety, opted against writing the book.

#### Commentary

The witnesses interviewed alleged that the preserved creature vanished mysteriously—something that occurs frequently in these cases, but we have confidential reports of a person in the northern part of the island who has the creature hidden. According to this source, the person is aware of the importance of these remains, but is equally fascinated by them, and refuses to turn it over for scientific analysis out of fear that it won't be returned or that government agencies that conceal these matters will take action against him. Even so, we are trying to convince him, by means of go-betweens, to allow us to take a skin and bone sample in order to have it analyzed by a professional laboratory in order to settle once and for all any doubts about the origin of this enigmatic corpse. This author's initial suspicion—that the remains could have been those of a fetus—has been discarded for the following reasons: all the witnesses, for the most part serious

persons, are certain, after having seen the figure closely, that it was not the fetus of a developing baby.

Years ago, Mr. Baerga presented photos of the corpse to a renowned veterinarian in the San Juan Metropolitan Area, who pointed out that it was neither a human nor animal fetus. He was unable to identify it. Mr. Baerga's son, who was a medical student at the time, showed the photos to different teaching doctors at the University of Puerto Rico's Medical School, who were also unable to say what was being shown in the photos. We have

shown the photos to different specialists, among them pediatric physicians specializing in neonatology, generalists, zoologists and others for their expert analysis and will present their conclusions when they are received.

One thing is certain: something did transpire in the hills high over Salinas. There are more witnesses in this case who do not wish to be publicly identified, but who attest to the veracity of the creature's discovery. Bear in mind that police officer Santiago informed his wife that he was ordered not to pursue the matter by higher levels in the police force, since apparently everything was being taken care of by U.S. federal and military personnel...which leads us to

other implications in this most significant case.

#### The Camp Santiago Connection

The area of "Chino's" encounter with the tiny beings is notorious for the high incidence of UFO sightings reported by locals. This region, and that of Camp Santiago, a base belonging to the Puerto Rico National Guard and the U.S. Army Reserve, have been the focus of UFO incidents of all description over the years, ranging from sightings to encounters with strange creatures. Soldiers and officers stationed there permanently or during maneuvers have told us about these incidents. Among them is the case involving a giant boomerang-shaped UFO, which hovered at a low altitude above a tamarind tree located in the base's maneuvers section, to the astonished eyes of a considerable number of G.I.'s, as well as the presence of UFOs on the base's airstrip. On other occasions, they have seen the sides of a nearby hill "open up" and disgorge luminous UFOs which disappear into the heavens.

Personnel of the Albergue Olímpico, located nearby, claim having seen large "flying saucer" type UFOs entering the base's perimeter in the early morning. This has been confirmed by policemen, toll booth operators at the Salinas toll barrier, and civilians traveling along the Las Américas Expressway. Many drivers have seen huge triangular objects and saucer-shaped craft over their cars and flying above the mountains containing the rocky promontories known as "Las Tetras de Cayey." There are also stories of encounters between drivers and creatures slightly larger than the one described in this article (some 3 to 4 feet). Among these cases is that of salesman Edwin Almenas Gutiérrez in 1977, in which the being—enveloped in a brilliant ball of light—pointed insistently at the nearby mountains and spoke in an unknown language. The mountains indicated were

# The Oklahoma City Bombing

*As this is being written, the last bodies have yet to be removed from the Alfred P. Murrah Federal Building. It's clearly too early to draw any definitive conclusions. However, we think you'll be interested in the following preliminary responses, gleaned from various online sources and periodicals.*

- According to **USA Today**, Linda Thompson, the militia movement's most prominent critic of Waco, believes that there were two bombs involved, with the second bomb having been placed inside the building. She reports that a black helicopter was seen flying above the building before the blast, and that the blast destroyed critical records regarding the Waco siege. She also has voiced suspicion regarding the apparently low number of federal law enforcement agents in the building at the time. (The day of the bombing, a BATF head John Magaw stated on CNN that no BATF employees were killed in the blast.) Like many in the militia movement, she fears the bombing will be used as a pretext for a harsh crackdown on the movement. Indeed, one ABC radio news report suggested that Thompson's two Waco critique videos may have influenced the bombers in their second anniversary action. Thompson virtually predicted the bombing in a public statement published in Issue 6 of **PARANOIA**. Though she got some of the details wrong, we think her statement is worth another look:

...We have been approached numerous times in efforts to sell us unbelievable weaponry; whether these were attempted "set ups" or legitimate, I don't know. We have been approached with numerous schemes that were obvious attempts to set me up very similar to the way the guys were set up on the world trade center bombing, so that "middle east terrorists" could be blamed...all set up by the CIA, I might add. These efforts to set me up failed, but in the process, were great for telling me exactly who is running the show. We have established excellent intelligence networks. Our sources have indicated that the CIA and a rogue faction of military and God-knows-who-else, plan to attack Washington, D.C., perhaps using nukes or Hawk missiles (we have confirmed reports of both in the possession of the CIA in this country). Originally, they planned to blame it on North Korea, but now, instead, plan to blame it on "the militia." Clearly, this would go the same way as the guys who were convicted of bombing the world trade center or the Waco assault: the media would do their part as the lame, idiot sheep that they are, regurgitating whatever tripe they were fed "by official government sources" and would convince the world that "the militia" nuked D.C.

- Unlike the alleged bombers, Attorney General Janet Reno doesn't think the feds behaved badly at Ruby Ridge and Waco. In fact, she thinks they did a dandy job. In a stunning example of either bad timing or gross bravado, she reacted to the Oklahoma bombing by promoting Larry Potts

as the FBI's No. 2 official, and approving his placement as head of the Oklahoma City investigation. Potts had been among twelve agents "disciplined" for his role in the fatal 1992 Weaver siege at Ruby Ridge, ID. He was also one of the officials who approved the Waco raid. According to the Hearst newspapers, FBI Director Louis Freeh stated that Potts "is superbly qualified to be deputy director because of his long and distinguished service to the American people." Translation: The Cryptofascist Conspiracy is letting us know that "we the People," by our silent complicity, have officially sanctioned the Idaho ritual murder of a mother and her young son, and that our leaders will continue to spill blood and reward those in charge. This is a test to see if anyone is awake. This is only a test.

- CNN and the **New York Times** both reported the statement of an army friend of bombing suspect Timothy McVeigh, who says that McVeigh told him that he had some sort of microchip device implanted in his backside while serving in the Persian Gulf. The report is unconfirmed.

- *The views of former FBI senior special agent Ken Gunderson were recently posted on the Internet, and come from an April 26 shortwave radio interview out of Nashville, Tennessee, heard on WWCR, 5065 Kilohertz, Shortwave. The show, INTELLIGENCE REPORT, has apparently been silenced by the feds because it was spreading "bomb-making" information:*

**KEN GUNDERSON:** Several days ago, I received a copy of the seismogram from the University of Oklahoma Geological Department, Norman, Oklahoma. It shows that there were two surface waves in the seismogram that was being monitored by the University of Oklahoma. Of course, they normally monitor for earthquakes.

But I called this morning and talked to Dr. Ken Luza. I asked him to read and interpret this seismogram for me. He told me that there were two surface waves on the morning of April the 19th. One was at 9:02 A.M. and 13 seconds, and the other was at 9:02 A.M. and 23 seconds, ten [seconds] apart. I asked him what that means, and he said that this indicates that there were two detonations of a bomb, not one, as our Government would like to have you believe. So, with that, I did more research, through some of my sources and contacts, and I came up with what I think is probably the bomb that was used. It was not a fertilizer bomb [as the U.S. Government states]. There are too many reasons why it was not a fertilizer bomb. The [actual] bomb is called an "electro-hydrodynamic gaseous fuel device"—a barometric bomb. Now what that does ... it's similar to the Army Blue-82 bomb, which is called the "Daisy Cutter." The primary detonation sets up a cold [coal?] cloud, a chemical cloud, which is energized with the electrostatic voltage, and the second detonation produces an enhanced explosion due to electrostatic microfronts. I called the person who developed this bomb, and I relayed the information from the seismogram, and pointed out to him that there were ten [seconds] between explosions. And he says that he is confident that it was the bomb that he developed.

Now, the bomb has a signature [such] that barometric pressure increases so rapidly and dramatically that it blows out the windows in buildings within a two-to-three-block radius. And, believe it or not, the bomb is the size of a pineapple. Now, the reason that I do not believe, nor do my two technicians believe that this was a fertilizer bomb is because

there is not enough "breisance" in an explosion of fertilizer to cause the shock wave that destroyed that building.

JOHN STADTMILLER: And with the fertilizer bomb [story], they [the Government] keep increasing the size of the bomb. It started out being a thousand to fifteen hundred pounds. And now they're up to two tons of it. But, even still, that type of blasting device is a low-yield, low-frequency [device], not capable of doing the type of damage that was done to that Federal Building.

CONSPIRACY NATION: A lot of people are interested in finding out about this bombing. What's your information now?

SHERMAN SKOLNICK: [Regarding McVeigh,] here's the way that it appears, according to published reports. McVeigh was a security guard of sorts for Mark Koernke. Koernke is suspected by others in the Michigan Militia of being a government plant. Because Koernke has high-level intelligence connections; he went to one of the top secret military intelligence schools—I believe in Arizona.

And yes, he is charming and he says a few things that are interesting. But he... There's something about him that indicates that he may be a provocateur! So the fact that Timothy McVeigh worked in some capacity for him, and is now accused of some role in the bombing—I find the whole chain of circumstances very suspect. In other words, did someone like Koernke tell McVeigh, "Go and spy out the building, [you know] 'Case' the building"—and not tell him why? And then other people [that] are now becoming witnesses for the FBI says, "Oh yes! We saw McVeigh, three days before the bombing, looking at the building!"

...And what is never discussed, is [that] the broadcast industry are subject to emergency proclamations—unpublicized—by the White House. And that started during the anti-Vietnam and civil rights marches and commotions that occurred in the '60s, the murder of Dr. King. Because after the murder of Dr. King, 103 cities were burning. So if Dr. King was assassinated today, they would quietly announce tonight that he died in the hospital of "natural causes." You see? In other words, the radio and TV stations are under the thumb of the White House! And that is happening now. People that I know in broadcasting confirm it, but they'll be darned if they'll go on the air and ever say it, because they fear their license will be in jeopardy. [So] Clinton gave an emergency order that the media is to support the White House policy that may be necessary to round up the militia as part of a "broad conspiracy to overthrow the government." And they need the help of the media to soften up the public that "It's okay to round up these people."

• Populist newsweekly **The Spotlight** (800-522-6292) placed the bombing in an international perspective, in an article on the nature of the CIA-sponsored terrorism. The CIA, says the article, has become "notorious for organizing terrorist attacks, assassinations, and car bombings, sometimes as punishments, sometimes as provocations." The article quotes former CIA operations analyst Gordon Thurlow: "The U.S. government has publicly proven its capability to commit terrorist mass murders of innocent civilians and small children. It has done so in Lebanon, where a CIA-Mossad hit team killed 91 bystanders with a bungled car bombing designed to assassinate a Muslim cleric—who escaped unharmed." **The Spotlight** has also reported that a tape recording of a May federal court hearing of James Nichols, friend of

Timothy McVeigh, was "accidentally" erased while in the custody of court officials. The tape was provided to the **Detroit Free Press** under a court order.

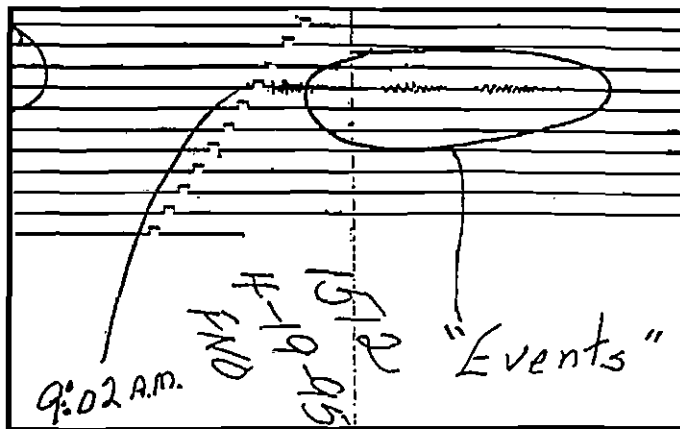
• In a May 15, 1995 column, **The Nation** Columnist Alexander Cockburn ably provided grim details of the above-mentioned Lebanon car bombing, noting that it was "the biggest bomb attack on a non-military target in the eighties." However, he does not finger the Mossad as the CIA partner, but rather "the Saudis and a

special unit of the Lebanese secret service." Reflecting on the militia movement, he says,

Politics are so decayed in America, so rotted out, that the surprise is not that there are patriot militias across the country but that there aren't more of them. Freedom is discussed with vibrancy mostly on the right, at its best in such enterprises as the Fully Informed Jury Association. Between the FIJAs and President McMuff, hot to erode constitutional freedoms and expel people with brown skins, give me the former every time. They cared what happened to those people at Waco. Most liberals and leftists did not, sandbagging the Davidians with the word "cult" and leaving it at that.

Now the mainstream press is likening the "ultra right" of today to the extreme left of the late sixties, as if the baby killers and bombers then had been the earlier Weather Underground, not the Pentagon.

The lead **New York Times** editorial for April 27 actually quoted William Kristol, former chief of staff to Dan Quayle, solemnly deploring attacks on government as "not healthy". Of course, Reaganism subsisted rhetorically on incessant onslaughts on government in any role exclusive of policing dissidents at home or abroad... One more thing about the alleged perpetrator, McVeigh. He ratifies the idea that TV movies don't breed violence, though, like talk radio, they can nourish it. Violence breeds violence. The US Army did its job, and you don't need an Arab to tell which way the fuse goes. Uncle Sam has all the know-how. •

# Extraterrestrial Friends



## The Deception of Everyday Life

by George Andrews

Following is a transcript of a November 1994 lecture by author George Andrews before the Providence Conspiracy League. Mr. Andrews is the author of *Extraterrestrials Among Us* and *Extra-terrestrial Friends and Foes*. He is currently working on a new book, *Other Worlds in This One*.

**W**hat is the connection between UFO phenomena and political activities? How do these two apparently disparate subjects relate to each other?

One way in which they relate, and for which there is documentation, is in the systematic suppression and distortion of UFO information by the government and the news media for the past half-century. Another way in which they relate is more subtle, and the documentation for it is rare. Although the influence of secret societies on political activity has been studied extensively, very few researchers have understood

that the so-called Secret Masters at the summit of the hierarchies of these human societies may be non-human in nature. The tendency of the researchers has been to assume that these Secret Masters are merely imaginary and therefore delusions. I would like to suggest that they may genuinely exist, but be extraterrestrial and/or other-dimensional in nature, as the two terms are not mutually exclusive. If we terrestrial humans awaken the potential latent in our brains to the point of acquiring the ability to mentally access hyperspace, and the abilities now considered paranormal become part of our normal functioning, no matter where in other worlds or dimensions we may travel, we will still be Earthlings, since Earth is our home star, our place of origin.

Although I was unfortunately unable to attend the lecture that Eustace Mullins gave here, I see from the flyer that he traces the New World Order doctrine back some 5,000 years. This would take it back to the First Dynasty of ancient Egypt, which was founded by the Pharaoh Menes, who besides his own name had a Horus name, as did all the pharaohs who succeeded him in the First Dynasty. The superb workmanship in stone which contributes so much to our fascination with ancient Egypt appeared full-blown and already perfected during the First Dynasty, which was consecrated to the supremacy of Horus, son of Osiris, in his battle against Set, the prototype of our modern Satan, and the deceitful murderer of the good king Osiris.

In the transition between the First and Second Dynasties, there was a switch in allegiance. Instead of a Horus name, besides his own name, Pharaoh Peribsen had a Set name. Throughout most of the Second Dynasty, Set was the supreme deity. Set was associated with the constellation of the Great Bear and with Sirius. Horus was associated with the constellation of Orion.

The winged disc, also known as the boat of millions of years, is conventionally assumed to have been the sun disc. This was indeed the literal and obvious meaning, but what if this obvious meaning was intended for the uninitiated public, acting as a screen for the secret esoteric meaning known only to the initiates, who knew that the winged disc symbolized an extraterrestrial spacecraft, and who also knew that the battle between Horus and Set symbolized two different types of extraterrestrials in conflict with each other? What if this war has continued down to the present day, and we happen to be living in the time just before the final showdown?

Contemporary abduction researcher Robin Quayle described a case she investigated in 1979, long before such research began to be taken seriously, in which the abductee, when under hypnosis, would sometimes speak in unknown languages, one of which was identified to be ancient Egyptian. One day during a hypnosis session, he began to speak in this fashion, then, while still in a trance, got up and walked out of the house and pointed to the sky. Robin Quayle thought he was acting out some imaginary scenario, until she looked up at where he was pointing in the sky and saw a large hovering UFO.

Themes related to ancient Egypt surface infrequently but persistently in the abductee reports. I once had a dream during a sequence of UFO-related experiences in which a man with the head of a black dog, dressed in a modern military uniform, appeared at my front door. In the dream, I immediately recognized him as my old friend Anubis, but what puzzled me was why Anubis was wearing a modern military uniform instead of his traditional Egyptian costume. That is what I found puzzling in the dream, not that I was talking with a man with the head of a black dog. Of course, in my normal waking state, my reaction would have been quite different.

If the speculation I am engaged in is on the right track, ancient legends such as the conflict between Horus and Set may have considerable relevance to our present-day situation. The

same is true of the legendary conflict between Marduk and Tiamat, as Zecharia Sitchin has so ably pointed out, as well as the conflict between Ahura Mazda and Ahriman in ancient Persia. The same theme surfaces again in the Dead Sea Scrolls, which are themselves loaded with references to extraterrestrials under the code name of "the Watchers," some of which are human in appearance and some of which are reptilian in appearance. In her excellent book **Glimpses of Other Realities**, Linda Howe quotes Israeli Biblical scholar David Flusser: "There is a predestination doctrine known as the Two Spirit Theology, in which one's soul is said to be fated for all eternity, blessed or cursed as the result of a kind of angelic wrestling match between two of the "Watcher" spirits ... a Good Angel and an Evil Angel, who struggle for possession of your soul..." She also quotes from The Testament of Amram, Dead Sea Scrolls translated by Professor Robert Eisenman: "I saw Watchers in my vision, the dream vision. Two men were fighting over me ... holding a great contest over me. I asked them, "Who are you, that you are thus empowered over me?" They answered, "We have been empowered and rule over all mankind." They said to me, "Which of us do you choose to rule you?" I raised my eyes and looked. One of them was terrifying in his appearance, like a serpent, his cloak many-colored yet very dark ... And I looked again, and in his appearance, his visage was like a viper ... I replied to him, "This Watcher, who is he?" He answered, "This Watcher ... his three names are Belial and Prince of Darkness and King of Evil." I said (to the other Watcher), "My lord, what dominion (have you?)" He answered, "You saw (the viper), and he is empowered over all Darkness, while I (am empowered over all Light) ... My three names are Michael, Prince of Light and King of Righteousness.

Contemporary abductees are describing encounters with entities both human in appearance and reptilian in appearance, as well as insectile in appearance. The ubiquitous Grays, who account for the majority of the abduction cases in the United States, are short humanoids with both reptilian and insectile traits. The Grays are sometimes seen in the company of large reptilian humanoids, at other times in the company of entities that are human in appearance. Some cases involve all three types acting together, sometimes along with other types. What makes the picture more complex is that there appear to be different groups of entities who are human in appearance, and different groups of entities who are reptilian or insectile in appearance, as well as different types of

Grays. However, anyone who considers the number of stars in our galaxy, and the number of galaxies in the universe, should not be surprised at a vast diversity of life-forms, with differing characteristics and motivations for interacting with us. In spite of this diversity, certain specific types interact with us more frequently and persistently, some of which have been interacting with us since prehistoric times. The extent to which ancient myth and legend can be used to elucidate contemporary UFO phenomena is open to question, but every now and then significant correlations do occur. We may as well take note of them when that happens, as they could be clues that help distinguish between extraterrestrial friends and foes. These myths that have survived the centuries are highly condensed nuggets of ancestral wisdom, which may contain meanings valid in the present day.

According to some of the modern abduction reports, as well as some of the ancient legends, it is the extraterrestrial Reptilians who are the

greatest danger to humanity's well-being, since among other things they use us like we use chickens, pigs and cattle, just as Charles Fort stated. However, we should not forget that during the Kesozioc era when the dinosaurs were dominant on this planet, besides the carnivorous dinosaurs there were herbivorous dinosaurs, some of which may have also evolved to high levels of intelligence. So there may be exceptions to the rule that contact with the Reptilians is

bad news, but they appear to be few and far between. Barbara Bartholic, who has investigated over 300 abduction cases, told me that it is standard operating procedure for the Reptilians to rape every human they abduct, raping males anally, following this with memory erasure, so that although the abductee may feel vaguely there is something wrong, there is no memory of the incident. The equipment at their disposal not only erases memories, it creates virtual reality by inserting false memories. The type of alien known as the Grays is subservient to the Reptilians and in alliance with them. The Reptilians use the Grays to interface with terrestrial humanity because the Grays are less repugnant and terrifying to terrestrial humans. Once again, let us beware of the simplistic assumption that all Grays are alike, though they do seem to be each individually linked to an insectile hive mind, so human standards of individuality may not be applicable to them. As their DNA has deteriorated to the point that they are cloned in vats instead of being carried in the womb of a mother, there is no parental bonding, and emotional response is so weak as to be almost non-existent. They can be said to experience emotion vicariously and secondhand, since they derive not only gratifica-

tion but nourishment from intense emotion generated by humans, all through the spectrum from agony to ecstasy, but focused particularly on fear. They have ways of harvesting our emotions and deriving energy from them. Notice how the abductees are kept on a continuous emotional roller coaster ride, up one day then down the next, in ways that generate maximum amounts of emotion.

One of the most frequently described Insectoid entities is about as tall as a human and resembles a Praying Mantis. These are almost always seen in the company of Grays. Large spider-like entities are more rarely reported. Just as with the Reptilians, encounters involving these large Insectoids tend to be bad news. There are many different groups that are more or less human in appearance. However, it should be remembered that an entity being human in appearance is not a guarantee of benevolence. Since these extraterrestrial and other-dimensional entities have extensive camouflage, shape-shifting and mind control abilities, the compass to steer by is one's internal gut feeling, one's intuitive impression rather than the entity's external appearance.

The Blonds who resemble Scandinavians are divided into several different groups, the presence on Earth of at least some of which is compatible with human well-being, and may even enhance human well-being. The Greek legends of the Olympians and the Scandinavian legends of the Aesir describe the activities of this type of extraterrestrial during the early period of our human history. A contemporary abductee who has had experience with several different alien groups told me, "You know what convinced me the Blonds were wise? Do you know why I trust them? Because they don't tell me to! They do not lecture and teach as if they have all the answers, as so many misinformed people claim. The time I remember a Blond telling me that so many of the Greys were negatively-oriented, he did not just tell me that

statement. He showed me and explained why. He did not condemn them. He seemed sad but matter-of-fact. Then, when I made the unthinkable move to doubt the prophet ... and told him I didn't think I could believe him, he actually seemed PLEASED with me. He smiled and said, "You don't have to believe me. Please just listen for now and then draw your own conclusions later, as you gather more information." Needless to say, that won my vote of confidence. I have since heard other anecdotes similar to this one. I listen for the manner of speech and the patient non-authoritarian way of the Blonds, to compare the truth of each person's story. Also the Blonds do not just dump all the answers into a given person's lap all at once. They

gently draw one around to looking at a factor of existence and then stand there and wait. One small thing at a time. Another item to consider is the sheer numbers. Blonds and other human alien types are here only by the hundreds, as compared to the hundreds of thousands that the Grays have.

Besides the Blonds, who are not always blond, there is the Tau Ceti group, also known as the Browns. They could pass as terrestrial humans in a crowd, except for rather large and slightly flattened noses, no eyelashes, and somewhat pointed ears. Their skin is a bronze color, similar to that of inhabitants of the Mediterranean region. They have brown eyes and their hair is usually brown, but is sometimes black. They are of particular interest because they are at war with the Grays. These are the ones I think we should make an overt publicly

acknowledged treaty with that specifically cancels and nullifies the previously made secret and illegal treaty with the Greys. There are reports of quite a few other types of human-appearing entities. One group is tall and pale with dark hair and a widows peak hairline. There are indications that either this entire group or certain of its members work in alliance with the Reptilians. The entity known as Ashtar is sometimes depicted with a widows peak hairline. I have my doubts that Ashtar is as he presents himself to be. Speaking for myself, I can say that I would not be inclined to trust members of this group. There are also other human-appearing groups that make occasional appearances, but I've now covered the main types of aliens interacting with us.

I'd now like to digress for a bit, but the digression has a purpose. High strangeness becomes more comprehensible if presented in the context in which it occurs. If I focus on things that seem familiar, this is preliminary groundwork for some very high strangeness further on down the line. The approach is intended to bring into perspective the relationship between the UFO cover-up and other governmental cover-ups.

It is when the different types of cover-ups are seen in relation to each other that the grand lines of the overall strategy for enslaving the planet become visible, while if research is focused on only one governmental cover-up, those large-scale connections are less likely to be made.

Conspiracies can be short-circuited by making their inner workings publicly known, which gives us a valid and realistic reason to study them. This applies even to conspiracies that have had long-standing success in manipulating large groups of people. Once the secret strategies of the elite clique become known to the outside world, the previously successful strategies no longer work. Once the cat is out of the bag, the game is over. The elite clique goes from dominant to dormant, or even defunct. The academics and authority figures who turn up their



noses in disdain at the study of conspiracies are perpetuating the public ignorance on which predatory elite cliques depend to carry out their parasitic manipulations. Meetings such as this one, and publications such as **PARANOIA**, have a powerful potential for bringing about positively-oriented social change. My dictionary defines "paranoia" as "a chronic psychosis characterized by well-rationalized delusions of persecution or of grandeur," but there are factors which this dictionary definition does not take into account.

The definition assumes the perceived persecution to be delusion, and in many cases it is, but as the old song goes, it ain't necessarily so. The possibility that genuine persecution may be involved should always be checked out. Is it a piece of rope in your path, or is it a rattlesnake? There are also the subtle aspects of the situation to be considered, since predatory entities can be either human or non-human, physical or psychic, incarnate or discarnate. These subtle aspects are ignored not only by the dictionary, but by almost the entire academic community, with a few rare exceptions.

In the presence of any real danger, paranoia becomes a valuable early warning signal. Justified paranoia is a precious asset to survival, the very opposite of a delusion, since one's life may in fact depend upon responding to its promptings. The ability to sense danger where it lurks is essential to survival in both the jungle and civilized societies, and may be intuitive rather than logical in nature, but should not be confused with delusion. In the presence of real danger, paranoia becomes an advantageous state of heightened awareness. Artists such as Salvador Dali have deliberately cultivated their paranoia, experimenting with critical paranoia, in order to access this heightened awareness and work from it, creating works of art while in this state. So there is a lot more to paranoia than what the dictionary definition covers. And it is quite obvious that at present the rate at which all sectors of society are being bombarded with danger signals constitutes ample justification for widespread public paranoia.

As we scan the horizon of the contemporary scene, what danger signals stand out as being particularly prominent? The danger at the top of my list is the implantable bio-chip, which would put an end to individual liberty, and put Big Brother right inside our heads, in ways even worse than what Orwell described in **1984**. Anyone who has been implanted with a bio-chip is at the mercy of the operator of the computer the chip is hooked up to. The bio-chip can be implanted simply by injection, and what an elite clique within our government wants to do is to inject every single citizen of the United States, under no matter what pretext, and as quickly as possible. The Clinton Health Plan features a so-called "smart card," which contains a chip similar to a bio-chip, except that it is not yet in your body. However, you would not be able to function in society without carrying your so-called smart card, actually your slave card, on your person. At first it would contain only your health record, but then your financial and legal records would be added, and the card would replace cash for transactions. At that point, cash would be made illegal. Then, since cards can get lost or stolen, all card-holders would have to line up for replacement of cards by injected bio-chips. Instead of computers being used to enhance human well-being, the reverse would have occurred. Humanity as a whole would be enslaved to a tiny elite clique of computer programmers, who would themselves be under the control of the alien group known as the Grays. In this fashion, planet Earth would become a slave colony of the Grays, managed by human overseers. The implantation of bio-chips into untold thousands of abductees by the Grays may be in preparation for this takeover.

Let us bear in mind as we scan the horizon that matters of importance may seem at first glance trivial, having been systematically trivialized and obfuscated by the news media, conditioning the public accordingly, to the point that most people have an automatic response, rather than a response they have thought out for themselves. I suggest that we focus our collective attention for a moment on the plight of my old friend Maria Juana, also known as Mary Jane or Mary Warner. Reagan and Bush managed to transform any association with this

## **The Dead Sea Scrolls are loaded with references to extraterrestrials under the code name of "the Watchers," some human and some reptilian in appearance.**

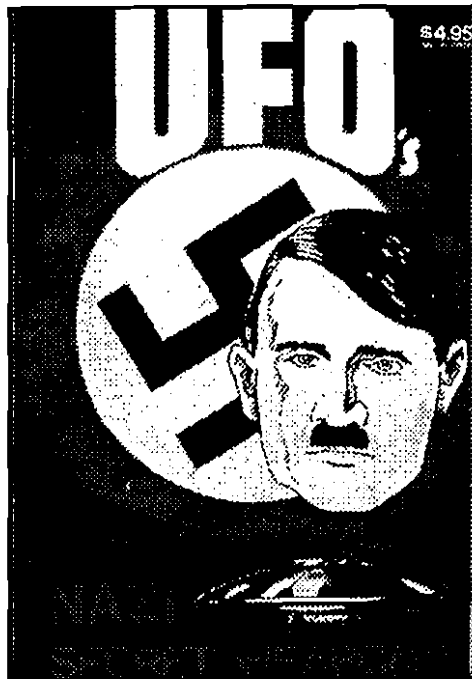
much misunderstood lady into a major crime, thereby vastly expanding the percentage of the population that could be declared criminal, of course at the same time vastly expanding requirements for prison facilities and numbers of law enforcement officers. Fines that were totally out of proportion began to be imposed for possession of small amounts. People had their homes and life savings confiscated for possession of a personal supply of grass. Money seized in this fashion routinely lined the pockets of corrupt officials and disappeared into realms beyond the reach of public accountability. The legislation was not only blatantly unfair, it was in flagrant violation of the Constitution. When we voted Clinton in on what was supposed to be a liberal Democrat ticket, we expected this violation of the Constitution to be corrected, and hoped that progress toward decriminalization might be made along the lines of the Dutch model. What we got instead was the treason concealed in the middle of the bulk of the recently passed Anti-Crime Bill, which has so far received next to no media attention, although it constitutes a final death blow to the Constitution if it is left unchallenged. That brief section of only a few paragraphs authorizes the police to seize and sell the assets of any person who comes under investigation for a drug offense. They no longer even need to find any physical evidence in order to seize and sell everything you

own. All they have to do is to suspect that you might have some drugs stashed away somewhere, then start to investigate you. The moment they start to investigate you, as of right now it is the law of the land thanks to Bill Clinton, they can seize and sell everything you own without even bringing you to trial. According to the Constitution, they can't seize or sell your assets until you have been tried and convicted. What Clinton's law has done is to authorize the police to usurp the functions of both judge and jury. Another sinister novelty is that the law imposes the death penalty for the crime of growing large amounts of marijuana. Giving the police the power to seize and sell a person's assets without a trial, without the person having been convicted of any wrongdoing whatsoever, merely on suspicion, at the whim or caprice of a police officer or group of police officers, imposes the nightmare of Nazi Germany on the citizens of the United States.

This is the same type of tyranny as that of the Gestapo. It is a sure way to escalate police corruption beyond our wildest dreams. It will turn police squads all over the country into greed-crazed inquisitors, specializing in legalized piracy, with the full clout of the government behind them. This one section of a few paragraphs, concealed in the middle of the bulk of the Anti-Crime Bill and passed by Congress almost without debate, is not only the final death blow to the Constitution if left unchallenged, but seems designed to create an intolerable situation, disastrous for the entire nation, in which the most dangerous thieves of all have become the thieves in uniform. The law is an ass, and should be struck down without delay, since it is in flagrant violation of the Constitution.

As you may remember, Rex 84 was

Reagan's notorious executive order authorizing the round-up of political dissidents throughout the nation and their confinement in concentration camps. When the contents of this horrifying directive became publicly known, and a new administration was voted in to correct the excesses of the previous administrations, we thought that Rex 84 was a thing of the past, a nightmare we no longer needed to worry about. However, this has not turned out to be the case. There are multiple indications that the implementation of Rex 84, under whatever its new name may be, is very close to happening. Just as under Reagan and



Bush, under Clinton the transformation of former army bases into immense prison facilities has proceeded full speed ahead. We already have a higher percentage of our population in prison than any other nation on the planet, yet we are driving ourselves into bankruptcy and beyond in order to finance the

construction of even more endlessly vast prison systems for ever-increasing numbers of prisoners, all the while proclaiming ourselves the Land of the Free. Clinton has authorized the U.S. Army to take orders from the United Nations, and United Nations troops to operate on U.S. territory. Many soldiers in the U.S. Army would revolt if ordered to carry out an operation such as Rex 84, but United Nations troops would be unlikely to revolt, and would therefore be the troops of choice for such an operation. UN troops would at first be brought in supposedly to quell domestic disturbances, such as race riots. Their actual mission would be house-to-house searches nationwide, the excuse being to search for guns and drugs. However, it would be es-

entially the same type of operation the Nazis performed when they came into power, known to history as Krystallnacht. The Nazi Krystallnacht was the model after which Rex 84 was patterned: arbitrary arrest of a large percentage of the population followed by their imprisonment in concentration camps and the confiscation of their property. That was the pattern of events which was inflicted on the citizens of Germany, and which is about to be inflicted on the citizens of the United States, unless we wake up in time to put a stop to it.

What sort of coalition would have the power to correct the situation? Almost all of the various minority groups would be prime targets for such a latter-day Krystallnacht or Rex 84 type of operation. Besides the ethnic minorities, there are the owners of firearms who do not wish to give them up. There are the smokers of marijuana, and also the smokers of tobacco, who are being inexorably criminalized more and more from day to day. Anyone using or suspected of using any drug, anyone advocating legalization or decriminalization of drugs, environmental activists, UFO researchers and abductees who refuse to toe the party line, conspiracy researchers, victims of AIDS and other newly developed infectious diseases, the myriad multitudes of the homeless, non-conformists of all varieties, and anyone involved in political activities of any kind, except the straight Republican or Democrat tickets that give us the liberty to choose between Tweedledum and Tweedledee. It is not only the poverty-stricken who are in danger. The more wealth a person possesses, the more interested the teams of police inquisitors will be in investigating that person in order to seize and sell his or her belongings.

It is undeniable that all the social categories just mentioned put together would add up to an overwhelming majority of the citizens of this country. If all of those threatened join forces and work together, it is in our power to stop these acts of treason to the Constitution.

# the Dan Rather Connection

## JFK, CBS and the CIA

**P**erhaps no temporal truth in all human history has proven more elusive than that of the John F. Kennedy assassination conspiracy. Carefully concealed since its conception, it has been shielded from the public eye by flawed or outright bogus government "investigations," the violent deaths of scores of potentially crucial witnesses, and a vast welter of "misinformation" often reported as gospel-etched-in-stone by a compromised media. As a community of serious researchers struggles through that blizzard of misinformation intended to blind us from the truth, we find our ranks thinning as some become too discouraged to continue on. Like a volcano erupting lava, American mass media spews out mountains of molten misinformation that engulfs us all.

It is thus the most extreme irony that the JFK research community's greatest hope for rejuvenation and vindication in the eyes of Americans lies in the very epicenter of that volcano of untruths, the seemingly inexhaustible fountain of misinformation that is the American mass media. The one great hope we have to acquaint our fellow Americans with the sheer enormity of the JFK assassination cover-up is directly proportionate to our ability to acquaint them with the peculiar story of that media's brightest star, the most familiar information authority in America today, a man whose name and face are recognizable to virtually every citizen: CBS News anchorman Dan Rather.

Although obscured by the US government and mass media watchdogs, the mysterious truth of the JFK assassination does exist, even if only visible as loose threads finer than gossamer. Yet none of those threads have tantalized serious researchers more than the ones cobwebbed around a mass media personality who has profited

mightily from that murder, the man who has proven himself a major pillar of the "Oswald alone" myth with his constant efforts of support for that fable. The threads are particularly tantalizing when we find them weaving directly to the very crime scene.

### Dan in Dallas

A native Texan, Dan Rather graduated from Sam Houston State Teacher's College with a journalism degree in 1953. After a brief stint with the Marines, he launched his career as a reporter in his hometown Houston. Moving from newspapers to radio to television, he first gained national notice by courageously covering a 1962 hurricane story. That campaign earned him a position as a correspondent for CBS. The network, which we now know was a primary CIA asset at the time (1), assigned the chunky, crewcut Texan to be its bureau chief in Dallas. Some eighteen months later, CBS decided to consolidate its two southern bureaus in Dallas and Atlanta into a single one at New Orleans. Dan

Rather was chosen to be the new chief correspondent and spent the next several months shuttling between Dallas and New Orleans, laying the groundwork for the transition.

Meanwhile, at that very time, another Texan ex-Marine with a background even more fascinating than Rather's, would also be meandering back and forth between Dallas and New Orleans. His name was Lee Harvey Oswald, and he was the principal character in the assassination conspiracy that was then taking root in the latter city that would soon kill John F. Kennedy in the former.

The assassination conspiracy proved successful on November 22, 1963, when JFK's suddenly somnolent Secret Service detail steered him into a sophisticated crossfire ambush. JFK was fatally hit some eight seconds after the first shot was fired. Finally ready to clear out of the killing zone, Secret Service agent William Greer gunned the limousine down the sloping Elm Street toward the triple

underpass that led to Parkland Hospital. Meanwhile, a stunned crowd of onlookers screamed in horror and gave chase toward what is now known as the grassy knoll, where no fewer than seventy assassination eyewitnesses believed gunfire had originated. (2) Somewhere among them, though by no means certain exactly where, was CBS New Orleans bureau chief, Dan Rather.

To begin, exactly where was Dan Rather while the team of snipers fired their bullets at John F. Kennedy? Over the years, Rather has consistently claimed to have been standing on the on-ramp leading to the Stemmons Freeway on the opposite side of the triple underpass. He was separated from the grassy knoll assassin(s) by a twenty-five foot high railroad grade that had five sets of train tracks. Rather, who as the CBS southern regional news chief, was in Dallas to coordinate the network coverage of the President's trip to Dallas, claims he was standing there waiting for a roll of news film

to be tossed from a mobile camera unit following the President.

Rather's story seems unlikely; why would the CBS southern bureau chief assign himself the menial task of retrieving a bag and relaying it to CBS' Dallas affiliate KRLD studios? Any "gopher" could have handled that chore while the bureau chief monitored the newsroom for bulletins. After all, the President of the United States was parading downtown and anything could have happened! Wouldn't it seem that the bureau chief would want to be ready in the studio for any sudden development instead of posting himself at such a remote station? These peculiarities pale in contrast to the report in Jim Marrs' 1989 book **Crossfire**, which discovered news footage showing the limousine racing up the on-ramp revealing no sign of Dan Rather. Nor do still photos taken of that scene. Rather claims he was standing there when the limo raced by, but the newsreel and photos dispute his account. So if he was not by the on-ramp, where was he?

## Grassy Knoll Hotfoot

Though Rather has been consistent in his claim to have been by the on-ramp, his report of his activities immediately after the murder has been anything but. In March 1964, he told John Mayo the following, which Mayo published in his book: "I had a cab

waiting to rush the film to KRLD studios ... [after the shooting] I jumped into my cab and went straight to the studios." (3) However, in Dan Rather's 1977 autobiography, **The Camera Never Blinks**, his story changed significantly. This time he claimed:

I had to hotfoot it back to the station...I started off at a full run...I topped the railroad grading a few yards away and paused long enough to shade my eyes...The moment I cleared the railroad tracks I saw a scene I will never forget. Some people were lying on the grass, some screaming, some running, some pointing. Policemen swarmed everywhere...there was nothing but panic wherever you looked. [I decided] to hustle back to the station. I ran every step. (4)

Obviously, we have a major discrepancy on our hands. Did Dan Rather hack it or hike it to the KRLD studios? If he did proceed through Dealey Plaza on foot, he was entering an area flooded with scores of people in hot pursuit of at least one sniper who had fired from behind the picket fence straddling the grassy knoll, an area where police officers with drawn guns encountered suspicious persons who eluded arrest by flashing bogus Secret Service credentials. (5) Suspiciously, no Secret Service agents were assigned to the knoll and none left the motorcade to pursue the gunmen. Yet this trained, observant reporter somehow failed to notice the surging wave



of witnesses spilling into the parking lots behind the fence, though this was happening right in front of him. Nor did he notice the two men fleeing frantically through that parking lot immediately after the shots were fired. (6)

Rather then claims to have spent several seconds shielding his eyes from the sun while scanning the disintegrating motorcade for the news media's camera truck. (7) This part of his story rings true, because at that angle the sun would have been directly over his eyes. However, his statement poses another disturbing problem: how did he know the camera truck was well back in the motorcade? Indeed, it is the extremely curious positioning of the camera truck in the rear of the motorcade that disturbs many researchers to this very day. The camera truck always followed the President for obvious reasons; but that day in Dallas somebody scrambled the motorcade order, (8) so the cameras were unable to capture the assassination on film. That, of course, proved fortunate for the conspirators.

Obviously, Dan Rather had to know that the camera truck was in the rear of the motorcade; there is no doubting it. Yet, in his autobiography, he offers this statement: "In those days the truck often traveled well back in the motorcade; because of Dallas, it now usually travels in front." (9) That is absolutely false. The camera truck had always been in position to film the President, before and after Dallas; this being the only suspicious exception to that rule. (10) We also have to wonder why the CBS bureau chief would post himself in such a remote spot for a film that would not feature the President!

Rather claims that he then ran the "five blocks" to KRLD studios (it was actually nine blocks); arrived in the newsroom before anyone realized anything out of the ordinary had happened. He claims he hollered at his underlings to turn up every radio and police band they had, conversed via telephone with a CBS colleague stationed at Dallas Trade Mart, dispatched reporters to the scene of the crime, listened to the welter of frantic police radio activity, trying to decipher their codes, twice dialed Parkland Hospital, on the first call receiving word from an unnamed "doctor" that the President was shot dead and on the second receiving confirmation from a "priest" (again unnamed) that JFK had indeed been killed. (11)

Rather's autobiographical narrative continues:

I only knew that a tumultuous few minutes had passed since my four block run from behind the grassy knoll. On the United Press International news wire the first words of

a bulletin dictated by Merriman Smith had clattered to the rest of the world: Dallas, Nov. 22 (UPI) Three shots were fired at President Kennedy's motorcade today in downtown Dallas. The time was 12:34 p.m. (12)

Given that the President was shot at 12:30 p.m., this account is impossible. Rather could not possibly have engaged in even a small fraction of the activity he describes before the UPI bulletin of 12:34. Also, JFK's limo didn't arrive at Parkland until 12:35, (13) so how could the hospital have known him dead before that time?

It is very difficult to accept Rather's dawdling at the assassination site for maybe a minute and then making it nine blocks to KRLD by 12:34, at least by the means of transportation (taxicab or hotfoot) he claims to have used. He had to move about a half-mile, and he was a 32-year old,

slightly overweight man in street shoes. Even as a teenaged football player, he was by his own admission never fleet on his feet. (14) It is impossible to imagine Rather running a half-mile in three minutes flat, particularly through the huge, dispersing throngs, to arrive in time for the UPI bulletin, never mind the welter of other activity he describes. It is also difficult to accept a taxicab getting him to KRLD in that span of time. It is not a direct route from behind the overpass to downtown Dallas, and he still would have had all that parade-spectator traffic to wend through. It

seems to this observer that only an emergency vehicle equipped with a siren, or perhaps a motorcycle, could have put him at KRLD in time for the UPI bulletin, since it stands to reason that he did make it there by 12:34 in that nobody in the newsroom was aware anything was wrong. (Which brings to mind an old proverb: tell the truth, it's easier to remember.)

### **Where the Priest Has No Name**

Whatever the circumstances of Rather's race to KRLD, there can be no doubt the world's most famous reporter has his story sequence glaringly out of whack in **The Camera Never Blinks**. However, the next development in the unfolding drama of Dealey Plaza Dan is extraordinarily sobering. Incredibly, acting on word from correspondent Dan Rather in Dallas, CBS radio announced that President Kennedy was dead at 1:16 p.m., (15) central standard time, seventeen minutes before the official announcement of death. Dan

Rather claimed the premature announcement was due to his reporting the words he had heard from the "doctor" and the "priest" at Parkland to a colleague in Dallas while being overheard by CBS executives on their phone system's multi-hookup. (16) In his autobiography he writes:

It has never been clear exactly how, and by whom, the signal was given to announce the bulletin and play the national anthem. Months later, Mort Dank [CBS editor in New York] told me, "None of us were ever sure ourselves." (17)

Rather claims he was totally distraught by the early CBS radio announcement, even though he was certain his information was correct. He continues:

The official announcement was made to the press at 1:33 p.m., Dallas time, by Malcolm Kilduff, the assistant press secretary. More than half an hour had passed since CBS radio reported the death of the President. It does not take much imagination to know what was going through my head most of that time. I knew if the story was wrong, I would be seeking another line of work. Rightfully so. I also knew I wasn't wrong. (18)

This is incredible! Dan Rather makes no secret that hearing the news of the official announcement of President Kennedy's violent death relieved him of an intense inner turmoil, the kind of turmoil one feels when one's job is on the brink. We can only marvel at the literal obscenity of a man who needed John F. Kennedy dead more than anything in the world, a man who eventually evolved into a four million dollar per annum anchorman. Except for perhaps the assassination conspirators themselves, nobody seems happier about the President's passing than Dan Rather as he makes not even a token effort to conceal his emotional priority: a deeper concern for his job than for the President's survival.

In addition, how did Rather know he "wasn't wrong"? His information sources were an unnamed doctor, an unnamed priest and a colleague at the Trade Mart, the chief of staff of Parkland Hospital. But, upon examination, these sources evaporate into thin air. Who was the doctor who first told Rather the President was dead? Parkland was in a near-panic state of emergency, with the President of the United States and the Governor of Texas in separate trauma rooms with critical gunshot wounds. What "doctor" had time to converse with Dan Rather over a switchboard phone?

As for the priest, Rather's claims sound suspiciously like the story of the priest who "administered the last sacrament of the church to President Kennedy" that went out over the AP wire at 1:23, seven minutes after the CBS announcement and ten minutes before the official confirmation of JFK's death. However, it eventually turned out that the priest in question never said any such thing, (19) and Rather claimed to have heard him before the false AP quote. Nor did the other priest present acknowledge any such remark or confirmation of Kennedy's death to any reporters. Finally, why did Dan Rather take the word of the chief of staff of Parkland Hospital when that official was not even at the hospital?

#### Zapruder and the Missing Frames

However, the President was dead, and Rather's job was secure, and he began coordinating the CBS coverage of the tragedy. Somehow he learned of a Dallas dress manufac-

turer, Abraham Zapruder, who had filmed the murder with a home movie camera, and off he went in search of the cinematic amateur who had stumbled upon the crime of the century. Here we have an extremely curious situation. According to Rather's autobiography:

We started a search for anybody and everybody who might have been there carrying an eight-millimeter camera. [KRLD station manager] Eddie Barker's people began calling all over Dallas. And slowly we picked up a trail. Someone had seen a man standing at a certain spot. Someone else thought he was in the retail clothing business (wholesale, it turned out.) We ran our leads through the FBI and the Dallas Police. Finally, we had a name: Abraham Zapruder. (20)

Though replete with high drama and suspense, this account is very much improbable. Who were the two "someones" who saw "a man standing at a certain spot" and who thought Zapruder was "in the retail clothing business?" Once again, Rather offers no names for his seemingly endless supply of anonymous benefactors. However, Rather proceeds past the point of all credibility when he says CBS "ran our leads through the FBI and the Dallas police." The President of the United States is shot dead, the Governor of Texas is wounded, a Dallas policeman is shot dead, several suspects are in custody, and Rather would have us believe that authorities took time out to help him track down somebody said to be carrying a movie camera? And again he offers no names. We are left to ponder who brought Zapruder to Rather's attention, and who told him where to find the Dealey Plaza film-maker.

It is the author's opinion that Zapruder must have been followed from the scene of the crime. It strains all credulity that such a vague description could result in such a quick identification in a city as large as Dallas (pop. 750,000 in 1963). Rather's statement that someone thought Zapruder was in the retail clothing business is telling, because Zapruder did indeed go straight to his office after filming the assassination. His "tail" probably reported that the cameraman had entered a clothing establishment.

Whatever the circumstances of the Rather-Zapruder meeting, the newsman was able to make headway with the merchant. In **The Camera Never Blinks** he writes:

When we reached him Zapruder did not know what he had. We didn't either, but we helped arrange for Eastman Kodak to process the film. This job had to be done by the best equipment. It had to be done fast. And it had to be kept confidential. (21)

Now we run up against some very serious problems. Researchers have long wondered what happened to six extremely important Zapruder film frames. Two brief sequences representing fractions of seconds, numbers

155-156 and 208-211, have never been located (22), though Rather claims only one frame was lost. (23) These two missing sequences might have provided concrete proof of conspiracy. According to Robert Groden, undoubtedly the leading Zapruder film expert, frames 155-156 coincided with the first gunshot heard on the acoustical tape of the assassination, and frames 208-211 could have shown a bystander across Elm Street snapping a picture that would have provided a perfect synchronization of the movie. (24) The mystery of the missing frames was perhaps solved in 1980, when assassination researcher David Lifton wrote:

[After discovering numerous discrepancies] I then began exploring the possibility that the Zapruder film itself had been altered sometime before it became Warren Commission evidence in 1964, perhaps even before it went to Life [magazine, which purchased it from Zapruder] on November 23, 1963...But alteration of the film required a film laboratory with the sophisticated apparatus normally used by Hollywood to create special effects. Was the original Zapruder film at some point taken to such a laboratory? Officially, the film went only from Zapruder to Kodak in Dallas; then to the Jamison Film Co. in Dallas, where three prints were made...then back to Zapruder, and then to the vault at Life. I suspected it had taken a secret detour, but I could find no direct evidence to prove that.

Then in 1976, among records released by the CIA under the Freedom of Information Act (FOIA), Paul Hoch found CIA item 450, a group of documents indicating that the Zapruder film was at the CIA's National Photo Interpretation Center (NPIC), possibly on Friday night, November 22, 1963, and certainly within days of the assassination. NPIC is one of the most sophisticated photo labs in the world. (25)

Meanwhile, we have another nugget of information from perhaps the unlikeliest source, David Belin. As Counsel to the Warren Commission and Executive Director of the 1975 Rockefeller Commission that whitewashed CIA complicity in the assassination, Belin is the undisputed champion of the "Oswald alone" myth. However, in his book **Final Disclosure**, Belin perhaps unwittingly reveals:

The person who had actually first contacted Abraham Zapruder after the assassination was Dan Rather, CBS News, who, after finding Zapruder, took the film and was able to have the processing of the film expedited. (26)

Was Dan Rather the first person to acquire possession of the most precious piece of evidence in the assassination case? If so, that might solve the mystery of how the CIA lab was able to secure it before Life purchased it on November 23. It is also yet another disturbing discrepancy in Rather's autobiography concerning his consistently curious behavior in Dallas that tragic weekend. According to Rather, he never had possession of the film, though he acknowledges obtaining Zapruder's name from mysterious sources and expediting the processing. But, according to Belin, Rather "took the film." Belin, it should be noted, is a lawyer's lawyer; he is the most competent Warren Commission apologist because he is very rarely caught making statements that can be proven to be untrue. If Belin says Rather "took" the film, it is a safe bet that Rather did exactly that.

Rather can probably be believed when he says he only saw the movie when Zapruder's lawyer showed it to him in

the lawyer's office on November 23; had he seen it earlier, he would have certainly reported its contents to television viewers. Also, it stands to reason that Rather didn't personally take the film to the Kodak lab or Jamison Film because, as he readily admits in his autobiography, he was ready to show it on the air without Zapruder's permission and damn the consequences! When Rather realized he might lose out on the bidding for the movie to Life, he said to himself: "If I have to, I'll just knock [the 59-year old Zapruder] down, grab the film, run back to the station, show it one time and then let him sue us." (27)

It appears that someone else was in league with Rather when it concerned the film; anyone ready to knock an elderly man down to steal his movie could not possibly have resisted an opportunity to view and broadcast the film if he had access to it after its development. So somebody else, probably whoever "expedited" the film to Kodak, must have turned it over to the CIA for its apparent tampering at the NPIC lab. But who? We must keep in mind that Rather makes constant references to anonymous helpers in his Dallas story; one of these shadowy assistants is probably responsible for the film's secret detour. On this particular count, Rather's ruthlessness ironically seems to exonerate him from taking the film directly to NPIC himself, or returning it from there. If Belin is right, if Rather was the first person to take possession of the film from Zapruder, he almost certainly turned it over to someone else. And that someone else must have had a mighty influence on Rather for him to have surrendered it so readily!

#### The Cover-up

After finally viewing the Zapruder film in the lawyer's office on November 23, 1963, Rather made his famous "honest mistake" that has haunted him for years. Rushing to the KRLD studios, he requested immediate air time to describe what he had seen. According to Rather, President Kennedy's head snapped "forward with considerable violence" upon receiving the fatal head shot. (28) This, as we now know, is totally at variance with the truth. Eventually a bootleg copy of the film made its way into the public domain, Time-Life failing to keep it under wraps as it had hoped after purchasing it from Zapruder. The American public then saw that, contrary to what Rather had reported, the President's head had snapped backward (and leftward), consistent with a fatal shot fired from the grassy knoll to the right-front, where the overwhelming majority of witnesses placed the sniper. Rather's "honest mistake," of course, aligned perfectly with the "one rifle from behind" cover story.

When confronted with his obvious error after the film finally reached the public in 1973, Rather simply claimed he had made an honest error because Zapruder's lawyer had not allowed him to take notes. (29) However, it is difficult for anyone seeing the film even once to forget the dramatic left-rearward reaction of the President's skull as it exploded in a pink halo of blood and brain. There is no denying that Dan Rather glaringly misrepresented the contents of the Zapruder film. What makes this particularly disturbing is that he was the only broadcasting reporter allowed to view the film! (30) Time-Life, a media giant with extensive connec-

tions to the CIA (31), kept the film from the public for almost ten years before a bootleg copy found its way into the public domain. (32) It is obvious that some people intended to conceal it from the American public forever, not allowing even reporters to see what it showed: an obvious crossfire that executed the President in broad daylight while his Secret Service "guardians" merely relaxed and watched the show.

It is also noteworthy that Rather had two opportunities to describe the film correctly. It seems CBS insisted he repeat the first take because of yet another controversial Rather report. The network executives forced Rather to do another take and delete an offensive reference to Jacqueline Kennedy "fleeing" the death car. (33) In actuality, she was reaching out for a piece of her husband's skull that had been blown backward onto the limo's trunk, itself more evidence of a shot from the front. (34) Rather reluctantly omitted the reference, but stated "I wished I had not." (35) Rather was apparently not so reluctant to refer to Mrs. Kennedy "fleeing" in private conversation; and soon the "sick comic" Lenny Bruce was wisecracking about her "hauling ass" out of the limousine.

Now we will examine why Dan Rather was in Dallas during that tragic weekend. He had moved from Dallas to New Orleans only a few weeks previous, having completed the transfer of the southern bureau to the latter city. According to Rather, while in New Orleans he was asked by CBS editor Ralph Paskman for recommendations as to how the network should cover the President's pre-campaign trip to Texas. Rather later wrote in **The Camera Never Blinks**:

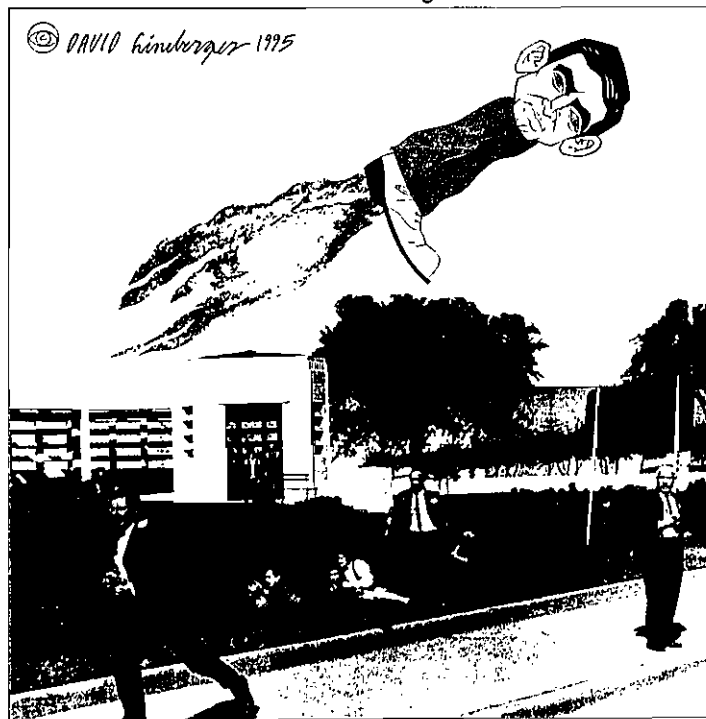
I quickly put my report together. The President's swing would take him through San Antonio, Houston, Fort Worth, Dallas and Austin. "This is not a routine trip," I said. "Not routine politically. Not routine in terms of security." Paskman said, "You'll have to explain that to me about the security..." He was aware that Dallas had been the scene of angry political incidents. His question was intended to draw me out. Whatever manpower CBS assigned to Texas would be based on his judgment. So I reviewed the recent trouble signs: Adlai Stevenson had been spat upon in Dallas in October; even Lyndon Johnson had been brushed by a picket sign. The John Birch Society flourished there. "Impeach Earl Warren" bumper stickers were a big seller...

The President's advisor's were known to be nervous about his visit to Texas. Some Dallas businessmen had urged him to postpone the trip until the temper of the city had cooled... Paskman agreed that we should lay on double coverage all over Texas and quadruple it in Dallas. He went to the top and fought for more people. When the

President's party left Washington, CBS was staffed for the road as fully as a network can be without planning an invasion. Still, I do not mean to invest in this any mystical implications. We were preparing for the unexpected. An incident. A reaction. A story. We were not having visions. But whatever was to happen in Dallas, I knew we would be in an unusually good position to cover it. (36)

We can gather from this passage that Dan Rather knew the President was taking a major security risk in traveling to Dallas; that Rather was in fact responsible for CBS dispatching a huge contingent of broadcasting technicians to that city in anticipation of the President's trip; and that, in Rather's words, "whatever was to happen in Dallas, I knew we would be in an unusually good position to cover it." Several paragraphs later, Rather claims that, though he was responsible for the launching of the CBS array to Dallas, he himself was in that city only by fluke, because someone again unnamed discovered that Friday, November 22, 1963 was the ninety-eighth birthday of (former Vice President) John Nance Garner... "So it was decided that I would fly that morning to the Garner ranch at Uvalde, Texas, and film an interview, then return to Dallas and feed, with the rest of our coverage, to New York." (37)

This statement would apparently cause Rather considerable consternation in the period immediately following publication of **The Camera Never Blinks**. In the July 22, 1977 issue of **The Continuing Inquiry**, Penn Jones published a savage review of Rather's autobiography, pointing out numerous inconsistencies



and outright lies. Included was this observation:

Rather reports he went to Uvalde, Texas for an after-breakfast meeting with former Vice President John Nance Garner at his home there, but he doesn't mention the distances involved. He does not bother to tell his readers it was a six hundred mile round trip and that he was back in Dallas before the President's parade. That kind of timing would have required a jet, we think. Whose jet? Rather didn't say. (38)

Jones had raised an interesting point. There was no round-trip commercial air traffic from Dallas to Uvalde that could have enabled Rather to make two 300-mile journeys in just a couple of hours. Rather clearly needed to delete that sojourn in future editions of his autobiography. Jones apparently struck a nerve, for in ensuing publications of TCNB the passage was altered to "it was decided I would fly that morning to Dallas and feed the piece...." Prior mention of the trip to and filming in Uvalde was omitted. (39)

Once back in Dallas, Rather, who had encouraged his network to give quadruple the coverage a President normally received in a heartland city, decided, in his own words, "What the hell, I'm not doing anything, I'll go over" to cover an unmanned film drop. We must certainly marvel at his good fortune in that film drop just happening to be virtually adjacent to the assassination site. As he modestly told *Current Biography* twelve years later, "It was simply a matter of having been at the right place at the right time." (40) Thanks to Dan Rather's remarkable prescience in getting CBS to quadruple the Dallas coverage, and his great luck in stumbling upon the assassination site, his network was the first to go live to the assassination story, and enjoyed a huge beat on its competition, ABC and NBC. (41)

This was very fortunate for CBS which, according to Carl Bernstein, like Time-Life, was not only intimately connected with the CIA but was also "unquestionably the CIA's most valuable broadcasting asset." (42) Perhaps the most intriguing phenomenon with which to compare the great CBS "luck" is the record "short-selling" spree that swamped the New York Stock Exchange before the shots were fired on November 22, 1963, the morning of the assassination. According to Lincoln Lawrence, the people prompting that massive short-sell proved extremely fortunate, reaping some five hundred million 1963 dollars (worth at least two billion today) when the market crashed upon news of the assassination. Quite a bonanza for one morning's effort. (43)

When we recall: the photographs and newsreels of that remote spot revealing no trace of Rather; his two very different accounts of his movements in the first sixty seconds after the shooting; his apparent blindness to the obvious conspiratorial activity in the grassy knoll area he was inhabiting; his curious knowledge of the camera truck being out of its proper motorcade sequence; his haphazard account of

the initial assassination coverage at KRLD; his mysterious telephone conversations with people that convinced him to declare the President dead before that official announcement; his obvious lack of compassion for the slain President and his widow; his seemingly supernatural discovery of Abraham Zapruder's identity and his remarkable ability to pry cops and FBI agents from the assassination case to help him make that identification; his having "first possession" of the Zapruder film that we now know was tampered with soon afterward; his blatant failure to accurately report the explicit film's most significant feature after being the only broadcaster allowed to view it; his insistence that CBS vastly increase its manpower in Dallas, though he himself saw no reason to wait in the newsroom for bulletins; the seemingly impossible round-trip visit to Uvalde on the assassination morning that was quickly excised from subsequent editions of his book; when we recall all of these peculiarities, we cannot help but wonder just what was going on with the CBS New Orleans Bureau Chief in Dallas that tragic weekend.

In this most bewildering murder mystery, it is ironic that the one man most noted for denying that any mystery exists is himself a cauldron of puzzling uncertainty. Indeed, Dan Rather is even a rival to his fellow Dallas-New Orleans ex-Marine Lee Harvey Oswald himself as the most enigmatic figure connected to the JFK assassination. However, whereas Oswald's personal contact with the infamous case terminated that very weekend, courtesy of Jack Ruby, Dan Rather's would not. Indeed, he would prove, if only unwittingly, to be a key player in the massive effort to conceal the truth from the American public for many more years to come.

## Continuing Cover-up at CBS

**"We (at CBS) came up with better evidence than the Warren Commission that Oswald acted alone."**

Dan Rather

Over the next four years, Dan Rather was instrumental in several special reports that insisted Lee Oswald had been the solitary assassin of President Kennedy. The first special, **The Law and Lee Oswald**, broadcast on December 29, 1963, (just one month after the murder), was a "dialogue" about Oswald's legal situation while in custody. Incredibly, Rather tried to persuade his audience that Oswald, who was denied a lawyer up until the moment he was murdered, had received his constitutional rights! There was no travesty of justice, concluded CBS. Shortly after, Rather received a promotion to the prestigious White House beat. He assumed this new duty on January 22, 1964, exactly two months after Kennedy's death. Nine months later, Rather was the principal in a two-hour broadcast, **The Report on the Warren Commission**, which appeared on the eve of the release of the Warren report and assured its huge audience that the Commission had spared no effort in its quest for the truth.

After his return from news coverage in Vietnam in November 1966, Rather set to work on a huge CBS documentary, **The Warren Report**, which appeared in June 1967. (45) In retrospect, this project, where he was teamed with producer Les Midgely, was one of the most controversial TV efforts of all time. This four-hour, four-part series was per-



fectly timed to bolster rapidly faltering public support for the Warren Commission findings, which had been effectively destroyed by a wide-ranging number of critics (or "buffs" as disparagers like Rather referred to them). It should come as no surprise that CBS decided the Warren Commission conclusions, which had by then been totally repudiated in the minds of people familiar with the facts, were perfectly sound. Particularly significant is the claim made by Rather a decade later that the CBS documentary "came up with better evidence than the Warren Commission that Oswald acted alone." (46) However, within months of Rather's boast the U.S. House of Representatives Assassinations Committee rejected all of that CBS "evidence." (47) It simply did not withstand impartial scrutiny, and is now a monumental record of a mass media's grotesque distortion of reality in its desire to sway public opinion toward a desired end.

Entire books could be written about this blatantly biased CBS documentary that did much to "disinformationize" tens of millions of Americans. However, here we have space only to address a few statements made by Rather and the show's host, Walter Cronkite. After a grudging, circumlocutory acknowledgment that the marksmanship attributed to Oswald proved virtually impossible for rifle experts to duplicate, Cronkite, adapting a stance straight from Orwell's *1984*, declared that Oswald had not been shooting "under normal circumstances" because "Oswald was shooting at a President." In other words, the impossible was possible because it was accomplished; never mind the evidence, case closed: Oswald did it because he did it!

As for Rather, he would greatly augment his already prolific history of mis-statements about the Kennedy assassination. Particularly glaring is his explanation for JFK's dramatic left-backward thrust after the fatal bullet hit him. Dan Rather, who had neglected to mention that backward jolt after viewing the film in 1963, explained it in this 1967 CBS special by claiming "Jackie pushed him." (48) Even the most cursory examination of the Zapruder film reveals that Mrs. Kennedy did no such thing. Rather also assured the TV viewers that Oswald had, "after all, (scored) in the second highest category of marksmen in an outfit, the United States Marines, that prides itself on its marksmanship." (49) As an ex-Marine, Rather was certainly aware that there were only three categories of marksmanship in the Marines (expert, sharpshooter and marksman) and that Oswald's "sharpshooter" score of 191 was only one above the minimum for that grade. (50) Nor did Rather mention that Oswald's Marine buddies considered him a

lousy shot, as is evidenced by all his other rifle scores ranking in the lowest third of his outfit, on a good day. But it was necessary for CBS to depict this mediocre shot as capable of performing a feat that would have been the envy of any Olympic rifleman, considering the defective equipment he allegedly used, (51) because faith in the discredited Warren Report had to be bolstered. Especially since it was at this time New Orleans District Attorney Jim Garrison appeared on the scene.

### CBS American Assassins Report

In 1975, two months after the assassination attempts on Gerald Ford, Rather hosted four hours of documentaries on his CBS Reports forum. In this series entitled *The American Assassins* he was again paired with producer Les Midgeley. The first two hours of the series concerned JFK, and the next two hours focused on the King, Wallace and RFK shootings. (52) Naturally, Rather concluded that Oswald,



Sirhan, Ray and Bremer were solitary lunatics acting alone; there were no conspiracies of any kind at all. (53) Les Midgeley boasted that CBS retained the Itek corporation for analysis of the evidence, an "outfit which did very sophisticated work for people like big oil companies, the Defense Department and the CIA. (54) Oh really? We can wager those blocs wept as grievously for JFK as the Mob did!

This was Rather's fourth documentary in loud support of the "Oswald-alone" myth.

With these four documentaries comprising nine hours of support for the "Oswald-alone" myth dangling from his belt, it is difficult to name anyone else who has more invested in that falsehood than Dan Rather, the reporter behind the grassy knoll. [The author has also analyzed Dan Rather's 1992 CBS documentary *48 Hours*, which contributed heav-

ily to this media-orchestrated damage control in support of the Warren Commission findings.—ed. (55)]

### What's the Frequency Kenneth?

Whereas the Cronkites and Chancellors and Huntleys of the past prided themselves on maintaining an aloof detachment that accentuated their impartiality, Rather, in dramatic contrast, seemingly revels in being quarrelsome, egocentric and manipulative. Naturally, his odd behavior both hinders and bolsters his broadcast ratings. Many viewers have abandoned him, with some percentage doubtlessly alienated by his antics. Yet, the deserters are at least partially canceled out by people attracted to the negative publicity, waiting to see if Dan's going to "lose it" on the air.

Of all the favorite Dan Rather stories, perhaps the most bizarre incident is his mysterious, still unexplained assault on a Manhattan sidewalk during the evening of October 4, 1986, by two well-dressed but crisp-punching men whom Rather alleges continuously peppered him with the seemingly inane question, "Kenneth, what is the frequency?" (56) We have only Rather's word that that is what his attackers said. The two witnesses to the incident, a superintendent and a doorman, saved Rather from worse abuse, but failed to make out what the thugs were saying. Could it be that the mysterious men were actually saying something else? Something similar, perhaps, like Kennedy, w— f—?

Is it unreasonable to assume that this seemingly motiveless beating just might have been related to a Kennedy rather than a Kenneth? That perhaps Rather's controversial behavior since that 1986 night might be directly traceable to what those men asked him over and over again in between punches? Or, whether by extension or not, might be traceable to the very controversial aspect of the man's entire journalistic career? Specifically, his extremely curious behavior in Dallas, Texas, on November 22, 1963, the place and day where a Kennedy, not a Kenneth, was brutally murdered?\*



# I Love a (Wo)man in Uniform

**O**n Valentine's Day, 1995 four Department of Environmental Protection (DEP) agents, armed with guns and a warrant, stormed through a selectman's kitchen in Westport, Connecticut, Paul Newman's hometown.



They grabbed a baby deer, a doe, which the selectman had gotten attached to after finding it on the side of the road injured, with a broken leg. After trashing around in the selectman's laundry room, the wound had gotten infected. The "Green Police" carted off the doe and had its leg amputated. A cartoon illustrating the incident in the local paper pictured Bambi held at gun point. The animal lovers went ballistic! The three-legged doe has since been released in a reserve, relatively safe for now, at least until the next coyote comes around.

So what, right? There's a law, after all, against private citizens harboring wild animals. But more and more stories like this one keep surfacing in the press. Recently NBC's *Dateline* chronicled the efforts of the Pacific Legal Foundation to curtail out-of-control environmental law enforcement. When did the DEP, initially created to protect nature, wildlife and you & I from corporate polluters, turn the tables and start acting like SWAT teams on a drug bust for America's Most Wanted? Something in their job description got lost in the translation.

This innocuous little regional event

This article title is inspired by the song I Love a Man in Uniform by Gang of Four

takes on a new dimension when you look at it from the perspective of how the environment has now become the political "be all that ends all." Books like *Environmental Wars*, *Eco-Warriors*, *World War 3*, *Top Guns & Toxic Whales*, *War Against The Greens*, and *Green Rage* hit the bookstores with increasing regularity. Should we be getting worried, paranoid even, that this could be symptomatic of something much more insidious? Are you having Waco flashbacks?

Thankfully, in this case it simply demonstrates the broken chain of command linking the selectman, the town, the dog warden (whose responsibility this should have fallen under) and local DEP officials. Mountains were made of hell pavement and DEP thugs, ordered from above, simply came waltzing in like he had plutonium in his basement! The poor guy had become a faceless criminal, not some suburbanite without a clue wearing his heart on his sleeve.

So what's going to happen when the military as a whole takes on their green mission? It's no big secret. It's been on the Pentagon's wish list for months, subject to great fanfare. How did it come about? Once the cold war cooled down and we were buying

pieces of the Berlin Wall like pet rocks, they were quick to find other things to put on the agenda. At the same time that troops were piling up on the sands of Desert Shield, a conference was being held in Maryland between top brass and environmental groups. The environment had become a matter of national security. In his opening statements, then-secretary Cheney asked DOD to become the leader in environmental compliance and protection. Not "a" leader mind you, but "the" leader. There's a big difference. Our boys in the Gulf were facing nuclear biological chemical warfare, so nobody much noticed. But once the exercise was over, General Schwarzkopf told Barbara Walters he wanted to champion the environment, and became a chairman of the Nature Conservancy, the largest and wealthiest of all green non-profits. Today there's talk of drafting Colin Powell for president. Is this schizophrenic or what?

I remember smiling when Lyndon LaRouche would go on TV in the 80's, buying prime time from the networks, to bring his conspiratorial vision to couch potatoes. In one speech he predicted, as he always did, that the Rockefellers (also the arch enemy of ecologists at the time) would shut down all nuclear power plants, let the

roads go to dirt, and bring back the horse as the only means of transport in the affluent suburbs. It sounded like fun, and still does, but they were the ravings of a lunatic mind, or were they? All the while Bush, a president who couldn't tell the forest for the trees, had a Secretary of Defense preparing a Save The Planet offensive days before hundreds of oil wells went up in flames and billions of gallons of crude oil permanently disabled that part of the world. What went wrong?

Back during the Carter years, Lt. Col. Jim Channon was stationed in Hollywood in charge of providing military hardware to studio lots. He got a taste of the high life and attended a few EST training seminars, the tinsel town spiritual quest in vogue at the time. He realized how similar they were to boot camp and he came up with a concept for a special division of the army called the First Earth Battalion that would walk the talk. A demonstration video was produced and sits in a vault at West Point. When Carter got the boot, so did the project, and our visionary retired to Hawaii as an illustrator for Pontiac. But the seed was firmly planted and the results are plain to see in today's army, from Haiti to Somalia.

CNN recently did a special on our "Guardian Warriors." But the French author Paul Virilio warned us in his 1976 book **Popular Defense & Ecological Struggles**: "We must get it out of our heads that the military rushes to the aid of civilians, sets up emergency medical units and encampments for disaster victims, runs airlifts and clearing operations on the sites of great natural or man-made cataclysms out of pure philanthropy." In other words, they're just preserving their usefulness.

In a wonderful new book entitled **Scorched Earth**, which is designed to target Generation X, William Thomas, who served in the Navy, describes in rapid edit MTV style the litany of damages caused by the military in both wartime and peacetime activity. He should know, as he organized environmental relief efforts in Kuwait and produced a video diary called **EcoWars** which won first prize at the Environmental Film Festival in 1992.

Reading **Scorched Earth** will send chills down your spine. But it will also leave you with guilt pangs in the gut you won't shake for days, simply for letting this stuff go on unimpeded. **Scorched Earth** could trigger a renewal of student activity on campuses. We're on the threshold of a major shift in power, an eco-coup if you like, which could redesign the global map.

A special '92 Earth Day edition of

**The New American**, the magazine of the John Birch Society, reaches the same conspiratorial conclusions as **Scorched Earth**, but without fessing up to the reality of the ecological situation. The Birchers are off the mark when it comes to being conscious about the real threat we face: less oxygen, more carbon dioxide, radioactive traces in all fresh water supplies. In a review of Al Gore's **Earth In The Balance**, already subject to a lot of spilled ink downplayed during the elections, **The New American** shows a photo of our vice-president with the caption: "Gore calls for global Marshall plan." The editorial itself is spiced with alarmist descriptions of "Green Gestapo" and "Green Regime." Echoing

this concern in a February '95 book review of **The Chicago Gangster Theory Of Life** by NYU Professor Andrew Ross, **Village Voice** writer Erik Davis dismisses fears of a "paramilitary environmental-industrial complex that would oppress us all in the name of Gaia" as "B-movie hysteria". But, Davis then goes on to review **Contesting Earth's Future** by Michael Zimmerman without making the connection with 1982's **Ominous Parallels** by Leonard Peikoff, already warning against such a shift to the right. Zimmerman writes: "Because Nazi racism linked the blood purity of the Volk to a healthy natural environment, an entire generation had to pass after World War 2 before environmental movements could gain prominence in Western countries." Zimmerman claims "deep ecology" is inspired by German philosopher Heidegger who "viewed Hitler's revolution as constituting a new dawn."

Desperate problems lead to desperate solutions, and once again we are faced with an eruption to power by a political force rising out of our subconscious need for self-preservation. But kept out of check, set in motion by the burning desire of 30 million people on the streets for the first Earth Day in 1970, could this lead to a "Green Reich" and losses of freedom in America? Or do we still have time to backtrack and focus on the direction we have taken?

The push by wealthy armchair liberals toward global clean-up efforts, a restoration to a pristine earth, could lead us straight into the jaws of eco-fascism, a term used by the media to label the tactics of "eco-terrorists." The growth of misplaced environmental correctness is clouding the issue and diverting the public's attention on scapegoats. In the meantime, true "hard" engineering solutions to energy consumption, the major culprit in environmental degradation, are left "classified" under the pretext of national security.

Is the cure worse than the disease? You have to realize that if we didn't make such a public display of the atomic bomb, chances are the nuclear genie would still be top-secret, bottled

up or not. It's the case for dozens of other potentially planet saving technologies which are being worked on under the deep cover of a \$50 Billion annual black budget.

Environmentalists used to be anti-design, anti-technology, back to the earth Malthusians. But today's generation is plugged into cyberspace and the zine revolution. The cat is out of the bag, to quote UFOlogist Marc Davenport. Dirty little whispers of zero-point energy and over unity, long a touchy subject in quantum mechanics, are now on everybody's lips. How will we control this, and should we try? Was that the message of the Twin Tower bombing in Manhattan? That we need Big Brother to protect us against the big bad Islamic wolf? Imagine if someone had something "better" to play with. Have we forgotten Nikola Tesla was asked to leave New York at the turn of the century because an experiment in his lab nearly brought down all the buildings in town? In the seventies, John Philips proved anybody could build an A-Bomb by making it a science project in school and grabbing headlines all over the world. Perhaps the solution to our energy problems, in the wrong hands, could be much worse. What then?

In the last issue of **PARANOIA**, I discovered that the Fourth Seal in the Revelations of St John which reads "behold a pale horse" should actually have been translated "green horse," because the original Greek was "chloros," the color of plants. William Cooper's fascinating, if sometimes barely believable treatise by that name takes on an entirely new connotation. The conclusions of Whitley Streiber, John Mack and other reporters of the UFO experience agree that E.T. visits are rooted in a deep concern for the earth. Psychedelic guru Terence McKenna associates this with elves in Celtic and Pagan myths. Stories told by contactees like George Adamski in the 50's inspired the brilliant anti-nuclear film **The Day The Earth Stood Still**, where CIA agents were rumored to hang around the set while it was being filmed. Come to think of it, why hasn't the earth been given a day of rest since the industrial "explosion"?

Michael Tobias is a deep ecologist. His paperback **Voice of the Planet** was turned into an educational series starring William Shatner for Turner Broadcasting. So it was a surprise when he titled his new book **World War 3**. It goes against the grain of most greens who feel military intervention of any kind is counterproductive in the long run. But what Tobias means by World War 3 is the war we are waging against the earth itself, not the war that could result from wanting to save it. Ecofeminists feel that taking on a problem in a warrior-like fashion is at the very essence of the problem. We must, therefore, change our entire approach toward solving the situation. What's the alternative? Submission? Surrender? Jim Keith in **Black Helicopters Over America** quotes a Pentagon aide concerning the New World Order as saying: "The enemies we are likely to face through the rest of this decade and beyond will not be soldiers, but warriors, erratic primitives of shifting allegiances, habituated to violence, with no stake in civil order." Does he mean people like our Westport selectman?

Tobias goes on to print every fact and figure he can lay his hands on. In its evil twin, the hilarious **All The Trouble In The World**, conservative pundit P.J. O'Rourke points out in a footnote: "You may wonder how the government of Bangladesh, not renowned for its competence in other fields, is able to give the country's annual rate of population growth to the hundredth of a percentage point. It can't. The more precise the figure, the more general the lie."

There's no doubt the world is rallying around a green flag as a pretext for perpetuating global domination by a few financial institutions. People laugh when you mention Prince Charles and his love for gardening and his hate for bad architecture. They forget his family is the wealthiest in the world and contributes immensely to such things as a green theme park in Wales, which Real Goods, the largest green product mail order company in the USA, is now emulating in California. These are great things, but what concerns me is who pays for them: second and third

generation Rockefellers guilt ridden by the mess their families have left in their wake. The Energy Foundation, a joint venture between the Rockefeller Foundation and other philanthropic institutions, dispenses millions a year to undo the harm already done. David Packard, of Hewlett-Packard fame, sold his share of the company and created a foundation worth 1.3 billion for conservation and the laudable education of minorities. Doing good has never been greener!

Palm Beach, Florida, the capital of charity balls, hosts hundreds of benefits every season, raising an untold amount of money for the flavor cause of the year. The entire world of high finance and global economics is turning green, dancing to the tune of "Spiritual Politics," picking up where the Aquarian Conspiracy left off. But what are the consequences of cultural homogenization on indigenous people, the poor and the truly radical? Will time tell? The price of democracy is eternal vigilance, that's 101!

There's a few citizen's organizations courageous and patient enough to work hand in hand with military clean up teams like the Military Toxics Project and the Kentucky Environmental Foundation. Peter Nasselstein coins this "Blue Fascism" in #10 of **Flatland**.



Can we trust such a mobilization for survival by forces like the "Green Helmets" to remain an extension of the people's will? AmeriCorps, Clinton's new national service corp, and other volunteer services will not take gangs off the streets as long as it does not reflect a comic book atmosphere kids have come to expect. Could it be that's what Gorbachev and the U.N. are planning with the Green Cross?

The official "Report of the World Women's Congress for a Healthy Planet" held in Miami in 1993 advocates that the US military take on green missions. The Rocky Mountain Institute after "greening the White House" is now "greening the Pentagon" which is wall to wall asbestos. According to **E Magazine**, Langley is next! Soon we'll have two 24-hour cable networks, Planet Central and the Ecology Channel, piping green news into our living rooms. In the sci-fi movie classic, **When World's Collide**, a meteor rushing to earth is the brass ring unifying the race to build a Noah's Ark spacecraft so a chosen few can escape catastrophe. The Brookings Institute released a theoretical study of how mankind would react and how human institutions would stand up if superior alien intelligence became an absolute reality. They have also released British author Tony Brenton's **The Greening of Machiavelli** in the US, a blow by blow account of the rise of the environmental agenda around the world cementing a New World Order.

There's no doubt in my mind that the call to environmental action is necessary. What concerns me is the motivation of those assigned to lead. When Abbie Hoffman went undercover while on trumped-up coke charges, he became an environmentalist. He went to work stopping the Army Corps of Engineers from detouring the St Lawrence river and flooding dozens of islands. He got an award from Senator Pat Moynihan while wearing a fake beard.

In 1990 I did an interview at Wetlands' Eco-Saloon with Denis Hayes, once director of the Solar Energy Research Institute, renamed and scaled down by the Reagan administration. Hayes had few good words for government policy, except to praise the Corps for the work it was now doing restoring land instead of poisoning it. Would Abbie really commit suicide with so much more good works ahead?

In another Connecticut town, a man was taken to court for accidentally killing a stray dog on his property with a pellet gun only meant to discourage it from destroying his flower bed. In New Jersey another had his day in court for killing a rat who was eating his tomatoes. Bruce Siminoff recites countless such craziness in his book **Victim** about Americans caught in a whirlwind of green legislation leaving them either broke or in jail. Nixon created the Environmental Protection Agency under great pressure from the peace movement to address the issue. But since then citizens groups have had to fight an uphill battle to counteract the bureaucratic nightmare fueled by our own tax dollars. It's as if we now have to do everything twice. The EPA makes it worse, and we have to work twice as hard to set it right! One step forward, two steps back, to quote Bruce Springstein.

Earth Day '95, the 25th Anniversary, has come and gone. We've won a few battles but we're losing the war. Perhaps

its not a war after all. Perhaps we need to let go of our earthly attachments. Like a Chinese finger trap, the harder we pull, the stronger hold it has on us. The task is monumental. Billions in unison. A last hurrah or Eden at the end of the tunnel? We've spoiled our nest and there doesn't seem to be any place to move on to. What's keeping the lid on the spawning of human evolution? Is it that we have to clean up our room first? Transmute that plutonium back to harmless dirt or we don't get any dessert. Childhood Ends like Arthur C. Clarke predicted. ☺

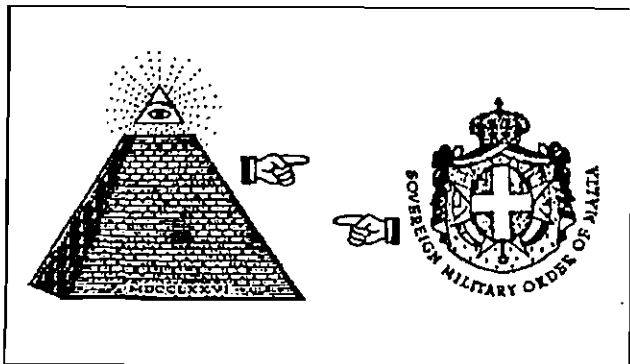

**I**s British Intelligence behind Whitewatergate? The following is excerpted from the 3/23/94 testimony of Webster G. Tarpley, President of The Schiller Institute (a political and economic think-tank) and an associate of economist and commentator Lyndon LaRouche, to the congressional Subcommittee on Treasury, Postal Service, and General Government of the Committee on Appropriations. It presents a unique perspective on Whitewater and related scandals, painting Bill Clinton not as a villain but as a victim.

# THE BRITS BASH BUBBA



I would first of all like to thank the members of the subcommittee for this opportunity to testify. I would like to address a very serious threat to the national security of the United States in the form of a concerted international campaign to overthrow our current President and permanently weaken the institution of the presidency in a way which would clearly undermine the integrity of our federal Constitution. The relevance of this issue to the subcommittee's purview of appropriations oversight involves the Secret Service of the Department of the Treasury, and specifically the Secret Service's mandated task of protecting the President and the institution he embodies. I wish to call these matters to the subcommittee's attention because they represent challenges for the Secret Service which may necessitate additional funding if they are to be dealt with efficiently and effectively. My starting point is that the ensemble of events which may be grouped under the heading of Whitewatergate is not solely or even primarily a phenomenon of United States politics and public

opinion. It rather constitutes the attempt by a foreign power to destabilize and overthrow the constitutional government of our country. The foreign nation which has been the prime mover in this entire affair and which has taken the lead in escalating the scandal at every critical turn has been the United Kingdom. What we know today as Whitewatergate could never have happened without a series of violent press campaigns attacking the American presidency that have been carried in the leading newspapers of London, above all the **Daily Telegraph** and **Sunday Telegraph**. The **Washington Post** and the **New York Times** have in the main followed the lead of the British newspapers and so-called investigative reporters in their attacks on Clinton. To put the question in a slightly different way: everyone remembers the role of the **Washington Post** as the flagship of damaging revelations during the original Watergate affair. To carry our analogy one step further, we can say that the "Woodward and Bernstein" of the

current brouhaha is one Ambrose Evans-Pritchard, an investigative reporter for the London **Telegraph** newspapers and a person who makes no secret of his close relations with the British Secret Intelligence Service, also known as MI-6. Whether Evans-Pritchard is in fact himself an agent of MI-6 is one which the American Secret Service and our other intelligence agencies should urgently answer.

I submit that it is only because of the propaganda drumbeat coming from London that the Whitewatergate scandal has come as far as it has, all on the basis of not one single colorable allegation of any crime having been committed. The pattern observable during the unfolding of the Whitewater scandal was summed up by an article published in another British publication, the **Economist**, during the first week of March. The **Economist** is of course the house organ of the powerful Rothschild banking interests. Under the headline "Shhhh: the Press and Whitewater," the **Economist** compared the crisis of the Clinton presidency to the 1936-37 crisis in the British royal family which preceded the abdication of King Edward VIII in connection with his romance with the American divorcee Mrs. Wallis Simpson. In 1936, argued the **Economist**, there existed an accord among the Fleet Street barons of the British press which prevented publication in Britain of the main facts about the King's activities and their implications for the monarchy. In those days it was therefore mainly the American newspapers whose reports fed the scandal that ultimately led to Edward's abdication. Today, the magazine continued, the roles are curiously reversed, with the American newspapers seeming "peculiarly inhibited" in their "lackluster coverage" of Whitewatergate, while the London press and especially the **Telegraph** are taking the lead in publishing damaging revelations. The **Economist** refers specifically to allegations made against President Clinton by a former Miss Arkansas named Sally Perdue, whose story was generally not given credence by the American media, but who enjoyed an avalanche of sensational publicity in London. The implication of all this is clear:

Clinton, like Edward, will be brought down, in this case thanks to a campaign of vilification spearheaded by the London press. Similarly, R. Emmett Tyrell, Jr., who is part of the London operation against Clinton, wrote in the London **Sunday Telegraph** of January 23 that the story of this former Arkansas beauty queen had "become front-page news all over the United Kingdom and in Australia" at a time when nobody in the United States except for Rush Limbaugh and the **Washington Times** would touch it. Tyrell added that "British papers have been reporting other acts of violence relating to scandals associated with Clinton's name."

The **Sunday Telegraph** makes no secret of its commitment to overthrow the Clinton presidency. On February 6, Ambrose Evans-Pritchard concluded a trilogy of "get Clinton" articles with the following comment: "The ordeal will not last forever. Indeed, the way documents keep popping up in Arkansas, Bill Clinton may be forced from office before the year is out."

Who controls the London **Daily Telegraph** and **Sunday Telegraph**? These papers are owned by the Hollinger Corporation, an international media conglomerate headquartered in Toronto, Ontario, Canada. The Hollinger Corporation is the descendant of the Argus Corporation, which was created by the British Special Operations Executive (SOE) during World War II. The owner of the Hollinger Corporation is Conrad Black, who was a protégé of E.P. Taylor, the head of the Economic Warfare branch of the SOE during the war. Hollinger owns the London **Telegraph** papers, the **Jerusalem Post**, the Canadian **Financial Post** and the **Caymanian Compass**. Hollinger owns about 80 newspapers in the United States, and has just acquired the **Chicago Sun-Times**.

The Hollinger board of directors includes Conrad Black, Peter Bronfman (chairman of Edper, the troubled real estate conglomerate), R. Donald Fullerton (CEO of Canadian Imperial Bank of Commerce), and Paul Reichmann (a principal of another bankrupt real estate empire, Olympia and York). Allan E. Gottlieb, the current Canadian

Ambassador here in Washington, is also a director.

Hollinger also maintains a body it calls its "International Advisory Board." Here we find Lady Thatcher, Lord Peter Carrington, Lord Jacob Rothschild, and Sir James Goldsmith. American members of this body include Dwayne Andreas of Archer-Daniels-Midland, former Secretary of State Henry A. Kissinger, former NSC Director Zbigniew Brzezinski, "National Review" editor William F. Buckley, former Defense Department official Richard Perle, former Federal Reserve chairman Paul A. Volcker, and columnist George Will.

The **Daily Telegraph** is a wholly owned subsidiary of Hollinger. There is also a board of directors of the **Daily Telegraph** as such. Here we find Rupert Hambro, the managing director of Hambro Bank, a City of London merchant bank with very close historic connections to the British intelligence community. During World War II, Hambro provided many of the leading figures for the Special Operations Executive. Another director of the **Daily Telegraph** is Henry Keswick, the chairman of Jardine-Mathieson, historically a British Empire trading company based in Hong Kong which has been implicated in international narcotics trafficking since the time of the first Opium War in the 1840's.

The most important writer for the **Daily Telegraph** is Sir Peregrine Worsthorne, a virulent racist and anti-American ideologue. Sir Peregrine is the stepson of Sir Montagu Norman, who was the director of the Bank of England during the 1930's, and who supported Hitler's seizure of power in Germany.

Ambrose Evans-Pritchard, the would-be Watergator, has admitted in conversation with investigative journalists that he has been exchanging information with the British Secret Intelligence Service and specifically with MI-6 over a period of years. Pritchard was posted to Managua, Nicara-

gua for a three-year period during the 1980's. During this time Pritchard says he was friendly with the Nicaraguan contras as well as to guerrilla movements operating in El Salvador and Guatemala. Pritchard reported to the political attaché of the British Embassy, whom Pritchard knew to be an agent of MI-6. Pritchard describes these practices as "swapping information."

Pritchard claims to believe that the late Vincent Foster was murdered by a hit team dispatched by the Clinton White House. The hit team, in his view, then made a maladroit effort to make the death look like a suicide. According to Pritchard, anyone who has any knowledge of the various nefarious activities carried out by Bill and Hillary Clinton is in danger of being eliminated by a sinister "Murder, Incorporated" based in the White House.

Pritchard's most recent article [1994], published in the **Sunday Telegraph** of March 13 and entitled "Little Rock's Mean Machine," is devoted to Pritchard's ostensible muck-raking in Conway, Arkansas. He alleges that he has discovered a "Deep throat" named Larry Nichols, a former functionary of

the Arkansas state government. Nichols is well-known, having begun a campaign of denigration against Clinton in 1991 with television and press interviews. Pritchard attempts to present Nichols as a goldmine of new scandals against Clinton that will be more powerful than Whitewater. In the same issue, Pritchard writes that "Washington has been slow to grasp the gravity of it all," but that now the American capital is "paralyzed, and likely to remain so" until Congressional hearings are held. According to Evans Pritchard, these hearings "will puncture the moral pretensions of this White House ... at worst, they will lead to criminal indictments and bring down the whole administration."

Here in the United States, one of the most aggressive press organs attempting to whip up hysteria around Whitewater has been the **American Spectator**, a periodical of the so-called neo-conservative circles. It was the **Spectator** whose scurrilous and unsubstantiated "troopergate" accusations, published shortly before Christmas, opened the current intensive phase of the Whitewater affair. The "troopergate" story was written by David Brock, and was arranged with the help of Cliff Jackson, the Arkansas lawyer who has devoted himself in recent years to dishing up scandals against

Clinton. A January 8 column in the American newspaper **Irish People** raised the relevant question when it asked whether Jackson is "part of a British cabal." But no questions were asked about "troopergate" when it first appeared by such news organs as CNN and ABC, which gave extensive coverage to the wholly unproven charges of the disgruntled troopers.

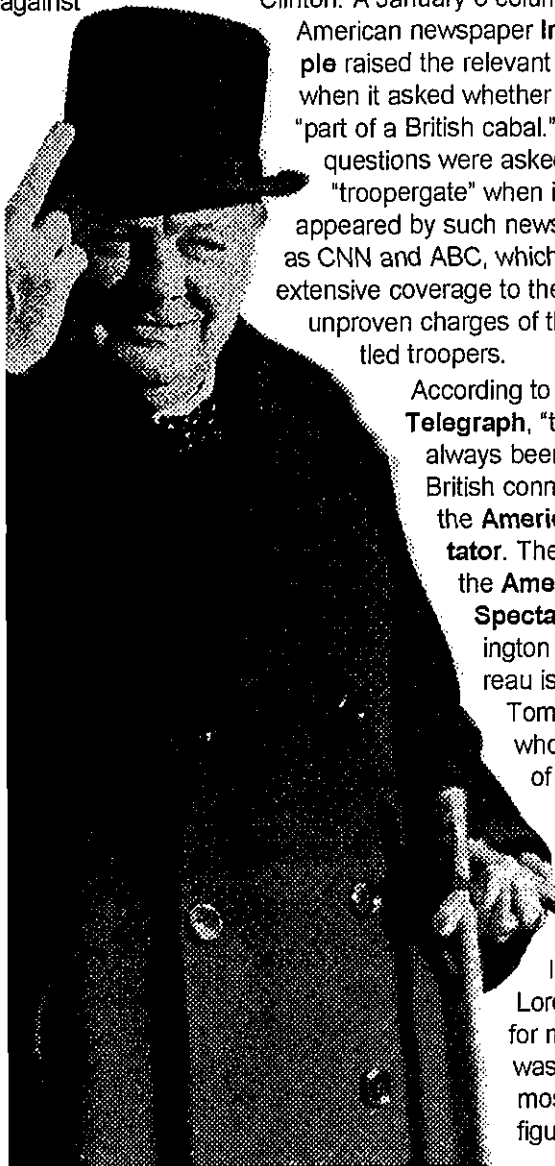
According to the **Daily Telegraph**, "there has always been a strong British connection" to the **American Spectator**. The head of the **American Spectator** Washington DC bureau is British: Tom Bethell, who is the son of Lord Nicholas Bethell of British intelligence. Lord Bethell for many years was one of the most important figures of

British intelligence operations in the Balkans region. It has been alleged that Lord Bethell cooperated with the efforts of British triple agent H.A.R. "Kim" Philby in sabotaging American operations in Albania during the early Cold War.

Sir Peregrine Worsthorne, whom we have already met as the leading writer for the London **Telegraph** newspapers, is an active member of the editorial board of the **American Spectator**, as is British journalist Paul Johnson. On February 13, the Sunday Telegraph printed an article praising Tyrrell and the **American Spectator** for spearheading the Whitewater campaign against Clinton in a way that has "aroused admiration around the world." In the same issue of the **Sunday Telegraph**, Sir Peregrine Worsthorne praised Tyrrell as the man who is "masterminding the campaign which is beginning to look like it might do for Clinton what the **Washington Post** did for Nixon."

The **American Spectator** editorial board lists, in addition to Sir Peregrine, such leading neo-conservatives as Jeane Kirkpatrick, Michael Ledeen, and Midge Decter; writers include scions of well-known neo-conservatives like Daniel Wattenberg and John Podhoretz. These figures are at the center of an American "neo-con" network which includes the **Washington Times** [owned by the Rev. Moon organization —ed.], William Safire, and other exponents of what Admiral Bobby Inman has accurately denounced as neo-McCarthyism. The neo-cons, it would appear, are the most energetic fellow travelers of London on this issue.

**W**hy are the British oligarchy and its intelligence agencies attempting to overthrow the President of the United States? The answer involves London's perception that the Clinton administration may be inclined to alter certain policies which London is hysterically and fanatically committed to maintain. These policies are generally those institutionalized during the Thatcher-Bush era, when the United States government was slavishly obedient to the demands of what Bush referred to as "the mother country" during the 1991 visit by Queen Elizabeth II. London currently demands that the Thatcher-Bush policies remain in force with no changes by Clinton, as if the American government were functioning on automatic pilot. The most important focus of disagreement has been the question of International Monetary Fund conditionality as applied to Russia and the other successor states of the former U.S.S.R. Here London demands continued adherence to "shock therapy" looting arrangements. But first in March 1993 and then more clearly in December 1993, the Clinton administration has manifested great disenchantment with the dangerous strategic consequences of continued shock therapy. After the December 12 Russian elections and the emergence of Zhirinovskiy, Vice President Gore attacked the IMF's handling of the Russian economic crisis. Strobe Talbott of the State Department, Clinton's personal friend, called for "less shock and more therapy" for Russia. This caused IMF director Camdessus to complain that the IMF was being made a "scapegoat" for Russian economic collapse, and occasioned scathing attacks on Clinton in the



British press. The essence of the British position is that the looting of Russia under IMF shock therapy must be continued at all costs, since the proceeds are necessary to support the international derivative securities bubble, to which the major London banks are irrevocably committed. The British are also interested in the advantages they could derive from a new era of Russian-American military confrontation, since London believes that a new cold war would enhance the importance of the US-UK "special relationship" in the same way that the original cold war did. The British are also angered by Clinton Administration support for the Israeli-PLO efforts towards a permanent peace settlement in the Middle East. The British

Foreign Office and intelligence agencies believe that Britain's position as arbiter of Middle East developments depends on a policy of divide and conquer which presupposes a continuation and exacerbation of the Arab-Israeli conflict. Since Prime Minister Rabin and Chairman Arafat appeared with President Clinton at

the White House last September, the British have mobilized all their efforts to procure the failure of the Israeli-PLO negotiation. Indeed, many of the same international "neo-conservative" networks that are implicated in the destabilization of the Clinton Administration also show up as those implicated in the recent Hebron massacre. Most fundamentally, we must recall that the dominant groupings of the British elite have long been convinced that British power and influence around the world—which they are fanatically determined to maintain and even expand—cannot survive without being able to draw upon and parasitize the power and resources of the United States. Only through the ability to mobilize American muscle could the decrepit economy and minuscule military forces of the United Kingdom hope to play a role upon the current world stage, as such recent events as the Falklands war and the Gulf war demonstrate. In the mind of London, the "special relationship" implies a passive subordination of American foreign and economic policies to British geopolitics and British monetarism. It was widely assumed that President Clinton, because of his background as a Rhodes Scholar at Oxford, was something of an Anglophile, but there are many signs that the disappointed British have concluded that the Clinton administration is less subservient to London than any in recent memory. Since London regards its ability to get its way in Washington as a matter of preeminent and overriding national interest, the response has been the blatant British orchestration of the White-water scandal. In conclusion, we have a very strong prima facie case that a power, certainly foreign and evidently hostile, has initiated an international conspiracy to overthrow the constitutional government of the United States with a sort of coup d'etat. These proceedings may involve violations of the internal security laws of the United States currently on the books. Certainly such an attempted destabilization of our government is a matter to which American intelligence agencies, and most especially the Secret Service, must pay the very closest attention. We therefore urge the subcommittee to provide whatever supplemental appropriations might be needed to defray the costs of the necessary investigative effort. Thank you very much.

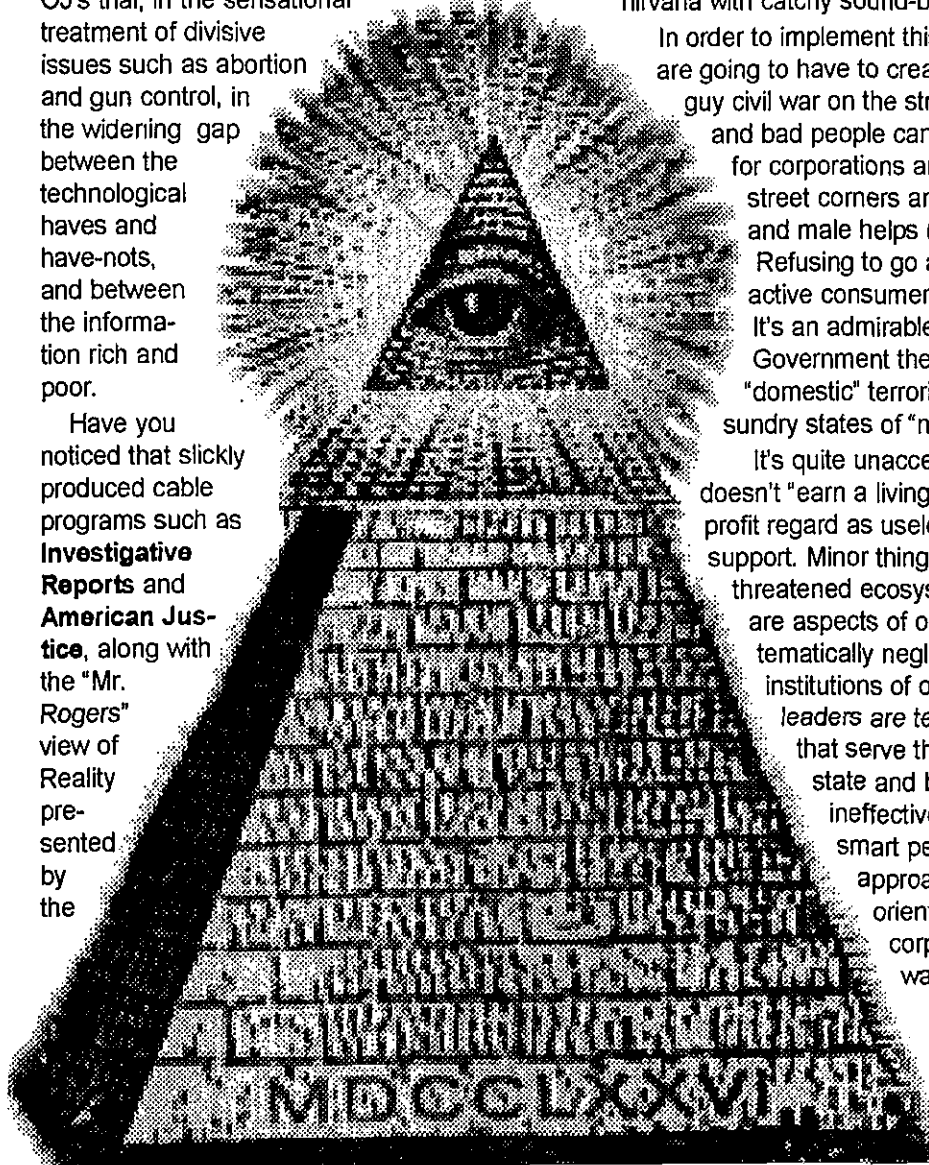
## THEY

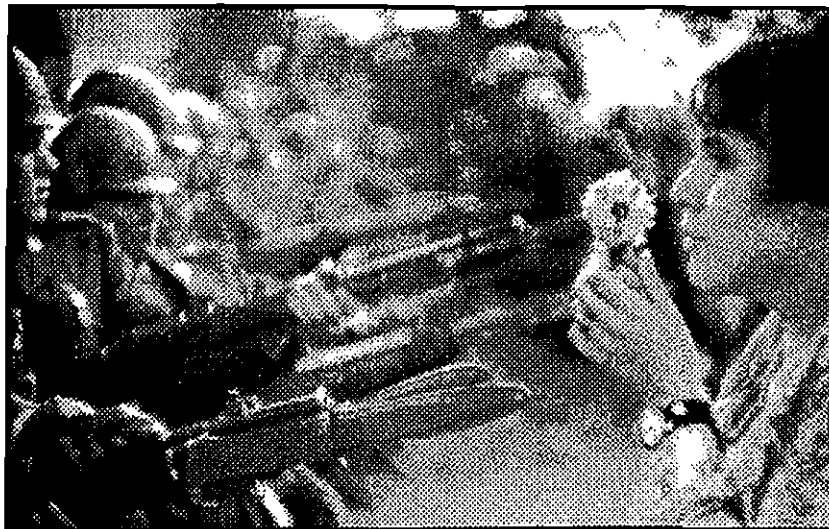

those where young "Chino" slew one of their number.

Mr. Juan Gonzalez of Caguas had another fleeting encounter with a similar being at the same location while at the wheel of his car. It was late at night when he noticed a "Volkswagen" with brilliant lights at the roadside, and what seemed to be a child standing beside the vehicle. When he came up to the presumed car, he realized that it was really a small oval object with an open section that emitted a yellowish light. The "child" was a large-headed little man in a one-piece white outfit. González continued to drive without stopping.


For almost two years, the mountainous area near the Tetas de Cayey where the caves in which the creatures allegedly live has been controlled by military personnel. The only explanation given was that the area was going to be "used as a practice range." Local residents claimed seeing military personnel entering the caves located at the base of the Tetas de Cayey.

Coincidence? We can only ask ourselves if the authorities are aware of these creatures and have taken action in the matter. This angle is still under investigation.

# Dear Diary,



**A**pril [1962] - At the turn of the century in America. In the emerging industrial revolution, private enterprise triumphed because it offered a new, efficient and promising future while still observing the idealistically democratic ideals of its overthrown predecessor, rural small enterprise. and at about the same time in tsarist Russia the aristocracy was overthrown by the peasants and workers and the road laid open for the gaining of power by the bolshives because they too, offered a bright new future without violating historical traditions of russian working class life. Therefore in history there are many such examples of the nucleus of the new order rooted in the idealistic tradition of the old. The industrial revolution honored the present atomic age and yet it has developed as a intricate part of its system its own shortcomings, automation for instant.

Automation may be compared to the run away robot who displays so many fallacies that it is obvious it is run away. rather it is the much more subtle aspects of Industrialization and mechanization which brings the greatest hardships upon the people a general decay of classes into shapeless societies without real cultural foundations, regementation, not so much of people since industrialization actively provides for more free movement of classes around each other, but rather of ideals although those regemented ideals have more freedom of expression throughout all the classes.

The biggest and deciding key fault development of our era is of course the fight for marketst between the imperialist powers themselves, which lead to the wars, crises and oppressive friction which you have all come to regard as part of your lives. and it is this prominent factor of the capitalist system which will undoutly eventually lead to the common destruction of all the imperialistic powers already many lesser imperialistic countries have become dependent upon other factors than domination of colonies through force, they have been devastated of their former colonies by the great imperialist countries or in some cases even given up their colonies themselves as unprofitable and many cases the oppressed peoples rose up and physically through the colonist out and this process in continuing even today as we all can see. but what is important to remember is that the old system of capitalism even within itself is revising and what is most evident, forming imperialist economic collations, such as the common market.

In the communist experamint several factions and unavoidable developments have emerge which Marx and Engles could not possibly have foreseen their emerges with increasing clarity two monumentle mistakes which Marx and Engles made, not to mention the very key stone of Marx's economic theory "the doctrine

of surplus value which has always been unshakey and controversial. The first mistake is fairly well known even at this stage in the communist development the "withering away of the state" as it was calated. Marx envisualized that the abolition of classes would lead to the gradual reduction of state apparatus. however this is not the case and is better observed than contemplated. the state rather becomes more extensive in that while the powers of central ministrys are delagated they are not reduced in the dividing of an organ of state power in smaller units at lower levels so although some of the ministers have actually disappeared to Moscow they have become more entrenched than ever at lower levels, thus in dividing power you multiply units, and in everyday life you become more and more depent on these organs of state power. Wherever you turn you meet them and they touch the lives of the people more and more, and a new beauracracy, rather than a withering away of the state. In Russia in the last two years their has been a shift of power from the capital of Moscow to the so-called Republics, but state apparist, simply grows into a greater maze throughout these republics, thus in minsk the capital of belorussia, the ministry of Interia became responsible in 1960 for determining the eligibility of aplicants for hard to get exit visas to leave the USSR formaly the official progative of Moscow alone, but now that this state ministry in Moscow has "withered away" it becomes all the more difficile to get an exit visa since now once has to go to the area, city and republican state capital commites of beaurocrats and on top of all that a last finale OK has to come from incredibly the Moscow ministry of foregn affairs! the withering away of the state as Marx envisualized was a unforeseeable mistake pointed out by many critizes of Marx.

The second mistake Engles and Marx made was much more obscure but fundelmentally just as important. In the late 1800s Engles wrote Vanti Duhring which rightly critized Eugen Duhrings, a German idealist who was supposedly not consistent enough in his materialism for the dialectical materilist Marx. In his critical anlyis of Duhring, Engles said with much heavy sarcism that Duhring only changed a word in his putting forward of his social revolutionary ideas that a changed word "was the word community from the word state" whereas Duhring wanted Social Democracy at a local or community level, Marx and Engles advocated a centralized state which would later "wither away"! But in this Engles was mistaken again.

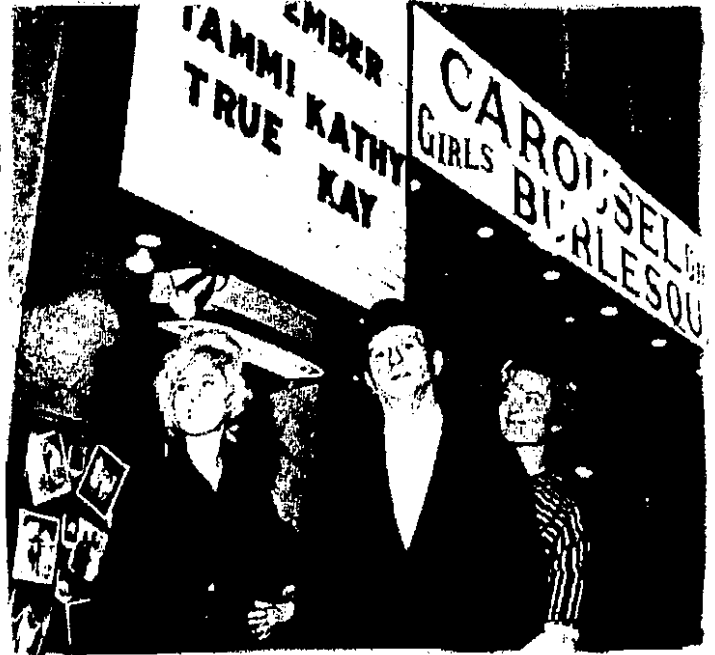
