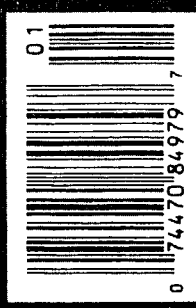

# Death and the Maiden

## Anorexia, Occultism, and the Spectacle of Control

It is difficult to determine just exactly how many women suffer from anorexia or bulimia. One figure on adolescent anorexia in Britain was that 1 in 150 girls are afflicted, but that figure was reported to be extremely conservative. A 1982 (Garfinkel and Garner) study stated that 20 percent of college female students in the U.S. were bulimic, while another study (Halmi, Falk, and Schwartz 1980) stated that 79 percent of them had experienced bulimic episodes. As for dieting, 80 percent of American women have dieted by age 18 (Sternhell 1985) and 60 percent by age 13 (Friedman and Miranda 1984.) One should take into account that these figures are over a decade old, and that by most accounts the situation has gotten worse since.

Medical problems which can result from anorexia are slow heart rate, hypothyroidism, insomnia, dehydration, emaciation, low blood pressure, bloating, constipation, swelling of hands and feet, dry, scaly skin, appearance of fine body and facial hair, loss of head hair, feeling of being cold, and anemia. (As well, babies born to women of low body weight have an increased chance of being underweight for age at birth.) Medical problems which can result from bulimia include fatigue, lethargy, abdominal discomfort,

constipation, menstrual irregularity, calluses on fingers, erosion of teeth, esophagus damage, and assorted heart problems. Clearly, this is not an isolated or minor phenomenon relegated to the ranks of feminist literature and TV movies; it is an epidemic. But why are the numbers so high, and why do we so rarely hear about it?

### A Binge-and-Purge Economy

The role of eating disorders in consumerist society needs to be examined. The fashion industry is a billion-dollar empire which tries to permeate our culture at every level. Models become actresses and household names. Designers put out clothes in order to invoke an image in the buyer. Status is inherent in apparel. When you buy Ralph Lauren Polo, you're making a statement about yourself. Teenagers kill each other for trendy jackets and shoes. Trends in music and attitude often originate on the runway, crossing back and forth with the mainstream, changing and evolving as they go. In short, high fashion often becomes culture.

Another enterprise measured in terms of billions is the diet industry. From info-mercials to best-selling books, we are given a myriad of ways to slim, trim, and shrink ourselves. We buy pills, shakes and intricately scheduled meal plans. We all want to look like the model, the movie queen, the hundred-pound starlet. And we fail to realize how they actually do it.

At the same time, many of the same companies who sell us diets also sell us chocolate bars, red meat, potato chips, and beer. They tell us to consume, consume, consume, and then they make us feel guilty about our poor health and the natural consequences of eating such things. We are rats on a literal treadmill, controlled by our whims, appetites, and fears—most of which we get from TV. They tell us one thing, and then turn around and tell us the exact opposite.

One could almost say that we have a binge-and-

purge economy, an economy which consumes far beyond reason and then spits out mountains of waste. You see this in our food, our medicine, our machines, our industries, and even our information and entertainment. The environmental consequences of this are obvious, and the detrimental, alienating effect it has on each and every one of us should also be evident. Never mind lasting forever, nothing seems to last even fifteen minutes! What kind of people populate such a world?

### The Cult of Beauty

The image of the anorexic model is sold to young girls. Models are portrayed as the epitome of glamour, possessing power and independence. They are rich, and every man wants them—thus giving them sexual power. They earn the

envy of other women, who long to look like them and obtain their power and place in society. The truth is models lead mediocre lives. The majority of them have drug habits—serious, in some cases. They naturally suffer from eating disorders and the resultant health problems. Their lives are clocked and controlled by agents, designers, and sponsors, with every move and minute being arranged and bought. One could even say they are hardly people. Objects might be a better word. They are the false goddesses in the cult of beauty.

Many women are basically obsessed with their body image, how they look, how much they weigh, etc. People who are obsessed with such superficial concerns have little time to contemplate their place in the world and the influence which

society has upon them. This obsession is far from personal. In the past, both anorexia and bulimia were often found to be caused by more personal issues. Anorexia was often due to familial issues, a power struggle between a girl and her mother, while bulimia was more social, it was more accepted amongst girls, and it had more to do with maintain-

ing rather than losing weight. Both seemed rooted in low self-esteem.

Now, however, both seem to have a greater degree of societal causes. Girls starve and binge-and-purge in order to fit in, be accepted, and match up

to the role models fed to them by the media. Diseases such as anorexia and bulimia have become casual weight-loss aides. And with the changing face of eating disorders has come an alarming increase in the number of cases. Even if someone were to claim that these disorders are predominantly due to familial issues, what has more influence upon the family than society at large?

## Inducing the Double Mind

Those familiar with the works of Michael A. Hoffman II and James Shelby Downard

are undoubtedly familiar with the idea of an occult cabal controlling and even creating this society, using symbolism, occultism, and a perverse mix of sex and death to command and captivate their mass of slaves. Their ultimate goal is nothing more than the devaluation and usurpation of God. Man thus replaces Him with a world of his own hand, brought to life through a process otherwise known as Armageddon.

The three things which must come to pass before this act of alchemy can be accomplished are as follows: the bringing of Prima Materia to Prima Terra (the moon landing and the return of moon rocks to the earth), the Killing of the Divine King (JFK), and the creation and destruction of primordial matter (the first atomic blast). This may sound a bit far-fetched, but the thing to consider is not the validity of such beliefs, but whether these beliefs may actually be held by those at the top, who may be implementing a secret plan based on these ideas.

The most important facet of the occult belief system is the juxtaposition of sex and death. The manifestation of the above act of alchemy occurs in the widespread cultural/medical phenomenon of our day, the anorexic/bulimic starlet. Having examined the role and place of eating disorders in our culture, let's take a look at how they might connect to the idea of occult mass mind control.

In *Secret Societies and Psychological Warfare*, Hoffman describes a technique of mass control called "inducing the double mind," whereby two seemingly contradictory ideas are fused together in order to confuse and disturb. He writes that while the Establishment allows us to enjoy and indulge ourselves in our most base pleasures, it then turns around and condemns those pleasures with the other hand. It is an open display of hypocrisy which entraps and enchants, pitting our minds and bodies against each other.

A clear example of inducing the double mind is found in the treadmill of diet and consumption. We are allowed our junk food and treats, but then we're told that they'll kill us (which is not entirely untrue) and that we're awful, slothful people for indulging in them. We're fed statistics and horror stories about obesity, and then shown food commercial after food commercial on TV. We become uncontrollable binge-and-purge artists, suffering from a form of mass insanity. And in the process they make billions and only further their domination over us, the willing participants.

Hoffman also cites the use of subliminal images in advertising and media, and the work of Dr. Wilson Bryan Key. Key's books describe how subliminally embedded images use sex, and even violence and death, to sell, sell, sell. While it might start with such things as hidden penises and the embedding of the words "sex" and "fuck," we soon see images of homosexuality and transgenderism, scatological references, and eventually the dark combination of sex and death. In one advertisement, for example, the word "cancer" is found embedded in a cigarette ad. In another, skulls are found in ice cubes. And, in a climax of sex and

death, Key shows the word "sex" embedded on nightly news clips of fleeing refugees—mostly women and children—and bombed corpses.

Over the past few decades, sex has been used more and more blatantly to sell anything and everything. Images of violence have become more and more prevalent, and the two are frequently seen together. No longer is it seventeen and eighteen-year-olds having sex (for instance, in the sexploitation movies of the seventies and eighties). Now we're seeing fourteen and fifteen-year-olds, maybe younger. In addition, pointlessly graphic rape scenes are found in movies like *An Eye For An Eye*, *A Time To Kill*, and *Showgirls*.

### The Alchemical Hermaphrodite

A criteria for severe anorexia would be amenorrhea, whereby the menstrual cycle ceases and it is not possible for the woman to menstruate or ovulate, thereby making her incapable of having children. Anorexic women are also more prone to miscarriages. Therefore, one could say that the anorexic condition is a disruption of the natural, or Godly, reproductive cycle. In a world of women incapable of giving birth, how will procreation come about? Is this yet another example of the usurpation of God/nature, leaving technology in charge of reproduction?

What would you call a person who didn't menstruate or have children, who didn't have curves or surplus fat on their hips and thighs, and who has an increased amount of downy fuzz (similar to that of an unborn baby) all over their body? Many of the actresses and models whom we see parading on the screen are beginning to look less and less like women, and more like eleven-year-old boys. Shouldn't we ask ourselves what exactly it means when our images of beauty and sexuality are homoerotic and androgynous? Is the professed homosexuality of the Men's Club now being pushed onto society at large, a projection of the secret, ritual power of sodomy? Does the changing of sexual mores have more to do with programming rather than natural social forces? Could something akin to the Alchemical Hermaphrodite be far off?

Many in the psychiatric field have suggested that anorexia is often an attempt to revert to childhood, to curtail womanhood. An anorexic girl does not develop properly sexually, and can become temporarily infertile. Due to her small stature, she has been made weak and easy to dominate. What exactly are we engaging in when we sexualize this image?

Digging even deeper, we find the issue of pedophilia. We are now seeing ritual abuse being practiced on a mass scale. No longer is it just in the realm of cults and the elite, but it has now spread to the media. Recall the infamous Calvin Klein commercials which idolized

thirteen-year-old girls with thousand-dollar portfolios. All of this occurs as the issue of child sexual abuse become more and more prevalent in the collective mind. Is this another revelation, the making manifest of what is hidden?

### Sex and Death

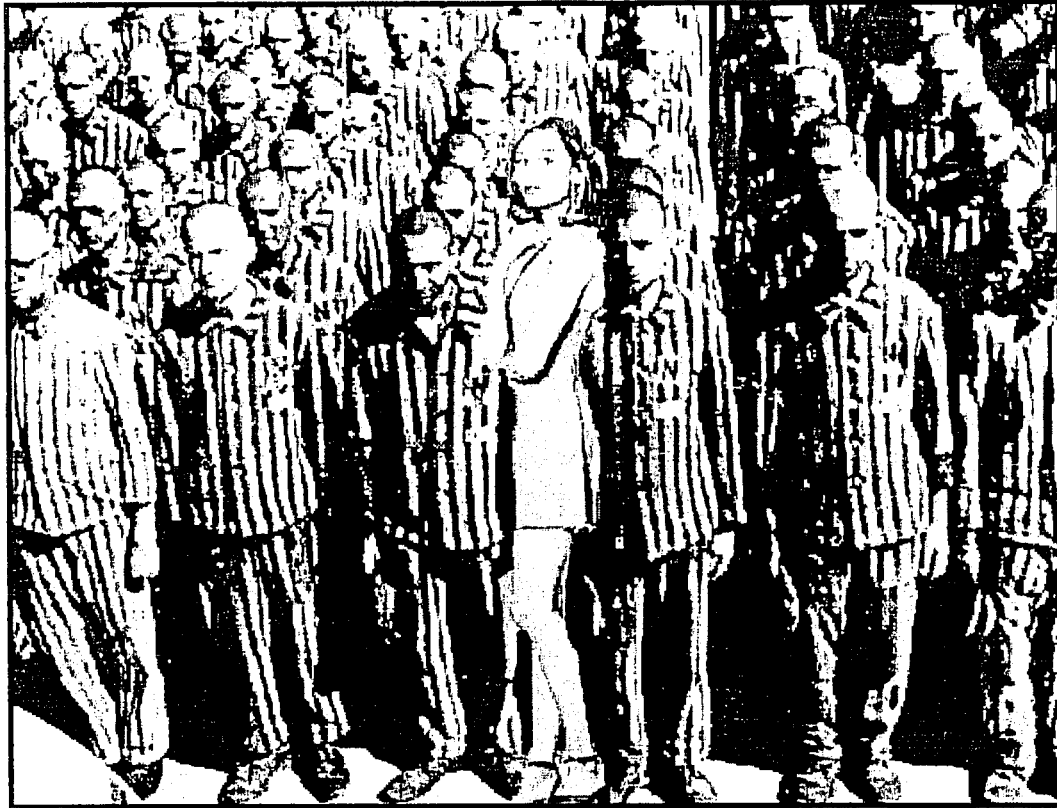
Anorexia and bulimia have an undeniable ritualistic nature, with the day-to-day monitoring of eating, exercising, and bathroom habits. Also consider what women do to make their bodies and selves match the image of the anorexic starlet: cosmetic surgery, breast implants, and liposuction. Can you think of anything more occult than taking apart one's face and remaking it? What about cutting the breast along the bottom, pulling it up, and then inserting the silicon sac underneath? Does this act have similarities to a rite of revenge or sacrifice?

You might even say, given the high occurrence of immunodeficiency disorders amongst implanted women, and the handful of fatalities that once resulted from liposuction, that these women are making a deal with the devil, whereby they risk infection, disease and even death, all in the name of looking good.

The ultimate culmination of the mix of sex and death is the anorexic starlet. Take a look at a picture of Kate Moss or Stella Tennant. Do you see the ribs, the spindly arms and legs with the prominent joints, the pelvis protruding from underneath the skin, the gaunt, almost skull-like face? Do they not look like skeletons? And then take a look at pictures from Dachau and Auschwitz. See any resemblance? (A joke from *Saturday Night Live* once put it best. It showed a picture of Kate Moss and then said, "*Schindler's List* opened today.")

A recent *60 Minutes* story ("Why is Hollywood starving itself?") stated that leading starlets like Helen Hunt, Jennifer Love-Hewitt, and Gwyneth Paltrow all suffer from eating disorders. More recently, we have seen the alarmingly thin Calista Flockhart ("Ally McBeal"), who nevertheless insisted to *People* magazine that "I am not anorexic." Basically, the overwhelming majority of glamorous, "sexy" women that parade before us could all be called anorexic starlets.

No longer is the spectacle of sex and death hidden and embedded, it is out there for everyone to see. The anorexic starlet is the perfect example of this. No one asks why the image of sex and death is so prevalent; hardly anyone questions it, and no one sees its implications. Hoffman writes that when something is so obvi-

ous and yet no one sees it, this is the ultimate form of mind/occult control. Deception is hardly needed and all is revealed. Revelation of the method, perhaps?

What does it mean when women who look like something out of a concentration camp are revered and sexualized? Are we not being trained to be aroused by such images? Why are so many of us turned on by pictures of people who are clearly suffering and hurting; people who more resemble skeletons and famine victims? Are we becoming sadistic and fetishistic, too? Are we not beating off to death itself? Is this the ultimate proof of the use of the anorexic starlet in the mass mind control of our society?•

# Espionage, Academia, & Secret Societies

**E**ver since the founding of the Republic, there has been a unique relationship between Yale University and the Intelligence Community. Nathan Hale, along with three other Yale graduates, was a member of the "Culper Ring," one of America's first intelligence operations. Established by George Washington, it was successful throughout the Revolutionary War. Nathan was the only operative to be ferreted out by the British and, after speaking his famous regrets, was hanged in 1776.

Today, a statue of Nathan Hale stands on Old Campus at Yale University. There is a copy of that statue in front of the CIA headquarters in Langley, Virginia. Yet another stands in front of Phillips Academy in Andover, Massachusetts, where George H.W. Bush (Yale '48) went to prep school and joined a secret society at age twelve.

## Opium Money

In 1823, Samuel Russell established Russell and Company for the purpose of acquiring opium in Turkey and smuggling it to China. Russell and Company bought out the Perkins (Boston) syndicate in 1830 and moved the primary center of American opium smuggling to Connecticut. Many of the great American and European fortunes were built on the "China" (opium) trade.

William Huntington Russell (Yale, 1833), Samuel's cousin, studied in Germany from 1831-32. Germany was then a hotbed of new ideas. The "scientific method" was being applied to all forms of human endeavor. Prussia, which blamed the defeat of its forces by Napoleon in 1806 on soldiers only thinking about themselves in the stress of battle, took the

principles set forth by John Locke and Jean Rosseau and created a new educational system. Johan Fitch, in his Address to the German People, declared that the children would be taken over by the State and told what to think and how to think it.

Georg Wilhelm Friedrich Hegel took over Fitch's chair at the University of Berlin in 1817, and was a professor there until his death in 1831. Hegel was the culmination of the German idealistic philosophy school of Immanuel Kant. To Hegel, our world is a world of reason. The state is Absolute Reason and the citizen can only become free by worship and obedience to the state. Hegel called the state the "march of God in the world" and the "final end." This final end, Hegel said, "has supreme right against the individual, whose supreme duty is to be a member of the state." Both fascism and communism have their philo-

sophical roots in Hegelianism. Hegelian philosophy was very much in vogue during William Russell's time in Germany.

### The Tomb

When Russell returned to Yale in 1832, he formed a senior society with Alphonso Taft (Yale '33). According to information acquired from a break into the "tomb" (the Skull and Bones meeting hall) in 1876, "Bones is a chapter of a corps in a German University ... General Russell, its founder, was in Germany before his Senior Year and formed a warm friendship with a leading member of a German society. He brought back with him to college, the authority to found a chapter here." So Yale valedictorian William H. Russell, along with fourteen others, became the founding members of "The Order of Scull and Bones," later changed to "The Order of Skull and Bones."

The secretive Order of Skull and Bones exists only at Yale. Fifteen juniors are "tapped" each year by the seniors to be initiated into next year's group. Each initiate is given \$15,000 and a grandfather clock. Far from being a campus fun-house, the group is geared toward the success of its members in the post-collegiate world.

The family names on the Skull and Bones roster roll off the tongue like the guests at an elite party: Lord, Whitney, Taft, Jay, Bundy, Harriman, Weyerhaeuser, Pinchot, Rockefeller, Goodyear, Sloane, Stimson, Phelps, Perkins, Pillsbury, Kellogg, Vanderbilt, Bush, Lovett and so on.

William Russell went on to become a general and a state legislator in Connecticut. Alphonso Taft was appointed U.S. Attorney General, Secretary of War (a post many "Bonesmen" have held), Ambassador to Austria, and Ambassador to Russia (another post held by many Bonesmen). His son, William Howard Taft ('87), is the only man to be both a President of the United States and Chief Justice of the Supreme Court.

The Order flourished from the very beginning, in spite of occasional squalls of controversy. There was dissension from some professors, who didn't like its secrecy and exclusiveness. And there was a backlash from students, expressing concern about the influence the Order was having over Yale finances and the favoritism that was shown to "Bonesmen."

In October of 1873, Volume 1, Number 1,

of *The Iconoclast* was published in New Haven. It was only published once and was one of the few openly-published works to be critical of the Order of Skull and Bones. From *The Iconoclast*:

We speak through a new publication, because the college press is closed to those who dare to openly mention 'Bones'... They have obtained control of Yale. Its business is performed by them. Money paid to the college must pass into their hands, and be subject to their will...

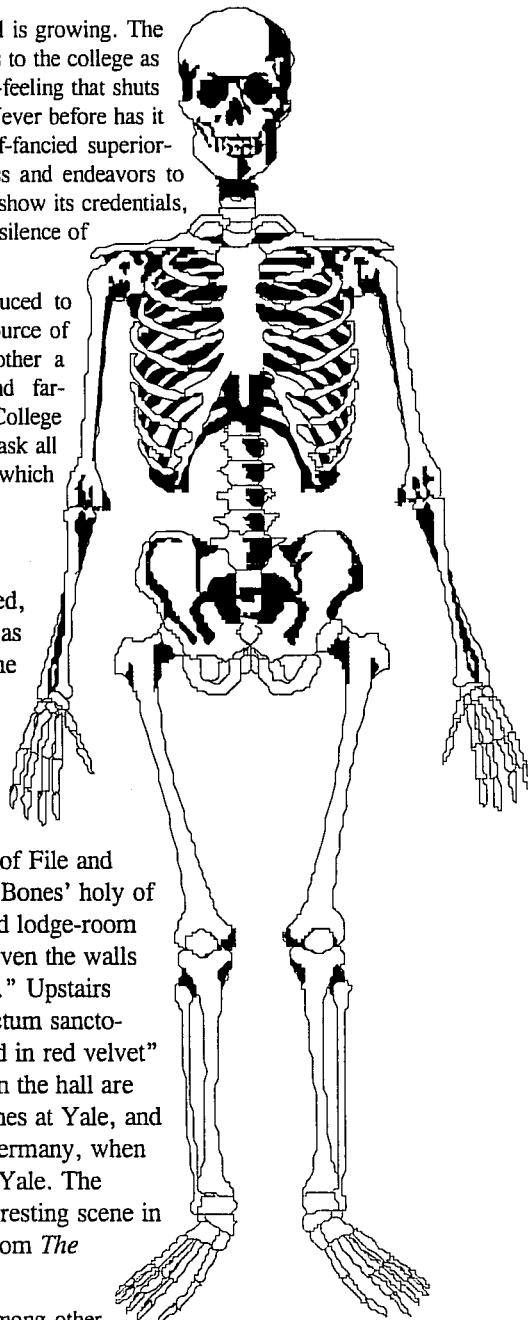
Year by year the deadly evil is growing. The society was never as obnoxious to the college as it is today, and it is just this ill-feeling that shuts the pockets of non-members. Never before has it shown such arrogance and self-fancied superiority. It grasps the College Press and endeavors to rule it all. It does not deign to show its credentials, but clutches at power with the silence of conscious guilt.

The question, then, is reduced to this: on the one hand lies a source of incalculable good - on the other a society guilty of serious and far-reaching crimes. It is Yale College against Skull and Bones!! We ask all men, as a question of right, which should be allowed to live?

At first, the society held its meetings in hired halls. Then in 1856, the "tomb," a vine-covered, windowless, brown-stone hall was constructed, where to this day the Bonesmen hold their "strange, occultish" initiation rites and meet each Thursday and Sunday.

On September 29, 1876, a group calling itself "The Order of File and Claw" broke into the Skull and Bones' holy of holies. In the "tomb" they found lodge-room 324 "fitted up in black velvet, even the walls being covered with the material." Upstairs was lodge-room 322, "the 'sanctum sanctorium' of the temple ... furnished in red velvet" with a pentagram on the wall. In the hall are "pictures of the founders of Bones at Yale, and of members of the Society in Germany, when the chapter was established" at Yale. The raiding party found another interesting scene in the parlor next to room 322. From *The Fall Of Skull And Bones*:

On the west wall, hung among other pictures, an old engraving representing an open burial vault, in which, on a stone slab, rest four human skulls, grouped about a fools cap and bells, an open book, several mathematical instruments, a beggar's scrip, and a royal crown. On the arched wall above the vault are the explanatory words, in Roman letters, 'We



War Der Thor, Wer Weiser, Wer Bettler Oder, Kaiser?' and below the vault is engraved, in German characters, the sentence: 'Ob Arm, Ob Reich, im Tode gleich.' The picture is accompanied by a card on which is written, 'From the German Chapter. Presented by D. C. Gilman of D. 50.'

### The Three Bonesmen

The significance of the German phrases carved on the wall will be explored in the following pages. "D. C. Gilman" refers to Daniel Coit Gilman ('52) who, along with two other Bonesmen, formed a troika which still influences American life today. Soon after

their initiation into Skull and Bones, Daniel Gilman, Timothy Dwight ('49) and Andrew Dickinson White ('53) went to study philosophy in Europe at the University of Berlin. Gilman returned

from Europe and incorporated Skull and Bones as Russell Trust, in 1856, with himself as Treasurer and William H. Russell as President. He spent the next fourteen years in New Haven consolidating the Order's power.

Gilman was appointed Librarian at Yale in 1858. Through shrewd political maneuvering, to acquire funding for Yale's science departments (Sheffield Scientific School), he was able to get the Morrill Land Bill introduced in Congress, passed and finally signed by President Lincoln, after being vetoed by President Buchanan. This bill, "donating public-lands for State College for agriculture and sciences," is now known as the Land Grant College Act. Yale was the first school in America to get the federal land scrip and quickly grabbed all of Connecticut's share at the time. Pleased by the acquisitions, Yale made Gilman a Professor of Physical Geography.

Timothy Dwight, a professor at Yale Divinity School, was installed as president of Yale in 1886. All presidents since have been either Bonesmen or directly tied to the Order and its interests. The influence of the Bonesmen would extend far beyond Yale, however.

For example, Daniel Coit Gilman was also the first President of the University of California. He also helped found, and was the first president of, Johns Hopkins. In addition, Gilman was first president of the Carnegie Institution and was involved in the founding of the Peabody, Slater and Russell Sage Foundations.

Gilman's buddy, Andrew D. White, was the first president of Cornell University (which received all of New York's share of the Land Grant College Act), U.S. Minister to Russia, U.S. Ambassador to Berlin and first president of the American Historical Association. White was also Chairman of the American delegation to the first Hague Conference in 1899, which established an international judiciary.

The Gilman/Dwight/White trio was also responsible for the founding of the American Economic Association, the American Chemical Society and the American Psychological Association. Through their influence on Thomas Dewey and Horace Mann, this trio continues to have an enormous impact on education today.

### Chains of Influence

In his book *America's Secret Establishment*, Antony Sutton outlined the Order of Skull and Bones' ability to establish vertical and horizontal "chains of influence" that ensured the continuity of their conspiratorial schemes.

The Whitney-Stimson-Bundy links represent a "vertical chain": W. C. Whitney ('63), who married Flora Payne (of the Standard Oil Payne dynasty), was Secretary of the Navy. His attorney was a man named Elihu Root. Root hired Henry Stimson ('88), out of law school. Stimson took over from Root as Secretary of War in 1911, appointed by fellow Bonesman William Howard Taft. Stimson later became Coolidge's Governor-General of the Philippine Islands, Hoover's Secretary of State, and Secretary of War during the Roosevelt and Truman administrations.

Hollister Bundy ('09) was Stimson's special assistant and point man in the Pentagon for the Manhattan Project. His two sons, also members of Skull and Bones, were William Bundy ('39) and McGeorge Bundy ('40), both very active in governmental and foundation affairs.

These two Bonesmen brothers, from their positions in the CIA, the Department of Defense and the State Department, and as Special Assistants to Presidents Kennedy and Johnson, exercised significant impact on the flow of information and intelligence during the Vietnam War. William Bundy went on to be editor of *Foreign Affairs*, the influential quarterly of the Council on Foreign Relations (CFR). McGeorge became president of the Ford Foundation.

Another interesting group of Bonesmen is the Harriman/Bush crowd. Averil Harriman ('13), Elder Statesman of the Democratic Party, and his brother Roland Harriman ('17) were very active members. In fact, four of Roland's fellow Bonesmen from the class of 1917 were directors of Brown Brothers, Harriman, including Prescott Bush ('17), George Bush's dad.

Since the turn of the century, two investment bank firms – Brown Brothers, Harriman and Guaranty Trust – were both dominated by members of Skull and Bones. According to Antony Sutton, these two firms were heavily involved in the financing of both Communism and Hitler's Fascism.

Bonesmen share an affinity for the Hegellian ideas of the historical dialectic, which dictates the use of controlled conflict – thesis versus anti-thesis – to create a pre-determined synthesis. A synthesis of their making and design, where the state is absolute and individuals are granted their freedoms based on their obedience to the state – a New World Order.

Funding and political maneuvering on the part of Bonesmen and their allies helped the Bolsheviks prevail in Russia. In defiance of federal laws, the cabal financed industries, established banks and developed oil and mineral deposits in the fledgling U.S.S.R.

Later, Averil Harriman, as minister to Great Britain in charge of Lend-Lease for Britain and Russia, was responsible for shipping entire factories into Russia. According to some researchers, Harriman also oversaw the transfer of nuclear secrets, plutonium and U. S. dollar printing plates to the U.S.S.R. In 1932, the Union Banking Corporation of New York City had enlisted four directors from the ('17) cell and two Nazi bankers associated with Fritz Thyssen, who had been financing Hitler since 1924.

In their book *George Bush: The Unauthorized Biography*, researchers Webster Tarpley and Anton Chaitkin state that:

President Franklin Roosevelt's Alien Property Custodian, Leo T. Crowley, signed Vesting Order Number 248 [11/17/42] seizing the property of Prescott Bush under the Trading with Enemy Act. The order, published in obscure government record books and kept out of the news, explained nothing about the Nazis involved; only that the Union Banking Corporation was run for the 'Thyssen family' of 'Germany and/or Hungary' – 'nationals ... of a designated enemy country.'

By deciding that Prescott Bush and the other directors of the Union Banking Corporation were legally 'front men' for the Nazis, the government avoided the more important historical issue: In what way were Hitler's Nazis themselves hired, armed, and instructed by the New York and London clique of which Prescott Bush was an executive manager?

After the war, Prescott went on to become a U. S. Senator from Connecticut and favorite golfing partner of President Eisenhower. Prescott claimed responsibility for getting Richard Nixon into politics and

took personal credit for getting Nixon the spot as Ike's running mate in 1952.

### Cloak and Gown

There were so many "Yalies" in the OSS (Office of Strategic Services, the forerunner of the CIA) that Yale's drinking tune, the "Whiffenpoof Song," became the unofficial "theme song" of the OSS. Many in the OSS were Bonesmen or belonged to the other Yale senior societies.

Robert Lovett ('18), Harriman's childhood friend, had been tapped into Skull and Bones by Prescott Bush's cell of '17 and was a director at Brown Brothers, Harriman. He was also instrumental in the founding of the CIA. Again, from *George Bush: The Unauthorized Biography*:

On October 22, 1945, Secretary of War Robert Patterson created the Lovett Committee, chaired by Robert A. Lovett, to advise the government on the post-World War II organization of U.S. intelligence activities.... Lovett pressed for a virtual resumption of the wartime Office of Strategic Services (OSS)... The CIA was established in 1947 according to the prescription of Robert Lovett.

Gaddis Smith, a history professor at Yale, has said, "Yale has influenced the Central Intelligence Agency more than any other university, giving the CIA the atmosphere of a class reunion." And Bonesmen have been foremost among the "spooks" building the CIA's haunted house:

- F. Trubee Davison (Director of Personnel at the CIA in the early years)
  - William F. Buckley
  - Archibald MacLiesh
  - Dino Pionzio (CIA Deputy Chief of Station during the Pinochet coup)
  - Senator David Boren (Senate Intelligence Committee)
  - Senator John Kerry (Senate Intelligence Committee)
  - William and McGeorge Bundy
- ...and, of course, George Herbert Walker Bush, who served as CIA Director in the 1970s. Some other

prominent Bonesmen include:

- Henry Luce (Time-Life)
- John Thomas Daniels (Agribusiness giant Archer Daniels Midland)
- Harold Stanley (Morgan Stanley investment banker)
- Pierre Jay (first chairman of the Federal Reserve Bank of New York)
- George Herbert Walker, Jr. (financier and co-founder, NY Mets)
- Alfred Cowles (Cowles Communications, *Look* magazine)
- Artemus Gates (President of New York Trust Company, Union Pacific, and the Boeing Company)
- Dean Witter, Jr. (investment banker)
- Potter Stewart (Supreme Court Justice)
- Senator John Chaffe
- Russell W. Davenport (editor, *Fortune* magazine, created Fortune 500 list)
- Richard Gow, president Zapata Oil
- Howe Bradford (husband of Carol Warburg Rothschild and a general manager for the *New York Times*)
- Winston Lord (former Chairman of the CFR, Ambassador to China and assistant Secretary of State in the Clinton administration).

John Lilley, Ambassador to China, is another example. In fact, ever since Nixon re-established America's political relationship with China, many of our ambassadors to that country have been Bonesmen, including George Bush, the first Chief U. S. Liaison Officer to the Peoples Republic of China. Why all this interest in China? Well, China, among other things, is still a large producer and user of opiates.

### Behind the Drug Trade

During the Opium Wars of the 1800s, the U.S. chose to stand on the sidelines and cheer for the English and French, knowing that treaty obligations would bring the U.S. a share in the spoils. Russell and Company was at times the only trading house operating in Canton, and used the opportunity to develop strong commercial ties and handsome profits.

Powerful national interests were behind the drug trade, because American traders

were badly in need of something which the Chinese would buy. If the Chinese had not bought opium from Americans, then United States imports of silk, porcelain and tea would have to be paid in precious coin, which was in short supply. In 1843, when the Port of Shanghai was opened, Russell and Co. was one of its earliest traders.

In 1903, Yale Divinity School set up a program of schools and hospitals in China. Mao Zedong was among the staff. During the intrigues of China in the 1930s and '40s, American intelligence called upon the resources of "Yale in China," and George Bush's cousin and fellow Bonesman Reuben Holden.

After stints as UN Ambassador and Chairman of the Republican National Committee for the beleaguered Richard Nixon, George Bush was sent to look after the "China trade." The Bush family is still very much involved in the economic activities of China.

Some researchers contend that George Bush has been with the CIA since the early 1950s, and that one of his jobs was to consolidate and coordinate the worldwide narcotics industry, the largest industry on Earth. Some even say that the Vietnam conflict was a cover for the consolidation of the drug trade emanating from the Golden Triangle.

Before the Vietnam War, the Golden Triangle was run by French Intelligence and Corsican mobsters. After the French bailed out and America moved in, the triangle was run by U.S. intelligence, with aid from Sicilian mobsters. This narcotics network is well documented in *The Politics of Heroin in S. E. Asia* by Alfred McCoy, *The Great Heroin Coup* by Henrik Kruger and *Double-Cross* by Sam and Chuck Giancana.

### Why Bush Hates Perot

Vice-President George Bush, as Chairman of President Reagan's cabinet-level working group and as Director of the National Narcotics Interdiction System, was the highest U. S. governmental official involved in the "war on drugs."

Frances Mullen, Jr., former head of the Drug Enforcement Agency (DEA), called Bush's efforts "an intellectual fraud" and "a liability rather than an asset." Soon after these statements, Mullen resigned and the resultant General Accounting Office (GAO) report was buried. In July, 1985, the suppressed GAO paper reported that there were "no benefits from the National Narcotics Border Interdiction System, directed by George Bush. In fact, the overall effect was to encourage supply...."

Monika Jensen-Stevenson, a *60 Minutes* producer, quit her job after the CBS news program refused to air the story she had uncovered relating to the covert drug trade. Her book, *Kiss The Boys Goodbye*, details how our intelligence community used the apparatus of the POW/MIA governmental agencies as a cover for the trafficking of opiates from the Golden Triangle.

President Reagan appointed Reform Party founder and Texas billionaire Ross Perot to the President's Advisory Council on Foreign Intelligence. Reagan made Perot a special presidential investigator, looking into America's POW and MIAs from the Vietnam War.

Ross took the job to heart and spent considerable time and money in pursuit of the quest. He was given special clearance and access. He asked questions and interviewed everyone he could find. Jensen-

Stevenson writes in *Kiss The Boys Goodbye*:

Relations between Bush and Perot had gone downhill ever since the Vice-President had asked Ross Perot how his POW/MIA investigations were going. 'Well, George, I go in looking for prisoners,' said Perot, 'but I spend all my time discovering the government has been moving drugs around the world and is involved in illegal arms deals.... I can't get at the prisoners because of the corruption among our own people.'

This ended Perot's official access to the highly classified files as a one-man presidential investigator. 'I have been instructed to cease and desist,' he had informed the families of missing men early in 1987.

The wholesale importation of cocaine into the U.S. during "Iran/Contra" is also well documented. George Bush is known to have been "in the loop" with many of the players, who were in direct contact with his office.

In addition, narcotics such as cocaine and heroin cannot be manufactured without the precursor chemicals. A large maker of these precursor chemicals is the Eli Lilly Company of Indianapolis, Indiana. The Quayle family is a large stockholder, and George Bush has been on the Board of Directors. Eli Lilly is also the company that first synthesized LSD for the CIA.

### Part of the Illuminati?

John Robison, a professor of natural philosophy at Edinburgh University in Scotland and a member of a Freemason Lodge, said that he was asked to join the Illuminati. After study, he concluded that the purposes of the Illuminati were not for him.

In 1798, he published the book *Proofs Of A Conspiracy*. He wrote:

An association has been formed for the express purpose of rooting out all the religious establishments and overturning all the existing governments.... the leaders would rule the World with uncontrollable power, while all the rest would be employed as tools of the ambition of their unknown superiors.

*Proofs of A Conspiracy* was sent to George Washington. Responding to the sender of the book with a letter, the president said he was aware the Illuminati were in America. He felt that the Illuminati had "diabolical tenets" and that their object was "a separation of the People from their government."

In his book, Robison related the ceremony of initiation of the "Regent degree" in Illuminism. In it, "a skeleton is pointed out to him [the initiate], at the feet of which are laid a crown and a sword. He is asked 'whether that is the skeleton of a king, nobleman or a beggar.' As he cannot decide, the president of the meeting says to him, 'The character of being a man is the only one that is of importance.'"

This is, essentially, the same as the writing in the Skull and Bones tomb: "Wer war der Thor, wer Weiser, Bettler oder Kaiser? Ob Arm, ob Reich, im Tode gleich," which translates as "Who was the fool, who the wise man, beggar or king? Whether poor or rich, all's the same in death."

Is the Order of the Skull and Bones part of the Illuminati? When a person is initiated into Skull and Bones, they are given a new name, similar to the practice of the Illuminati. And many recorded Illuminati members can be shown to have contact and/or strong influences with many of the professors that taught the first Bonesmen in Berlin.

When a secret society conspires against the sovereignty of a king, they

need to organize, raise funds, make their plans operational, and hopefully bring them to fruition. Could we have in the United States a secret society that has used the "National Security State"

# The Cyborg Hypothesis

## Robot Probes and Indefinite Survival

**I**n considering the origin of human civilization on Earth, Robert Temple, author of *The Sirius Mystery*, concludes that we should be ready to face the reality that extraterrestrial civilizations exist and have been here. He surmises that if intelligent beings have already visited Earth, they may possibly be “monitoring us at this moment with a robot probe somewhere in our solar system, and may have the intention of returning in person some day to see how the civilization they established is really getting on.”

The Cyborg Hypothesis has entered provocatively in the UFO literature on three occasions over the past few years. This article outlines those three instances, to conclude that we have likely failed to see what UFOs really are: the “robot probes” of a vastly superior race.

### The Anatomy of Alien Gray

On the surface, Earth humans and alien grays have a comparable number of appendages. The alien grays reportedly picking up Earth specimens have two arms and two legs, and they walk upright. Biologically speaking, explains Dr. David Jacobs, for locomotion only four legs beats two legs; but bipedalism frees up the hands. The alien grays have been variously described as having three, four or five fingers. We all know what opposable thumbs are for; but it is not clear that the grays typically have them. It is

true, agrees Jacobs, that the grays don't have several eyes; they have two. Neither do they have several heads; they have one. Two eyes are better than one, and locating them at the top of the head so they are directly connected to the brain makes visual reports instantaneous. As a model for survival, Jacobs suggests, the bipedal humanoid appears to be an adaptive and efficient one. Although Darwinists claim to know otherwise, let us establish the simple fact that no one *really* knows how old this model might be, nor its true genesis.

According to a talk given by Dr. David Jacobs of Temple University entitled “The Anatomy of an Alien,” a wide variety of alien types have been witnessed first-hand by sane people all over the world, but, Jacobs adds, the wide variety of descriptions may have more to do with a difference in perception, interpretation or reporting. According to Jacobs, the overt morphology of the most enigmatic of the Visitors, the grays, falls within a range of humanoid features, but under close scrutiny these reports describe a radically different creature “under the skin.” (Omega Conference, CT, 10/9/88)

A quick survey of these descriptions will suffice. While the skin color varies with reports from whitish or off-white, beige, tan,

various shades of gray, and sometimes a green or blue tinge (probably caused by artificial lighting), one of the most important observations is that *variations in skin tone do not exist*. Jacobs points out that the skin is remarkably smooth and even-toned, exhibiting no discolorations, bumps, blemishes, bruises, freckles, creases, wrinkles, pores, hair or hair follicles, veins, etc. The skin is often described as being like *plastic* or *rubber*. Importantly, there are no veins visible which would indicate blood flow beneath the skin. "There is an odd simplicity as if it is a *manufactured* or *synthetic* skin stretched over the frame," he reports.

The shape of the alien gray's head has been described as a "parking meter" or a "light bulb." The large dome or cranium is entirely hairless; there is no hair, fur or fuzz anywhere on the head or, for that matter, on the entire body. There have occasionally been striations noted on the head. Jacobs points out that communication is not dependent on facial cues. Therefore, although the face has a *somewhat human* morphology, he asserts, the underlying musculature which might portray *meaning* or *emotion* is missing. There is little or no movement of the black, "wrap-around" eyes, and there is no separate pupil or iris area in the eye. The eyes have functions beyond sight in that they are apparently used for telepathic communication. The eyes do not move from side to side, and there are usually no eyelids seen. It would seem that there is no need to cleanse or protect the eyes. There are also no eyebrows, although a completely hairless ridge is noted above the eye. There are no ears. If it doesn't need to talk, apparently it doesn't need to hear.

Some abductees report seeing a small mouth, but most report just a slit with no lips just above a very pointed chin. Jacobs points out that there is no evidence of a "hinged jaw" or muscles to open the mouth, nor are there teeth noted in the mouth, indicating that the beings do not consume in the manner typical of Earth humans. Mastication appears to be unnecessary. Some alien abductees describe a very small nose, and others note just two small holes in the area where a nose would be expected. A nose is useful not only for taste

and smell, but is also a "heating chamber" for the lungs in cold climates; nose hairs also trap pollutants. What might these various features taken in combination say about the alien environment? Jacobs deduces that the alien environment is "highly controlled, uncontaminated, unnatural and highly technical."

The alien gray's neck is like a thin tube. A twelve-year old boy reported to Dr. Jacobs that he grabbed one of his abductors by the throat. He stated that the neck felt solid, not soft. Drawings by abductees indicate that the neck does not gradually fit into the base of the skull, nor does it gradually slope out to fit the shoulders, but is rather like a straight tube between the head and the shoulders. The chest is small and narrow, with no noticeable clavicle, sternum, or bifurcated structure in the upper torso. In other words, the chest is not divided into two halves. There are no breasts, breast muscles or nipples noted. The chest is *motionless*; there is no motion indicative of breathing.

The upper torso of the alien gray is said to be proportionate with the waist or hip area; the torso is proportionately the same all the way down. There are no apparent hip or pelvic bones. The abdomen area is totally flat, indicating that there is no food being processed in the "stomach" area. There is also no indication of ribs; and there appears to be no male genitalia. Differences between the sexes of the alien grays are not overt; abductees simply report that they "know" or have a "feeling" that their abductees are a male or a female. On the alien gray's back side there is no indication of shoulder blades, spinal vertebra, or buttocks.

The arms of the alien gray are frail and spindly, and there is a "bend" where the elbow should be. The fingers are long and thin, generally with rounded pads or bulbs at the end, while some are reported as being tapered at the end. There are usually four fingers and a thumb, but sometimes three fingers and a thumb are noted. The legs are short and bend at the knee and the feet appear humanlike although they are usually

covered. In addition, the alien beings apparently do not age over time, and are *very curious about the aging process of Earth humans*. After a lifetime of abductions beginning at five years old, Jacobs reports that a 35-year old abductee has changed tremendously. She has been abducted by the same entity throughout her lifetime. While she, of course, has aged, the entity looks exactly the same. He has not aged; there are no wrinkles or age spots on his skin. There is no sense of change over time.

Although they appear to be weak and frail, the grays are reported to be surprisingly strong, and are apparently dexterous enough to dress and undress their abductees. Although musculature is not noticeable, the grays appear to be able to “carry” people; albeit some sort of mind control technology may be aiding them. These entities do not appear to walk, but rather, they seem to “glide” or “float.” Theoretically, the assumption of the evolution of the human animal as a novel cosmic occurrence has actually not been breached by the appearance of this overtly similar entity since, with the exception of a few obvious morphological features, these beings are actually “very alien.” All signs indicate that they do not age, they do not inhale or exhale, they do not ingest food or water, they do not excrete the waste products of food or water, they do not procreate, and they do not hear or talk. As H.V. Ditfurth writes, “a living being that does not engage in a continual exchange of energy with its environment is simply unthinkable.” (*The Origins of Life*, 24)

Jacobs stresses that we cannot make the presumption that these are biologically living entities in the sense that we understand the concept of “aliveness.” Neither can we say for sure that they are manufactured beings, although they very well may be. Perhaps, he concludes, they are some combination of the two: biological robots.

### **The Roswell Alien Autopsy**

Interestingly, this conclusion was arrived at separately some years after Jacobs made these comments at a 1988 conference. The worldwide showing of an alien autopsy on Fox TV on August 28, 1995 placed ‘aliens’ on center stage after decades of media silence on the subject. If you were lucky enough to see the original videotape, without the “talking heads” who poked their opinions into the Fox Television version, you got to see a lot more of the original footage. The autopsy film was purportedly purchased by British businessman, Ray Santilli, from an anonymous cameraman who claims to have taken the footage for the American government in 1947.

The mysterious circumstances surrounding the film’s arrival on the UFO scene merits serious scrutiny in itself. The film footage appears to have been dissected as much as the “alien” being, since parts of the footage were sold to Volker Spielberg, Ray Santilli’s German financial backer. Spielberg has rescinded early offers to show his sections of the footage, which are rumored to be much more disturbing than what we’ve seen. Somewhere, though, there must exist a complete copy of the most scrutinized film since Zapruder captured the killing of a president in 1963.

Anachronistic concerns regarding objects seen in the film were addressed by researchers early in the investigation. Bell Telephone ascertained that they did make a “curly” telephone cord at the time this film was supposedly shot. The camera, film type and reel length are consistent with what might have been used by the military in 1947. The Filmo camera that was used would have had similar focus problems, since up-close focusing is difficult without through-the-lens viewing. Kodak representative Lawrence Cate has ascertained from a small piece of a print, leader only, that the

codes on it were applied only in the years 1927, 1947 or 1967.

Later nicknamed SUE, for Santilli’s Unidentified Entity, the Roswell female alien caused quite a brouhaha with cries of it being a doctored-up human corpse or a human radiogenic mutant with severe hydrocephaly (water on the brain). A search in the files of the Institute for Radiation Research at Hiroshima and Nagasaki will show that nuclear radiation causes random malformations, burns, diseases of the nerves and birth defects in the offspring of those affected. Those birth defects would not consist of the addition of symmetrical appendages; that is, one extra well-formed digit on the hands and feet on this six-fingered alien. Nor would it cause water on the brain.

The Roswell Alien Autopsy film shows a small, hairless, six-fingered entity with an enlarged cranium and somewhat bloated stomach, perhaps due to body decomposition. The entity is lying on its back on a table while doctors, completely covered in white spacesuit-looking garb, perform a “routine” autopsy. With precision cutting instruments, they cut the skin and peel it back in a realistic manner, laying bare a body cavity filled with unfamiliar organs which are removed one by one. Doctors who have viewed this film claim that these organs are not comparable to the size, shape or locale of human body organs, and have no human counterpart. Pathologist Cyril Wecht stated that the body is like none he’s ever examined and called for a full-fledged scientific observation of the film with respect to the morphology of the body and the organs. (*UFO Magazine*, Fall ‘95)

### **Plastocene Portals and Looking Glass Eyes**

There are several disturbing qualities exhibited by the specimen named SUE. First, as the autopsy continues, the ‘peel-off’ black eye ‘coverings’ are removed to show white eyeballs set deep into the sockets with no apparent

pupils. At one point we watched in amazement as the alien blinked. We kept going over and over that same section of the video, and even slowed it down, and we were sure the alien blinked! Another disturbing aspect of the Roswell alien is the absence of a belly button, the insertion point for the umbilical cord which connects a mammalian fetus to its mother. Also disconcerting is the lack of nipples on an otherwise muscular chest which indicates presence of mammary glands. These details would certainly rule out objections that the cadaver is a doctored human corpse, but they also indicate that the entity did not “come into the world” in the manner in which mammals are born.

How can a “humanoid” with physical characteristics as close to our own not share the basic characteristics of mammalian reproduction? There are a limited number of options: (1) it was “hatched” from an egg or larvae and is insect, reptilian or amphibian in origin, or (2) it is bio-engineered and, therefore, it is a cyborg; or (3) the alien grays are some combination of both of the above.

Another bothersome aspect of SUE’s autopsy remains hearsay. I have seen the video in its entirety a few times and it is not clear where a crystal-like object is removed from the brain. This would be another indication, taken along with the previous two, that the entity is bio-engineered. Perhaps the sections of the footage owned by Volker Spielberg contain this enigmatic detail. It has been reported in *UFO Magazine* that several “still frames” of unreleased footage were shown at the International UFO Congress in Nevada. These frames are very detailed and are supposed to be released in the future. Perhaps these are the frames which purportedly show the brain crystal. Interestingly, Stanton Friedman has also noted that he was expecting to see something that he did not see in the film. He also had heard talk of an autopsy of a second alien which others had said was on the tape. He concludes: “one story is that Santilli sold this to a collector to make some quick money.” (*Top Secret/Majic*, 201)

Friedman has concluded that the public was hoodwinked and the Roswell “alien” was, in fact, a hoax. He has had a very difficult time getting Santilli and others to corroborate the factual evidence. In addition, since the film is not continuous, he asserts, we don’t know what took place when the camera wasn’t running. Also, nothing in the film links the entity to the Roswell crash. Oddly, the surgeons in the film did not weigh or measure the organs as they removed them. Furthermore, no alien abductee has ever seen an alien gray with six fingers; the usual number is four or five. Friedman asserts that the Turner’s Syndrome explanation is possible, except that this disease only strikes females, and this entity had no breasts. With regard to the segment of the tape which displays some type of beams with hand prints for six-fingered hands, Friedman comments: “these would not have been cheap to manufacture.” (*Top Secret/Majic*, 202)

In conclusion, all of the above qualities – large “plastocene portals” (which may blink after death and which appear to be removable), lack of a belly button and nipples, no stomach or intestines, and possibly a brain crystal – combine to suggest that the Roswell alien is a test tube baby, a biological robot engineered with real protein-based tissue, flesh and “blood” and a “power pack” possibly set to hundreds of years, barring any unforeseen space/time accidents.

## Corso’s “Foreign” Technology Desk

The Cyborg hypothesis was again supported by the revelations of a former Pentagon official in 1997. According to retired Col. Philip J. Corso in his book *The Day After Roswell*, the technological level of Earthlings was immedi-

ately catapulted into the future after the crash of an ET disk in the desert of New Mexico in July of 1947. In his book, Corso talks about his assignment to the U.S. Army’s Foreign Technology desk from 1961 to 1963. He describes in detail the contents of a file cabinet which was placed in his possession.

Corso’s file contained a two-piece set of elliptical eyepieces that were “as thin as skin.” A file description accompanying the lenses, written by pathologists at Walter Reed, indicated that these flimsy attachments were adhered to the lenses of the ET’s eyes and “seemed to reflect existing light.”

The pathology report stated that when the researchers peered through these plastocene portals in the dark, the outer shapes of objects were illuminated in a greenish orange hue. Also among these alien artifacts was a dull, silvery swatch of metallic fiber which bounded back to its original shape when folded or bent, and could not be cut with scissors. There were also plastic-like wafers shaped like oyster crackers about two inches in size. The thin, matte-gray wafers, in varied round and elliptical shapes, had tiny "road maps of wires barely raised or etched along the surface." Corso determined that this was a stacked wire circuitry of some kind.

Corso's job was to examine the materials contained in this secret file, which consisted of several bizarre technological artifacts of obvious "foreign" origin, along with the autopsy reports of several dead extraterrestrial biological entities (EBEs) examined by Army pathologists at Walter Reed Army Hospital in 1947. Corso's mission was to suggest a way that the Army could diffuse this technology into the military and public domain over the course of time, under the guise of foreign technology, while keeping the general public unaware of its extraterrestrial source. In his book, he outlines his proposal to General Trudeau: "we could farm out to industry the components that comprised the electromagnetic antigravity drive and brain-wave directed navigational controls ... dole them out piecemeal once we broke them down into developmental units, each of which could have its own engineering track." (*Day After Roswell*, 121)

The Roswell file also included pieces described as "tiny, clear, single-filament, flexible glasslike wires twisted together through a kind of gray harness." When held up to the light, an eerie glow emanated from this harness of narrow filaments, diffusing the light into different colors. Corso reports that, within five months of receiving this artifact from the Roswell crash, Bell Labs announced its discovery of the transistor. This fantastic story is also buttressed by the claims of Newark-based American Computer Company. The official history of the

transistor holds that the first one was created by Bardeen, Shockley and Brattain at Bell Laboratories in Murray Hill, NJ, out of germanium, crystal, a few slivers of gold and a paper clip. American Computer has a web page devoted to the Roswell incident. According to the company's president, Jack Shulman, they have mysteriously acquired a certain "shopkeepers notebook" which previously belonged to Bell Labs, dating from 1947, which suggests that "the transistor was back-engineered from an existing device." The "history" of the invention was apparently also back-engineered in a feat of Orwellian Newspeak. (<http://compamerica.com/roswell.htm>)

Shulman claims he has thousands of pages of supporting material which dates from this era. American Computer recently announced that it has developed a revolutionary device from information obtained from the same lab notebook which has the "potential to push computer technology ahead by a century." The device, which is called a "transcapacitor," is capable of storing up to 90 gigabytes of information while consuming very little energy. American Computer is predicting that it will manufacture a 90-gigabyte hard drive from this transcapacitor by late 1999 or 2000. Shulman claims that he will selectively leak technology secrets "at the rate of one bombshell per month" in order to provoke government UFO disclosure. (*UFO Magazine*, April, 1998)

## The Cyborg Hypothesis

With regard to the bodies of the EBEs, the Roswell alien autopsy reports which Corso studied indicated that the organs, bones and skin of the EBEs were different than that of humans. First, the heart and lungs were much bigger, especially given its height of 4 feet and its small body build. The autopsy personnel at Walter Reed had noted that the brain was larger "but not at all unlike ours." The brain of the EBEs had four distinct sections and was oversized in comparison with its tiny stature; its cranium was more like palatal cartilage than hard bone. In addition, the blood and lymphatic systems seemed to be combined. Curiously, there were no food preparation facilities nor any stored food on board the craft; neither were there any waste facilities. Neither was there a digestive or excretory system present in this biological entity. The autopsists noted that if any exchange of nutrients and waste took place, it had to have been through the entity's skin. (*Day After Roswell*, 103)

The skin of the EBEs consisted of a thin layer of permeable fatty tissue through which chemicals were likely exchanged with the combination blood/lymph system. The tiny mouth and lack of obvious digestive system was puzzling to the medical examiners at Walter Reed. They hypothesized that the EBEs recirculated waste chemicals, since there were no waste-processing facilities on board the craft. While reading the skin analysis report, Corso also speculated that the skin was "more like a house plant than the skin of a human being." Another suggestion made by engineers at Wright Field was that there was no need for food preparation on this craft because it was a "scout ship" which did not routinely travel far from the mother ship. Corso suggests another possibility: "they weren't actual life forms, only a kind of robot or android." (*Day After Roswell*, 105)

Walter Reed pathologists noted that the EBEs were remarkably well adapted for long distance travel, with large capacity heart and lungs,

and most likely a slow metabolism. A milky fluid pumped through a rather primitive circulatory system. The pathologists also noted that the EBE's heart functioned as a passive blood-storage facility and a pumping muscle, which worked less hard than a human heart muscle. In short, the EBEs "biological clock," Corso suggests, "allowed it to travel great distances in a shorter biological time." (*Day After Roswell*, 101)

Corso noted that the EBE's large lungs occupied a large percentage of the small chest cavity, and seemed to function somewhat like a scuba tank, releasing atmosphere slowly into the system. In addition, the bones of the EBE were flexible and resilient as though, Corso speculated, they functioned as "shock absorbers," making their bodies well suited for physical trauma and extreme gravitational forces. The bones and skin of the EBE showed a different atomic alignment, as if built for "greater tensile strength." Corso concluded that the skin may have been stronger in order to "protect the vital organs from cosmic rays or wave action or gravitational forces." Corso wrote in his report to General Trudeau that perhaps the EBEs represent "the end process of genetic engineering designed to adapt them to long space voyages within an electromagnetic wave environment." (*Day After Roswell*, 98)

### **Brain Wave Guidance System**

In short, Corso concluded that perhaps the EBEs were "humanoid robots rather than life forms, specifically engineered for long distance travel through space or time." In addition, he suspected that their technology made them part of the ship both with respect to piloting and navigation, as well as protection, by putting them essentially "in the eye of the hurricane." (*Day After Roswell*, 99)

In addition to the "inner skin" of the EBEs, the entities were enclosed in a one-piece protective jumpsuit which was worn like "an outer skin." When closely examined at Walter Reed, the medical examiner noted that this material reminded him of a spider's web: fragile in appearance but extremely strong and flexible. This space suit appeared to be stretched around the EBE "as if it were literally spun over the creature and seized up around it." Medical examiners noted that the suit might have protected the wearer against low energy cosmic rays which regularly bombard the space craft during a space journey. By accelerating the atomic structure and heating the body, such particle bombardment might produce the effects of being cooked in a microwave oven. Without the suit, suggests Corso, the oversized organs of the EBE would be vulnerable to the "cumulative trauma from constant energy particle bombardment." (*Day After Roswell*, 104)

But there was more to it than that. The secret to the navigation of the flying saucer, Corso speculated, also lay in the skin-tight material which was seemingly "spun around the creatures," somehow making them "part of the electrical storage and generation of the craft itself." The Air Force had discovered during its testing of the craft at Norton Air Force Base that the entire

vehicle functioned somewhat like a giant capacitor. The craft itself, they wrote, stored the energy necessary to propagate the magnetic

wave that elevated it, and allowed it to achieve escape velocity from the Earth's gravity. This internal energy also enabled it to achieve speeds of over 7,000 miles per hour. Corso described the vehicle as, essentially, a flying battery.

Corso speculated that the vehicle essentially became an extension of the EBE's bodies by being tied to their neurological systems via their space suits. This was how, he proposed, the EBE's became the primary circuit in control of the magnetic wave; in essence, "one with the vehicle and literally part of the wave." The pilots were not affected by the tremendous g-forces because they were, in effect, travelling "in the eye of a hurricane." (*Day After Roswell*, 110)

There are some remarkable corroborations between Dr. Jacobs' research into the outer morphology of the alien grays and the deductions made by Philip Corso from his analysis of the artifacts and reports contained in his *Roswell File*. According to the medical examiners at Walter Reed, this entity did not have to work very hard to sustain itself, and was especially adapted to long distance travel. Corso surmises that the entity is "part of the electrical storage and generation of the craft itself" via its own neurological

*engineered* as one unit. It is important to note that, according to Corso, the reports from the Roswell crash indicate that these beings did not have a chance of survival outside of their craft. The androids and their ship are a package deal. Since living beings cannot travel through time and space due to energy particle bombardment as well as other effects, this technological design is quite possibly *the only way to fly*.

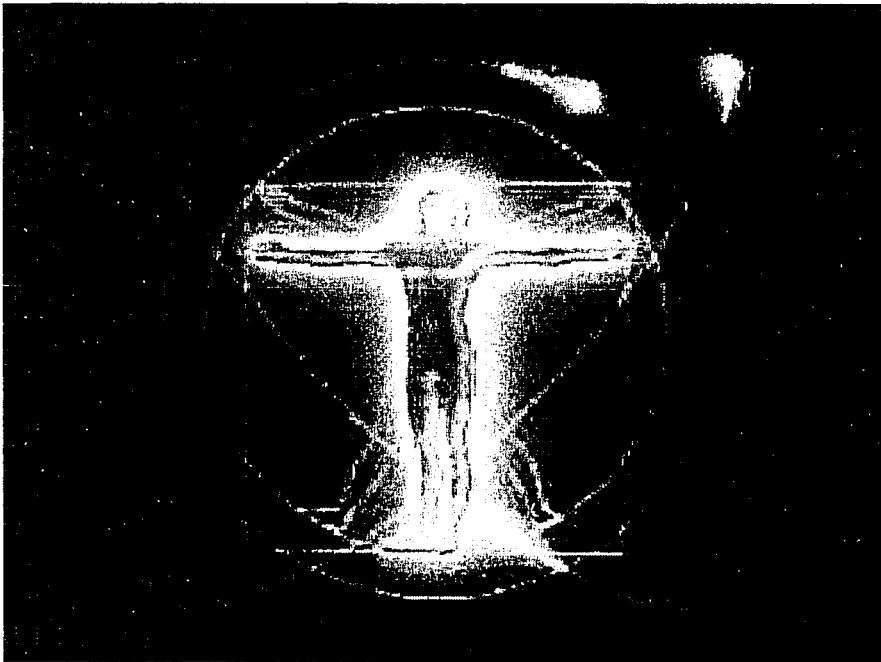
But this means that someone engineered them; someone came up with this design. It would appear that this high-tech package is somehow connected with the idea of the universal constructor or messenger probe.

### The Virtual Merkaba

A Merkaba is an internal time-space vehicle which can only be achieved by advanced meditative states. The internal merkaba is not functioning on most people, but it is said to be used by ascended masters to travel at the speed of thought. The merkaba is a time-space vehicle created by counter-rotating fields of electromagnetic energy which can only be created with

the emotional body intact. Bob Frissell explains: "The mental star tetrahedron, electrical in nature and male, rotates to the left. The emotional star tetrahedron, magnetic in nature and female, rotates to the right. It is the linking together of the mind, heart and physical body in a specific geometrical ratio and at a critical speed that produces the merkaba." (*Nothing in This Book Is True*, 22)

According to Frissell, the word *mer* denotes counter-rotating fields of light, *ka* is spirit and *ba* is body or reality. The merkaba is made up of counter-rotating fields of light which encompass spirit and body. It is, according to Frissell, "the image through which all things were created, a geometrical set of patterns surrounding our bodies." The geometry of the merkaba surrounding the body and



system, as well as by the addition of several different technologies. A bizarre headband device and the specially "shrink-wrapped" outer skin completes the package. This astronaut is ready for takeoff.

In turn, via a different analysis, Jacobs has deduced from abductee descriptions of the morphology of the alien grays that the alien environment is "highly controlled, uncontaminated, unnatural and highly technical." Thus, we can safely deduce that the highly technical environment which the grays call "home" is none other than the aircraft itself. They are

spirit forms all at once a star tetrahedron, a cube, a sphere and an interlocked pyramid. The merkaba can, however, be externalized. All flying saucers, Frissell writes, are based on the principles of the external merkaba. To manufacture an external merkaba, nothing from the emotional body is needed; it is all mind. Creating an external merkaba, however, turns emotions into technology. Therein lies its fatal flaw. (*Nothing in This Book*, 152)

Are flying saucers and the androids inside them essentially based on the idea of an external merkaba? As Corso has noted, the ship is essentially an extension of their bodies, tied to their neurological systems via their techno-gear, making them "the primary circuit in control of the magnetic wave." The rotating fields of light surrounding the body -- male energy spinning left, female energy spinning right -- might very well create the phenomenon described as "the eye of the hurricane." This leads to another interesting connection: that the androids are androgyns, neither male nor female, but something else.

## Smart Probes and Indefinite Survival

A Von Neumann Probe is essentially an advanced computer sent to another stellar system, which includes an intelligent universal constructor capable of self-repair, self-programming and self-replication. The universal constructor receives instructions from its system of origin to carry out a search for interstellar construction materials in order to build a colony or base in the stellar system. The probe is capable of building smaller probes to move around within the stellar system. So, then, the job of a universal constructor is to construct. According to the Space Travel Argument, Von Neumann probes are closely analogous to biological species. (*The Anthropropic Cosmological Principle*)

The Space Travel Argument contends that the launching of a universal constructor would increase the probability of the survival of a civilization. If a civilization possessed artificial womb technology, they could program a probe to synthesize members of their species in the other stellar system. These members could then be raised in a colony by robots also manufactured by the probe. The Space Travel Argument seems to put forth the idea that it is wise to populate the stars with "machine descendants" since that civilization would never become extinct. So, in Martha Stewart's words, 'it's a good thing.'

A messenger probe is essentially a collector of information, and the information it collects are the building blocks of life. If it is discovered that there is biological life in the stellar system to which a probe is sent, the civilization could also consider those life forms as a source for "construction materials." They might use the building materials (DNA) of those life forms to enliven its possibly degenerating DNA, to create a race to populate a local colony, or to send to other star systems for distant population projects. Thus, if there were biological life forms in the system, they would not need "artificial womb technology."

As Corso contends, the EBEs "are fabricated beings, just like robots or androids, created specifically for space travel and the performance of specific tasks on the

planets they visited." He speculates that "perhaps their programming could be updated or altered from a remote source." (*Day After Roswell*, 245) As engineers at Wright Field suggested, perhaps the smaller craft which crashed in New Mexico was a "scout ship" which only travels locally and does not venture far from the larger craft, or from a colony in outer space.

Does it not make sense that an advanced civilization, especially a nonhumanoid race, would utilize humanoid robots to collect information from a humanoid race? If we view the abducting gray entities and their UFOs as one unit, and as the programmed "universal constructors" of a vastly superior race, we have an explanation for the procreative nature of the abduction scenario. The grays may be seen as essentially traveling biochemists, collecting the DNA of all biological life forms they encounter in order to effectuate indefinite survival.

Perhaps in our thinking of "UFOs" as simply flying machines, we have overlooked a more accurate description and, therefore, have missed the true meaning of what they are: the computerized "smart probes" of an extraterrestrial civilization. •

# Should the House Impeach Al Gore?

Jan. 18 (EIRNS) Compelling evidence assembled by the EIRNS news service suggests that Vice President Albert Gore Jr. may have committed impeachable offenses under Article 11, Section 4 of the U.S. Constitution, which states, "The President, Vice President and all civil Officers of the United States, shall be removed from Office on Impeachment for, and Conviction of, Treason, Bribery, or other high Crimes and Misdemeanors."

Unlike the thoroughly bogus case tried in the U.S. Senate against President Clinton, which was the poison fruit of a six-year assault on the Presidency by London-centered foreign enemies, the case against the Vice President is straightforward.

Between July-September 1998, Vice President Gore, operating behind Clinton's back, attempted to re-install Viktor Chernomyrdin in the Prime Ministership of Russia. This was part of a corrupt arrangement he struck with a group of private Wall Street bankers and hedge-fund managers, who were threatened with the loss of billions following the Russian government's August 17, 1998 declaration of a 90-day freeze on the payment of certain debts.

Principal among the Wall Street bankers with whom Gore made his pact were: David E. Shaw, George Soros, and a group of major commercial and investment bankers who were later caught up in the near-

bankruptcy and collapse of the Long Term Capital Management (LTCM) hedge fund.

LTCM nearly went bust in late September, triggering an intervention by the Federal Reserve Board to force 16 of the world's largest commercial banks and brokerage houses to pay \$4 billion to avert an LTCM bankruptcy. Shortly after the LTCM collapse, the D.E. Shaw Hedge Fund did go belly up, forcing Bank of America to post \$500 million in second-half losses in 1998, all related to Shaw's speculation on Russian bond and currency markets. Already, on Aug. 27, George Soros's Quantum Fund had admitted to having lost \$2 billion in Russia.

The Wall Street desperados turned to Al Gore to bail them out, and the Vice President apparently was all too willing to oblige. Gore interceded against the national security interests of the United States, and in sharp conflict with the Clinton administration's overall Russia policy, in his briefly-successful effort to put Chernomyrdin back in power in Moscow. (The Wall Street-friendly Chernomyrdin had been fired by Boris Yeltsin in March 1998, along with the IMF's favorite "reformer," Anatoli Chubais).

Vice President Gore took at least \$40,000 in payoffs from top executives of D.E. Shaw in late July, in the form of contributions to his political action committee, Friends of Albert Gore, Jr., Inc.

Furthermore, beginning no later than 1995, according to the *New York Times* of Nov. 23, Gore intervened to suppress a CIA investigation of Chernomyrdin that had revealed that the Russian Prime Minister (and former

head of the state oil company, Gazprom) had amassed a personal fortune estimated at \$5 billion by looting the Russian Treasury and taking bribes from foreign business interests.

When Gore read the CIA study, according to the *Times*, he sent it back to the Agency with “barnyard epithets” scribbled across the cover page. The message from Gore to the CIA was clear: “Don’t go there!”

Elements of this bribery scandal, involving the subversion of U.S. policy towards Moscow, appeared in the media. But nowhere has the full extent of the Vice President’s impeachable activities been documented — until now.

### “Wannabe Presidents”

At the beginning of January, 1999, a well-placed European source informed the EIRN news service that, when Gore and Prime Minister Chernomyrdin met in Washington, D.C. on March 10-12, 1998, during a meeting of the bilateral commission which the two men co-chaired since 1993, a deal was consolidated between the two “wannabe Presidents” to secure each other’s ascent to power, using any means necessary.

The source added a crucial piece to the emerging picture of Gore, President Clinton’s so-called “loyal” partner, as a leading “inside” player in the insurrection against the Clinton Presidency. This would place him in league with Newt Gingrich, Trent Lott, and the Hollinger Corporation British Crown media cartel.

Sources in Washington had long underscored the fact that the Vice President had joined forces with former Presidential campaign adviser Dick Morris, and with hard-core “Conservative Revolution” Congressional Republicans to trap the President into backing The Contract on America’s murderous “welfare to workfare” plan. When President Clinton failed to veto the bill when it passed Congress in August 1996, the stage was set for the Republicans to retain control of both

Houses of Congress in the 1996 elections.

Had the Democratic Party fought, as urged by Senators Edward Kennedy (D-MA), Tom Daschle (D-SD), Jeff Bingaman (D-NM), Reps. Dick Gephardt (D-MO) and David Obey (D-Wisc), and, most emphatically, Lyndon LaRouche [whose organization originally published this article—Ed.], for a revival of the FDR-JFK policies and a mobilization of the traditional constituency of the party, the Democrats would almost certainly have won back control of the Congress in November 1996. The Clinton impeachment bandwagon would have gone over a cliff.

### The Phone Calls

Gore’s ham-fisted intervention to get Chernomyrdin his old job back began in earnest on August 23, 1998. Yeltsin had abruptly fired Prime Minister Kiriyenko one day before he was to announce new economic measures, and five days after the Russian debt freeze had sent shocks through the international financial community, causing near-instantaneous shutdown of worldwide lending by capital markets.

The Vice President was on vacation in Hawaii as the Russia crisis began to blow. President Clinton had just gone through the Starr grand jury testimony, and he was arriving for his vacation in Martha’s Vineyard, Mass.

Unbeknownst to the President, Gore held a series of phone discussions with Chernomyrdin, Kiriyenko, and Yeltsin. Sources have revealed to EIRNS that Gore questioned Kiriyenko and Chernomyrdin on their commitment to honor Russia’s foreign debts. Kiriyenko was evasive, while Chernomyrdin assured his partner-in-crime he’d pay in full — no matter the cost to the Russian people. Gore, seeming to speak for the Clinton administration, pressed Yeltsin to bring back Chernomyrdin; Yeltsin did.

Highly reliable sources told EIRNS that when Clinton learned about Gore’s Hawaiian diplomacy, he hit the ceiling. Gore had not even bothered to inform the President of his actions, until he had already spoken

with the Russian principals. Gore spoke to Chernomyrdin at least three times on August 23 alone.

There is compelling evidence that Gore was acting on behalf of Soros, Shaw, and

Fuerth have been pushing to get Clinton into a senseless military showdown with Saddam Hussein. They have used the Principals Committee, a Cabinet working group that excludes the President, to set Clinton up for conflict with Saddam.

On two occasions — in February and November 1998 — President Clinton had to buck the majority of his advisers and opt for a peaceful solution to an orchestrated showdown with the easily provoked and manipulated Iraqi leader. When Clinton decided, on Nov. 15, 1998, to call off planned bombings of Iraq, Gore, Fuerth, British Prime Minister Tony Blair, and the entire Hollinger Corp. apparatus went berserk. From that moment on, the financial oligarchy decided that there was no turning back. Clinton had to go, and there would be a military confrontation with Saddam.

- With President Clinton pinned down in Washington in November 1998 trying to extricate himself from the Iraq trap, it was Vice President Al Gore who was sent in his place to Kuala Lumpur, Malaysia, for the meeting of the Asia Pacific Economic Council (APEC) forum. Once there, Gore staged an unusual and vicious public intervention against the conference host, Malaysian Prime Minister Mahathir Mohammed.

Significantly, Mahathir had been in a highly-publicized war of words with Wall Street speculator George Soros since September 1997, when he singled out Soros as the man behind the looting of the “Asian Tiger” economies through currency speculation and other financial warfare. *The Wall Street Journal*, one of the leading anti-Clinton publications in the U.S., actually accused Mahathir of getting his information on Soros from Lyndon LaRouche.

Shortly before the APEC meeting, Mahathir had imposed capital and exchange controls to save his country from further ravaging by Soros, et al. His move was backed by both China and Japan [and opposed by Gore’s Wall Street backers—Ed.]

Gore’s outburst against Mahathir in Kuala Lumpur did severe damage to U.S. prestige in Asia, and threatens to wreck Clinton’s greatest achievement as President: the initiation of a strategic partnership with China aimed at bringing peace and prosperity to the Asia-Pacific region for the 21st century.

### **The Gore “Card”**

President Clinton’s most fanatical enemies are dying to see Al Gore in the Oval Office. Some, like *The Weekly Standard*’s William Kristol, have endorsed Gore in writing. The majority are simply moving to finish off Clinton politically in the days ahead.

A probe of the matters presented here would almost certainly lead to Gore’s impeachment and his elimination as a contender for the 2000 Democratic Presidential nomination. ## Y2K Mobilization Planned

• Reporter David M. Bresnahan warns that plans are underway to call out the entire National Guard in the event that computer failures from the so-called "Y2K bug" cause serious disruptions of America's power, communications, transportation, and banking systems. According to Bresnahan, COMEX/MOBEX, an exercise to practice a full mobilization of all 480,000 members of the National Guard, will take place on May 1, 1999. The call out will be done "without the use of phones, television, or radio," on the assumption that these means of communication may be disrupted by the Y2K bug. Meetings at the National Guard Bureau to plan ways to deal with the Y2K threat (including possible "civil unrest and riots") began in the fall of 1998, according to Bresnahan's sources. These sources also indicate that officials are considering a National New Years Eve Party for all Guard members to be held in each National Guard Armory on December 31, 1999. This would simplify a Guard recall in the event of a Y2K disaster. "If nothing happens, then it's a big ass party," noted one unidentified Guard member, "But if everything goes to hell in a hand-basket, I can promise you the party will be over quickly." ## Break-Ins at D.C. Pollster

• In January, 1999, burglars twice broke into the Capitol Hill office of a polling firm working for Israeli Prime Minister Benjamin Netanyahu's leading opponent, Ehud Barak. The break-ins at Greenberg Quinlan Research, Inc. targeted the firm's Barak files, including questionnaires, surveys, and strategies. Barak, a retired army general, is considered to have the best chance of beating Netanyahu in the upcoming elections on May 17. Also, in Israel, at least six Barak advisers and staff members have had their homes burglarized in what Barak campaign adviser Alon Pinkas has called efforts at "intimidation." After the second Washington burglary, which involved the quick disabling of a sophisticated security system installed after the first break,

Pinkas stated, "We hereby declare the demise of the coincidence theory," but fell short of accusing Netanyahu of direct involvement in or knowledge of the break-ins. In a sidenote which may be of greater significance, Greenberg Quinlan has also done polling for President Clinton, and Clinton campaign adviser James Carville is now working for the Barak campaign. (*Washington Post*)

## Navy Assassination Program Alleged

• Although military training is by definition behavior modification for the purpose of killing, recent revelations made at a NATO conference in Norway are disturbing nonetheless. At the Oslo conference of 120 psychologists, U.S. Navy Commander Thomas Narut claimed that the Office of Naval Intelligence (ONI) had taken convicted murderers from military prisons, used behavior modification techniques on them, and then placed them in American embassies worldwide. Dr. Narut, of the U.S. Regional Medical Center in Naples, Italy, described the men who went through his program as "hit men and assassins" who could kill on command.

According to Dr. Narut, the assassins, who have been used in several covert operations, were conditioned through "audio-video desensitization." This process, conducted at training centers in Naples, Italy and San Diego, California, involved forcing the trainees to watch films of people being injured and killed in increasingly violent and bloody ways. In a description reminiscent of Anthony Burgess' *A Clockwork Orange*, Dr. Narut stated that during the desensitization programming, restraints were used on the subjects' bodies and eyelids to force them to view the films. The Navy has emphatically denied Dr. Narut's allegations, and has suggested that his conference remarks should be discounted due to unspecified "personal problems." (*London Sunday Times*)

### **Air Force Jets Linked to Poisonings, Weather Modification**

- Environmental journalist Will Thomas [author of “Target Ozone: Project HAARP” in PARANOIA Issue 10] reported in late January that “hospital emergency rooms are filled to overflowing” with a nationwide “epidemic” of mysterious respiratory illnesses. The illnesses have followed “massive jet-spray operations” involving what Thomas contends are U.S. Air Force refueling aircraft. The nationwide “spraying” has taken the form of large X and grid patterns woven across the sky “like Tic-tac-toe,” according to eyewitnesses. Adding to the mystery, violent and unseasonable storms (such as the record January tornadoes over Tennessee) have occurred within days of the sprayings. In addition, Thomas reports that sharp spikes in the power output from the government’s ionospheric “heater” known as Project HAARP may be linked to the sprayings. (www.islandnet.com/~wilco)

### **Feds to Use License Photos in National “Mug Shot” Database**

- A federally-run database of all the states’ digital driver’s license photographs was proposed by President Clinton in his 1999 State of the Union Address. The plan is elaborated by a Department of Transportation booklet for law enforcement, “The Highway Safety Deskbook.” It notes that, “With a central image database of every driver in a state, the public safety community has a ready-made storehouse of photos to be used in criminal investigations.” With no apparent concern, the Department booklet goes on to declare that, “The uses for these images are limited only by the wants and needs of the public safety community.” This apparently includes the Secret Service, which is quietly assisting a New Hampshire company in building the national database. As digital facial-recognition technology advances, we can only guess at how our federal “digital mug shots” will be used.

### **Area 51 Lawsuit Squashed by Supreme Court**

- In November, 1998, the U.S. Supreme Court turned away an appeal by workers at the Nevada Air Force base popularly known as Area 51, effectively killing their lawsuit. The employees had alleged that they or their deceased spouses were exposed to harmful levels of hazardous substances at the facility. A federal judge had earlier dismissed the lawsuit, an action upheld by a U.S. Appeals Court. Invoking the legal privilege afforded by the “secret” nature of Area 51, the appeals court declared that the workers and

their widows were not even entitled to learn what dangerous substances exist at Area 51 and how they are handled. The appeals court also ruled that the results of a federal inspection and even the facility’s name could not be disclosed to the Plaintiff’s attorneys. The lawsuit, filed against the Department of Defense and the Environmental Protection Agency, had alleged that huge amounts of hazardous materials were routinely burned illegally at the site in open trenches. Area 51 has long been the subject of speculation among UFO researchers as a test site for highly-advanced and possibly extraterrestrial flight technologies. (*Associated Press*)

### **Former Alltel Executive Found Dead**

- The former president and chairman of the board of the Arkansas company Alltel was found shot to death in November, 1998. The death of Charles Wilbourne Miller, 63, was ruled a suicide. Circumstances were such that Miller would have had to carry both a handgun and a shotgun approximately 300 yards down the road from his home, enter a water-filled pit, and expend two rounds from the .357 handgun before using it to shoot himself in the head. It is possible, though by no means certain, that a further investigation of the death could reveal a web linking Alltel, Vince Foster, the Rose Law Firm, BCCI, and the National Security Agency.

In the 1980s, the banking software company known as Systematics became part of Alltel, in a deal arranged by Systematics’ financier and Arkansas billionaire Jackson Stephens. During the time when Miller was running Alltel (then called Allied Telephone), his subsidiary Systematics was allegedly involved in money-laundering for the intelligence community. This and other allegations were made in the article “Fostergate” by *Forbes* magazine senior editor James Norman, which was pulled at the last minute and eventually published in the magazine *Media Bypass*. According to the article, the late Vincent Foster had been “a silent, behind-the-scenes overseer on behalf of the NSA (National Security Agency) of a small Little Rock, Arkansas bank data-processing company,” Systematics, Inc. The article further claimed that, “having taken over the computer rooms in scores of small U.S. banks as their ‘outsourced’ supplier of data-processing, Systematics was in a unique position to manage the covert money flow.”

The article also states that in 1978 Jackson Stephens tried to take over the Washington-based Financial General Bankshares “on behalf of the Arab backers of the Bank of Credit and Commerce International (BCCI).” In addition, a lawsuit filed by the Securities and Exchange Commission (SEC) regarding the attempted takeover noted that Stephens “insisted on having the then-tiny Systematics brought in to take over all the bank’s data

processing.” The takeover failed, despite the efforts of Systematics’ two attorneys in the 1978 SEC case: Hillary Rodham Clinton and Webster Hubble. Another connection between Systematics and the Rose Law Firm was Firm partner William Kennedy, whose father was a Systematics board member. Finally, it is known that Systematics’ Jackson Stephens was a major backer of Bill Clinton, and was an associate of Bill, Hillary, and Vince Foster.

However, the fact remains that foul play in the deaths of Vincent Foster and, now, Charles Wilbourne Miller, has never been proven. Indeed, the Foster family, Kenneth Starr, and Starr’s predecessor Robert Fiske, Jr., have all concluded that the Foster death was a suicide. Most importantly, any conspiracy theory involving Systematics hinges on whether the company was in fact involved in managing the flow of covert money. At this point, we have only the spiked *Forbes* article’s un-named “sources” to support the allegation. On the other hand, BCCI’s links to global intelligence agencies have been documented. If Jackson Stephens attempted a bank takeover in 1978 on BCCI’s behalf, and further attempted to make Systematics that banks’ data processing supplier, at least some of the dots begin to connect. For its part, Systematics has through its spokesman called the conspiracy theories revolving around its operations “complete and utter nonsense.”

### **DNA Test Says Clinton Isn’t Boy’s Father**

- Back in 1992, *PARANOIA* published a photograph of a boy purported to be Bill Clinton’s half-black son, Danny Williams. Seven years later, in January 1999, the mainstream media reported on Danny and his mother Bobbie Ann. Ms. Williams has claimed for years that Clinton fathered the child during a sex-for-money encounter. She also alleged that she used cocaine with the then-Governor. Although the boy does bear a definite resemblance to the President, DNA tests have now shown that the boy is not Clinton’s son. *The Star* tabloid conducted the paternity tests in an attempt to prove Williams’ story. Although the tests were conclusive, they were questioned by internet reporter Carl Limbacher, who has theorized that the President’s DNA sequence was altered by the FBI for national security reasons prior to its publication in the Starr Report. ([www.NewsMax.com](http://www.NewsMax.com))

### **Masons, Racists, vs. Bill Clinton**

- The judicial panel which appointed Kenneth Starr in 1994 as the Whitewater independent counsel was headed by a Mason, and several House and Senate Judiciary Committee members are also part of the elite secret society. In 1992, Chief Justice William Rehnquist appointed David Sentelle to head the three-judge “Independent Counsel” panel. Previously, in 1987, Sentelle’s nomination to the federal appeals court of the District of Columbia was the focus of controversy when it was

revealed that Sentelle was a member of a “whites only” Masonic lodge. At that time, Senator Jesse Helms of North Carolina declared that he was “aghast” that Sentelle’s membership in a Masonic lodge had even become a matter of discussion. Senator Strom Thurmond, then the Chairman of the Senate Judiciary Committee, stated that he was “astounded” that the question was being raised. (Both Senators are 33rd Degree Masons.)

In addition, two of Clinton’s leading Congressional opponents, Representative Bob Barr and Senator Trent Lott, have ties to a racist organization called the Council of Conservative Citizens (CCC). Barr gave a keynote address to the group in June, 1998, while Lott spoke before the group in 1992. At that time, Lott declared that the CCC “stand[s] for the right principles and the right philosophy.” Furthermore, Lott met with CCC leaders in his Senate office as late as 1997. The CCC believes that racial intermarriage “amounts to white genocide” and that the “liberal media” are promoting interracial intimacy because many news stations have “black and white newscasters of opposite sexes.”

Masonry and racism have a historical link. The Ku Klux Klan was founded by Albert Pike, who served as Grand Master of the Southern Jurisdiction of the Scottish Rite from 1859-1891. Some historians contend that members of the Southern Jurisdiction of Masonry, acting as agents of Great Britain, were at the center of the Southern Confederacy and its attempt to split the United States during the Civil War. (*Richmond Times-Dispatch* and *New Federalist*)

### **U.S. Scientists Had AIDs Blood in 1976**

- Thanks to Dr. Alan Cantwell for reporting this little-noticed AIDS revelation. According to *Level 4: Virus Hunters of the CDC* by Dr. Joseph McCormick (1996), blood serum samples stored since 1976 at the U.S. Centers for Disease Control (CDC) are now known to have contained the HIV virus.

Collected from Africans exposed to the Ebola virus in a remote area of Zaire, some of these samples tested positive for HIV in the 1980s. Thus, two years before the U.S. AIDS epidemic began, HIV-positive African blood was in the hands of American virologists, and possibly scientists conducting biowarfare research as well. The HIV- and Ebola-contaminated serum samples were undoubtedly used for animal experimentation, and could have contaminated chimpanzees and green monkeys used in the development and manufacture of vaccines at that time. Significantly, a major vaccination program against hepatitis B was conducted among gay men in the United States in 1978, and a major smallpox vaccination program was conducted in Africa around the same time. •

# Lawsuit Alleges FEMA Funded by Laundered Drug Profits

**S**peculation about the mysterious origin and funding of the so-called Federal Emergency Management Agency (FEMA) has continued for decades.

The history of FEMA as an illegal and unconstitutional entity has been most recently exposed in an unprecedented lawsuit against the CIA and its alleged drug trafficking and money laundering operations.

In September 1998 a \$63 million lawsuit (Case No. 98CV11829JLT) was filed by Massachusetts attorney Ray Kohlman on behalf of former Green Beret Bill Tyree. Kohlman, a former legal investigator for attorney William Pepper in the Martin Luther King murder trial of James Earl Ray, filed a 101-page complaint on behalf of his client.

The suit, replete with five inches of affidavits and appendices, names the Central Intelligence Agency, Massachusetts Governor Paul Celucci, former Massachusetts Attorney-General Scott Harshbarger, former CIA director and US President George Bush and self-admitted government assassin D. Gene Tatum as

defendants in a far-reaching case involving US Government sanctioned drug smuggling, murder, and cover-up.

Bill Tyree is currently serving a life sentence for the murder of his wife – a case eerily similar to that of Dr. Jeffrey McDonald, a Ft. Bragg doctor who was framed for the murder of his wife and children in the early 1980s. In his newsletter *From the Wilderness*, former LAPD officer Mike Ruppert writes:

“In the mid 1970s, while serving in Panama, Tyree and other Green Berets were led into Colombia under the command of Green Beret Colonels Corone and Baker to plant radio beacons, so that plane loads of cocaine could fly below Colombian and US radar, and land undetected in Panama.”

“Orders for these missions came from the CIA’s Ed Wilson and Tom Clines,” continues Ruppert. “Tyree had been a part of many secret missions and was losing his taste for it. His wife was keeping a diary [for which she was presumably murdered, and which later disappeared].”

Ruppert also writes:

“Five Special Forces Colonels – Corone, Baker, Malvesti, Rower and Bayard – have died under mysterious circumstances since. The heart of the Tyree documentation consists of an affidavit allegedly written by

Colonel Carone who was also Tyree's commanding officer at Fort Devens, Mass. at the time of Tyree's arrest. Both were then with the 10th Special Forces."

"That fifteen page document gives precise details of CIA drug operations using Special Forces personnel. It also describes how Tyree was framed for the murder of his wife and how Special Forces personnel were used to intimidate and conduct illegal electronic and physical surveillance of anyone who might expose CIA drug dealing." (*From the Wilderness*, P. O. Box 6061-350, Sherman Oaks, CA 91413, <http://www.copvcia.com>).

According to the lawsuit, "the Plaintiff [Tyree] alleges that the Defendants CIA and George Bush were negligent and failed at the conclusion of Operation Watchtower to monitor the post-Watchtower events and seek legal congressional funding for the origination of FEMA (Federal Emergency Management Agency). This failure led to the concealment and cover-up of Operation Watchtower, written about in the diaries of Elaine Tyree, seized illegally and turned over to Colonel Carone and then to the CIA, which ensured that the Operation Watchtower drug trafficking operation would remain covert, allowing the drug profits from this Operation to be used to circumvent Congress and fund FEMA and continue the pattern of criminal activity."

Colonel Carone, who died in 1990, was an alleged CIA paymaster and Mafia-connected money launderer, who incidentally held the rank of full colonel in Army Intelligence. As Oliver North's bagman, he also transported large amounts of cash in and out of the country.

### Carone's Complex Relationships

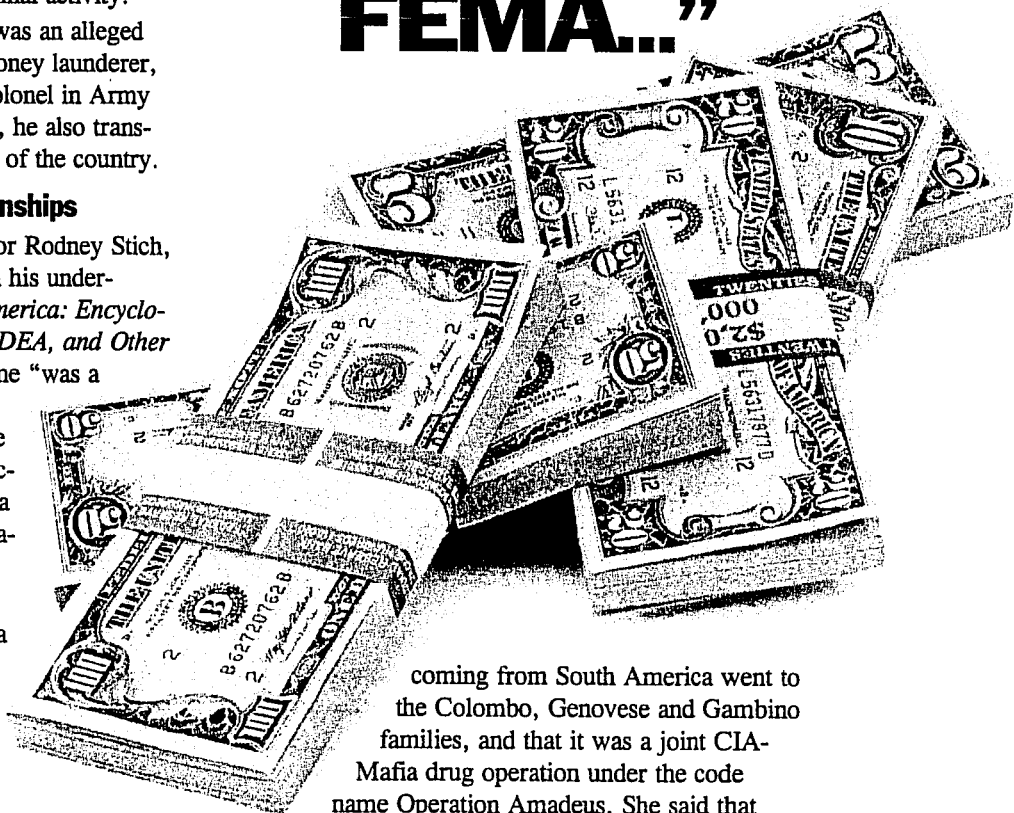
According to former FAA investigator Rodney Stich, "Carone had complex relationships." In his underground best-selling book *Defrauding America: Encyclopedia of Secret Operations by the CIA, DEA, and Other Covert Agencies*, Stich writes that Carone "was a member of the Gambino family with connections to other crime groups in the eastern part of the United States, a detective on the New York City vice squad, a member of the military and a CIA operative."

Stich writes that "Dee [Ferdinand, Carone's daughter] said her father was a detective and bagman in the New York City police department, collecting money that was distributed to captains and inspectors as payoffs for looking the other way where drugs were involved..."

Stich goes on to write:

"Referring to CIA-Mafia drug trafficking, she said she knew from what her father said that the drugs

coming from South America went to the Colombo, Genovese and Gambino families, and that it was a joint CIA-Mafia drug operation under the code name Operation Amadeus. She said that during World War II, Operation Amadeus was involved in transporting Nazi officers from Germany into South American countries. According to her father's notes, Operation Amadeus split into several other

operations, including Operation Sunrise and Operation Watchtower.”

Tyree’s lawsuit alleges “[a] cover-up of Operation Watchtower, which was one of several illegal drug operations that produced a profit which was used in turn to help originate and implement FEMA. [FEMA is a violation of the Constitutional] Separation of powers: the executive branch brought about an agency (i.e. FEMA) which has the authority to suspend the US Constitution, (e.g. further suspending legislative and judicial branches), but is vague in its verbiage as to what does constitute an emergency and fails to list what, if any duties, the legislature and judiciary will have to perform if the US Constitution is suspended.”

Even though the origin of FEMA has remained historically unclear, Tyree’s lawsuit alleges that FEMA, created by Executive Order, is illegitimate “since Congress had to approve FEMA for two specific reasons: (1) FEMA is a vaguely written Executive Branch-created agency that has the power to suspend the US Constitution and put the legislative and judicial branches of government out of work; (2) FEMA is an Executive Branch creation that clearly affects the branches of Government capable of silencing the voice of the people, (i.e. legislative) and the legal redress of the people, (i.e. judiciary).”

FEMA was allegedly created by Executive Order 12148, which became law simply by its publication in the Federal Registry. In other words, Congress was bypassed for FEMA’s authorization as well as its funding. But if Congress never authorized the “agency,” where do operational expenses come from? Tyree’s lawsuit alleges that laundered drug profits were the initial source of funding.

According to the lawsuit, “the Plaintiff alleges the Defendants CIA and George Bush did intentionally engage in the complained of conduct herein to conceal: (1) the origins of FEMA and that profits from drug trafficking by the CIA were used in some part to originally fund FEMA and the drafting of the FEMA infrastructure.”

### Two FEMAs?

In an even more astounding allegation, the lawsuit claims that Colonel Carone told the Plaintiff that “Colonel Ollie North worked on developing a plan known as FEMA, which would in an ill-defined national emergency, allow the US Military to take control of the United States to ensure National Security” and that Colonel Carone said that “FEMA” originally stood for “Federal Emergency Military Action.” (i.e. Martial Law), but was retitled Federal Emergency Management Agency because it would

be better received by the people of the United States.

The late Colonel Carone also claimed that “he took drug profits that were clean and laundered in 1982-1984 to NSC Colonel Oliver North, who used the funds to create and develop FEMA.” [p. 88 of the lawsuit]

Colonel Carone also testified in the lawsuit that “FEMA was one of those off-the-shelf creations that was funded through the giant black operations fund which came about from drug trafficking operations instituted by the CIA, which Congress has no idea of and no control over.” Further, he testified that “the FEMA Chain of Command, rules and regulations that he had seen violated the US Constitution, and actually established a succession to the Office of the President in the event of an emergency that circumvented the Vice President and the Speaker of the House of Representatives.”

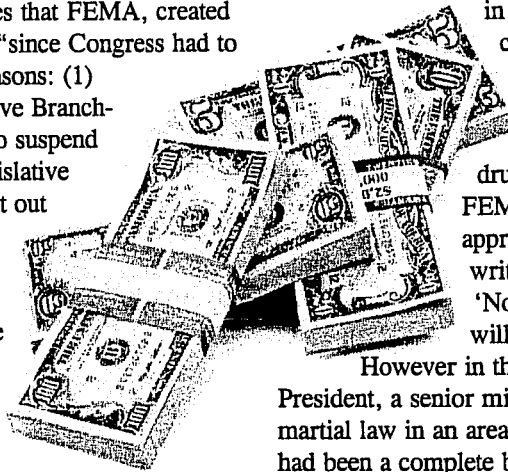
Carone said, “NSC used drug trafficking profits to start FEMA without congressional approval... a 1981 NSC Directive written by Frank Carlucci [states]: ‘Normally a state of martial law will be proclaimed by the President.

However in the absence of such action by the President, a senior military commander may impose martial law in an area of his command where there had been a complete breakdown in the exercise of government functions by local authorities.’”

In addition, Colonel Carone said a literal interpretation of the 1981 NSC Directive was that “a local yokel national guard commander could institute martial law, and the actions of FEMA, without local citizens ever knowing how FEMA came to be, or what FEMA was originally intended to be about, would automatically be triggered without any type of presidential order... Congress doesn’t even have the purse strings on this one. It’s all from the Black Operations Fund which Congress will never force the US Intelligence Community to admit even exists.”

None dare call it fascism, but due to this explosive lawsuit, the origin of FEMA and its funding may finally be known. On the other hand, don’t hold your breath. If this lawsuit escapes the black hole of so-called “national security law” or the clutches of a corrupt judiciary, it will be a major miracle. •

# THE MEANING OF LIGHT

A Synopsis of Extra-Terrestrial  
Intentions and Methods

In the first week of December 1995, I made a significant breakthrough in understanding the extra-terrestrial phenomenon. three years ago when my wife and I came to the realization that we were being continually abducted by extra-terrestrials. At that time I knew very little about UFOs or the phenomenon of abduction.

In the past three years I have worked with over forty abductees and contactees, some of whom are close relatives. I have previously recorded the results of my work with some of these abductees in my first book, *The Programming of a Planet*. I discovered that abductees have often been abductees and contactees in many prior lifetimes. Sometimes abductees experience lifetimes in high-level positions in governments, secret societies, and religious sects. For example, I recovered some memories of a very revealing lifetime as Pharaoh Rameses II in which I met an extra-terrestrial by the name of Ra. One abductee that I worked with discovered that he too had been contacted by Ra in 1632 A.D., and was instructed on how to start a new religious sect and secret society.

Much of the following information, which I have acquired from my own past life memories, has been confirmed by other people's past life accounts as well as historical and archaeological records. Please forgive me for not being more self-conscious regarding the "high strangeness" and incredibility of this information. I have progressed beyond any personal desire to be accepted or believed. I am merely presenting the information that I know to be true. Anyone can verify my research results by conducting extensive research into the past lives and in-between lives phenomenon.

WARNING: WHAT YOU ARE ABOUT TO READ MAY TRIGGER PAST LIFE TRAUMA.

I learned from my past life as Rameses II that the Eye of Ra was what we Egyptians called Ra's flying saucer. Ra is a human-looking ET with a beard. He works in consort with Thoth and the ancient "Goddess" Isis (Ishtar). Their symbol is a staff with a snake (or two snakes) coiled around it. They purportedly hail from the Pleiades star cluster, which is located in the constellation of Taurus. I therefore refer to this group as the Serpent Staff Pleiadians, or SSPs. (As in all cases with ETs, there is no way we can substantiate where they actually come from.)

Ra's M.O. was to land his "eye" on Earth and convince people that he was God (which was not difficult to do in ancient times). Any other ETs who were also aboard his craft would also claim to be gods and goddesses. The three most influential ETs were Ra, Isis, and Thoth. These ETs were the source of ancient "mythology." It appears that their "eye" can move through time as well as space. This explains why they were able to establish various religions and secret societies throughout history over the entire planet.

The Egyptian "God" Ra was also known by such names as Zeus (Greek), Marduk (Babylonian), Thor (Nordic), Ahura Mazda/Mithra (Persian), Ashur (Assyrian), El/Baal (Canaanite), Jehovah/Yahweh (Is-Ra-El-ite), and Indra (Indian). The Egyptian "God" Thoth was known as Hermes (Greek), Mercury (Roman), and *Queztalcoatl* (Aztec word for "feathered serpent," this word may have also applied to Ra).

The Egyptian "Goddess" Isis was also known as Ishtar (Babylonian), Inanna (Sumerian), Ashtoreth (Canaanite), Hathor (Egyptian), Aphrodite/Athena/Hecate (Greek), Cybele (Phrygian), Shakti/Kali-Ma (Indian), Freya (Nordic), Venus (Roman), et al. These ETs created all the major religions on the planet, and established secret societies within these religions. In ancient times the outer, public religion was known as the "Lesser Mystery," and the inner secret society was known as the "Greater Mysteries." Ra's job was to fly around and put the "fear of God" into people. Thoth's primary job was to establish and perpetuate insidious secret societies and to teach naive votaries how to achieve immortality of the physical body as well as the soul.

### **The Brotherhood of the Snake**

In Egypt, Ra and Thoth established the initiation of the "Brotherhood of the Snake." When I was embodied as Pharaoh Rameses II, Ra ordered me to travel (from Thebes) to the Great Pyramid at Giza to be initiated into the Brothers of the Snake. The purported purpose of this initiation was to obtain immortality. This didn't just mean immortality as a spiritual being, but also meant immortality of one's physical body. The SSPs used this deceptive ploy of physical body immortality as a carrot to enlist votaries in ancient civilizations as well as in modern times.

The Brotherhood of the Snake initiation in the Great Pyramid began with the Eucharist of Osiris. I ate a hard biscuit made of wheat and drank ale from a chalice. The biscuit represented the body of Osiris and the ale represented his blood. In actuality, this

ritual was the heart of the Egyptian religion, and was practiced by all Egyptians as the Lesser Mystery. Osiris represented immortality, and so the initiates believed that they, too, would become immortal by partaking in the Eucharist. Osiris was the predecessor of Christ. Even today many Christians believe that they will be taken bodily up into heaven and live forever. [The Roman government (Justinian) made it illegal to believe in the "prior existence of souls" (reincarnation) in 553 A.D.]

As an initiate of the Brothers of the Snake, I then lay on the top of the sarcophagus in the Great Pyramid while the priests walked counterclockwise around it. (This is the origin of the Masonic ritual of circumambulation.) I then walked to another room where I walked up some steps surrounding a throne. I sat on the throne and drank a powerful drug from a chalice. I stood up again and stumbled down the steps, disoriented and hallucinating. I ended up on my back on the floor by the steps, totally incapacitated. They picked me up, carried me back to the sarcophagus room, and laid me inside the sarcophagus, and the stone slab was placed back on top of the sarcophagus. At this point I left my body.

After a while I re-entered my body as they raised me out of the sarcophagus. I stood by the end of the sarcophagus—still recovering from the effect of the drug—and watched a priest sacrifice a woman on the slab. The priest cut her heart out and held it against my lips so that I could drink her blood. [Note: This is not a complete description of the Brotherhood of the Snake initiation.] The SSPs taught—in the inner Mysteries—that it was necessary to drink the blood of a living human in order to obtain immortality. This rite was also later practiced by the Aztecs and, I have discovered, the very same ritual was practiced 12,389 years ago in Atlantis.

The Brotherhood of the Snake initiation is the basis of Freemasonic rituals (and other secret societies) as well as modern Satanic rituals. Surrounding this ritual is the Isis-Osiris-Horus-Set myth, which I will not expound upon here, except to point out that Set was the deceptive usurper, and the word "Satan" is a cognate of "Set" (also spelled Seth). The Satanic symbol of the baphomet, or Boat of Mendes, was derived from the ritual practice of public fornication with a goat in the city of Mendes.

## The Programming of a Planet

The Serpent Staff ETs created religions and secret societies for three major reasons as I now understand it:

(1) The purpose of religions is to keep people from discovering the

real truth about the plight of Earth-bound humans and the real meaning of the LIGHT. Dead-end religious practices keep people distracted so they won't discover what's really going on. It is analogous to the old

magician's trick of distracting the attention of the unsuspecting audience with one hand while performing the "magic" trick with the other. Also, the creation of many different religions helps perpetuate disunity and conflict amongst the peoples of Earth. Thus, people are too occupied with basic survival needs to spend much time seeking the truth.

(2) Ra, Ishtar, and Thoth created secret societies to infiltrate governments and create war and chaos. This is the inner meaning of the symbol and motto of 33 degree Masonry. The symbol is a two-headed eagle clutching a sword; the motto is Order Out Of Chaos.

(3) Another major purpose of the SSPs, which is most pertinent here, is to program Earthlings to worship the LIGHT. The Serpent Staff Pleiadians have enormously and perniciously affected the history of this planet in so many ways. The three salient points listed above certainly do not encompass the entirety of the ramifications of their insidious machinations.

The worship of the Sun God was very prevalent in ancient times all around the planet. In Egypt, Ra was the SUN God as well as the SON of God. His father was Ptah. The sun, of course, brought LIGHT. Ra, under his various names in many cultures, was the Lord of LIGHT, the LIGHT of God, the Bringer of the Dawn, Lucifer the LIGHTbearer. This is the inner meaning of the Masonic

All Seeing Eye above the pyramid on the reverse side of the Great Seal of the United States. The secret destiny of America is to become the "New Atlantis." A totalitarian one world government (New World

Order) is one of the primary goals of secret societies.

The three "LIGHTS" of the Masonic lodge are the Sun, Moon, and Mercury, which represent respectively Ra, Isis, and Thoth. 33rd Degree Mason Albert Pike refers to Masons as "Children of the Light." The secret society called "Illuminati" reflects the symbolism of light and illumination. "Illumination" is a deceptive concept of the SSPs; it means the opposite of what we think it means.

The universal symbol of the Sun God all around the globe was a point within a circle. This was also the Egyptian symbol for Ra, the symbol for the Illuminati, and a symbol of Freemasonry. Coincidence?

## The Light Workers

The New Age movement also originated with these Staff Serpent Pleiadians, although most New Agers are not cognizant of this fact. Many New Agers refer to themselves as "Light Workers," especially those who cling to the teachings of channeled entities. Thoth (Hermes) is purportedly the originator of alchemy, astrology, numerology, magic, metaphysics—all of which are major components of modern metaphysical/New Age groups. New Age channels often relay messages from "Ra," "Ptaah," and "Pleiadians," who refer to their votaries as "Family of Light."

New Agers often report being attracted to ancient Egyptian life and religion. Trance channel/contactee Barbara Marciniak visited the Great Pyramid and other "sacred" sites in 1988. Soon afterward she was contacted by "Pleiadians" while meditating on the King's Chamber of the Great Pyramid. A modern prophet of "Earth changes," Gordon Michael Scallion, now claims to be in contact with Thoth. A man who goes by the name of Drunvalo Melchizedek also reports being

contacted by Thoth, who—not surprisingly—is still teaching physical body immortality (amongst other lies).

In metaphysical circles it is considered beneficial to surround oneself in white light and to “go to the light” after death. The “Great White Brotherhood” and “Ascended Masters” are simply cover names for ETs who manipulate people’s beliefs regarding spiritual or metaphysical phenomena. If Ra were to land his “Eye” in America today, we would probably think it quite comical to hear him claim that he is God. What worked in ancient times would not work today, so now the SSPs disseminate their lies as unseen channeled entities. It is not a coincidence that most channelers are also abductees.

Most New Agers believe Ra and Thoth are benevolent beings. However, I fail to see any redeeming value in the practice of cannibalism, war, chaos, sexual perversion, hallucinogenic drugs (poison), and Satanic rituals—all of which are direct products of the Ra/Ishtar/Thoth ET group.

So why have the Serpent Staff Pleiadians been conspiring for such a long time to keep Earthbound humans’ attention on the LIGHT? Does this have anything to do with the near death experiences in which people leave their bodies and go toward the light? To answer this question I must first introduce a phenomenon that I have repeatedly encountered during abductions by Grays and Reptilians.

### **In a White Room at the Implant Station**

During many abductions into spacecraft, I recall being taken into a room filled with a thick, foggy, white light. It is so thick that one can barely discern someone standing two feet away (unless they have two big black eyes that stand out in the contrasting white light). I even

encountered this type of room in the secret underground military base that I was abducted into in July of 1994. I speculated initially that this was a room to disinfect the abductee in order to prevent the exchange of bacteria and viruses between aliens and humans.

However, I recently uncovered a past life abduction which occurred in 1942 in which the airplane I was flying was beamed up into a very large Reptilian ship. They yanked me out of my airplane, took me to an adjoining room, and strapped me into a metal chair. An electronic torture device that looked like a television studio camera hit me with bursts of white light. The powerful blasts of energy eventually overwhelmed me and drained my will power.

I was then taken to a large, adjacent room filled with a thick, misty, WHITE light. I was then programmed by the Reptilians to be aggressive, to like war, to want to kill, and that killing gives one power and strength. They told me (telepathically in German) that I was a “Chosen One,” that they would take care of me, I belong to them, and I’ll do their bidding. I was also told that I am to stay on Earth, Earth is my home, and will always be my home. I then realized that these white light rooms were used by Grays and Reptilians for programming posthypnotic suggestions and installing amnesia.

I was then taken to another white light room where I had to lie on a table, and I was spun around horizontally. This is another phenomenon that I’ve also encountered on alien Gray’s ships. I believe it is used to disorient the abductee in order to reinforce the amnesia. Before I uncovered this incident, I had been experiencing chronic fatigue for over a year. After I recounted and re-experienced this incident seven times in session, I suddenly found that my chronic

fatigue had completely vanished.

As I continued to open past life memories, I began to discover the phenomenon of going into extra-terrestrial implant stations between lifetimes. These implant stations are gargantuan mother ships that have very large white light programming rooms. After death one enters the implant station through a tunnel and toward the light at the end of a tunnel. The only alien beings that I have seen so far in these implant stations are a type of being that reminds me of a praying mantis. I don’t know what they are officially called, so I call them Insectoids, Mantis Men, or the Bug Boys. To understand the phenomenon of in-between lives implantation, I must first define what a “free being” is.

### **The Light at the End of the Tunnel**

A free being, from my experience, is a state of spiritual beingness whereby there exists no compulsion to be in a body or tendency to be stuck in a body. A free being is not stuck in the continual life and death reincarnation cycle. A free being can be in a body or not be in a body at will—he’s just not stuck in one. Up until 12,389 years ago I was a free being. I had been hanging around Earth for thousands of years until I got too close to an implant station. These implant stations have some type of tractor beam—apparently electronic in nature—that can paralyze and pull in a free being. I was pulled into the implant station through a tunnel. I traveled toward the LIGHT at the end of the tunnel.

After coming out of the tunnel and into the LIGHT, I was then electronically compressed (implanted) into a female human body by a device that radiated an overwhelmingly powerful white light force field. An insectoid then escorted me into a very large white light room. There were many other people (in bodies) aimlessly milling

around like zombies in this thick, misty, white light. I then heard very soothing, hypnotic programming in my mind. There was a command to "Sleep" and assurances like "We'll take care of you," and "Don't

worry." I was also given hypnotic amnesia commands like "Don't remember," "You have no past," "You will not need to remember your past," "Be here now," "Forget the past," "You will begin a new life in the LIGHT." and (most important) "You will always return to the LIGHT."

After being thoroughly inculcated, two insectoids escorted me to a large hangar area where there were many flying disks. When they walked me up the ramp of one of the ships, I was rather astonished to see that this particular ship was a carbon copy of Ra's ship. This ship, like Ra's ship, was very open on the inside, and it looked like a

theater-in-the-round. There was a pole in the middle of the craft that extended from the floor to the ceiling. The only difference is that this spacecraft lacked Ra's personal piece of furniture—a throne. The insectoids then "flew" me down to Atlantis where I ended up in a temple where I was sacrificed on top a stone sarcophagus. Ironically—but certainly not coincidentally—this was the same "Brotherhood of the Snake" ritual in which I was initiated over 7,000 years later.

I then left my body and automatically "reported in" at the same implant station, entering through a tunnel and traveling toward the LIGHT. Like a ping-pong ball, I bounced back to Atlantis (without a body) where I entered the body of a baby girl on her way out of her mother's womb—i.e., through the "tunnel" and towards the LIGHT at the end of the tunnel/birth canal. It has become obvious to me that these ETs have intentionally designed their programming methods and equipment to parallel the natural birthing process.

I have subsequently recovered the memories of many similar in-between lives incidents. In most cases, I am not put into a body while aboard the implant station, but rather I simply report in as a spiritual being and then bounce back to a hospital or wherever there is a mother-to-be in her last moments of labor. In another in-between lives incident (1312 A.D. in England) I rose about a half mile above the dungeon in which I had just been tortured to death, only to find a small, alien Gray's disk waiting for me. They "escorted" me to another area of the country where I entered the womb of a mother giving birth.

In my research I have uncovered considerable evidence that implicates

an elaborate conspiracy to keep mankind in spiritual darkness. The Grays, Reptilians, Insectoids, and Pleiadians are only four of the participating ET groups in this conspiracy. I have examined other Pleiadian sources (i.e., Ashtar Command, "Contact's" Hatonn, Semiase, channeled Pleiadians. etc.), and after comparing this information with extensive past life research, I find that all of the so-called Pleiadians—whether channeled or not—are disseminating disinformation that should not be trusted. In fact, I have yet to find any ETs who are telling the truth about what is really going on.

In-between lives implantation explains why people don't consciously remember their past lives. Amnesia is one of the primary tools used by ETs to enslave mankind and is also used in abductions. Of course, not everyone is abducted in their physical bodies during their lives on Earth. However, all the Earthbound humans who are stuck in the compulsive reincarnation cycle are sometimes abducted as spiritual beings after death due to this ubiquitous programming.

The bottom line is that Earth is a kind of prison planet. This does not mean, however, that we will always be trapped here. People can disable their programming by recalling these and other similar incidents with past life therapy. After a considerable amount of past life therapy, people can break free and leave this planet. •

# **The Finders?**

The following information is excerpted from a detailed report of an investigation into the "Finders" cult, which was coordinated between the offices of the United States Customs Service and the police departments of Tallahassee, Florida, Washington, DC and Reston, Virginia. It should be noted that allegations of child abuse, devil worship, and connections to intelligence agencies on the part of the Finders have never been proven in court.

**P**olice in Tallahassee received an anonymous telephone call on or about February 4, 1987, relative to the sighting of two well-dressed white men in Myers Park who were apparently tending to six dirty and unkempt children in the playground area. The men were standing near a 1980 blue Dodge van bearing Virginia tags. The children were covered with insect bites, and it appeared that they had not been bathed in days. Most of them were not wearing underwear. The inside of the vehicle was later described as foul-smelling, and was filled with maps, books, and letters; a mattress situated to the rear of the van suggested that all eight persons were living in it.

The men were arrested and charged with multiple counts of child abuse and were lodged in the Leon County Jail. Once in custody, the men were evasive in their answers to the police regarding the children, and stated only that they were the children's teachers. They insisted they were en route to Mexico to establish a school for brilliant children. They otherwise refused to identify themselves and kept silent.

Upon questioning, the children stated they had lived in tents in a commune in Washington, DC, and were going to Mexico to go to a school for "smart kids." The children could not adequately identify themselves or their custodians. The children were also unaware of the function and purpose of telephones, televisions, and toilets. In addition, they stated that they were not allowed to live indoors and were given food only as a reward.

Within a few days, the Tallahassee police were contacted by the Washington, DC Metropolitan Police Department indicating that the case in Tallahassee appeared to be strongly related to a case in the Washington area. The detective stated that the actions of the two men in custody in Tallahassee relative to the children might give this case enough probable cause for search warrants to search the premises allegedly occupied in DC by a cult group called the "Finders."

## Enter the U.S. Customs Service

On Thursday, February 5, 1987, the Duty Agent received a call from Special Agent of the USCS in Tallahassee seeking assistance in coordinating the case. He requested assistance in checking names, addresses and the vehicle through the Customs Child Pornography Unit database, stating that there was suspicion of the subjects being involved in supplying children for the production of child pornography in Mexico. Customs was interested in the case as a result of the Child Protection Act of 1984.

Computer checks on the names, addresses and vehicle registration through the Customs Child Pornography Unit database turned up negative. However, at this point, it was learned that Tallahassee police had discovered large quantities of records, computer disks, and a U.S. passport in the van. From some of these records the police had obtained tentative identification of the two adults and partial identification of the children. Furthermore, two Washington, DC addresses were ascertained. Search warrants were obtained to search these premises, and the U.S. Customs agents were invited to participate on these searches due to the possibility of violations of laws enforced by the Customs Service.

It was later discovered that detectives had initiated an investigation of these same premises in December of 1986, which resulted from earlier information regarding a cult known as the Finders. The Finders had allegedly operated various businesses out of a warehouse on 4th Street in the Northeast section, and allegedly housed children at another location in the Northwest section of the city. The informant had specifically described "blood rituals" and sexual orgies involving children, and a murder in which the Finders may have been involved.

Using the information which had previously been provided by an informant, Washington detectives were able to match up some of the children with the names of children alleged to be in the custody of the Finders. Furthermore, they were able to match the tentative identification of the two adults in custody with known members of the cult.

## The Premises are Searched

During the search of the living quarters, the detectives noted large quantities of children's toys and clothing, consisting of diapers and

clothing in the toddler to pre-school range. No children were found on the premises. Several subjects who were found on the premises were renting living space, and one was deemed to be connected to the group. Also on the premises was a "computer room" which contained several computers, printers, and volumes of documentation. Examination of the documents revealed detailed instructions for obtaining children for unspecified purposes. The instructions also included information on how to impregnate female members of the community, purchasing children, trading, and kidnapping.

There were also telex messages using MCI account numbers between a computer terminal believed to be located in the same room, and others located across the country, as well as foreign locations. One such telex specifically ordered the purchase of two children in Hong Kong to be arranged through a contact in the Chinese Embassy there. Another telex expressed interest in "bank secrecy" situations. Other documents identified interests in high-tech transfers to the United Kingdom, as well as information regarding various properties under control of the Finders, a keen interest in terrorism, explosives, and the evasion of law enforcement.

Also found in the computer room was a detailed summary of the events surrounding the arrest and custody of the two adults and six children in Tallahassee the previous night. There were also sets of instructions which appeared to be broadcast via a computer network advising the participants to "move the children" and keep them moving through jurisdictions, including instructions on how to avoid police attention.

The following day, Friday, February 6, 1987, the warehouse on 4th Street, N.E., was searched. There, numerous documents were

found to describe explicit sexual conduct between members of the community known as the Finders. There was also a large collection of photographs of unidentified persons, some nude, who were believed to be members of the Finders. There were numerous photographs of children, some nude, at least one of which was a photo of a child "on display," and which appeared to accentuate the child's genitals. One photo album contained a series of photos of adults and children dressed in white sheets participating in a "blood ritual." The ritual centered around the execution of at least two goats, and portrayed the execution, disembowelment, skinning and dismemberment of the goats at the hands of the children. This included the removal of the testes of a male goat, the discovery of a female goat's womb with baby goats inside, and the presentation of a goat's head to one of the children.

Further inspection of the premises disclosed numerous files relating to the activities of the organization in different parts of the world, including London, Germany, the Bahamas, Japan, Hong Kong, Malaysia, Africa, Costa Rica, and various European countries. There were also several passports found. There was a file labeled "Palestinian," and other files were identified by member name or project name. The projects appeared to be operated for commercial purposes under front names for the Finders.

Included also were files on private families unrelated to the Finders in a process which appears to have been a systematic response to local newspaper advertisements for babysitters, tutors, etc. A member of the Finders would respond to the ad and gather as much information as possible about the habits, identity, occupation, etc. of the family members. The use to which this information was to be put is still unknown. There was also a large

amount of data collected on various child care organizations.

The warehouse also contained a large library, two kitchens, a sauna, hot tub, and video room. The video room appeared to be set up as an indoctrination center. It also appeared that the organization had the ability to produce its own videos. There were areas which appeared to be training areas for children, and an area which appeared to be an altar. Jars of urine and feces were discovered in this area. Notably, both premises of the Finders were equipped with satellite dish antennas.

The MPD began its investigation of the materials in furtherance of its child abuse case and promised Customs agents full access to the materials after their review.

### Final Report

The final investigative report on this matter is dated April 13, 1987. After all passport data had been turned over to the State Department for investigation, a meeting of the DC MPD detectives was held. On April 2, 1987, the Agent in charge met with a "third party" to discuss the case "off the record." He was advised that all travel and use of the passports by the holders of the passports was within the law and no action would be taken. This included travel to Moscow, North Korea, and North Vietnam from the late 1950s to the mid-1970s. The third party advised the Agent of circumstances which indicated that the investigation into the activity of the Finders had become a CIA internal matter. The MPD report was classified "Secret" and was, from that point on, unavailable for review by any party. He was also advised that the FBI had withdrawn from the investigation several weeks prior and that the FBI Foreign Counter Intelligence Division had directed the DC MPD not to advise the FBI Washington Field Office of anything that had transpired.

The official directive was: "No

further information will be available. No further action will be taken."•

**I**n 1990 I moved to Hoboken as a highly successful arts administrator working in Manhattan. My career was well established, I had two Master's Degrees and nearly 14 years devoted to a history career. I was about to publish, among many articles, my first national history book.

From the time I moved to Hoboken until now, my life and career have slowly and torturously been shattered. I write this seeking to find and help others who have experienced similar violent horrors and to lend my research to them. I also endeavor to expose criminal elements in Hoboken and throughout New York City who may be continuing to spread the sort of violence I have endured.

From 1990 to 1994, I believe it is probable that I was set-up by several fertility clinics and doctors in New York and New Jersey whom I consulted. I also believe I was set up by a group of homosexual men who may have used me as a breeder for other women's pregnancies. These perpetrators were probably working for financial gain. Suddenly and overnight, my NJ apartment experienced continual break-ins, I felt drugged, and I kept feeling someone was in the

apartment on a regular basis, stalking me. All of these strange events occurred as I, as a single woman, was trying to make a child at local fertility clinics. I did not recognize for two years or more that these break-ins and druggings were happening, since the perpetrators were the quintessential professionals, using keys to enter my apartment. I believe now that someone copied keys in my purse at my job in Manhattan, and they were staging these assaults some 10 miles away.

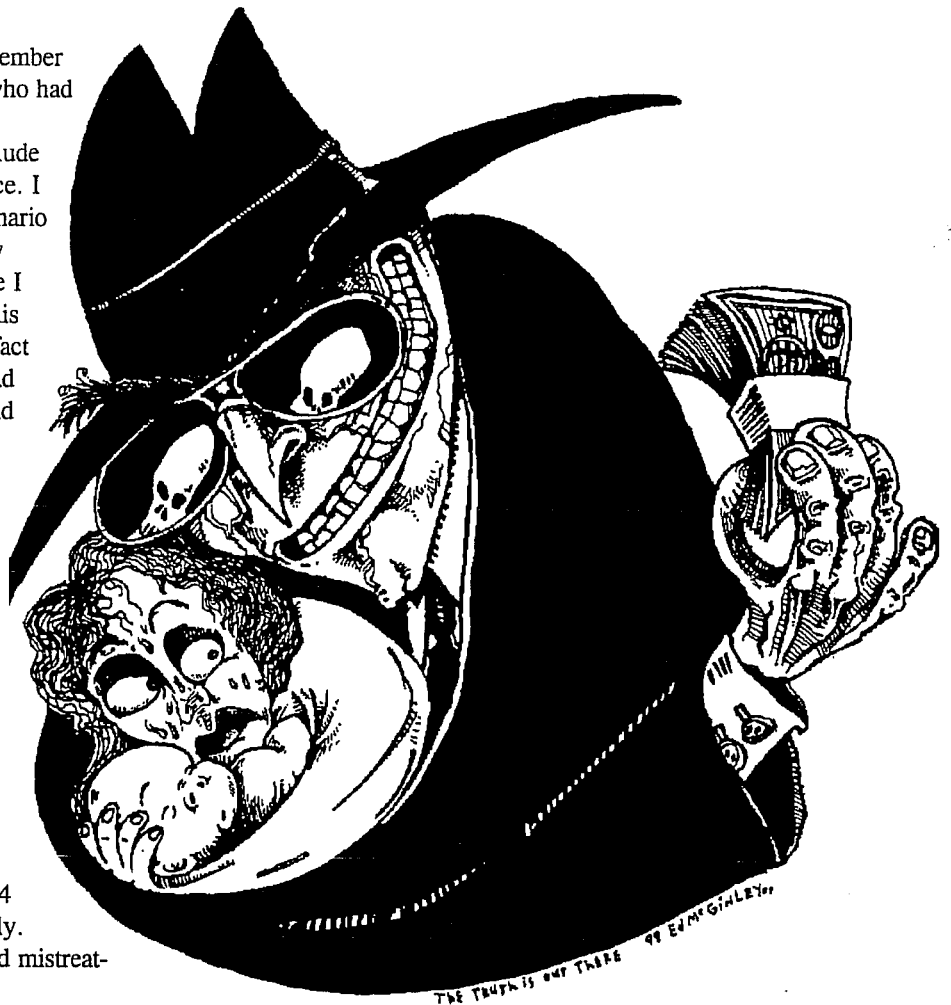
This criminal violence was also occurring as I watched some dozen or more people around me become pregnant in a short period of time in the early 1990s, including two of my female doctors, two female attorneys, and about a dozen friends and acquaintances. When I saw several of these children a few years later, they looked and sounded distinctly like me, not like their parents. I could precisely trace their pregnancies back to my fertility work and inseminations. I suddenly figured that at least four or five children, now living with acquaintances and close friends, might actually be mine.

As I traced my history, I could remember pregnancies developing with women who had spent the night in my apartment. The breeder scenario, I realized, might include situations as far back as my adolescence. I began to suspect the most horrible scenario possible: that "my children" were now owned by dozens and dozens of people I had known over decades. Adding to this sudden horrifying realization was the fact that many of these pregnant women had quite suddenly severed ties with me and my immediate family after their pregnancies.

In the middle 1990s, I was drawn to a few of these possible breeder children. One child which I suspected was mine even had the name I had chosen for one fetus during a fertility clinic insemination. This child had been born exactly nine months after I had been inseminated and briefly thought I was pregnant. I had four pregnancies during this time period; two pregnancy tests at the clinics wound up "lost," and two came up positive. The last two fetuses died at 14 weeks and had to be removed surgically. During the hospital stay, I also endured mistreatment, probably by cults.

I later learned through many reliable sources (psychiatrists, attorneys, doctors) that my fetuses may have been "transferred into" other women by specialized crime syndicates who could make a great deal of money farming out my ovum, utilizing advanced technologies and drugs. Reports are that these specialized cults often use veterinarians for "snatches" (word for obtaining women's ovum - the word for obtaining men's sperm is "catch") to obtain babies from particular women. Biker groups are sometimes involved in these clandestine activities. Women have reported having parts of ovaries stolen (needle rapes) and these taken probably for "harvesting" in clinics.

On October 23, 1996, I was viciously assaulted in Paris, probably by a group of U.S. Intel agents (CIA/FBI) and I lost half of an ovary (visible in ultrasounds), which I learned can be harvested later in clinics. These crime syndicates will even go through orifices (vaginas and colons) to remove organs and parts of organs. The victims may not realize why they are in pain, and doctors seeing the internal mutilations often will not disclose it for fear of syndicate retribution. Some women appear to be "marked" as bloodlined breeders by particular eugenics rings. (1) Accounts from these sexually assaulted women include descriptions of physical "marks" in their vaginas, visible to doctors with speculums. Some Gyns/OBs (who are in on this activities) can recognize these markings and then stage further assaults upon

designated bloodlined breeder women.

Breeder women may also be tagged with implants as infants so that they are easier to surveil, stalk and harvest by eugenics cults most of their lives. Couples pay large amounts of money to obtain these bloodlined children through breeders' reproductive elements (both blood or ovum). Fees from \$5,000 to \$50,000 have been reported for one "snatch" of four ovum in repro clinics. (2) Unusual crime elements are also involved in arranging and using women in this manner. It is reported that this can include homosexual men, so-called transvestites, and paramilitary men. All of this is, obviously, handled clandestinely.

While bloodlined women (3) may be more in demand, the cults may also simply use "pretty women," such as actresses and models. With sterility rates skyrocketing throughout the so-called free world, harvesting women is a very lucrative business. I believe that a strong breeder-cult occult element is alive and working in Hoboken, NJ where I first experienced the unusual criminal problems. A major medical research facility is only a few miles to the south of Hoboken. And this victim has found another seven victims.

Victims will likely find, as I did, that their lives suddenly and for unknown reasons may become shattered; they may lose friends, they may watch people become pregnant around them, they may feel assaulted but not remember the incidents (these cults use stun guns and drugs to wipe out victims' memories). Victims may also experience odd bruising and the feeling of being drugged. Victims only have victims for support and information about these vicious assaults (4), but in groups, it is my hope we may prevail. (5) Bloodlined breeder women can endure horrendous and vicious violence all their lives; they may lose their children to wrongful parents, and may wind up violently victimized by their so-called friends and family who want to use them as breeders.

I now believe that some of my stolen children are still in New Jersey with the "wrong" parents. I now have a list of 36 couples who may have my genetic children, because I believe I am marked as a bloodlined breeder (and have been used for cloning experimentations probably most recently). I am seeking to inform women about this very real situation, which is occurring in Hoboken and in New York City.

I would like to bring out the crime syndicate rings in Hoboken (and all of Hudson County; probably Mafia-inspired) but to do it, I need to find

other women also being victimized there and elsewhere. (6) I have filed five court cases to open up some of the stalking and chemical violence I have endured. (7)

I am taking risks in sharing this information since I am still targeted and dealing with continued and ongoing cult violence. The crime elements assaulting me are still in the Hoboken area and I would like to locate other targeted women in an effort to bring out these perpetrators. I am seeking your active responses through the fax number enclosed here. If you or someone you know is being targeted for stalking violence, I will return your message.

# A New Generation of Vipers

## Part Two Babylon: The New World Order

So you thought you were safe at church? Don't bet your soul on it. Not when liberation theology, ecumenicism, the interfaith movement, ecospirituality, and the Ruling Elite are loose in the land, invading Christianity like devouring hordes. Productions such as the Parliament for the World's Religions and buzzwords like "faith communities" are treacherous harbingers of their new collectivism. They call it the Kingdom of God on earth—but we call it Babylon, the New World Order.

### World Council of Churches

*"O my people, they which lead thee cause thee to err, and destroy the way of thy paths..."* —Isaiah 3:14

One organization worthy of scrutiny is the World Council of Churches (WCC). According to Texe Marrs in *Dark Majesty*, the president of the WCC's financial affairs is a senior Skull and Bonesman. Perhaps this is why in the early 1990's ex-presidents Gerald Ford, Jimmy Carter and Ronald Reagan accepted co-chairmanship of a fundraising drive for the Ecumenical Development Initiative of the World and National Councils of Churches. The money (\$150,000,000 by 2000) is earmarked for "cooperative efforts in the social and political arena." Former presidents stumping for world religion (operating in the social and political arena) confirms the nature of the ruling class controlling myth.

The August, 1993 WCC Conference on Faith and Order hinted at the shape of things to come. Top Vatican ecumenicist Cardinal Edward Cassidy reasserted the non-negotiable primacy of the papacy; Desmond Tutu called for a "symbolic and honorary" papal primacy over other Christians; a Nigerian Roman Catholic bishop "discerned a readiness among some churches to acknowledge some sort of papal leadership." By August 1996, the Vatican quit pussy-footing around. "Christian unity will not become a

reality," John Paul II declared, "unless all churches accept the authority Christ entrusted to St. Peter and his successors...No alternative form of church authority exists."

Ecumenical and interfaith overtures mark a new Dark Age of papal Romanism. "By her relationship with Christ, the Church is a kind of sacrament of intimate union with God, and of the unity of all mankind, that is, she is a sign and an instrument of such union and unity." In *The 1993 Directory for Ecumenicism* (the Roman curia's blueprint by the Pontifical Christian Unity Council), Catholic doctrine remains untouched; other Christians must give up their every gain. This follows the directive of Vatican II: "[The faithful's] ecumenical activity must not be other than fully and sincerely Catholic" and "Nothing is so foreign to the spirit of ecumenicism as a false conciliatory approach which harms the purity of Catholic doctrine." Vatican II called for a "full visible communion of all Christians" but it is a unity created in the image of Rome (a fact largely misunderstood by sleepy-headed Protestants.)

Agreements made by Protestants with Rome are sometimes cloaked in secrecy. One major accord between Lutheran theologians and Rome underscored the mysterious nature of these agreements: "the document itself was not made public, nor would participants in the dialogue spell out the specific areas of agreement and disagreement." Lest anyone minimize the threat, there is also a Pontifical Council for Dialogue with Non-Believers. The World Religion must be all-inclusive to achieve total dominion. At the pinnacle of Rome's power, Boniface VIII issued the papal bull *Unam Sanctum*. (A papal bull is the same as speaking *ex cathedra*; the pontiff claims infallibility.) "Moreover, we declare, affirm, define, and pronounce that it is altogether necessary for salvation that every human creature be subject to the Roman Pontiff."

Rome rose to her greatest power under circumstances that parallel our time: "No control but that of religion appeared sufficient to restrain the abuses of society..." Just as today's Vatican offers itself as intermediary, Innocent III stepped in as the "general arbiter of differences and conservator of peace." Within a very few years, Innocent executed 30,000 Albigenses. "Rome inspired...all the terror of her ancient name. She was once more mistress of the world, and kings were her vassals." Under the banner of moral order, Rome's cruelty reached new heights. The same "moral order" tactic is being used today, sold to the conservative middle class as "traditional family values," and peddled in the guise of "ethics" and "spiritual renewal" to others.

### The Moral Orderlies

*"I formed them free, and free they must remain, Till they enthrall themselves."* —John Milton, *Paradise Lost*

Why has real-time religion suddenly become the overarching ambition of the ruling elite? Shall we regard their breathless ardour as simply a more noxious than usual variety of *noblesse oblige*? Or are they in fact earning their keep by purveying scripted, relentless brainwashing? Let the reader be the judge.

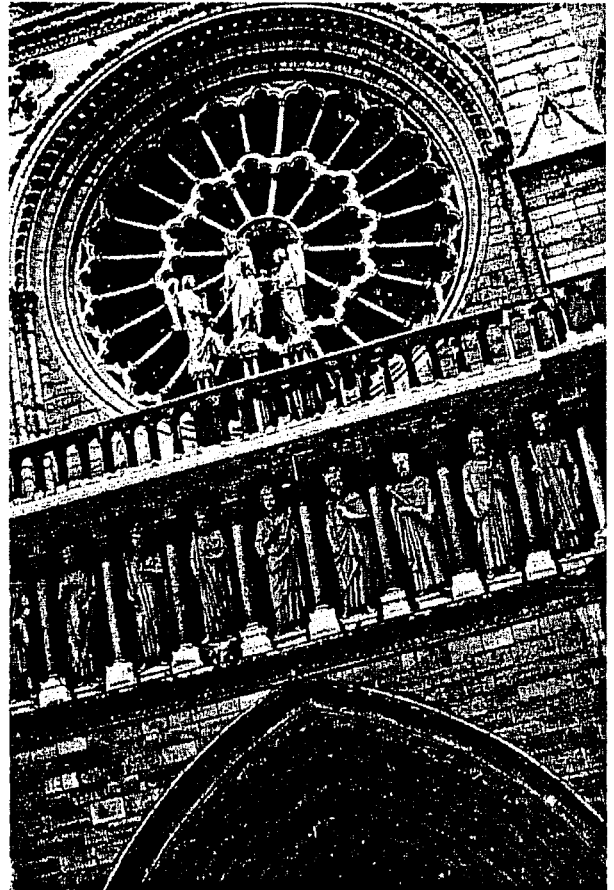
Mikhail Gorbachev: "We need spiritual values. We need a revolution of the mind. This is the only way toward a new culture and a new politics that can meet the challenge of our time" (from a speech at the Vatican.) Also, "...along with this 'new way of thinking' will come 'universal values to take advantage of man's spiritual capital'." Robert Muller, Temple of Understanding member, calls for a "new code of behavior which will encompass all races, nations, religions and ideologies. It is the formulation of these new ethics which will be the greatest challenge for the new generation."

Alice Bailey (Lucis Trust/World Goodwill; deceased disciple of theosophist Madame Blavatsky): "The objective of the new social order, of the new politics, the new religion, is...to bring in the Kingdom."

Liviu Gota, Director General of the UN to members of Lucis Trust and its partner organization World Goodwill in 1990: "man must end his individual will and conform to common aspirations." According to Gota, a universal spirituality must be achieved... Gota also said that the United Nations will play a great part in developing these common aspirations. Spirituality, Gota stresses, is to be the keystone of the work of

strengthening the United Nations.

Javier Perez de Cuellar, former Secretary General of the UN: "On many occasions debates arise between the partisans of a strictly individual morality and those who



believe in a community ethic that takes into account community interests. The problem of the relationship between freedom and morality will sooner or later concern the international community." (From a speech delivered at the Palais de Chaillot in Paris, France.)

William Ruckelshaus, former head of the Environmental Protection Agency: "First, a clear set of values consistent with the consciousness of sustainability must be articulated by leaders in both the public and the private sector. Next, motivations need to be established that will support the values. Finally, institutions must be developed that will effectively apply the motivations..."

Mere acceptance of a changed value structure, although a prerequisite, does not generate the required change in consciousness."

Al Gore: "As Erikson once wrote, 'The possibility of a specieswide destruction creates for the first time the necessity of a specieswide ethic.'" Hillary Clinton: America suffers "from a sleeping sickness of the soul... Let us be willing to remold society." Teilhard de Chardin: "The fate of mankind, as well as of religion, depends upon the emergence of a new faith in the future." (Quoted by Al Gore in *Earth in the Balance*.) Vaclav Havel: Calls for "a global revolution in the sphere of human consciousness. We still don't know how to put morality ahead of politics, science and economics."

Maurice Strong, UN Earth Summit chief: "...revival of moral and spritual values [is] the real key to survival of the human species." Carl Sagan: "What good is all the data in the world without a steadfast moral compass?" And "It's clear that science alone cannot by any means provide the moral impetus that religion can." Jesse Jackson: Calls for "a social values revolution."

Zbigniew Brzezinski: "[The new era] can emerge only as a consequence of a new historical tide that induces a change both in values and in conduct... The global crisis of the spirit has to be overcome if humanity is to assert command over its destiny." John Paul II: "The broadcasting industry should develop a moral code that reflects family values." Pat Robertson: Encourages Christians to become "a united and effective force for moral renewal in America."

Bill Clinton: "We cannot renew our country unless we are willing to work with the churches." (January 1994 State of the Union message.) "President Clinton credits the catholic social teaching of [Jesuit Georgetown University] with forming his philosophy of morality and politics." Jesuit newspaper columnist Eugene Kennedy also noted that "The Clinton Administration, far more than that of Reagan, parallels the teachings of papal encyclicals on social policies" of a wide variety.

Newt Gingrich, author of *To Renew America*: "We must renew the spiritual and moral dimension of American Civilization." Gingrich wants churches to assume responsibility for caring for the needy. Dan Quayle, author of *The American Family: Discovering the Values That Make Us Strong*, wants public assistance distributed through churches and synagogues. Chicago Mayor Richard Daley believes "religious leaders should be leaders of community policing in their own communities." (Zola Levitt's

August 1996 newsletter noted, "The CIA wants to use clergymen for intelligence purposes.")

Merovingian Archduke Otto von Hapsburg, a King Of Jerusalem candidate: "Together with ecumenicity, European unity has become the major issue of our time." Also "...it might be possible to establish a united Europe and world peace, together with a Christian community and harmony between all believers...our survival will depend upon a spiritual revival..." One highlevel official from NASA even referred to the agency's spiritual mission in *Parade Magazine*.

The desire to change the values of the West is on the lips of elites everywhere. The agenda they seek to impose upon us is evil, and their labours to kill our liberties is the working of wickedness. How odd the ruling class imagines itself fit to dictate morals to anyone! These "morals" are not to be understood in the classic Christian sense. Christianity is not a value system, but a personal commitment to Jesus Christ as the son of the living God and to his words as truth. Pretending that Christianity can be used as a good set of rules is deceitful beyond measure. Christianity is not a matter of changed rules, but changed hearts. Furthermore, Christianity was never meant to be popular. Christians caught up in worldiness were admonished, "Ye adulterers and adulteresses, know ye not that the friendship of the world is enmity with God? Whosoever therefore will be a friend of the world is the enemy of God." (James 4:4) This verse emphasizes the aspect of separateness that was once well understood. Any system based upon popular ideas or cutting-edge philosophies is not Christian, whether promoted by the Roman Catholic Church, or Chuck Colson, or anyone else.

The New Moral Order instead resembles the ancient Roman religion, which had no true definition of sin or personal holiness, and thus lacked any inner value. The Roman religion can be summed up as obedience to the State, peace with the gods (achieved only by meticulous ritual) and "goodwill" among men. It proved so unsatisfactory that Roman rulers regularly imported depraved religions from the East (whose fashion likewise soon passed) due to the spiritual unrest of the people.

## The Two Babylons

"My people are destroyed for lack of knowledge."  
—Hosea 4:6

The New Order will much resemble the earlier pagan States, and in particular that of The Holy Roman Empire. It is high time that people realized Roman Catholicism is not a Christian faith that borrowed from the ancient Roman religion in order to welcome pagans. Roman Catholicism is the ancient Babylonian-Roman religion tricked out in a few Christian trappings. It is Caesar's religion, which history readily confirms. Even the Church's organization is identical to that of the Roman Empire. The political structure of the

New Order will be that of the Caesar's Roman Empire, and the religion will be Babylon's. The Roman Church is heir to both.

After the fall of Babylon, the Chaldean priestly college established itself in Pergamum (a.k.a. "Satan's seat" according to Christ in Revelation 2:13.) Attalus III, king of Pergamum, bequeathed his kingdom to Rome in 133 B.C., and with this the title Pontifex Maximus of the Babylonian religion thereafter was held by Roman rulers. When the Babylonian/Roman title and office were refused by Gratian in 375 A.D., they were snatched up by the bishop of Rome. Catholic pontiffs still retain the title of Pontifex Maximus—for both the Roman and Babylonian religions.

The Babylonian nature of Catholicism was boldly attested to by Luther: "And now farewell, unhappy, hopeless, blasphemous Rome! The wrath of God has come upon you in the end, as you deserved...because you have chosen to grow more evil from day to day! We have cared for Babylon and she is not healed. Let us then leave her that she may be the habitation of dragons, spectres, ghosts, and witches, and true to her name Babel, an everlasting confusion, an idol of avarice, perfidy, apostacy, of cynics, lechers, robbers, sorcerers, and endless other impudent monsters, a new pantheon of wickedness." Luther, a German monk, knew whereof he spoke.

There seem to be few Luthers among us. Our times can be compared to the years preceding Nazi Germany, when "the German theologian...had deteriorated to an unbelieving liberalism... Understanding the moral treason of churchmen required knowledge of the doctrinal state of much of Europe during the first four decades of this century... the satanic influence."

Outright betrayal of the faith by

ecumenically-minded, interfaith-mongering Protestant Christian ministers cannot pass without remark. Displays of this ecumenical depravity on the part of Protestants are by far the greater sins. Whether by ignorance or design, they are without excuse. Today's social woes, in large part, are due to dereliction of duty by Protestant leadership. These "pious" ones have chosen to set themselves above the fray to serve as moral and spiritual guides for their fellow men. Yet under their watch, the morals and strength of the West have collapsed. This has more to do with what is coming out of the pulpits than any combination of societal evils: it is the paucity of truth and the dearth of spiritual wisdom on the part of Christian leaders and scholars that is doing us in. They are clothed in shame.

If the current Christian leadership had a valid message, if they had anything to offer spiritually to their flocks, if the hand of Almighty God was truly guiding them, *if they spoke the truth*, it is certain that Western society would be considerably better off than it is now. Having thoroughly failed and utterly forsaken their own flocks, these religiously compromised poobahs now grandly proceed to the international arena, presuming that we await their solutions to global evils. But these *petit* princes have no clothes. They parade before us wretched, poor, miserable, blind and naked.

#### Profits for Prophets?

*"There is a conspiracy of her prophets in the midst thereof, like a roaring lion ravening the prey; they have devoured souls; they have taken treasure and precious things, they have made her many widows in the midst thereof."*— Ezekiel 22:25

The ecumenical-interfaith ruling class myth provides insights about conspiracy unavailable elsewhere. Given that the very same myth was

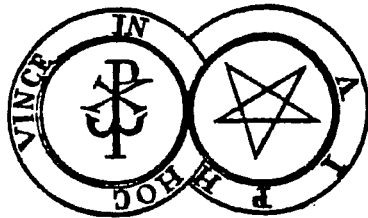
used by ancient Babylon and her successors for control over populace and rulers alike, history provides a reliable motif for our own future as well. The Babylonian priesthood had much to gain by such unity: their temples served as "the courts of justice and of astronomical and

medical science, the official legal archives [where] extensive science collections were kept," and also contained the public treasury.

Furthermore: "...since the priests attached to the temples remained for all times not only the scribes, but the authors of all literary productions, and the exponents of the entire intellectual life, the literature never lost its association with religion." And "the whole of life was thought of as a unified religious

exercise.” The priesthood wielded absolute control over every aspect of life and knowledge, creating complete dependency with their ecumenical myth (adjusted as necessary to sustain control). These quotes could equally apply to Catholic monks in the papist Dark Ages: “The medieval spirit, in all its various manifestations, aimed at universal empire by way of external and visible rule. The

idea of the State was the Holy Roman Empire actually embracing and dominating over all the countries of Europe; its idea of the Church, that visible and tangible catholicity which existed before the great Reformation; and in the department of knowledge it showed its characteristic quality in its desire to embrace in one system, under one science, the whole of human thought.”

The control of human thought is the key to human bondage, the most horrifying aspect of the 1000-year duration of the Dark Ages. When Rome’s priestcraft was in ascendancy, the effect was almost immediate. “Although personal and institutional libraries were an important feature of GrecoRoman culture, none survived the dissolution of the Western Roman Empire.” Curious, is it not? All libraries vanished. (Equally curious is that “paper had disappeared in Europe by 650 A.D.”) Chief among the oppressors were the so-called Early Church Fathers, probably more accurately described as the Early Robber Barons of the faith. Coincidental with their introduction of pagan concepts into Christianity were their efforts to obliterate liberties. They succeeded on both fronts.

Following closely on the heels of Constantine, Augustine (354-430) gave a hefty boost to intellectual bondage with his much-vaunted City of God. He fostered the idea that the Church was the visible kingdom of God on earth, the very Government of God itself. “To the authority of this eternal kingdom—that is, to the authority of the Church—all believers were urged by Augustine to submit without reservation. In the teaching of Augustine,

therefore, the church gained complete control over the beliefs of men.”

“This was at the very same time when the Edict of Theodosius was closing the temples of the old gods. The state was thus assuming the power to suppress all other beliefs, and henceforth it maintained its power over both the bodies and the minds of its subjects. In accordance with this idea Justinian had closed the university at Athens in order to stop freedom of thought and the teaching of the old philosophy. To the authority of the state over the beliefs of its people, Augustine added the authority of the church. Thus ended all intellectual liberty in the ancient world.” Theodosius also set precedent by allowing the Church to dictate political policy.

During the Dark Ages, with few exceptions, books were kept in churches and monasteries for the singular benefit of the clergy: “...only a particularly privileged outsider, such as a well-known scholar, might have access to them.” The books were mostly in Latin; when learning was later institutionalized (ca. 12th century) education was set forth in the long-dead Latin tongue. Knowledge was sealed in the precincts of the privileged. The Bible, translated only into Latin, was entirely forbidden. Like a sop thrown to the wretched masses, Roman Catholic images served as “books for the unlearned” in the none-too-generous words of Thomas Aquinas. Western man was reduced to intolerable serfdom and kept under through enforced ignorance, a lesson not to be forgotten as Rome rises once more.

This technique of control was used in the Tibetan monasteries formerly ruled by the current Dalai Lama, until his theocracy was overthrown: “Before 1950, secular education was nonexistent.” Literacy was strictly “the privilege of monks and the nobility.” The lot of the common man was predictable: “a large percentage of the [over one million] people, most of them concentrated in central Tibet, were serfs tied to an estate by birth...95% of the land was held by 3 groups: the fewer than 200 families comprising 10,000 nobles, the monasteries with 120,000 monks and 13,000 nuns, and the government, run by 333 lamas and 280 nobles.” The “religious and administrative power centered in one person”—the same Dalai Lama who now compasses land and sea seeking to restore his former kingdom.



The essential nature of religious power—and those who seek it—hasn't changed one whit. Whether travelling under the guise of Rockefeller's beatific vision, or foisted upon us as the gooey "unity of all men," ideas of power like tantalizing sugar plums dance under noble brows. The common denominator in each case is the spirit of sacerdotalism, which elevates priesthood to an undeservedly lofty position. The power of priestcraft over the affairs of men is essential to the success of world government; without it, failure is assured (as witnessed with socialism.)

Winning the minds of men is not enough, it is the souls that must be captured, the spiritual nature that must be manipulated for complete takeover.

### **The Bible: Fact or Fabrication?**

*"...for ye have taken away the key of knowledge: ye entered not in yourselves, and them that were entering in ye hindered."* —Jesus Christ (Luke 11:52)

Fabulous accusations are regularly hurled against the Bible, such as the charge that the Scriptures were manufactured for ruling-class control. A convenient concept for those wishing to ignore the Bible and its God, perhaps, but a matter of rash, uninformed folly for anyone familiar with history, religion, or the Scriptures themselves. That the Bible does not easily lend itself as an instrument of authoritarian control is demonstrated by the fact that the Bible has been consistently forbidden by tyrants (most notably Roman emperors and pontiffs) throughout history. Only recently has the Bible been allowed in Russia and Eastern Europe. It continues to be banned in Moslem countries. Currently more than 40 countries prohibit open distribution of Bibles.

There are strong reasons why the Bible cannot be incorporated into the ruling-class controlling myth. "Most Jews and Christians had agreed that God gave humankind in creation the gift of moral freedom." Nowhere does the Bible authorize the suffocating sacerdotalism found everywhere in religion today. Under the Jews' Levitical priesthood as originally established and lasting until approximately 1100 B.C., "there was no king in Israel: every man did

that which was right in his own eyes." Neither does the New Testament give support to a priestly caste. Indeed, Peter himself referred to all Christians as "a royal priesthood."

When freed from the mythico-religious traditions of men, the Bible emphasizes personal (not collective) holiness. *A controlling myth always engenders collectivism.* The recent doctrine of societal evils results in collective culpability and consequently requires binding collective solutions. In comparison, the Bible teaches about personal sin with individual responsibility resulting in voluntary personal change. The West operated quite successfully on this basis for some time. As this sense of Christianity is lost, many personal freedoms are on the wane as well.

From the time of earliest Christianity, the New Testament has been the bane of despots because, unlike the lip-service paid to such principles today, it fostered individual dignity and freedom, and deflated their controlling mythologies. So great was this threat that "copies were ruthlessly hunted down and destroyed" during the Roman Empire and the papal Dark Ages. Emperors and pontiffs would brook no knowledge competing with their prevailing myth. Our English Bible was literally born in blood. Out of the 2,000 years since the New Testament was written, the Bible has been allowed free course in the West for less than 500 years—and free society has flourished wherever the Scriptures took root.

England's King Henry VIII delivered the blow that brought Roman tyranny to an end, with his decree in the 1500's that the churches must allow the common man to avail himself of the Bible, "in the Englyshe tounge, to be fyxed and set vp openlye in euery of the sayd paryshe churches." (Until that time, the Bible was forbidden under penalty of death.) Henry was the true father of Protestant-

ism, which is defined as “freedom to dissent.” Is not every liberty based on freedom to dissent? Thus, from the fount of the Scriptures, all of our freedoms and prosperity flow—freedom from priestcraft, freedom of conscience, freedom of nations, and freedom of knowledge to name but a few. Where were these freedoms in the Dark Ages? Where was prosperity for the common man during the feudal heyday of the Roman Church and her Empire?

One hundred years after Henry’s reign, with the Reformation in full sway, the Empire lay stripped of its power, existing only in barest form. From that time, the

Protestant nations (Great Britain, Switzerland, et al.) began to uphold a standard of individual liberty so superior that it remains the envy of nations. Having prospered in their climate of moral and intellectual freedom, these countries ultimately increased the opportunities and wealth of the common man to the high standard of living still commonplace in Protestant countries.

Encouraging such liberties is anathema to emperors, popes and the ruling class, for the obvious reason. They cannot, on their own, afford to live so deliciously when the people are free—which explains why those fabulous palaces and cathedrals were built in medieval times. Therefore churchmen routinely affirm to this day, “The elevation of individual conscience above the revealed truth taught by the historic Church is a protestant heresy” and hope that we’re listening. This statement exemplifies the spiritual despotism for which Rome has always been famous. The individual conscience is one’s soul, which Rome would keep in her fetters; it is the souls of all mankind that will be bound (in their own words!) by the forthcoming Global Ethic.

## Constantine and Catholicism

*“Therefore my people are gone into captivity, Because they have no knowledge.”* —Isaiah 5:13

The myth-mongering Constantine is credited with “Christianizing” the Roman Empire, but nothing could be farther from the truth. “Constantine was not so much a worshipper of Christ as he was a worshipper of himself...[he] considered himself the incarnation of ‘the supreme god, a combination of Apollo, Mithra, Jupiter, the sun and Christ... A contemporary historian said Constantine was ‘more greedy for praise than it is

possible to tell’.” Constantine recognized the threat Christianity presented to the moribund religions of the time and thus to his own regime. Separation, the hallmark of Christianity, interfered with Constantine’s collectivism. “Let us cherish peace and forbearance,” saith Constantine, “for it would be truly disastrous that we should assail one another. Let us banish strife.”

The similarity of Constantine’s controlling myth to today’s prevailing philosophy is no mere coincidence. We are simply witnessing the latest incarnation of the same Babylonian collectivism that has bedeviled mankind

throughout history. Thus, Constantine put Christianity at the service of the Empire in a wholly corrupted form, in order not to disturb the Empire’s pagan, hybridized composition. By the time that heathen religions were banned, Christianity had been reduced to a state that allowed easy absorption of pagans into the Church. Had the Scriptures actually been given free rein, the Roman emperors and the Catholic Church would not have had such wide berth to force conversions or to commit so many other horrors. The Christian is not permitted to force conversion — a forced conversion makes a most unsatisfactory Christian.

Nor does Christianity call for the rooting out of pagans, but rather winning pagans with a message of truth. The typical pagan would be well able to see the superiority of Christianity when compared to his own ghastly heathen rituals and beliefs. Additionally, Jesus advised his followers that his truth would make them free. But truth and freedom are not concepts the ruling class can live comfortably with. Therefore, political necessity moved Constantine to enact laws that grossly mixed Christianity with paganism in order to protect his

collectivist, controlling mythology. Christians preferring to worship according to individual conscience were severely punished: "the authorities practiced violent coercion."

Roman Catholicism followed suit: its earliest teachings would steal away the liberty God granted. Among the worst of Catholicism's deceptions is that "free will is the cause of our doing evil." This seminal belief brought forth immeasurable sorrow during the centuries when Rome ruled. Yet Revelation 22:11 plainly states, "He that is unjust, let him be unjust still: and he that is filthy, let him be filthy still..." *Let him...* Constantine's moral posturing and oppression of individual conscience received no support from the Scriptures. Neither does Rome find justification there for the blood on her hands, for her iniquitous Inquisitions and savage massacres. Not a word of succour can be found for binding Global Ethics or forced Moral Orders. Not a chance, not a breath, not a prayer. Just as the Roman Church boasts an authority which is entirely bogus, these too are mere inventions of men.

As Quintus Mucius Scaevola, Roman Pontifex Maximus in the 2nd century B.C. so succinctly stated, "It is expedient that the populations should be deceived in the matter of religion." Foremost among men as a foe of truth and freedom, Rome is a sworn enemy of the Bible. Most telling of all, "it was American Roman Catholic bishops in the middle and late 19th century who demanded the removal of Bible reading from public schools..." Today, the 17th-century King James Version of the Bible (the best selling Bible of all time, used throughout this article) is targeted for extinction in particular because it uses superior Greek and Hebrew texts differing from all other versions. The ruling elites

have mounted opposition to this version in every way imaginable, especially through their seminaries and universities. But the Catholic Church has included it on its Index of Forbidden Books for centuries.

Regrettably, there are few who read the Bible, and even fewer who decide what it means for themselves. This will exact a heavy price. There is a yawning chasm between what is actually written in the Bible, and what others pretend that it says. By relying upon the words of men about the word of God, the common man accepts lies about God and leaves himself entirely at the mercy of those religious leaders (and they are legion) who wish to enslave us.

#### **Faith Communities or Communism?**

*"Ye serpents, ye generation of vipers, how can ye escape the damnation of hell?"* —Jesus Christ (Matthew 23:33)

Consider again this passage from the Parliament of the World's Religions Global Ethic, drawn up by Roman priest Hans Kung. "Every form of egoism should be rejected. All selfishness, whether individual or collective, whether in the form of class thinking, racism, nationalism or sexism." This skillfully crafted New Order newspeak brings with it a deliberate confusion of terms and ideas to hide the fact that certain communist tenets have indeed triumphed over the West, not vice versa.

But the new communism comes upon us unawares, under the banner of "faith communities." And nationalism—that Protestant antagonist of Empire—has become the equivalent of egoism and selfishness, instead of the freedom from priestcraft gained from the Reformation. Consequently,

# THE AIDS-ET CONNECTION

**T**he AIDS-ET Connection is a unifying scientific hypothesis. It provides simple and logical explanations for otherwise incomprehensible phenomena. It explains the simultaneous origin of two different HIV strains at two widely separated locations, in Africa and the United States. It explains why cattle are mutilated and people are abducted, and also why these phenomena take the form they do. The ability of this hypothesis to neatly explain so much provides confidence, but not proof. Until recently, the mass of evidence favoring the AIDS-ET Connection was only circumstantial, but now there is a case of hard, direct evidence.

The AIDS-ET Connection also explains cattle mutilations as an HIV related phenomenon. As the only logical explanation for the format of these phenomena, it predicts that mutilated cattle will have positive HIV test status. I have repeatedly urged the National Institute of Discovery Sciences, which is in the process of autopsying mutilated cattle, to determine HIV test status. To my knowledge, no such testing has been performed.

There are major obstacles to research in Ufology, and as the AIDS-ET Connection depends on the existence of ET intelligence capable of and responsible for originating HIVs and their pandemics, the same obstacles hinder study of it. Due to the official public policy that all UFO phenomena must be explained as observer error, no scientific journal will publish this hypothesis, and no official granting agency will provide funding for research on any aspect of UFO related phenomena. These measures effectively close all the usual avenues of research.

## Evidence for the AIDS-ET Connection from HIV/AIDS

The simultaneous origin of at least two different "parent" HIV strains at two widely distant locations, along with the properties of the viruses and their pandemics, all strongly indicate these events could not possibly have occurred by accident, that is, according to natural causes. Researchers are well aware of this. As author Laurie Garret has asserted, "... many people sought iatrogenic or conspiratorial explanations for the appearance of HIV-1." (1) Iatrogenic means physician-caused. Highly respected AIDS historian Mirko D. Grmek M.D., Ph.D. said this: "The discovery of HIV-2, however, compels us to admit a double and even a simultaneous outbreak of the AIDS agents. Such a coincidence is extremely improbable, even impossible, if held to be the result of chance biological mutations." (2) Briefly, the facts are these.

In 1981, the disease which was later named AIDS surfaced in otherwise healthy sexually active homosexual young men. Their immune systems were severely weakened, allowing multiple opportunistic infections by microorganisms that ordinarily cannot cause human disease. (3) In 1984, Drs. Robert Gallo of NIH and Luc Montagnier of the Pasteur Institute took joint credit for the discovery that infection with a virus later named HIV terminates, after about ten years on average, with the disease AIDS. On average, death results about two years later. Medical treatment is helpful but does not change the eventual outcome of AIDS.

Nothing like the HIVs or AIDS had ever been seen before in man or beast. These were brand new viruses spreading in pandemics which promised to kill more people than any previous pandemic. Dr. Grmek again had an appropriate comment, short and to the point: "The epidemic's spread is exponential, justifying cataclysmic predictions." (4)

The HIV pandemic is currently sweeping the world, with an estimated 100 million infected globally by 2000 A.D. With an average doubling time of one year, by 2006 almost all sexually active people will be infected with HIV worldwide.

Evidence indicates that the pandemics began at two widely distant locations, in Central Africa and New York city, with two different strains of HIV-1, at the same time. The African strain was heterosexually infectious, and spread rapidly throughout the general population. The New York

strain was not heterosexually infectious, but was readily transmitted by male gay anal sex and also by sharing blood contaminated needles. Infection was also readily spread through transfusions of contaminated blood, and use of contaminated pooled blood clotting factors (by hemophiliacs). In America, a conservative administration was slow to act against a disease that affected gay males and IV drug addicts. (5)

### Biological Warfare: The War of the Worlds

Properties of HIVs/AIDS make the viruses ideal Biological Warfare agents. The unusually long, asymptomatic period of about (on average) ten years very much facilitates disease spread. Until AIDS appears, the only way to determine if a person carries an (infectious) HIV strain is by lab tests. Many people would rather not know. Therefore, many people carrying HIVs and capable of infecting others are not aware of it.

HIVs work to destroy the lymphocytic part of the cellular immune system. When the immune system is weakened enough, numerous opportunistic infections occur. Because the organisms involved are ordinarily harmless, treatment of infection was previously considered relatively unimportant, and little studied. When AIDS occurs, other viruses, bacteria, protozoa, fungi and yeast become dangerously infective. This pathogenic (disease causing) mechanism of multiple opportunistic infections makes successful long term treatment essentially impossible. The current belief is that once AIDS develops the outcome can only be delayed.

Because HIVs are spread primarily by sexual relations, infection occurs heavily in productive age adults. AIDS is now the leading cause of death in young men aged 25-44. Now that heterosexually infective HIVs are spreading throughout areas where formerly only the gay infective strain was present, AIDS can be expected to become the leading cause of death for young men and women in the prime of life. Women infected with HIV can be expected to have HIV infected babies. Proper treatment with anti-HIV medicine can prevent such infection. The ability of HIVs to infect vertically (by birth) can be seen as an effective property of the ideal Biological Warfare agent.

HIV is an RNA retrovirus. Like all retroviruses, it employs the enzyme Reverse Transcriptase (RT) to make DNA from its RNA. RT is very prone to transcription errors. Therefore, when HIV replicates, numerous antigenically different strains arise naturally. This constantly changing antigenicity makes production of a generally effective antigenic vaccine (the usual type of vaccine) essentially impossible. (6)

### HIV-2: The "Accidents" Continue

A third different "parent" HIV type is also known. Designated HIV-2, it is genetically quite different from the HIV-1s. It also causes AIDS and is heterosexually infective. Despite this, the current screening of blood for transfusion detects only the HIV-1s and not HIV-2. This is justified by the Centers for Disease Control on the basis that the incidence is so low it would not pay to screen transfusion blood for it. This is the beneficial Red Cross, which also was very slow to employ testing for HIV-1.

Introduction of HIV-2 is not well known, but it is believed to be of more recent origin than HIV-1s. This further weakens all theories of accidental origin, since the "accidents" seem to be continuing. Due to HIVs' Biological Warfare properties it

has been repeatedly suggested that HIVs are escaped Biological Warfare agents of human origin. This belief is effectively ruled out by the reliable evidence that HIVs began between 1940 and 1950. (7) At this time, human science was quite incapable of such a feat. RT and DNA polymerase, both essential tools in the discovery of HIVs, were unknown in 1960. Therefore, this possibility can be ruled out.

It has been suggested that HIVs arose from Simian IVs (SIVs), when a simian bit a human. For this to happen, two different simians carrying two different strains of HIV would have to bite an African (heterosexual) and a New York gay man, at the same time. An HIV-2 positive simian would have to bite an African, probably at a later date. If simians in the wild could get AIDS from their HIVs, and transmit it vertically to newborns, how have they managed to survive? Due to such considerations, the concept that HIVs arose from SIVs can be ruled out.

What is left? Only the AIDS-ET Connection. According to this view, the "parent" HIVs were selectively developed with the involuntary help of human abductees. Once developed, it would be easy to selectively infect Africans and gay New Yorkers. Human abductions with medical exams and samplings would provide monitoring and additions to the pandemics, if desired. I will address human abductions in more detail after an overview of the subject of cattle mutilations.

### Evidence From Cattle Mutilations

Cattle mutilation phenomena involve the discovery of previously healthy animals with specific mutilations, without evidence of blood or tracks. Body parts which both humans and predators do NOT eat by preference are removed "with surgical precision," usually involving anal coring, reproductive organ removal in both males and females, missing mouth parts, a missing eye, stripped skin, and one missing ear. Udders are also removed. UFO sightings and black (unmarked) helicopters are frequently associated with cattle mutilations. Sometimes animals are found with horns stuck deep in the ground or other evidence of having been taken up and dropped. In one case, a large bull was found in a tree. (8)

Due to the nature of cattle mutilation phenomena and in the absence of any other explanation except cult activity, it is assumed cattle mutilations are related to UFO phenomena. No one had any idea why cattle mutilations were performed or why they take their specific nature, until the AIDS-ET Connection, which fully answers all these questions.

The physical locus of the cattle mutilations correspond with HIV transmission in humans, except for the ear. The blood is a site of HIV replication in humans. Cattle mutilations are explained on the basis that animals are previously infected with HIVs or related viruses and locator implants are placed in the ear. At the appropriate time, the cattle blood with virus and antibodies is harvested, and transmission data is obtained by study of corresponding transmission sites. The ear is removed to facilitate locator device recovery with minimum exposure.

Based on this, I have proposed that mutilated cattle blood would test positive for HIV. I have contacted numerous people concerning this. Dr. Colm Kelleher of the National Institute of Discovery Sciences, is directing the autopsy of mutilated cattle, in cooperation with the Bigelow Foundation, and I have repeat-

edly urged him in writing to perform HIV testing on mutilated cattle. He has repeatedly refused to do so. Most recently I have urged him to simply retain frozen blood samples for possible future testing. Other persons interested in cattle mutilations have also made the request for HIV testing, without result.

It is interesting that my AIDS-ET Connection research has been criticized within the UFO community (10), and, although it would be easy to determine mutilated cattle HIV status, no one has done this testing. I have the impression that they are afraid testing would confirm my hypothesis.

#### Evidence From Human Abductions

According to abductee reports, humans are taken by alien "grays" into a secure location and are subjected to detailed medical examinations against their will. The examinations are performed using various devices under gray alien direction, with no explanation for the procedures. Tissue and blood samples are taken, and a small foreign object may be implanted. Some type of telepathic communication between abductee and alien may occur, after which all conscious memory of what transpired is repressed, and the abductee is returned. Although there are variations on this general theme, usually most of the above occurs during an abduction.

According to the work of Dr. David Jacobs (11), abductions occur for the purpose of obtaining reproduction related biological materials: eggs and fetuses from females, sperm from males. These materials are employed in the production of alien/human hybrids. As strange as this concept may seem, there is massive evidence for it. The viewing of their hybrid offspring, and request that they be nurtured, etc. is reported by numerous female abductees. The motive for alien/human hybridization is to obtain a being better suited to living on Earth than are the gray aliens.

I believe the work of Dr. David Jacobs is entirely valid, but does not tell the full story concerning human abductions. According to the AIDS-ET Connection, some human abductions have a different purpose and are related not to alien/human hybridization, but to HIV/AIDS. The evidence for this is as follows:

The detailed medical examinations which abductees receive correspond to sites of possible HIV transmission. Anal probing invariably occurs, along with study of the vagina, male urethra, the mouth, eyes and skin. Blood is taken in quantity corresponding to "lab test" needs. If the abductee is nursing, milk is also taken. The fact that study of possible HIV transmission sites is emphasized suggests the medical exam seeks information regarding HIV. The exam is obviously not for purposes of studying general health, because the major internal organs: heart, lungs, liver, kidneys, brain, etc., are essentially ignored.

According to the AIDS-ET Connection, HIVs were purposefully developed and introduced into the human population. The easy, logical way to do this would be via abductees. Now that the HIV-1 pandemics are well established, it would appear there is little need to continue their spread, and monitoring may be the reason for HIV related testing. On theoretical Biological Warfare considerations,

the relatively limited HIV-2 pandemic should be increased as fast as possible. Therefore, it may be that abductees are being employed in the spread of HIV-2.

If abductions are driven in part by consideration of HIV/AIDS, then the HIV test status of abductee and non-abductee populations may be different. In the attempt to obtain data on

this subject, I have repeatedly written prominent abduction researchers, informing them of my work, asking for information concerning HIV test status, and suggesting that HIV status be determined whenever possible. Only one person responded. That was Dr. Roger Leir.

Dr. Roger Leir is an increasingly prominent researcher who specializes in surgical removal of alien implants from abductees. (12) We corresponded and Dr. Leir brought the following situation to my attention. A male abductee with implant tested positive for HIV until his implant was removed, after which he tested (and remains) HIV negative. The implant was hollow and contained a substance. Dr. Leir wrote that he vouched for this result. Dr. Leir also informed me that in the future HIV test status results will be obtained on all implant patients. Additional data can therefore be expected.

Before the AIDS-ET Connection, no one ever checked for possible correlation of abduction related phenomena and HIV test status because there was no known reason to do so. Now there is. The finding of a positive correlation between implant presence and HIV test results is evidence in favor of the AIDS-ET Connection. I urge other abduction workers to also deter-

mine the HIV test status of abductees.

### Conclusion

The AIDS-ET Connection hypothesis is in agreement with information relating to the origin of HIVs and their pandemics and Biological Warfare properties, the phenomena of cattle mutilations and the diverse events of human abductions. Apparently unrelated phenomena from medicine, cattle mutilations, and human abductions are shown to be clearly related as part of a larger, unifying agenda. All known phenomena relating to HIV/AIDS and Ufology can, I suggest, be logically explained in terms of the gray alien agenda. That agenda is for the gray aliens to live here without us.

The case cited by Dr. Leir has an interesting explanation which is implicit in the work of Dr. Jacobs. HIV clinical testing involves serological studies which detect antibodies to HIVs, not the virus itself. If the virus had been present initially, with implant, it should have remained present after implant removal. It is difficult to see how implant removal

could remove a virus which is present throughout the bloodstream. Therefore, the implant provided (protective) antibodies against HIVs. According to Dr. Jacobs' work, some abductees will be kept around for useful duties. I suggest that in order to perform their duties, they must be kept alive, and so must be protected against HIV pandemics. The correlation of the work of three different researchers, Drs. Leir, Jacobs, and myself, has the result of increasing confidence in all of our work.

At this time, the AIDS-ET Connection must still be considered a hypothesis, but with more confirming data it will graduate to a theory. # INTRO TO ASSASSINATION

**F**rom “A Study of Assassination,” a training manual written by the CIA and distributed to agents and operatives at the time of the agency’s 1954 covert coup in Guatemala, which ousted the country’s democratically-elected president, Jacobo Arbenz-Guzman. The manual, which was among some 1,400 pages of files on the operation that the agency released in May, 1997, was obtained by the National Security Archive, a public-interest group in Washington D.C.

## DEFINITION

“Assassination” is a term thought to be derived from “hashish,” a drug similar to marijuana that is said to have been used by the eleventh-century Islamic leader Hasan ibn al-Sabbah to induce motivation in those of his followers who would carry out political and other murders, usually at the cost of their lives.

## EMPLOYMENT

Assassination is an extreme measure, and it should be assumed that it will never be ordered or authorized by any U.S. headquarters, though officials may in rare instances agree to its execution by members of an associated foreign service.

No assassination instructions should ever be written or recorded. Ideally, only one person will be involved. No report may be made, though the act will usually be properly covered by news services.

## JUSTIFICATION

Murder is not morally justifiable. Assassination can seldom be employed with a clear conscience. Persons who are morally squeamish should not attempt it.

## CLASSIFICATIONS

The techniques employed will vary depending on whether or not the assassin himself is to be killed with the subject. If the assassin is to die with the subject, the

act will be called “lost.” If the assassin is to escape, the act will be called “safe.” It should be noted that no compromise should exist here. The assassin must not fall alive into enemy hands.

Assassination techniques will also be affected by the subject’s vulnerability. Assassinations in which the subject is unaware of his danger will be termed “simple;” those in which the subject is aware but unguarded will be termed “chase;” those in which the victim is aware but guarded will be termed “guarded.”

A further division concerns whether or not it is necessary to conceal the fact that the subject was actually the victim of assassination. If such concealment is desirable, the act will be called “secret;” if concealment is immaterial, the act will be called “open.” If the assassination requires publicity to be effective, it will be termed “terroristic.”

Using these definitions, the assassination of Julius Caesar was safe, simple, and terroristic, while that of Huey Long was lost, guarded, and open. Obviously, successful secret assassinations are not recorded as assassinations at all.

## THE ASSASSIN

Except in terroristic assassinations, it is desirable that the assassin be transient. In a lost assassination, the assassin must be a fanatic of some sort. Politics, religion, and revenge are about the only feasible motives. Since a fanatic is unstable psychologically, he must be handled with extreme care. While Trotsky's assassin has never revealed any significant information, it was unsound to depend on this.

## TECHNIQUES

A human being may be killed in many ways, but the assassin should always be cognizant of one point: Death must be absolutely certain. The attempt on Hitler's life failed because those planning the conspiracy did not give this matter proper attention.

Techniques may be considered as follows:

### Manual

It is possible to kill a man with bare hands, but very few are skillful enough to do it well. Even a highly trained judo expert will hesitate to risk killing by hand unless he has absolutely no alternative. The simplest local tools are often the most efficient means of assassination: a hammer, ax, wrench, screwdriver, fire poker, kitchen knife, lamp stand, or anything hard, heavy, and handy. A length of rope or wire or a belt will do if the assassin is strong and agile. All such improvised weapons have the important advantage of availability and apparent innocence. The obviously lethal machine gun failed to kill Trotsky, where an item of sporting goods succeeded.

### Accidents

For a secret assassination, the contrived accident is the most effective technique. When successfully executed, it causes little excitement and is only casually investigated.

The most efficient accident is a fall of seventy-five feet or more onto a

hard surface. Elevator shafts, stairwells, unscreened windows, and bridges will serve. Bridge falls into water are not reliable.

A private meeting with the subject may be arranged at a properly-cased location. The act must be executed by a sudden, vigorous tripping at the ankles, tipping the subject over the edge. If the assassin immediately sets up an outcry, play the "horrified witness," no alibi or surreptitious withdrawal is necessary.

Falls in front of trains or subway cars are usually effective, but these require exact timing and can seldom be free from unexpected observation.

Automobile accidents are less satisfactory. If the subject is to be deliberately run down, exact timing is necessary and investigation is likely to be thorough. The subject may be stunned or drugged and then placed in a car, but this is reliable only when the car can be run off a high cliff or into deep water without observation.

### Edge and Blunt Weapons

Any locally obtained sharp-edged device may be successfully employed, though a minimum amount of anatomical knowledge is needed for reliability. The most reliable methods are severing the spinal cord in the cervical region (with the point of a knife or a light blow with an ax or hatchet) and severing the jugular and carotid blood vessels on both sides of the windpipe.

As for blunt weapons, their main advantage is their universal availability. A hammer may be picked up almost anywhere in the world. Baseball bats are widely distributed. Even a rock or a heavy stick will do, and no weapon need be disposed of.

Blows should be directed to the temple; the area just below and behind the ear; and the lower, rear portion of the skull. Of course, if the

blow is very heavy, any portion of the upper skull will do. The lower frontal portion of the head, from the eyes to the throat, can withstand enormous blows without fatal consequences.

### Explosives

A small or moderate explosive charge is highly unreliable as a cause

of death, and time-delay or booby-trap devices are extremely prone to kill the wrong man.

Bombs or grenades should never be thrown at a subject. While this will always cause a commotion and may even result in the subject's death, it is sloppy, unreliable, and bad propaganda.

### EXAMPLES

[Agents] may be presented brief outlines with critical evaluations of the following assassinations and attempts: Archduke Franz Ferdinand, Gandhi, Harding, Hitler, Lincoln, Long, Mussolini, Rasputin, Roosevelt, Trotsky, and Truman. •

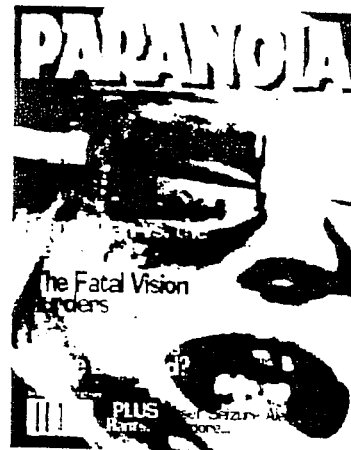
