## Non Conformity

### Issues:

Regulatory compliance and effectiveness of the applicable operational controls cannot be fully demonstrated as follow:

- 1. PNRI Radioactive Material License # Y16.2009.07 (Leighton-use of Ce-137 and Am-241 for nuclear gauges) and I16-19028.07 (WITCO-Industrial radiography): Use of unauthorized personnel during handling and testing of radioactive material was noted (i.e. Leighton: Jason Carredo / WITCO: Niel Aumentado radiation dosage reported in the utilization log). PNRI Radioactive Material Licenses require only authorized users as listed in the permit to use the radioactive material. Furthermore, proactive detection of any radiation leakage cannot be determined since survey meter is stored together with radioactive material. The survey meter was noted out of battery during the time of the audit (i.e. 18 Feb. 2008 pm).
- 2. DOLE Department Order # 13: Not all heavy equipment has testing and certification from or its recognized organization/s prior to commissioning of said equipment. Sect. 10.1 (b) of the regulation requires "All heavy equipment must be tested and certified in accordance with the standards prepared by DOLE or its recognized organization/s prior to commissioning of said equipment".
- 3. DOLE OSH Standard Rule 1053.01 and 1053.02: Dangerous occurrence happened on 14 October 2007 as reported in the Accident/Incident/Near Miss Notification Report # P2324-001 (i.e. IHI excavator operated by Square Steel Builders fell into the pit). However, no record of regulatory reporting was evident during the time of the audit. OSH Standard Rule 1053.01 and 1053.02 requires reporting on the 20<sup>th</sup> day of the month following the incident. Furthermore, Section 4.1.3.2 (7) of the Project OH&S Management Plan requires reporting of the case to DOLE, DENR and Building Official within 24 hours, in writing.
- 4. 2 contractor personnel were conducting painting work at Hydrocarbon area without the Work Permit on 19 Feb. 2008 at 1345. Project OH&S Management Plan requires Work Permit during working at height.

# Requirements

OHSAS 18001:1999 clause 4.5.1(c) states "... The organization shall ... and maintain procedures to monitor and measure OH&S performance on a regular basis. These procedures shall provide for: proactive measures of performance that monitor compliance with operational criteria and applicable legislation and regulatory requirements..."

# Observation

- 1. No accredited Safety Practitioner at the project site
- 2. Documented procedures and work instructions on proper handling of radioactive materials were not readily available at the Laboratory
- 3. Consider update of on Heavy & Light Equipment Safety Inspection Checklist to cover track pad inspection items for backhoe, bulldozers, etc.
- 4. Passenger Ship Safety Certificate (Expiration date: 25 Feb. 2008) and Passenger Insurance Coverage (03 March 2008) will expire before end of period (i.e. 10 March 2008).
- 5. Consider to include ill-health investigation as part of the project OH&S plan.
- 6. Consider review of the existing medicine, medical supplies and equipment to ensure compliance to OSH Standard Table 47.
- 7. WITCO Safety Officer defined in the project organization. However, records of competency are not available.
- 8. Records of drug test clearance for 3 personnel involved in the boat operation cannot be effectively demonstrated.
