Creating a Post-Gender Society

BERLIN — Caitlyn Jenner may have given Americans a crash course in transgender acceptance. But progressive pockets of Europe are moving toward an even higher plane — embracing what advocates describe as a post-gender world that critics say is leaving no room for women to be women and men to be men.

In Berlin, for instance, fresh rules for billboard ads in a district of the liberal German capital read like a new constitution for a land without gender identity. Girls in pink “with dolls” are basically out, as are boys in blue playing “with technical toys.” In ads showing both adult women and men, females cannot be depicted as “hysterical,” “stupid” or “naive” alongside men presented as “technically skilled,” “strong” or “business savvy.”

Adult women — featured alone or otherwise — must not be shown “occupied in the household with pleasure.” And in one stipulation pounced upon by critics, the equal-opportunity board of Friedrichshain-Kreuzberg — home to Checkpoint Charlie and remnants of the Berlin Wall — no longer wants to see images of women “smiling for no reason.”

“Women are always portrayed in a nice, easygoing way, and that is what we do not want,” complained Petra Koch-Knöbel, head of the committee that drafted the new rules that went into effect in April for 28 billboards leased out by the district. The board is now pushing to expand the policy to privately owned sites. Detractors call it further evidence of an assault in Europe on gender roles that, some claim, is especially targeting heterosexual men. Facetiously celebrating the benefit of the new ad rules for men, Die Zeit newspaper columnist Harald Martenstein wrote, “We are allowed to smile where and whenever we want, even while doing the dishes.”

Millennials in both the United States and Europe are breaking free of gender roles and rejecting stereotypes. This week, pop idol Miley Cyrus told Paper Magazine that she felt neither male nor female. Jenner's butterfly-like transformation, meanwhile, has touched off a broader conversation over transgender Americans.

In Europe, the crusade against sexual inequality, gender roles and stereotypes has been raging for years, with nations like Sweden pioneering progressive policies toward women and Denmark legally recognizing same-sex couples as far back as 1989.

But advocates in Europe are taking increasingly aggressive action regarding “gender mainstreaming,” or the erasing of lines between the sexes. They are pressing for policies and laws ensuring that everything from bathrooms to boardrooms to street signs are gender neutral.

In part, the push is about fuller equality for women and sexual minorities, in both the job market and the public sphere. But, proponents say, it is also about enforcing respect and breaking the male domination of European life.

In March, Germany — home of Chancellor Angela Merkel, arguably the most powerful woman in the world — became the largest nation in Europe to legislate that women must occupy at least 30 percent of the seats on corporate boards. That means that some of the globe’s largest multinational firms, including Siemens and Daimler, must by law also now be among the most inclusive.

Politics of language

In Germany — a country that, unlike some of its neighbors, doesn’t recognize same-sex marriage and where surveys still show significant levels of sexual harassment of women — the march toward gender mainstreaming is sparking heated debate. Some critics are decrying what they see as the rise of a militant feminism and gender-based political correctness that, in some cases, is altering age-old traditions.

Niko Schilling, a 27-year-old sports organizer at the University of Passau in Bavaria, for instance, said he was shocked when he received a call several weeks ago from his school’s equal-opportunity coordinator. She forbade him to hold a series of contests on campus, including a competition involving a Bavarian tradition, called fensterln, in which men in lederhosen race up ladders to be the first to kiss a woman on a balcony.

“I thought it was an April Fools’ Day joke when she called me five days before the event and told me it was offending university guidelines,” he said. “Gender mainstreaming is going too far in some respects.”

Sweden this year added the gender-neutral pronoun “hen” to official dictionaries. The word caught on several years ago when Egalia, a preschool in Stockholm, began using it as a substitute for “boys” or “girls” to avoid referencing gender roles in children.

In Germany and Austria, a push is also underway to alter the gender-based German language, in which nouns such as “police officers” or “teachers” take a masculine form even when referring to a mixed group of men and women.

Some German and Austrian university professors are demanding that students embrace new gender-neutral vocabulary in essays and thesis papers. In Austria, a special language committee recommended last year that gender-neutral language be made standard in official life — a proposal that so divided politicians and society that ultimately the board was dissolved.

“Language reflects power structures,” said Anne Wizorek, a self-described feminist author based in Berlin. “If we want an inclusive society, we need to reflect that in our language.”

Traffic lights in Germany have long flashed images of green- or red-lit men — some wearing cute hats — to tell pedestrians when to walk or stop at intersections. But gradually that is changing, with cities like Bremen and Cologne among those that have replaced many of the male figures with those of women. Last month in Vienna, city officials went further, replacing traffic-sign figures of solitary men with heterosexual and same-sex couples. That came three years after Austria officially changed its national anthem, which once spoke only of its “great sons.” The new language heralds women first, celebrating “great daughters” and “sons.”

Taking a lead from gender-neutral Swedish retailing, the 2015 catalogue for the German toy store [BR-Spielwaren](#) features a girl playing with a toy gun and boy in an apron playing in a toy kitchen.

Awkward transitions

Some changes take more getting used to than others. Over the past two years, at least six unisex toilets — most with multiple stalls and some fitted with urinals — have opened in Berlin city administration buildings and theaters. The city is now conducting reviews of public buildings with the aim of establishing dozens more such bathrooms in coming years.

The hope is to create even more spaces where men, women and anyone else

can heed the call of nature side by side, doing away with prudish notions of sexual differences.

Berlin — like Germany more generally — is already a city that is no stranger to intimate exposure between sexes. It is not unusual to see naked members of both sexes luxuriating in the summer sun in city parks or public pools. The sharing of bathrooms is merely the next step and, officials say, also offers a safe place for those with gender identity issues.

“Initially we were laughed at for this, but now that people are discovering that unisex toilets are just normal bathrooms, we are experiencing rather broad acceptance,” Simon Kowalewski, a member of the Berlin state parliament whose Pirate Party proffered the idea in the first place.

It can, however, still be awkward. The Studio F theater in Berlin, for instance, converted its male and female bathrooms to unisex toilets about 18 months ago. On the doors are the universal gender signs for men and women but also signs for transgender and intersex.

Blooms sit in the urinals, along with a sign saying “Flowers for a Gender Free World.” Felix Witzlau, a 26-year-old student, exclaimed in wonder as he entered the toilet, where both men and women were coming out of stalls. Looking at the urinals, he said, “Should I water the flowers now?”

But he shyly chose a stall instead. “It did feel a bit awkward hearing female voices outside,” he said after emerging. “But I could get used to it.”

However, despite incredibly small numbers feeling that transgenderism is something morally acceptable, school districts like Fairfax are determined to make it mainstream—and part of the mandatory curriculum.

America's Most Biblically-Hostile U. S. President

When one observes President Obama's unwillingness to accommodate America's four-century long religious conscience protection through his attempts to require Catholics to go against their own doctrines and beliefs, one is tempted to say that he is anti-Catholic. But that characterization would not be correct. Although he has recently singled out Catholics, he has equally targeted traditional Protestant beliefs over the past four years. So since he has attacked Catholics and Protestants, one is tempted to say that he is anti-Christian. But that, too, would be inaccurate. He has been equally disrespectful in his appalling treatment of religious Jews in general and Israel in particular. So perhaps the most accurate description of his antipathy toward Catholics, Protestants, religious Jews, and the Jewish nation would be to characterize him as anti-Biblical.

Listed below in chronological order are (1) numerous records of his attacks on Biblical persons or organizations; (2) examples of the hostility toward Biblical faith that have become evident in the past three years in the Obama-led military; (3) a listing of his open attacks on Biblical values; and finally (4) a listing of numerous incidents of his preferential deference for Islam's activities and positions, including letting his Islamic advisors guide and influence his hostility toward people of Biblical faith.

1. Acts of hostility toward people of Biblical faith:

December 2009-Present - The annual White House Christmas cards, rather than focusing on Christmas or faith, instead highlight things such as the family dogs. And the White House Christmas tree ornaments include figures such as Mao Tse-Tung and a drag queen.

June 2013 – The Obama Department of Justice defunds a Young Marines chapter in Louisiana because their oath mentioned God, and another youth program because it permits a voluntary student-led prayer.

February 2013 – The Obama Administration announces that the rights of religious conscience for individuals will not be protected under the Affordable Care Act.

January 2013 – Pastor Louie Giglio is pressured to remove himself from praying at the inauguration after it is discovered he once preached a sermon supporting the Biblical definition of marriage.

February 2012 – The Obama administration forgives student loans in exchange for public service, but announces it will no longer forgive student loans if the public service is related to religion.

January 2012 – The Obama administration argues that the First Amendment

provides no protection for churches and synagogues in hiring their pastors and rabbis.

December 2011 – The Obama administration denigrates other countries' religious beliefs as an obstacle to radical homosexual rights.

November 2011 – President Obama opposes inclusion of President Franklin Roosevelt's famous D-Day Prayer in the WWII Memorial.

November 2011 – Unlike previous presidents, Obama studiously avoids any religious references in his Thanksgiving speech.

August 2011 – The Obama administration releases its new health care rules that override religious conscience protections for medical workers in the areas of abortion and contraception.

April 2011 – For the first time in American history, Obama urges passage of a non-discrimination law that does not contain hiring protections for religious groups, forcing religious organizations to hire according to federal mandates without regard to the dictates of their own faith, thus eliminating conscience protection in hiring.

February 2011 – Although he filled posts in the State Department, for more than two years Obama did not fill the post of religious freedom ambassador, an official that works against religious persecution across the world; he filled it only after heavy pressure from the public and from Congress.

January 2011 – After a federal law was passed to transfer a WWI Memorial in the Mojave Desert to private ownership, the U. S. Supreme Court ruled that the cross in the memorial could continue to stand, but the Obama administration refused to allow the land to be transferred as required by law, and refused to allow the cross to be re-erected as ordered by the Court.

November 2010 – Obama misquotes the National Motto, saying it is “E pluribus unum” rather than “In God We Trust” as established by federal law.

October 19, 2010 – Obama begins deliberately omitting the phrase about “the Creator” when quoting the Declaration of Independence – an omission he has made on no less than seven occasions.

May 2009 – Obama declines to host services for the National Prayer Day (a day established by federal law) at the White House.

April 2009 – When speaking at Georgetown University, Obama orders that a monogram symbolizing Jesus' name be covered when he is making his speech.

April 2009 – In a deliberate act of disrespect, Obama nominated three pro-abortion ambassadors to the Vatican; of course, the pro-life Vatican rejected all three.

February 2009 – Obama announces plans to revoke conscience protection for health workers who refuse to participate in medical activities that go against their beliefs, and fully implements the plan in February 2011.

April 2008 – Obama speaks disrespectfully of Christians, saying they “cling to guns or religion” and have an “antipathy to people who aren't like them.”

2. Acts of hostility from the Obama-led military toward people of Biblical faith:

- March 2015 - A decorated Navy chaplain was prohibited from fulfilling his duty of comforting the family (or any member of the unit) after the loss of a sailor because it was feared that he would say something about faith and God. He was even banned from the base on the day of the sailor's memorial service.
-
- March 2015 - A highly decorated Navy SEAL chaplain was relieved of duty for providing counseling that contained religious views on things such as faith, marriage, and sexuality.
-
- June 2014 - Official U. S. government personnel, both civilian and military, in Bahrain (a small Arabic nation near Saudi Arabia, Iraq, and Iran) must wear clothing that facilitates the religious observance of the Islamic holy month of Ramadan.
-
- March 2014 - Maxwell Air Force Base suddenly bans Gideons from handing out Bibles to willing recruits, a practice that had been occurring for years previously.
-
- December 2013 - A naval facility required that two nativity scenes -- scenes depicting the event that caused Christmas to be declared a national federal holiday -- be removed from the base dining hall and be confined to the base chapel, thus disallowing the open public acknowledgment of this national federal holiday.
-
- December 2013 - An Air Force base that allowed various public displays

- ordered the removal of one simply because it contained religious content.
-
- October 2013 – A counter-intelligence briefing at Fort Hood tells soldiers that evangelical Christians are a threat to Americans and that for a soldier to donate to such a group “was punishable under military regulations.”
-
- October 2013 – Catholic priests hired to serve as military chaplains are prohibited from performing Mass services at base chapels during the government financial shutdown. When they offered to freely do Mass for soldiers, without regard to whether or not the chaplains were receiving pay, they are still denied permission to do so.
-
- October 2013 - The Air Force Academy, in response to a complaint from Mikey Weinstein's Military Religious Freedom Foundation, makes "so help me God" optional in cadets' honor oath.
-
- August 2013 - A Department of Defense military training manual teaches soldiers that people who talk about "individual liberties, states' rights, and how to make the world a better place" are "extremists." It also lists the Founding Fathers -- those "colonists who sought to free themselves from British rule" -- as examples of those involved in "extremist ideologies and movements."
-
- August 2013 - A Senior Master Sergeant was removed from his position and reassigned because he told his openly lesbian squadron commander that she should not punish a staff sergeant who expressed his views in favor of traditional marriage.
-
- August 2013 - The military does not provide heterosexual couples specific paid leave to travel to a state just for the purpose of being married, but it did extend these benefits to homosexual couples who want to marry, thus giving them preferential treatment not available to heterosexuals.
-
- August 2013 - The Air Force, in the midst of having launched a series of attacks against those expressing traditional religious or moral views, invited a drag queen group to perform at a base.
-
- July 2013 - When an Air Force sergeant with years of military service questioned a same-sex marriage ceremony performed at the Air Force Academy's chapel, he received a letter of reprimand telling him that if he disagreed, he needed to get out of the military. His current six-year reenlistment was then reduced to only one-year, with the notification that he "be prepared to retire at the end of this year."

- July 2013 - An Air Force chaplain who posted a website article on the importance of faith and the origin of the phrase "There are no atheists in foxholes" was officially ordered to remove his post because some were offended by the use of that famous World War II phrase.
-
- June 2013 - The U. S. Air Force, in consultation with the Pentagon, removed an inspirational painting that for years has been hanging at Mountain Home Air Force Base because its title was "Blessed Are The Peacemakers" -- a phrase from Matthew 5:9 in the Bible.
-
- June 2013 – The Obama administration “strongly objects” to a Defense Authorization amendment to protect the constitutionally-guaranteed religious rights of soldiers and chaplains, claiming that it would have an “adverse effect on good order, discipline, morale, and mission accomplishment.”
-
- June 2013 – At a joint base in New Jersey, a video was made, based on a Super Bowl commercial, to honor First Sergeants. It stated: “On the eighth day, God looked down on His creation and said, ‘I need someone who will take care of the Airmen.’ So God created a First Sergeant.” Because the video mentioned the word “God,” the Air Force required that it be taken down.
-
- June 2013 – An Army Master Sergeant is reprimanded, threatened with judicial action, and given a bad efficiency report, being told he was “no longer a team player,” because he voiced his support of traditional marriage at his own promotion party.
-
- May 2013 - The Pentagon announces that "Air Force members are free to express their personal religious beliefs as long as it does not make others uncomfortable. "Proselytizing (inducing someone to convert to one's faith) goes over that line," affirming if a sharing of faith makes someone feel uncomfortable that it could be a court-marital offense -- the military equivalent of a civil felony.
-
- May 2013 - An Air Force officer was actually made to remove a personal Bible from his own desk because it "might" appear that he was condoning the particular religion to which he belonged.
-
- April 2013 – Officials briefing U.S. Army soldiers placed "Evangelical Christianity" and "Catholicism" in a list that also included Al-Qaeda, Muslim Brotherhood, and Hamas as examples of "religious extremism."
-
- April 2013 – The U.S. Army directs troops to scratch off and paint over tiny

Scripture verse references that for decades had been forged into weapon scopes.

-
- April 2013 - The Air Force creates a "religious tolerance" policy but consults only a militant atheist group to do so -- a group whose leader has described military personnel who are religious as 'spiritual rapists' and 'human monsters' and who also says that soldiers who proselytize are guilty of treason and sedition and should be punished to hold back a "tidal wave of fundamentalists."
-
- January 2013 – President Obama announced his opposition to a provision in the 2013 National Defense Authorization Act protecting the rights of conscience for military chaplains.
-
- June 2012 – Bibles for the American military have been printed in every conflict since the American Revolution, but the Obama Administration revokes the long-standing U. S. policy of allowing military service emblems to be placed on those military Bibles.
-
- May 2012 – The Obama administration opposed legislation to protect the rights of conscience for military chaplains who do not wish to perform same-sex marriages in violation of their strongly-held religious beliefs.
-
- April 2012 – A checklist for Air Force Inns will no longer include ensuring that a Bible is available in rooms for those who want to use them.
-
- February 2012 – The U. S. Military Academy at West Point disinvites three star Army general and decorated war hero Lieutenant General William G. (“Jerry”) Boykin (retired) from speaking at an event because he is an outspoken Christian.
-
- February 2012 – The Air Force removes “God” from the patch of Rapid Capabilities Office (the word on the patch was in Latin: Dei).
-
- February 2012 – The Army ordered Catholic chaplains not to read a letter to parishioners that their archbishop asked them to read.
-
- November 2011 – The Air Force Academy rescinds support for Operation Christmas Child, a program to send holiday gifts to impoverished children across the world, because the program is run by a Christian charity.
-
- November 2011 – President Obama opposes inclusion of President Franklin Roosevelt’s famous D-Day Prayer in the WWII Memorial.
-

- November 2011 – Even while restricting and disapprobating Christian religious expressions, the Air Force Academy pays \$80,000 to add a Stonehenge-like worship center for pagans, druids, witches and Wiccans at the Air Force Academy.
-
- September 2011 – Air Force Chief of Staff prohibits commanders from notifying airmen of programs and services available to them from chaplains.
-
- September 2011 – The Army issues guidelines for Walter Reed Medical Center stipulating that “No religious items (i.e. Bibles, reading materials and/or facts) are allowed to be given away or used during a visit.”
-
- August 2011 – The Air Force stops teaching the Just War theory to officers in California because the course is taught by chaplains and is based on a philosophy introduced by St. Augustine in the third century AD – a theory long taught by civilized nations across the world (except now, America).
-
- June 2011 – The Department of Veterans Affairs forbids references to God and Jesus during burial ceremonies at Houston National Cemetery.
-
- January 2010 – Because of "concerns" raised by the Department of Defense, tiny Bible verse references that had appeared for decades on scopes and gunsights were removed.

3. Acts of hostility toward Biblical values:

- March 2014 - The Obama administration seeks funding for every type of sex-education -- except that which reflects traditional moral values.
-
- August 2013 - Non-profit charitable hospitals, especially faith-based ones, will face large fines or lose their tax-exempt status if they don't comply with new strangling paperwork requirements related to giving free treatment to poor clients who do not have Obamacare insurance coverage. Ironically, the first hospital in America was founded as a charitable institution in 1751 by Benjamin Franklin, and its logo was the Good Samaritan, with Luke 10:35 inscribed below him: "Take care of him, and I will repay thee," being designed specifically to offer free medical care to the poor. Benjamin Franklin's hospital would likely be fined unless he placed more resources and funds into paperwork rather than helping the poor under the new faith-hostile policy of the Obama administration.
-
- August 2013 - USAID, a federal government agency, shut down a conference in South Korea the night before it was scheduled to take place because some of the presentations were not pro-abortion but instead presented

- information on abortion complications, including the problems of "preterm births, mental health issues, and maternal mortality" among women giving birth who had previous abortions.
- - June 2013 – The Obama Administration finalizes requirements that under the Obamacare insurance program, employers must make available abortion-causing drugs, regardless of the religious conscience objections of many employers and even despite the directive of several federal courts to protect the religious conscience of employers.

 - April 2013 – The United States Agency for Internal Development (USAID), an official foreign policy agency of the U.S. government, begins a program to train homosexual activists in various countries around the world to overturn traditional marriage and anti-sodomy laws, targeting first those countries with strong Catholic influences, including Ecuador, Honduras, and Guatemala.
 -
 - December 2012 – Despite having campaigned to recognize Jerusalem as Israel's capital, President Obama once again suspends the provisions of the Jerusalem Embassy Act of 1995 which requires the United States to recognize Jerusalem as the capital of Israel and to move the American Embassy there.
 -
 - July 2012 - The Pentagon, for the first time, allows service members to wear their uniforms while marching in a parade - specifically, a gay pride parade in San Diego.

 - October 2011 – The Obama administration eliminates federal grants to the U.S. Conference of Catholic Bishops for their extensive programs that aid victims of human trafficking because the Catholic Church is anti-abortion.

 - September 2011 – The Pentagon directs that military chaplains may perform same-sex marriages at military facilities in violation of the federal Defense of Marriage Act.

- July 2010 – The Obama administration uses federal funds in violation of federal law to get Kenya to change its constitution to include abortion.

- January 2009 – President Obama’s nominee for deputy secretary of state asserts that American taxpayers are required to pay for abortions and that limits on abortion funding are unconstitutional.

America is at War - - - Against Jesus Christ!

America, Christianity, and the Culture War

For 185 years, American culture was friendly toward Christianity. America was, in fact, considered a “Christian nation.” After all, America has **never** been considered an Islamic, Buddhist, or Hindu nation, even as it has never been a religionless nation. But for the last 50 years, sinister forces—from humanism, atheism, and evolution to social liberalism, pluralism, and “political correctness”—have been aggressive in their assault on the Christian religion. They have succeeded in gradually dismantling many of the moral and spiritual principles that once characterized society. America’s religious, moral, and spiritual underpinnings are literally disintegrating.

Indeed, **America is at war!** This war is far more serious and deadly than any physical conflict (like the Iraq war). America is fighting a spiritual culture war. Regardless of the surface issues, **the central issue is—God**. Make no mistake: ***America is in the throes of a life-and-death struggle over whether the God of the Bible will continue to be acknowledged as the one true God, and Christianity as the one true religion.***

Now more than ever before, social and political liberals—from Hollywood to the University to the nation’s Capitol—are openly hostile toward God. Those who profess Christianity are facing the most perilous times ever faced in America. Every effort is being made to expunge references to God and Christianity from public life. Revisionist historians, liberal politicians, secularist educators, morally bankrupt entertainers, and activist judges, prodded by socialistic organizations like the ACLU (American Civil Liberties Union), AUSCS (Americans United for Separation of Church and State), and the NEA (National Educational Association), are feverishly reshaping our history, laws, and traditional way of life. [NOTE: The politically and socially liberal orientation of the NEA was demonstrated at its 2005 national convention with “its usual favoritism toward the gays and the feminists, hostility to parents, and support of liberal causes” (Schlafly, 2005).]

These sinister forces have mounted a massive, full-scale assault on traditional moral values. They are endeavoring to sanitize our society, cleansing it of its Christian connections. This conspiracy parades itself under the guise that the Founding Fathers and the *Constitution* advocated a “separation of church and state.” The clever ploy goes something like this: “The Founders intended for our political institutions and public schools to be **religiously neutral**; a strict **church-state separation** must be observed, with religion completely excluded from the public sector; any such religious references would constitute an **illegal endorsement of religion by the government**.” Thus, no references to God or Christianity in public settings must be allowed—whether in the government, the community, or the public school.

This conspiratorial departure from the nation’s origins, which has been spouted incessantly for some 50 years, has thoroughly permeated the American population and will surely go down in history as one of the big myths perpetrated on a people. For all practical purposes, America has become an atheistic, secularized, pluralistic state. Even the pagan monarchies of world history at least allowed their polytheistic beliefs to be incorporated into public life.

For the last 50 years, in their orchestrated conspiracy to gain sanction for abortion, pornography, homosexuality, atheistic evolution, and a host of other evil, morally-bankrupt behaviors and beliefs, “first amendment rights,” “free speech,” “intolerance!,” and “censorship!” have been the whips that social liberals have used to beat, bully, and berate their opponents into silent submission. But let one person utter even one peep of disagreement, and suddenly the “compassionate” liberals begin spewing **hate-speech** and, ironically, **become completely intolerant, mean-spirited, and insensitive!**

Prior to the 1960s, when the Christian worldview thoroughly permeated American civilization, the anti-Christian forces demanded “equal time” and clamored for “freedom to express dissenting, alternative views.” They derided the moral majority by accusing them of using “Gestapo tactics” to suppress ideological opposition. But now that they, to a great extent, have had their way, free speech and open discussion in the free market of ideas is out the window and opposing views are swiftly squelched. The anti-Christian forces in American society now exhibit the same intolerant mindset that has characterized totalitarian and communist regimes throughout history.

Undoubtedly, during the social ferment of the turbulent 1950s and 1960s, when subversive moral and religious ideologies began to assert themselves, one of the strategic mistakes made was permitting the instigators to redefine the historical terms and concepts as originally articulated by the architects of American civilization. “Free speech” was redefined to mean the right to practice and

promote any and every idea or behavior that contradicted Christianity—no matter how immoral or depraved. Everything from burning or urinating on the flag to hardcore pornography came to be classified as “free speech,” while Christian resistance was considered “censorship.” The minority within America who has exhibited hostility toward God, the Bible, and Christianity have literally intimidated and coerced the majority into accepting, as justification for their outrageous stance, the backing of the *Constitution*. Yet, the historical evidence demonstrates that the Founders and Framers never would have countenanced the notion that “free speech” encompassed speech and behavior deemed immoral by Christian standards (see “Religion and the Founding...,” 2003).

We live in a time warp far removed from America’s origins. The Founders clearly believed that the initial existence and future survival of the Republic was heavily, if not exclusively, dependent on a perpetuated diffusion of the Bible and Christianity throughout society. Yet, for half a century, Americans have been pounded and prodded with the propaganda that public expressions of Christianity should not be allowed lest we “offend” those who do not share our Christian beliefs. Who could have ever imagined that the day could come that the practice of the Christian religion in a Christian nation would be deemed “insensitive”?

To illustrate the extent to which America has plummeted from its original heights, while a Federal judge was demanding that the Chief Justice of the Alabama State Supreme Court remove a Ten Commandments monument in Montgomery, Alabama (“Chief Justice...,” 2003), guess what was happening in California? A small marker was unveiled in Sacramento, California (Capitol Park) along the walkway of the California Veterans Memorial that reads: “In Honor of Gay, Lesbian, Bisexual, and Transgender Veterans Killed in Action” (Sanders, 2003). Gay-rights advocates hailed the memorial as the first such **state-sanctioned** landmark honoring homosexual war veterans.

Incredible! Honoring “gays” is praiseworthy, while honoring God is repugnant and unconstitutional. This scenario is a microcosm of what is happening all over the nation. Allusions to the God of the Bible are being systematically stripped from public life—from Christian symbols in city and county seals, to pre-game prayers after school, to the use of the Bible in jury deliberation rooms (see Palm and Krannawitter, 2004; Hume, 2005; Johnson, 2005).

Is it true that the Founding Fathers and the *Constitution* intended for Christianity to be kept out of the public sector? Did they desire that references to God, Christ, and the Bible be excluded from public life? Or were they, in fact, actually more concerned with preventing the government from interfering with public expressions of the Christian religion? Did they, themselves, appeal frequently to God in political and public settings? Did they (and their descendants for the first 180+ years), in fact, recognize and subscribe to the critical principle: “Blessed is

the nation whose God is the Lord” (Psalm 33:12)? Indeed, they did. I invite you to consider but a small portion of the massive amount of available evidence from the withered roots of America’s forgotten heritage.

PUBLIC EXPRESSIONS OF GOD POLITICAL DOCUMENTS

The Declaration of Independence

The *Declaration of Independence* is the premiere document that launched America as a new nation. Here is a quintessentially **political** document—a public expression of national concerns intended to articulate justification for declaring a separation from England. If the Founders intended to keep God out of national life, here was the perfect opportunity to manifest that intention. However, in this relatively brief document, they used the following phrases: “Nature’s God” (i.e., an 18th century way to refer to the God Who created nature), “all men are **created** equal” and “endowed by their **Creator**,” “appealing to the **Supreme Judge** of the world,” and “with a firm reliance on the protection of **divine Providence**” (*The Declaration...*). Astounding! The 56 signers of the *Declaration of Independence*, in risking their very lives, put their signatures to a **political** document that **acknowledged and appealed to the God of the Bible four times!** So much for their alleged insistence on “separation of church and state.”

The Federal Constitution

It is evident that the federal *Constitution* refrains from giving specific directives regarding Christianity. Why? The popular propaganda since the 1960s has been that “the irreligious Framers did not want the nation to retain any attachment to the Christian religion.” Such an assertion is a monstrous perversion of historical fact. The truth of the matter is that they were fearful of the potential interference by the federal government in its ability to place restrictions on the free exercise of the Christian religion. Consequently, they desired that the specifics of religion be left up to the discretion of the several states. However, we must not think for a moment that the federal Framers did not sanction the nation’s intimate affiliation with Christianity, or that they attempted to keep religion out of the *Constitution*. On the contrary, **the Christian religion is inherently assumed and implicitly present in the *Constitution***. In fact, the *United States Constitution* contains a **direct reference to Jesus Christ!** Consider three proofs for these contentions:

First, consider the meaning of the First Amendment to the *Constitution*: “Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof....” We have been told that by “establishment of religion,” the Framers meant for the government to maintain complete religious neutrality and that pluralism ought to prevail, i.e., that all religions (whether

Christianity, Islam, Buddhism, or Hinduism), though equally tolerated, must not be given any acknowledgement in the public sector. **But such an outlandish claim is absolutely false.** All one has to do is to go directly to the delegate discussions pertaining to the wording of the First Amendment in order to ascertain the context and original intent of the final wording (*Annals of Congress*, 1789, pp. 440ff.). The facts of the matter are that by their use of the term “religion,” the Framers had in mind the several Protestant denominations. Their concern was to prevent any single Christian denomination from being elevated above the others and made the State religion—a circumstance that the Founders had endured under British rule when the Anglican Church was the state religion of the thirteen colonies. They further sought to leave the individual States free to make their own determinations with regard to religious (i.e., Christian) matters (cf. Story, 1833, 3.1873:730-731). The “Father of the Bill of Rights,” George Mason, actually proposed the following wording for the First Amendment, which demonstrates the context of their wording:

[A]ll men have an equal, natural and unalienable right to the free exercise of religion, according to the dictates of conscience; and that **no particular sect or society of Christians** ought to be favored or established by law in preference to others (Rowland, 1892, 1:244, emp. added).

By “prohibiting the free exercise thereof,” the Framers intended to convey that the federal government was not to interfere with the free and public practice of the **Christian** religion—the very thing that Christians are now experiencing.

Second, consider the wording of a sentence from Article 1, Section 7 of the *Constitution*: “If any Bill shall not be returned by the President within ten Days (Sundays excepted) after it shall have been presented to him, the Same shall be a Law, in like Manner as if he had signed it...” “Sundays excepted”? Oh, you mean that the government shuts down and does not transact business on Sunday? Why? If this provision had been made in respect of Jews, the *Constitution* would have read “Saturdays excepted.” If provision had been made for Muslims, the *Constitution* would have read “Fridays excepted.” If the Founders had intended to encourage a day of inactivity for the government without regard to any one religion, they could have chosen Monday, Tuesday, Wednesday, or Thursday. Instead, the federal *Constitution* reads “Sundays excepted”—proving conclusively that America was **Christian** in its orientation and that the Framers themselves shared the Christian worldview and gave political recognition to and accommodation of that fact.

Third, if these two allusions to Christianity are not enough, consider yet another. Immediately after Article VII, the *Constitution* closes with the following words:

Done in Convention by the Unanimous Consent of the States present the

Seventeenth Day of September in the Year of our Lord one thousand seven hundred and Eighty seven and of the Independence of the United States of America the Twelfth....

Did you catch it? Their work was done “in the Year of our Lord.” The Christian world dates all of human history in terms of the birth of Christ. “B.C.” means “before Christ,” and “A.D.” is the abbreviation for the Latin words “*anno Domini*,” meaning “year of our Lord.” If the Framers were interested in being pluralistic, multi-cultural, and politically correct, they would have refrained from using the B.C./A.D. designation. Or they would have used the religionless designations “C.E.,” Common Era, and “B.C.E.,” Before the Common Era (see “Common Era,” 2006). In so doing, they would have avoided offending Jews, atheists, agnostics, and humanists. Or they could have used “A.H.” (*anno hegirae*—which means “in the year of the Hijrah” and refers to Muhammad’s flight from Mecca in A.D. 622), the date used by Muslims as the commencement date for the Islamic calendar. Instead, the Framers chose to utilize the dating method that indicated the worldview they shared. What’s more, their reference to “our Lord” does not refer to a generic deity, nor does it refer even to God the Father. It refers to God the Son—**an explicit reference to Jesus Christ**. Make no mistake: the *Constitution of the United States* contains an explicit reference to Jesus Christ—not Allah, Buddha, Muhammad, nor the gods of Hinduism or Native Americans!

So, Who is the Force Behind the War Against Christianity?

Jewish Anti-Christianity Intensifies As Christians Ignore It

Attacks by Jewish activists on Christianity have never been bolder in the US than this past year. Some Jews themselves state this fact, such as Rabbi Daniel Lapin, who warns of his liberal brethren’s onslaught against Christianity. Zef Chafets, Jewish journalist and author of *A Match Made in Heaven*, recently offered a warning, too. He wrote a Christian-friendly rebuttal to Abe Foxman’s scathing critique of the church in *Time* online.

Chafets cites the hostility of Foxman, Rabbi Eric Yoffie, and Rabbi James Rudin of the American Jewish Committee, who all shrilly attack Christians’ political

efforts as a supremacist threat. "Never before in U.S. history had Jewish leaders shown such bold hostility toward Evangelical Christians, the largest Protestant community in America and, by most measures, the most philo-Semitic and pro-Israel," writes Chafets.

A long string of books and national articles this past year decry Christian "supremacists." One of the latest is *The Baptizing of America* by Rabbi James Rudin, who claims the most urgent threat facing America is the religious right. As noted in a previous article, (See, <http://truthtellers.org/alerts/openseason.html> - Open Season on Every Religion but One) Rudin's book just adds to the list of at least 21 major books or national articles published in 2006 attacking the Christian right.

Jewish leaders like Rudin can hardly even muster up thanks for the massive evangelical support of Israel. Last October, a rabbis' listserv (electronic mailing list) hosted debate about whether rabbis should attend John Hagee's "Night to Honor Israel" or similar events across the nation. Rabbis say they wouldn't deign to show up; evangelical motives are not to be trusted. Hagee promises not to witness to Jews (shame on him!) but other Christians might. Besides, the rabbis complain, Christian eschatology winds up with Jews having to convert to Christ, a prospect that horrifies religious Jews more than any other.

Is there any substance to the charge of Christian supremacism? Hardly. In his rebuttal of Foxman, Chafets correctly notes that the charge is both alarmist and incorrect. Christians don't want a theocracy. "Evangelicals have an agenda," says Chafets, "but it is largely the restoration of moral and ethical standards that have typified the U.S. since its inception but have been neglected in the last half century. You may disagree with this agenda, but it is not theocratic."

Wake up, we're having a fight!

Even though Foxman and other Jews attack so boldly, most evangelicals won't acknowledge Jewish attacks on them and their political freedom. The church at large continues to lavish Israel and American Zionists with material and spiritual support. The rabbis who criticize Hagee and refuse to show up for his "Night to Honor Israel" show more clarity than most Christian pastors; they are openly aware of the antagonism between true Christianity and their own humanist, globalist, Christ-rejecting agenda. They recognize the gulf that stretches in America between Christian morality and motives and the Jewish liberal social agenda.

If you don't think this gulf exists, browse www.jewsonfirst.org. This website openly displays Jewish hatred of Christianity and Christian expression. With the tagline, "Defending the First Amendment against the Christian Right," the

JewsOnFirst site showcases Jewish efforts to silence Christian expression in America.

The site boasts, for instance, of Jewish activist Rabbi Cheryl Rosenstein's attempts to force Kern High School District in Bakersfield to change the names of school breaks from "Christmas" and "Easter" back to "winter" and "spring." The site approvingly reviews Rabbi Rudin's previously mentioned book, *The Baptizing of America*, with its hand-wringing assessment of the looming "Christocracy" that will shred our freedoms if the "religious right" isn't squelched. Rudin says Christians are taking over in the bedroom (censuring homosexuality), the schoolroom (questioning Darwin), the courtroom ("Christocratic takeover of the judiciary") and "the newsroom, with its thousands of Christian broadcasts"

JewsOnFirst demonstrates a ferocious allergy to any kind of Christian expression. This is the same hatred shown by the Anti-Defamation League whose "anti-hate" laws should really just be called "anti-Christ" laws. Such laws have been used in Canada to warn pastors against quoting from Scripture in public and to stifle Christian, conservative expression wherever they have been enacted. This Dog Ain't Sleeping

For most evangelicals, Jewish rejection of Jesus Christ is the sleeping dog they want to leave alone. But this dog isn't asleep at all. Modern Talmudic Judaism possesses a virulent hatred of Jesus Christ and Christianity that is both awake and rabid in Israel and in the United States.

The Talmud is woven with anti-Christ and anti-Christian themes and stories.

THE SEXUAL DECADENCE OF WEIMAR GERMANY

“The decay of moral values in all areas of life—the period of deepest German degradation—coincided exactly with the height of Jewish power in Germany.” — Dr Friederich Karl Wiehe, *Germany and the Jewish Question*.

No account of the Jewish Question in Germany can be complete without some mention of the tidal wave of sexual immorality that was to engulf the country during the period of the Weimar Republic (1919-1933) following World War One. This also happened to be the apogee of Jewish power in Germany. Every single sphere of major influence had now fallen under Jewish control.

As you read this, remember this is the decadent and degenerate “Germany” that Hitler inherited when he took over as the leader of Germany. It is no wonder that he wanted to get the Jews out of positions of power, and give Germany back to the Germans.

1. THE CULTURAL TAKEOVER OF GERMANY BY THE JEWS

Dr Karl Wiehe, in his *Germany and the Jewish Question*, is painstaking in the details he provides:

Well before 1933 the Jews had taken possession of the *film industry* even more thoroughly than of the theater. That was understandable, because the earnings in the film industry overshadow the earnings of any other artistic activity....

The biggest step in the direction of the decline of the German cultural life [however] was taken in the field of the *light entertainment* genre. Here—in the genre of musical comedy and above all in revue and burlesque—frivolity and lasciviousness were to rear their ugly heads. So much so that during these years Berlin was quite correctly considered the most immoral city in the world.

It was Jews who introduced this pornographic “art form” to Germany, a debased genre completely unknown before the Great War, and so it is the Jews who can be held responsible for the general decline in morals.

The Jewish sexologists Ivan Bloch and Magnus Hirschfeld became the representatives of “sex research” camouflaged as science—a bogus science that was merely an excuse for pornography and propaganda designed to destroy the institute of marriage and the sanctity of the family.

Wiehe provides the following useful facts and statistics:

In 1931, over 60 percent of German films were produced by Jews and 82 percent of the film scripts were written by Jewish writers, though Jews made up less than 1 percent of the German population (0.90%). A quick look at the names of directors, producers, stage managers, actors, script writers and critics, “revealed everywhere an overwhelming preponderance of Jews.”

A cursory survey of the film titles, Wiehe tells us, shows us that the Jews had only one thing on the brain: sex. Here are some typical titles: “Moral und Sinnlichkeit” (*Morals and Sensuality*); “Was kostet Liebe?” (*What is the Price of Love*); “Wenn ein Weib den Weg verliert” (*When a Woman loses her Way*); “Prostitution” (*Prostitution*); “Sündige Mutter” (*Sinful Mama*); “Das Buch des Lasters” (*The Book of Vices*).

“The sensational titles correspond to the sleazy contents,” Wiehe complains. “All wallow in filth and display with cynical frankness the vilest scenes of sexual perversion.”

Light entertainment (revue/burlesque) was a Jewish innovation. The revue theaters, all concentrated within great cities such as Berlin, were owned and run almost exclusively by Jews. Shows consisted of little more than excuses for sexual titillation involving the display of the female form in lascivious dances that were to degenerate later into striptease and scenes of public masturbation. “In these revues,” Wiehe notes indignantly, “the uninhibited sex drive surrendered itself to disgusting orgies. All life was reduced to a common denominator of lust and its satisfaction. Chastity and self-discipline were mocked as old-fashioned prejudices.”

The Jews had managed, in the space of a mere fourteen years, to bring about a major “transvaluation of values” in Weimar Germany. The vices of the past were now its virtues. The only vice that remained was chastity.

A glance at the revue titles is again sufficient: “Zieh dich aus” (*Get Undressed*); “Tausend nackte Frauen” (*One Thousand Naked Women*); “Die Sünden der Welt” (*The Sins of the World*); “Häuser der Liebe” (*The Houses of Love*); “Streng Verboten!” (*Strictly Forbidden!*); “Sündig und Süß” (*Sweet and Sinful*).

Finally, there was the rich field of sexology: a new science consisting largely of dubious “case histories” purporting to reveal the depraved sexual habits of various anonymous patients. In order to give an air of academic respectability and erudition to these masturbatory fantasies—thrilling adventure stories involving necrophilia, bestiality and handkerchief fetishism—the more exciting details were often given in vulgar Latin “in order to exclude the lay reader.” However, it was not long before the Latin was diligently translated into the vernacular for the benefit of the unlatined lay reader, thus defeating the purpose of the prim “schoolmaster’s Latin”.

Wiehe reels off a long list of Jewish sexologists who he claims were in the forefront of writing such salacious treatises that were no more than pornography masquerading as science. Drs Magnus Hirschfeld and Ivan Bloch were the star writers in this field, their books still read avidly today by a gullible public hungry for details of the bizarre, the kinky and the perverse. Drs Ludwig Lewy-Lenz, Leo Schidrowitz, Franz Rabinowitsch, Georg Cohen, and Albert Eulenburg are some of the names Wiehe mentions.

Here are some of their depressing titles: “Sittengeschichte des Lasters” (*The History of Perversions*); “Sittengeschichte des Schamlosigkeit” (*The History of Shamelessness*); “Bilderlexikon der Erotic” (*Picture Lexicon of Eroticism*); “Sittengeschichte des Geheime und Verbotene” (*The History of the Secret and the Forbidden*). And here are some of the titles published by Dr Magnus Hirschfeld’s Institute of Sexual Science in Berlin [9]: *Aphrodisiacs, Prostitution, Sexual Catastrophes, Sexual Pathology, The Perverted*. Wiehe describes all these books as “the filthy publications of these pseudo-scientists”, all of them written by Jewish authors and published by Jewish publishers. He continues in the same acerbic vein:

These books were allegedly supposed to be scientific treatises, their ostensible purpose being to “educate” the broad masses about the dangers of sexual excesses. Under the guise of science, however, they speculated in the lust and lower instincts of their audience. Criminals, prostitutes and homosexuals took center stage in their repertoire.
