

Speech of RABBI Emanuel RABINOVICH as reported by Eustice Mullins May 14 1952.

The following is a a speech of Rabbi Emanuel Rubinovich before a special meeting of the Emergency council of European Rabbis in Budapest, Hungary, January 12 1952.

Greetings my Children: You have been called here to recapitulate the Prinipal steps of our progress. As you know, we had hoped to have twenty years between wars to condolidate the Great Gains which we made from world war Two. but our increasing numbers in certain vital areas is arouseing opposition to us, and we must now work with every means to precipitate world war Three within bive years.

the goal for which we have striven so concertedly for three thousand years is at last within our reach, and because of its fullfillment now apparent it behoves us to increase our efforts and our caution tenfold. I can safely promise you that before ten years have passed, our race will take its rightfull place in the world, with every Jew a KING and every Gentile a slave: (applause from the Gathering.) You remember the the success of our propaganda campaign during the 1930s' which arroused Anti-Americanu PassionanianuGermany, and at the same time we aroused Anti-German Passions in America, a campaign which culminatated in the Second world War. a similar propaganda is now being waged intenseively through out the world. (campaign)

A war fever is being worked up in Russie, by an incessant Anti-American Barrage, while a nationwide Anti-Communist scare is Sweeping America.

Our next pressing problem at the moment is to inflame the lagging Militaristic Spirit of the Americans. The failure of the Universal Military training act was a great set back to our plans, but we are assured that a suitable measure will be rushed through congress immediately after the 1952 elections. The Russian, as well as the Asiatic peoples, are well under control, and offer no objections to war. But we must wait to secure the Americans. This we hope to do with the issue of Anti-Senitism, which worked so well in uniting the Americans against Germany, we are counting heavily on reports of anti-Semitic outrages in Russia to whip up indignation in the United-States, and produce a front of solidarity against the Soviet Power. Simulta-nameously, to concentrate to Americans the Reality of outspokenly Anti-Semitic elements in America to increase their effective ness, and we shall stage AntipSemitic outbreaks in several of their largest cities. This will serve the purpose of Exposeing reactionary sectors of America, which then can be silenced, and of welding the United States into a devoted Anti-Russian Unit.

Within five years this Program will achieve its objectives, the Third world War, Which will surpass in destruction all previous contests. Israel of course will remain Neutral, and when bith sides are devastated and exhausted, we will arbitrate, sending our control Commissions into all wrecked countries. this war will end for all time our struggles against the Gentiles.

We will openly reveal our identity with the races of Asia and Africa. I can state with assurance that the last generation of white children is now being born. Our control Commissions will, in the interests of peace and wiping out inter-racial tensions, forbid the whites to mate with whites, The white woman must cohabit with members of the dark races, and the white men with dark women. Thus the white race will disappear, for mixing the dark with the white means the end of the white man, and our most dangerous enemy will become only a memory. We shall embark upon an era of ten thousand years of peace and plenty. The Pax Judaica, and our race will rule undisputed over the earth. Our Superior intelligence will enable as to retain mastery over a world of dark peoples.

\*(meaning friendly, cooperative symbology as between Judaists )

There will be no more religions, not only would the existance of a priest class remain a constant danger to our rule, but belief in an after life would give spiritual strength to irreconcilable elements in many countries, and enable them to resist us. We still however, retain the rituals and customs of Judaism as the work of our hereditery ruling caste, strengthening our racial laws so that no Jew will be allowed to marry outside our race, nor will any stranger be accepted by us.

We may have to repeat the grim days of World war Two, when we were forced to let the Hitlerite bandits sacrifice some of our people, in order that we may have adequate documentation and witnesses to legaly justify our trial and execution of the leaders of America and Russia as war Criminals, after we have dictated the peace, I am sure you will need little preparation for such a duty, for sacrifice shas always been the watchword of our people, and the death of a few thousand Jews in exchange for world Leadership is indeed a small price to pay.

To convince you of the certainty of that leadership, let me point out to you how we have turned all of the inventions of the white man into weapons against him, His printing presses and radios are the mouth pieces of our desires, and his heavy industry manufactures the instrument which he sends out to Asia, and Africa against him. Our interests in mashington are Greatly extending the Boint Four program for developing industry in backward areas of the World so that after the industrial plants and cities of Europe are destroyed by Atomic warfare, the whites can offer no resistance against the larger menace of the dark races, who will maintain an unchallenged techno logical superiorty.

And so with the vision of world victory before you, go back to your countries and intensify your good work, until that approaching day when Israel will reveal herself in all her glories destiny as the Light of the (World.

Although millions of American citizens were stunned by the decision of the Supreme Court of the United States that segregation in public schools must be ended, few realized that this decision was the culmination of a victous campaign to destroy American liber-ties. This campaign had its origin in a 1921 directive of the Communist International written by the Soviet Chief of Propaganda, Karl Radek, the alias of a Jewish revolu-tionary named Sobelsohn.

The Radek directive gave explicit orders to the Communist Party of America to stir up racial strife between white and black American citizens, to force the two groups together is order to create race riots, and to carry on relentless agitation for "Negro rights".

This directive was read at the Bridgman Michigan convention of the Communist Party of America on August 20, 1922. It had down the basis for Convertibiting a significant for the profession which have been used since that date by the American Jewish Congress and its subsidiary, the National Association for the Advancement of Colonal Association for the Advancement of Colored People.

Two days later, on August 22, 1922, the Bridgman Convention was raided by gov-ernment agents and the Radek directive as well as hundreds of other Communist docu ments were seized. These documents are in the files of the Federal Bureau of Investigation today, but J. Edgar Hoover is under strict orders not to reveal the Radek directive at any cost, because it would brand the Supreme Court as a front or agent of the Communist International.

One of the great authorities on Communist infiltration, R. M. Whitney, wrote in his definitive work "Reds In America", published in 1924 by the Beckwith Press, on page 189.

"The Communists' earliest program in the United States included the use of the negro masses in its campaign to bring about the overthrow of the Government of this country by violence."

At the Sixth World Congress of the Com-nunist International held in Moscow in 1923, the slogan for America "Self-Determi-nation in the Black Belt" was devised. In 1930 the Communist Party published the official "Resolution of the Communist Inter-national on the Negro Question in the United Nation." We greate form this resolution. States". We quote from this resolution,

"The main Communist slogan must be: The right of self-determination of the Negroes in the Black Belt. . . . If the slogan of self-determination of the Negroes is to be put into force it is necessary wherever pos-sible to bring together into one governmensable to bring together into one governmental unit all districts of the South where the majority of the settled population consists of Negroes. . . The right of the Negroes to governmental separation will be unconditionally realized by the Communist Party. . . The Communist Party must stand up with all strength and courage for the struggle to win independence and for the establishment of a Negro Republic in the Black Bett."

On January 25, 1953, Davis Lee, Negro Publisher and editor of the Newark, N. J., Telegram, expressed this sound and timely view of the repercussions we might expect if the forces of agitation prove victorious. It is the best argument we have read.

He said:

"The efforts being made by certain paid agitators and pressure groups to have segregated schools in the South declared unconstitutional — may cause Southera Negroes to lose a lot more than they will

gain. "The trouble with this group, as with similar ones, is that the initiators don't count the overall cost to the race. The present effort is designed to destroy the whole pattern of segregation — and to establish an integrated social order is which there will be no distinction made in this country on the basis of race, religion, color or nationality.

"This is a laudable objective, but human nature just has not changed that much, and the achievement of such an objective could cause repercussions that might set the

nature just has not changed that much, am the achievement of such an objective could cause repercussions that might set the Negro back fifty years.

"Integration in the schools in the North and East — is not a howling success. A Negro can attend most of the schools up here — and get an education — but few of the states that educate him will hire him as a teacher. The State of Connecticut doesn't have twenty-five Negro teachers... "Nowhere in these integrated states do Negroes get anywhere near proportionate representation. Every device is employed to keep qualified Negroes from being assigned. Recently a reputable New York labor union made a report on the employment of Negro teachers in New York City — and charged that a systematic scheme has been adopted to exclude Negroes as teachers. teachers.

"This is not true in the South. The State of Georgia employs 7.313 Negro teachers, and paid them close to \$15,000,000 in salaries last year. North Carolina paid its .—(Continued on Page 3)—

"Communists must unreservedly carry on a struggle for the self-determination of the Negro population in the Black Belt in accordance with the decisions of the Sixth World

Congress of the Communist International."
This dictate has been periodically restated by the Communist Party, and in December, 1916 it was reissued as a "Resolution on Negro Rights and Self-Determination."

Felix Frankfurter

The anti-segregation decision of the Su-preme Court was dictated by one of the most sinister men in America, an Austrian Jew named Felix Frankfurter, leader of the radical World Zionist movement and a lifelong advocate of Socialism and leftwing objectives. Felix Frankfurter was head of fense committee for Sacco and Vanzetti, rense committee for Sacco and vanceus, anarchists who were electrocuted in Massachusetts in 1927. A law partner of Henry L. Stimson in the furm of Winthrop and Stimson, lawyers for Kuhn, Loeb Co., international Jewish bankers who financed the Communist Revolution in Russia, Frankfurter was first thrust upon the American people by President Woodrow Wilson, who brought a horde of alien Socialists to Washington and set up the Socialist hierarchy which was reinstated in power fifteen years later by his understudy Franklin D. Rooseyell

Wilson appointed Frankfurter as counsel for the Presidential Mediation Commission in the Mooney Case. As the defender of a group of Communist bomb-throwers and terrorists, Frankfurter had the temerity to try to influence Theodore Roosevelt in the decision. Theodore Roosevelt replied in an open letter which has been publicized for years, as follows:

You have taken and are taking an atti-tude which seems to me to be fundamentally that of Trotsky and the other Bolshevist leaders in Russia, an attitude which may be fraught with mischief to this country. . . . There again you have engaged in excusing men precisely like the Bolsheviks in Russia, who are murderers and encourages to murder, who are traitors to their allies, to democracy and civilization, as well as to the United States, and whose acts are nevertheless apologized for on grounds, my dear Mr. Frankfurter, substantially like those which you allege.

The official publication of the World Zionist Organization, the Zionist Bulletin, reported in the issue of September 2, 1919:

"A dinner in honor of the Hon, Justice Brandeis, prior to his return to America, was given by the Executive of the World Zionist Organization on August 26 at the Ritz Hotel. Prof. Frankfurter, in proposing the toast to his Majesty's Government, re-ferred to the months of hard work in which he and the other Jewish delegates had been engaged in Paris. They often spoke in different tongues; but they were all animated by a single sentiment—the westere of Israel and the good of Zion."

The westere of Israel and the World Jew-

ish conspiracy has always been the single sentiment of Frankfurter's life. One of the architects of the Versailles Peace Conference in 1920 which made the Second World War inevitable because of the impossible terms inflicted upon Germany, Frankfurter was instrumental in carving out the artificial state of Czechoslavakia by forcing together people of different nationalities, which made the Sudeten crisis inevitable. He also stirred up anti-Semitism all over Europe by including in the Treaty special privileges for Jew-ish residents of all European countries, with the threat that the United States would force the European nations to grant those special Jewish privileges.

Douglas was a classmate of radical Robert Hutchins at Yale, A darling of leftwing labor leaders and Jewish revolutionaries, Douglas has been advocated for the Presidency of the United States by these groups. He recent-ly accepted a \$1000 Sidney Hillman Award from Jewish labor leaders.

Chief Justice Earl Warren was appointed to that post by Eisenhower for the specific job of ratifying the anti-segregation decision. Warren as Governor of California spent so much time at Jewish banquets that it was said he lost his taste for Christian

Justice Tom Clark has cravenly refused to appear before Congressional Committees investigating the startling corruption of the Department of Justice during his term Attorney General. He has been sharply criticized by many Congressmen investigating this corruption. A typical greedy, self-serving politician, he eagerly went along with the anti-segregation decision, although he is from Dallas, Texas, where he was unknown in the legal profession.

Jewish Revolutionaries Enlist Negro Supporters

The Jewish Communist Party of America has always envisioned arming the 15,000,000 American Negroes as an army with which American Aegroes as an army with which to entitate the white population of America. For instance, when Senator Eastland of Mississippi proteted against the recent antisegregation decision of the Supreme Court, Nath Post America, 1974 lew York Post of June 15, 1934 carried a letter by Harry Brice. The New York Post is edited by Dorothy Schiff, Jewess, and owned by the Schiff family, Jewish Inter-national bankers financed the 1917 Communist Revolution in Russia. The letter carried in the New York Post, of June 15, 1951, is as follows:

"Sen. Eastland (Dem. Miss.) says the government would have to send an army into the south to enforce non-segregation. That's no problem. You could raise ten divisions in Harlem alone."

This letter is typical of what the radical Jews want to do to the White Christian population of America. Our Congressmen were horrified to learn from many witnesses before the House Un American Activities Com-mittee that the wholesale slaughter of min-isters. planned by the Yiddish revolutionaries, in the process of setting up a Black Republic under the leadership of the motorious Negro Communist Paul Robeson. Robeson was awared the 1952 Stalin Peace Award. During the Hearing before Un-American Activities Committee be declared "he would go to jail before he would say whether he was a Com-muist." He educated his son in Soviet Union. Robeson, who made millions of dollars as an entertainer in America because he was publicized and given rave reviews by the radio, television, and the movies, has always bated America.

Every other Negro who has been brought into prominence by the Iews has somewhere in his background an affiliation with Com-munism and left-wing causes. Consider the case of Dr. Mordecal Johnson, President of Howard University, an Alb-Negro University in Washington, D. C. which year after year receives more federal aid funds than any other school in America, a school which is the apple of the eye of Frankin D. Roose-vell's sallow helpmate, Eleanor, and a school which has harbored many of the most dan-gerous radicals in America. Here are the sentiments of Dr. Johnson as reported in the Chicago Defender of June 10, 1933. Speaking before an audience of young Negro in-tellectuals who were being trained as the black elite of the Communist Party, Dr. Johnson was reported as follows: "Dr. Johnson urged his hearers not to

allow the words Communism and Socialism to blind their eyes to the reality that on Russian soil today — it makes no difference what mistakes are being made or what crimes are being committed — there is a movement for the first time in the history of the world to make available all their natural resources for the life of the common

With such speeches many thousands of were recruited for the Communist Party. Yet Dr. Mordecai Johnson continues today as the President of Howard University. supported by large grants of taxpayers' funds, and is constantly hailed as one of our

Doctor, When Count Folke Bernadotte was assassinated by Jewish terrorists in Israel, one of the most shocking crimes in modern diplomatic history, Bunche was chosen to replace him as United Nations mediator in the theft of Palestine from its Arab inhabi-tants. The Jews were pleased with Bunche's tants. The Jews were pleased with Bunche's bandling of their affairs, so pleased that David Niles (Neybus) offered him the position of Assistant Secretary of State in Traman's calmet, Bunche sneeringly refused, claiming that Washington is a Jim Crow lown. Since the population of metropolitan Washington is already predominantly Negro, it is difficult to see how this could be. Actually, Bunche was merely creating an artificial issue for Communists to publicize in Russia. He accepted a better-paying job with the United Nations.

And below is a telegram welcoming him back to America from his church-burn-ing expedition overseas. The signer of the telegram is Ralph Bunche of Howard University. Thus Bunche reveals his real allegiance and explains his sudden rise to fame and fortune, backed by the Jewish Commupost clique,

They Planned It That Way

American citizens, stunned by the unconstitutional anti-segregation of our leftwing Supreme Court, do not realize that this de-cision has its origins in Communist dictates of more than one hundred years ago, Like the income tax and the inheritance tax, the anti-segregation decision was demanded by the Communist Manifesto of 1848, which first used the phrase "without regard to race, creed, or color". NAACP", the National Association for the Advancement of Colored People declares that "The NAACP supports the United Nations and opposes colonialism and racism wherever they appear." Thus the NAACP follows the Cohen directive.

NAACP Founded by Jewish Revolutionaries The fact that the National Association for the Advancement of Colored People so closely follows the sims and directives of the Communist Party is more understandable when we learn that it was not founded by Patriotic Negro American citizens. An NAACP leaflet featuring congratudatory statements by prominent citizens quotes Rabbi Irving Miller, former President of the American Jewish Codgress as follows:

The American Jewish Congress itself, working with the NAACP for common objectives, was founded by Jewish revolutionaries who had been expelled from Russia and who found a haven in the New York

Its President today is the Jew Arthur Spingarn. More than one-

Military vs. Civilian Control

As soon as the Second World War was ended, the Jewish leftwing press, spearheaded by Eugene Meyer's Washington Post' and the Daily Worker, began a hysterical campaign to

get the atomic bomb away from military control. Although it was a military weapon, the Jews argued that our loyal American generals would use the bomb to create a "fascist' state here in America (fascist being a catchall term for anyone who opposes Jewish Communism). They were so successful in this vicious propaganda that public opinion was hulled to sleep when the Zionist-Communist traitor David Niles (Neyhus). Truman's Jewish master in the White House, created the U. S. Atomic Energy Commission in 1946, which took atomic energy control away from our generals and gave it to a five-man board, of whom four were Jews and one Centule fellow-traveler of the Zionist conspirators.

This Commission was headed by David Lalienthal, now consultant with the international lewish banking house, of, Lazard Kreres, which was Eugene Meyer's family banking house. The other three Jews were Strauss of Kuhn, Loeb Co. and Dr. Robert F. Bacher, who was at the Los Alamos atomic bomb base with Jewish Communist spies David Greenglass and Julius Rosenberg, and William Waymack, editor of the Des Moines Register Tribune, owned by Gardner Cowles of Look Magazine, which follows the pro-Jewish racial line laid down by Eugene Meyer's Washington. Post. Waymack's name has appeared on the boards of directors of many organizations dedicated to the destruction of the American Republic, among them the American Association for the United Nations, a nest of Communist fellow-travelers. He also is a director of the Federal Reserve Bank of Chicago. The Federal Reserve System was set up by Paul Warburg of Kuhn, Loeb Co. as exposed in The Federal Reserve Conspiracy by Eustace Mullins (order from Common Sense \$1.00). The Gentile stooge was Sumner Pike, a Wall Street banker.

In 1949, Lilienthal and Bacher were replaced by Justice Robert H. Jackson, prosecutor of the legal farce, the Nuremberg Trials, when we dealt out Soviet Justice to our defeated foes, and his Nuremburg assistant, Cordon Dean this being their reward from the Jews for destroying the reputation of our nation's respect for due legal procedure.

In 1951 a protege of Samuel Coldwyn and other Hollywood Jews, T. Keith Clennan, was appointed to the U. S. Atomic Energy Commission. A former studio manager for Samuel Coldwyn, Clennan certainly knew all about atomic energy! He also had been on the board of the Warburg-controlled Ansco Film Corporation and the Ceneral Aniline and Film Corporation (American branch of I. C. Farben of which Paul Warburg was directly

which Paul Warburg was director).

Today the five-man Commission is headed by Lewis L. Strauss, who besides being a partner of Kuhn, Loeb Co. is on the board of directors of Industrial Rayon Corporation with Secretary of the Treasury Humphrey and State Senator Harry F. Byrd Jr. Strauss also for years has held the title of "financial advisor to the Rockefeller Erothers", showing the international Jewish banking control of the Rockefeller-Standard Oll trust and the Marxist dedication of the Rockefeller Froundation. The original Rocke-

feller expansion was master-minded by Jacob Schiff of Kuhn, Loeb Co, with Rothschild money, and Kuhn Loeb has guided Standard Oll ever since, Strauss is also a director of Radio Corporation of America, Rockefeller Center Inc., and the National Broadcasting System, which may explain the Marxist orientation of our radio-television networks.

Also on the present Commission is another Jew, Eugene Zuckert, son of Harriet Pincoffs, and three Centiles, Henry Smyth, who was on the Manhattan Project with Greenglass and Rosenberg, Joseph Campbell, who is on the boards of corporations with partners of the international banking house of J. and W. Seligman Co. and Coorge E. Warren of Wallace and Tiernan (the chlorination and fluoridation trust); and the fifth member is Thomas E. Murray, who was chosen by the Jewish bankers as receiver for the IRT subway system in New York after they had looted it of hundreds of millions of dollars through crooked financing. He is a director of the Bank of New York with John Foster Dulles.

More alarming is the fact that most of the members of the U. S. Atomic Energy Commission to date have been members of the Councis on Foreign Relations, central and co-ordinating international agency in the United States, supported by Kuha Loeb and the Rothschilds, and sister organization of the Royal Institute of International Affairs in London, also supported by the Rothschilds. These two organizations were founded jointly by Baron Eduard de Rothschild at the Paris Peace Conference of 1919, and are parent institutes of the Institute of Facific Relations, the agency which the McCarran Committee investigation proved was responsible for the delivery of China to the Soviet Union, giving Communism 400,000,000 new allies, and condemning the Chinese people to hopeless slavery under Jewish commissars from Moscow. Thus Chinese Communist troops were able to slaughter thousands of captured American boys in Korea However, the Institute of Pacific Relations traitors still go unpunished, because they are the Wall Street bankers and lawyers who support Communism.

Oppenheimer's Treason

On April 6, 1834 Senator Joseph R. McCarthy revealed to his television audience that trattors had delayed one development of the hydrogen defenge homb program by eighteen months. He declared that our intelligence agencies had mormed him that Soviet Union had caught up with our lead in the production of nuclear weapons. He also said he wanted to make a full scale investigation into the H-bomb treason.

This meant that he would be investigating the three international Jewish bankers, Lehman, Lilienthal, and Strauss. Immediately a terrific smear campaign, more intense than any yet made against him, was launched through radio, television, and the daily press. The television farce of McCarthy-Army began, its avowed purpose being to crush McCarthy once and for all, its instigators believing that because the entire proceedings were so ridiculous, McCarthy would necessarily be made ridiculous. Of course secretary of the Army Stevens would be made into a Milton Berle type of clown, but he was to be sacrificed in the vicious attempt to halt McCarthy's threatened probe into the H-bomb program. It is intended that Stevens will resign as soon as the hearings are concluded.

McCarthy has repeatedly told the television audience that the hearings are a circus; designed only to stop his committee's vital investigations. The audience should write to their Senators, demanding that Eisenhower stop his criminal attempt to crush McCarthy and his investigations.

#### Doom Of Western Civilization

Because of the eighteen-month delay in our production of the H-bomb, by Oppenheimer and Lilienthal, Senator McCarthy warned that our nation and our civilization may die. It is almost a certainty that this means a Third World War with all the horrors of atomic weapon destruction visited upon our homeland. The terrible blame rests upon these Jewish bankers and their Jewish scientists who profess the Marnist philosophy. The New York Times, Congressman Sterling Cole of the Joint Congressional Committee, and every other authority on the subject name David Lilienthal and J. Robert Oppenheimer as the two men who delayed the II-bomb. What is wrong with us? Do we have to be shot down in our homes before we see the necessity for protecting our nation from these enemies in our midst? Oppenheimer is the

personal protege of Lewis Lichtenstein Strauss, as revealed by the New York Times of April 13, 1954, which stated that Strauss had appointed Oppenheimer to the post of head of the Institute for Advanced Study at Princeton, New Jersey.

Had we been able to retain our leadership in the production of atomic weapons, we could have warned Soviet Union, "Stop the spread of aggressive Communism and release the captive nations from the deathgrip of your Jewish commissars, or we will employ atomic weapons against you." This course of action has been urged by many of our military leaders, who recognized loog ago that either Soviet Union would wipe us out or we would stop Communism There is no middle ground in dealing with an infernational conspiracy. Smister influences in Washington demoted and alenced those military leaders, gave the atomic bomb to Russia, and delayed our production of the H-Bomb. These influences have now been proven to be entirely Jewish, boldly committing treason from the protection of the White House on a scale hitherto unknown in the world.

#### Jew Control

The New York Times of April 18, 1934 says, Ferthi, Szilard, and Wigner of Princeton met with Alexander Sachs of the Lehman Corporation to discuss the possibility of an atomic bomb. On Oct. 11, 1939, Sachs read to President Roosevelt a letter from Einstein and a memo from Szilard. The President ordered an Advisory Committee on Uranium to be set up. Who's Who In America, 1931, contains the

Who's Who In America, 1951, contains the following entry,

"Dr. Alexander Sachs, born Rossien, Russia, economist, graduated from Harvard Graduate School, now economic advisor and director of the Lehman Corporation, member of the National Policy Committee, special consultant to the Office of Strategic Services during World War II, originated the atomic project in conference with President Roosevelt in 1939, and served as the President's representative on the organizing committee of the Manhattan Project (atomic bomb program)."

A gentile, Major Ceneral Croves, was placed in charge of the Manhattan Project, but he was powerless to maintain control over the horde of alter Jewach Committee which initioated every level of the operation. The influence of Harry Hopkins and Anna Rosenberg was too much for him. They as well as Dr. Sachs must be held responsible for the long last of convicted Jewish spies, Rosenberg, Creenglass, Sobell, Cold, Brothman, Weinberg, etc. who gave the atomic bomb to Russia and placed the American people in grave danger of atomic annufilation.

Dr. Sachs was a special consultant to the Office of Strategic Services in 1945 when that agency compled a secret hist of German scientists who had been working on the atomic program in Germany, and gave that hist to the Russian secret police, who immediately arrested these scientists and shipped them to Russia to work in the Soviet atomic program. Those on this list, whose names could have been known only to Sachs or his co-workers, were obligingly arrested by our military police, acting on orders from the Eisenhower administration of Germany, and handed over to the Communists.

#### Baruch And The Atomic Program

The aged Bernard Baruch himself came out of retirement to take charge of the atomic program. He appointed himself U. S. Representative to the United Nations Atomic Energy Commission in 1946, and came forth with a plan of international control of atomic energy, in blussful ignorance of the fact that it had been developed in America with American money and resources. The following year Oppenheimer came out with a program which clearly showed his political allegiance. He wanted a World Atom Authority, with six laboratories in different countries, to be open to any scientists of any nation seeking information and aid in atomic development. Naturally this would include Soviet Union.

The alternate U. S. Representative to the U. N. Commission on Atomic Energy was John Hancock, partner of Senator Herbert Lehman's family banking house of Lehman Brothers, which has furnished so many top people for the atomic program.

#### Atomic Treason

In November of 1946 it was estimated by our intelligence agencies that Russia could not possibly build an atomic bomb in less than six years, and even in 1949 the Presidential Company.

Harrison (Covernor of the Federal Reserve Bank of New York, who is dealt with at length in The Federal Reserve Conspiracy), who acted as Chairman in my absence; James F. Byrnes, personal representative of the President (Byrnes had been Baruch's right-hand man and political lieutenant since 1912); Ralph A. Bard, Under Secretary of the Navy; Wilham L. Clayton, Under Secretary of State (former law clerk to Justic Brandeus, fanatical Zionist leader and uncle of Felix Frankfurter. 



### The Activities Of One E. Mullins

Behold! I am told that a Chicago millionaire, who I assumed is a friend of mine, is financing the Institute for Biopolitics, which made me a bit miserable, for the name mentioned is that of a good American. Let us pull a veil over it all!

#### Some Background

Then I received a letter from the Institute for Biopolitics saying: "Your support is needed today!" The document is addressed to "The Whitemen of America." The subject of the letter is "Parasitism." The first paragraph of this letter reads:

"The philosophy of the group led by Jews, which now holds power in the United States and in the other 'people's democracies', is that of humanism. This doctrine holds that since all human beings are equal, any human being who works harder and earns more shall have a percentage of his earnings taken from him and donated to those who work less

Some time ago, I received a or not at all. As any biologist letter from E. Mullins of the knows, the human beings who subsist on the efforts of others are parasites . . , the philosophy of humanism is the philosophy of parasitism."

> The House Committee on Un-American Activities in 1954 issued a report on "Neo-Fascist and Hate Groups." Among those mentioned was the National Renaissance Party and the report notes that Eustace Mullins, my Chicago pen pal, wrote an article' for the NRP Bulletin, entitled. "Adolf Hitler: An appreciation." He is also noted to be a staff writer for "Common Sense," a particularly vicious anti-Semitic publication.

In his article on Hitler, Mullins wrote on October 1952:

"Eventually America must admit her debt to Adolf Hitler for it was Hitler who first called upon all Aryan people to unite and challange (sic) Jewish economic and political power. It was Hitler who first enunciated the doctrine of national self-determination and led the armies of Christian Europe in a great crusade against the godless Jews of the Kremlin. Hitler, like Christ before him, was crucified on a Cross of Gold through the duplicity of his own Christian people."

Mullins is associated with Mavnard O. Nelsen who heads the "Realpolitical Institute" which gives the same P. O. box in Chicago. From the record that I have gathered, Mullins is a very active and aggressive person. He seems to be obsessed with the word "whiteman" and his institute has published "Pax Americana, the Elite Whiteman's Guidebook."

Mullins' associate, Maynard O. Nelsen, started his neo-pazism while still at the University of Minnesota where he paraded in a Nazi uniform and distributed Nazi literature. The police went after him and he had lots of trouble. In 1964, he founded the "Realpolitical 'Institute," which has, to repeat, the same P. O. address as the "Institute for Biopolitics." Nelsen is not only anti-Semitic but he is anti-Christian, he regarding Christianity as a Jewish subversive movement.

Still Another Another organization owned by these two men is called "M & N Associates." This firm engages in political engineering." Here Pustace Mullins signs himself "State Chairman of the Constitution Party of Illinois." In an article written by Mullins in this guise, he says that "J. Edgar Hoover's recent book, 'Masters of Deceit,' was largely written for him in the ADL offices in New York, for favors received." A D.L. refers to the Anti-Defamation League.

I have much more material on Mullins and Nelsen but this suffices to show what the Institute for Biopolitics is. We thought that Hitler was dead but it is apparently possible to make a living out of his ghost. The neo-fascists end the Communists ought to get together to pool their resources in their mutual effort to damage the United States.

It is often suggested that these small efforts be ignored. Nothing can be ignored in these perilous times when our country suffers subversive groups.

Mr. COLLIN E. SMITHERS, Principal of Robert E. Lee High School, Staunton, Virginia, advised on August 9, 1960, that MULLINS is still residing with his mother on Madison Street, but has noticed during past month that he leaves Staunton or the neighborhood for periods of one to three days. On June 21, 1961 the records of the Corporation Court of the City of Staunton, Virginia were made available by EDITH H. PAXTON, Clerk. These records revealed a suit by EUSTACE C. MULLINS, JR., plantiff against the Leader Corporation of Staunton, Virginia, defendant. The Leader Corporation publishes the Staunton Leader Newspaper in Staunton, Virginia. This suit is for the sum of \$1,250,000 and in substance alleges as follows:

On May 11, 1960 defendant published in the Staunton Leader a column by which contained numerous untruths, errors and distortions concerning plantiff which libeled him to the thousands of readers of said newspaper, by such epithets as "neo-rascist", "neo-Nazi", "making a living out of Hitler's Ghost", and engaged in an "effort to damage the United States".

The column by \_\_\_\_\_\_ is part of a continuing effort over a period of years to defame and injure plantiff and make it impossible for him to earn a living and to prevent him from further exposing Communist subversion in the United States.

The defendant cited in said column a discredited, unauthorized and unofficial report on "neo-fascist" and "hate groups" issued under the imprint of the House Un-American Activities Committee in December of 1954 and later discounsed by the members of same committee, which identified plantiff as a member of, an associate of, and a writer for so called "neo-fascist" and "hate groups"

The Chairman of the House Un-American Activities Committee, Homorable FRANCIS E. WALTER, in a letter dated April 20, 1960, referred to said report, stated, "this report cannot be considered official". Congressman WALTER stated, at the time that this report was issued, that the House Un-American Activities Committee had held no hearings on said report, that no witness had been called, and that the persons mentioned in the report had not been asked to appear to defend themselves as is customary in any Congressional hearing. All this information was known to author of said column which appeared in defendant's publication, said co-author of said report and official apologist for it through the organization known as the Anti-Defamation League of B'Nai B'Rith, an organization which hires professional "anti-semites" to hold meetings and issue publicity denouncing "Jews", in order to convince members of the American-Jewish Community that there is in fact a large and powerful national organization of "anti-semites" "fascists" and "Nazis" who intend to exterminate the American Jews, when said organization consists solely of the paid agents and propagandists of said Anti-Defamation League, who are so maintained in order to aid the Anti-Defamation League to extort more than five million dollars a year from the American-Jewish Community by keeping them in fear of their lives and property, and said Anti-Defamation League has also aided and maintained Communist agents, spies and propagandists in the United States.

The defendant had attacked the Anti-Communist efforts of the late Senator JOSEPH R. MC CARTHY, who had employed the plantiff to battle against Communist subversion in the United States and defendant has editorally attacked the Anti-Communist John Birch Society.

The defendant in said column further identified plantiff as "a staff writer for 'Common Sense' a particularly vicious anti-semitic publication", when plantiff has not worked for or had association with said "anti-semitic" publication since November, 1952, plantiff

having discovered at this time that said "anti-semitic publication" was being financed and operated by the Anti-Defamation League of B'Nai B'Rith as part of its five million dollar-a-year shakedown of the Jewish Community and plantiff wanting no part of said operation, has been for more than nine years disaffiliated and publicly opposed to said publication, its editor, CONDE MC GINLEY, and its financial backer, the Anti-Defamation League of B'Nai B'Rith.



#### AT STAUNTON, VIRGINIA

The following investigation was conducted by SA WILLIS A. BENNER:

High School, Staunton, Virginia, subject and his mother, Mrs. E. C. MULLIN, has been contacted on a continuing basis during the past 45 days. He claims that the subject has not indicated what his future plans are in regard to leaving the area. He stated that this is the longest period of time that the subject has stayed in Staunton during recent years, and there is no question about it that his mother has induced him to stay with her. Mr. SMITHER said that subject's mother has had very little to say about her plans or the plans of her son, but it is believed that she would dispose of her very large home if he were to decide to leave. He added that he would report any information he received regarding a change of plans on the part of the subject.

Captain M. E. MILLER, Staunton, Virginia Police Department, Staunton, Virginia, advised on March 26, 1962, that he has talked to subject's brother, EUGENE MULLINS, on several occasions concerning subject and what he is doing, but EUGENE has never indicated what the subject plans to do.

He further advised that EUGENE MULLINS indicated that his brother is still doing considerable writing, but apparently does not know what he is writing or for what purpose. MILLER stated that he has seen very little of the subject during recent weeks and is of the opinion that he is staying very close to home. He added that should he receive any information concerning the future plans of the subject or any of his activities in Staunton, he would immediately furnish this information to the FBI.

In view of the fact that the subject has now been in the Staunton area for a considerable length of time and there apparently is no information available to indicate a change in residence, it is suggested that the Chicago Office might desire to have the Bureau change the office of origin to the Richmond Office.

#### Virginian Sues Hoover's Estate

WASHINGTON (UPI) — Claiming his knowledge of certain "details" of the private life of the late J. Edgar Hoover has led to 20 years of FBI harassment, a Staunton, Va., man has filed a \$3 million suit against the former director's estate.

In a suit filed Tuesday in District of Columbia Superior Court, Eustace Mullins, 50, said an acquaintance gave him the information in 1952 and that the FBI promptly forced his firing from the Library of Congress.

Mullins charged similar incidents cost him jobs in New York and Chicago during the next 10 years.

Then in 1961, while working on a biography of poet Ezra Pound in Lake Mecosta, Mich., Mullins said, FBI agents contacted him again.

He claimed the agents tried to force him to sign a statement that he knew nothing of Hoover's personal life. He refused and the agents allegedly began to harass his aged parents, "who subsequently died of heart attacks," Mullins said.

Attached and considered a part of this memo for investigation outside of the Richmond HQ City area is one (1) copy each of referenced Buairtel to Albany.

For further information, captioned organization filed Articles of Incorporation in California in October, 1964, with the primary purpose of establishing, maintaining and conducting a Church of the Christian faith. The group has been referred to as a cover for an underground army and has a mailing address of P. O. Box 423, Glendale, Calif. As reflected in reBuairtel of 9/6/74, the leader of the Identity Group is WILLIAM POTTER GALE, who espouses hatred for Jews and Negroes and advocates assassination of FBI Agents and Internal Revenue Service Agents as well as the hanging of certain judges. The group also advocates tax rebellion and the formation of a Posse Comitatus, a voluntary group of citizens who would act in the name of local Sheriffs to "enforce" the law.

ReLAlet to Bureau, 7/17/74, included LHM reflecting, as of 5/28/74, a booklet entitled "Identity Directory For All Anglo-Saxon, Celtic and Kindred Peoples", 1974 Edition. This directory provided a state-by-state listing of names and addresses. The following names were within the Richmond Division:
