To The Agents of the Incorporated City of San Gabriel,

Enclosed please find our check for the business license renewal period of 1/1/2014 - 12/31/2014.

Please be advised that we are we are paying the renewal fee for the Business License No. XXXXXX - UNDER PROTEST.

The incorporated City of San Gabriel has changed the criteria of business license renewals and approved corporate polices that we did not vote for and we do not agree with. . . Your polices are destroying local businesses. The public did not vote for the Energy Action Plan under ICLEI/Sustainability. The public is not represented by their understanding of these plans and these plans do not represent the community. You are accepting money/grants

from state and federal corporate government grant programs and instituting regional planning policies that are resulting in eliminating small business and individual rights.

The incorporated City of San Gabriel has already proven that making good business decisions for the benefit of the community is in question, in that, there is pending criminal investigation into the SGVCOG, former executive director, Nick Conway who allegedly has mismanaged "contract" funds aka grants that the city obligated the city tax payers to without their full knowledge on consent . . We will wait to see what the verdict is . . .

When you read this letter please attempt to remove your filters and not dismiss this information . . .all this information is based upon government documents and corporate policies that you are approving on our behalf without our consent.

Certainly the REAL concerns are being avoided by government and corporate agencies, in that, there is NO conversation about the assaults upon us that really matter . . . We are being massively polluted by the daily Geoengineering Programs, the fluoride and other chemicals in the water supply in many areas, and the many unhealthful additives in our food supply - thus our air, water, food is not promoting good health, and we are all being compromised by the damaging effects of the RF and MW radiation frequencies from all the wireless communication devices. San Gabriel's Energy Action Plan is designed around the idea that these EAP programs must be implemented and required to reach the target dates or the effects of climate change will cause certain devastating human health risks, even death . . . these are fancies that have been created to bring about the rewriting of the local business model to that of a corporate structure for both business and government. The too big to fail is failing the very fiber of our local communities health and self reliance according to the programs presented in the EAP, in that, the plan must be implemented or the "health" of the community is threatened which is absurd . . The Geoengineering Programs, currently in full operation, are the very programs that are NOT even mentioned in the EAP and are the programs "creating" the fundamental concerns that promote the Energy Action Plans in the first place . . . Should you be unfamiliar with the "Geoengineering" term used above we would hope you would search the programs that patents and taxes have executed. It is obvious that NO one in the City understands the damage the EAP plan will cause based on the omission of the "Geoengineering" . . .

A Geoengineering research paper presented to the Air Force 2025 was published August 1996. Weather as a force multiplier - "Owning the Weather in 2025". Chapter Two explains weather modification. Chapter Three is systems description.

While to many this will seem impossible we remind you to search this information before passing judgement and remember we have been consenting by lack of knowledge . . Here is

the definition of Geoengineering - "the deliberate large-scale manipulation of the Earth's climate". Right now at the Harvard Kennedy School - the Belfer Center for Science and International Affairs they have requested and accepted applications for Research Fellowships to create policies for the global governance of geoengineering . . The Belfer Center and the Harvard Kennedy Center stated, "it appears that most individual states could readily use geoengineering tools to alter the global climate unilaterally" . . Thus, Global Policies and RULES for who manipulates the weather is NECESSARY to prevent other rogue countries from creating extreme heat events, increased air pollution, floods, droughts, wildfires, storms, changes in weather patterns, higher food prices, food scarcity, sea-level rise, storm surge, longer Red Tides causing toxic algae blooms in the ocean . . . We have ALL been lead to believe that UNLESS we reduce our carbon foot print the effects to human health will include the following: heat-related illness/death, worsening of chronic health conditions, increased respiratory illness, seasonal allergies, injury, waterborne illness, food born illness, displacement, stress-related disorders, mental health impacts, increased/shift in infectious disease, increased hunger, decreased nutrition, wastewater system impacts, poisoning from contaminated shellfish . . These certain risks to the health of the populations have been incrementally fed to all of us through the silent weapons system of manipulation which has been accepted by many due to lack of knowledge . . . in the 44 page "Silent Weapons Quiet Wars" manual victory is achieved by or CONSENT . . We have been consenting by lack of knowledge and allowing fraudulent corporate polices to dictate our futures . . .

With all this having been said we now must inform you that our property does not belong to your corporation nor do we agree with the City of San Gabriel's membership with ICLEI/United Nations polices or the Energy Action Plan that the city adopted, November 20, 2012 . . .

Since the City of San Gabriel is a corporation, which is a for-profit corporation listed on Dunn and Brad Street vs a legitimate governing body we are not intending on consenting with any of the corporate policies the city thinks they can force upon non-corporate private individuals or non-corporate private properties . . . The reason the corporate government made our counties, cities, townships and states into corporations is so that they could: do business and enter into contracts. After making numerous attempts to obtain the signed energy action plan "contract" we received a resolution and NOT the contract . . . Did any elected San Gabriel city council members sign onto the Energy Action Plan grant/contract?

We are once again, herein, requesting the ENTIRE grant/contract that the city signed pertaining to the Energy Action Plan.

The Energy Action Plan itself is based upon fraudulent science, according to over 31,000 American scientists. NONE of the environmental corporate organizations that sold the Co2

global warming nonsense to policy makers spent any money reviewing the so-called science or the so-called solutions. This is about restructuring the business model under the "new green economy" that was planned during JFK's administration according to the "The Iron Mountain Report" and the Technocracy goals to create a centralized control through massive global inventory, monitoring and registration of all distribution of energy - now called the Global Smart Grid or Smart Meters. . . Only ten days before JFK was assassinated he gave a speech where he warned us by saying we are threatened by a monolithic ruthless conspiracy - we did not listen and did not act. (This speech was given at Columbia University and we recommend you listen to his warning).

The plans you have adopted by accepting grants/bribes and signing corporate contracts to create polices using the United Nations ICLEI Climate Action Plan Template are based upon false science . . ICLEI lists San Gabriel as an ICLEI member - whether the city is currently paying dues or not does not warrant your complacent adherence to ICLEI policies. We oppose the notion that we MUST reduce GHG emissions aka Co2 which is the cover for Private Public Partnerships, Corporate Stakeholders with the real purpose to centralize corporate control - San Gabriel has adopted those very polices and has agreed to regionalization and no longer does the bidding for the people that reside in San Gabriel or the private unincorporated businesses. The corporate structure you have implemented is designed to limit your liability and to impose illegal corporate policies that have eliminated public discussion and real public participation. More importantly local independent businesses have been the fiber of main street and now you are sending local businesses to Wall-street . . .

The EAP states that - "68% of the the City of San Gabriel homes are over 30 years old, with significant opportunities for improvements in energy efficiency and reduction in utility bills . . . According to the EAP 50% of the cities homes are owner occupied and owner occupied households typically have a higher level of interest in completing home upgrades because they directly reap the benefits of lowered utility bills and increased property values" . . . Now merely speculation on our part, however, it appears with the decline in jobs that support wages to pay mortgages it is highly unlikely the property values will increase. With lower wages fewer families can qualify for mortgage loans and cannot afford the required maintenance and upkeep costs . . as the jobless economy continues it is likely that fewer homeowners will be able to afford the maintenance costs including the "required" retrofits of inefficient appliances and electronics to Energy Star that have RFID chips for tracking and monitoring and transmit wirelessly to the smart meters which are the collection devices . . .

We find it extremely troubling, on page 57, of the cities Energy Action Plan where it states - "GHG's from electricity use can be reduced, primarily through increasing conservation (i.e., avoiding using electricity) and improving efficiency (i.e., using less electricity for the same activity) when conservation cannot be realized. Increasing energy efficiency means

replacing inefficient or older models of appliances and electronics with NEW, preferably Energy Star models in order to use less energy when it is NECESSARY". Further, on page 90 the Energy Action Plan states, "the city will use the Implementation Program to track, monitor and update the EAP. As the City reports on progress in implementing the EAP, staff will evaluate the effectiveness of each policy to insure anticipated electricity and GHG reductions are occurring. In the event the reductions do not occur as expected, the City will be able to modify and add further policies to the EAP to insure the City meets its reduction targets" . . . this sounds tyrannical in nature and who will decide what policies will be implemented to INSURE the City meets the target reductions of our carbon foot print aka GHG?

We researched the U.S. Department of Energy's website and found this quote - "Aiming for Zero - This is the ultimate goal - to not use energy. THE MOST EFFICIENT ENERGY IS ENERGY WE DO NOT GENERATE! This is not a technology, it is behavior modification, or learning to live in a new reality." There was no public debate about the EAP. The corporate facilitators you have hired to conduct out reach for "public" meetings, are conducting meetings using the DELPHI TECHNIQUE - where there is the perception of public input. These meetings exploit the public process and are deceptive. The public is not influencing policy. In fact, the corporate policies have predetermined outcomes. The DELPHI Technique was setup by the RAND Corporation and is the meeting style now conducted on a global basis - consensus via manipulation and steering the meetings to the desired outcomes. . .The more centralized the decision making the more control the corporate structure will have . . . You must ask when a few corporate agencies want to control the many it is crucial to control the decision making - what would they need to do? And what are the methods of manipulation being used by the corporate structure to take us there? The corporate structure has developed as few points of decision making as possible to create centralized control . .

The idea that regionalization provides strength in numbers to effectively lobby for state and federal grants eliminates the individual consent factor of the people that will be taxed to pay back the debt. Lobbying for grants = contracts = bribes increases the city debt obligations which will ultimately require increasing taxes to pay back that debt . . . We do not consent to the corporate city structure that is signing contracts to deliberately increase debt obligations and expecting us to be responsible to pay YOUR debt back . . .You have signed these contracts and we did not, we do not consent. It would seem prudent that during a time of economic downturn the city would seek to manage debt reduction. The Energy Action Plan is requiring the retrofitting of all appliances to Energy Star Electric Appliances (RFID chipped) that will interface with the smart meters. . . We have opted out

of smart meters due to the pulsed MW microwave radiation that the military states are frequencies used for behavior modification, and that will cause health impacts to 100% of the population. The EAP plan will eliminate the opting out of the smart meters, but then again since you are working with So. Cal Edison which has in-part funded and participated in San Gabriel's Energy Action Plan you MUST already be aware of this . .

The replacement of gas appliances in older properties may require new electric circuits to retrofit from gas to electric. These properties may even require up graded electric service panels in order to increase electric capacity resulting in major upgrades involving permits, inspections and additional costs beyond the procurement of the electric Energy Star appliances and electronic devices. .

We understand So Cal Edison and other corporate agencies will be offering different forms of financing for the replacement of some electronic devices and appliance retrofits/replacements that in some instances will be collateralized against the property for varying terms and interest rates. Please know that we cannot justify the rental increases during a time of economic downturn that would be required for us to afford additional loans and costs for retrofitting . . We know this is a corporate grab of our rights based upon fraudulent corporate policies and thus we will NOT participate in this FRAUD . . . good and decent people are being taken advantage of by trusting policies that are not in their best interest and they believe their representatives are trustworthy . . . and they are NOT.

Sadly, while our entire Bill of Rights and Constitution has been shelved and you have accepted either knowingly or not terms under centralizing global corporate governance, which is a corporate structure posing as a legitimate government which it is NOT, we cannot sit back and consent to the corporate policies you have initiated and intend to enforce upon our private properties . . You have given up local government control and have engaged in regionalizing San Gabriel into (SGVCOG) San Gabriel Valley Council of Governments.

What the agents for the Incorporated City of San Gabriel have entered into with the EAP's programs of implementing "unachievable" target dates to reduce our carbon foot print aka GHG is an illusion. Corporate interests have presented you with the GLOBAL Climate Action Plan Template that you have not been able to evaluate or understand and the ramifications of the EAP, unknown by you, will not benefit the people in the City that have blindly relied upon your best intentions for policy making decisions. It is most important to understand the policy adopted by the Bilderbergs in 1954 in order to realize what the EAP is REALLY intended to accomplish. The EAP is part of the silent weapons system that has been engaged . . . you can read this Manuel entitled "Silent Weapons Quiet Wars" which is the plan of global manipulation to subvert history, law, economies and to control the populations through types of physiological, psychological and biological warfare where

people do not realize they are being attacked and subdued by a weapon . . . This is SURREAL but REAL . .

What effort you put into confirming what has been presented herein will determine the course of how our community moves forward with acknowledging the rights of the individual or the heavy fist of a planned corporate structure that has been put in place to dissolve individual rights for the common good . . which is shaping into a Totalitarian Government which has long been the plan under Technocracy.

You have been advised and now you know. Our children and grandchildren are being positioned with a future of an unsustainable debt burden through illegitimate programs with treasonous goals, and that is what is not sustainable . . . If you fail to rebut these claims within thirty days then we will consider your acknowledgement of our statements herein as being factually correct . . . which they are.
