Report of the Secretary-General on children and armed conflict (S/2007/757)

The agenda was adopted without objection.

The President, with the consent of the Council, invited the representatives of Afghanistan, Argentina, Australia, Austria, Bangladesh, Benin, Brazil, Canada, Chile, Colombia, Côte d'Ivoire, Egypt, El Salvador, Georgia, Germany, Guatemala, Guinea, Iceland, Iraq, Israel, Japan, Kazakhstan, Liechtenstein, Mexico, Myanmar, Nicaragua, Nepal, the Netherlands, Nigeria, Peru, the Philippines, Qatar, the Republic of Korea,

Slovenia, Sri Lanka, Switzerland, Thailand, Uganda, the United Republic of Tanzania and Uruguay, at their request, to participate in the consideration of the item without the right to vote, in accordance with the relevant provisions of the Charter and rule 37 of the Council's provisional rules of procedure.

In accordance with the understanding reached in the Council's prior consultations, the President, with the consent of the Council, extended invitations under rule 39 of the Council's provisional rules of procedure to Ms. Radhika Coomaraswamy, Special Representative of the Secretary-General for Children and Armed Conflict, and Ms. Ann M. Veneman, Executive Director of the United Nations Children's Fund.

In accordance with the understanding reached in the Council's prior consultations, the President, with the consent of the Council, extended an invitation under rule 39 of the Council's provisional rules of procedure to Ms. Jo Becker, representative of Watchlist on Children and Armed Conflict.

The President drew attention to a letter dated 19 July 2006 from the Permanent Observer of Palestine to the United Nations (S/2008/88), requesting an invitation to participate in the meeting in accordance with the Council's previous practice. In accordance with the provisional rules of procedure and the previous practice in this regard, the President, with the consent of the Council, invited the Permanent Observer of Palestine to participate in the discussion.

The Council heard briefings by Ms. Radhika Coomaraswamy, Ms. Ann M. Veneman and Ms. Jo Becker.
