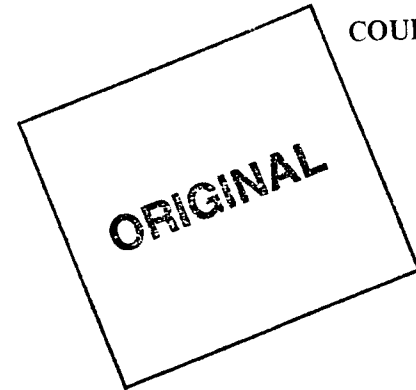

COUP D'ETAT

a sudden overthrowing of government and seizure of power by others.

WAR

a state of open, armed conflict carried on between nations, states, or parties.

EXECUTIVE ORDER

Under the Constitution, the president is vested with the executive power of the government (Article II, Section I, clause I), the power to "preserve, protect and defend the Constitution" (Art. II, Sect. I, clause 7), and the power to see that the laws are faithfully executed (Art. II, Sect. 3). From these powers is implied the authority to issue "executive orders".

The president must have the authority to issue directives to keep control of the executive branch and to provide detail to legislation. Neither Congress nor the courts have right to prohibit the executive branch from adding or subtracting authority from one government agency to another, for example.

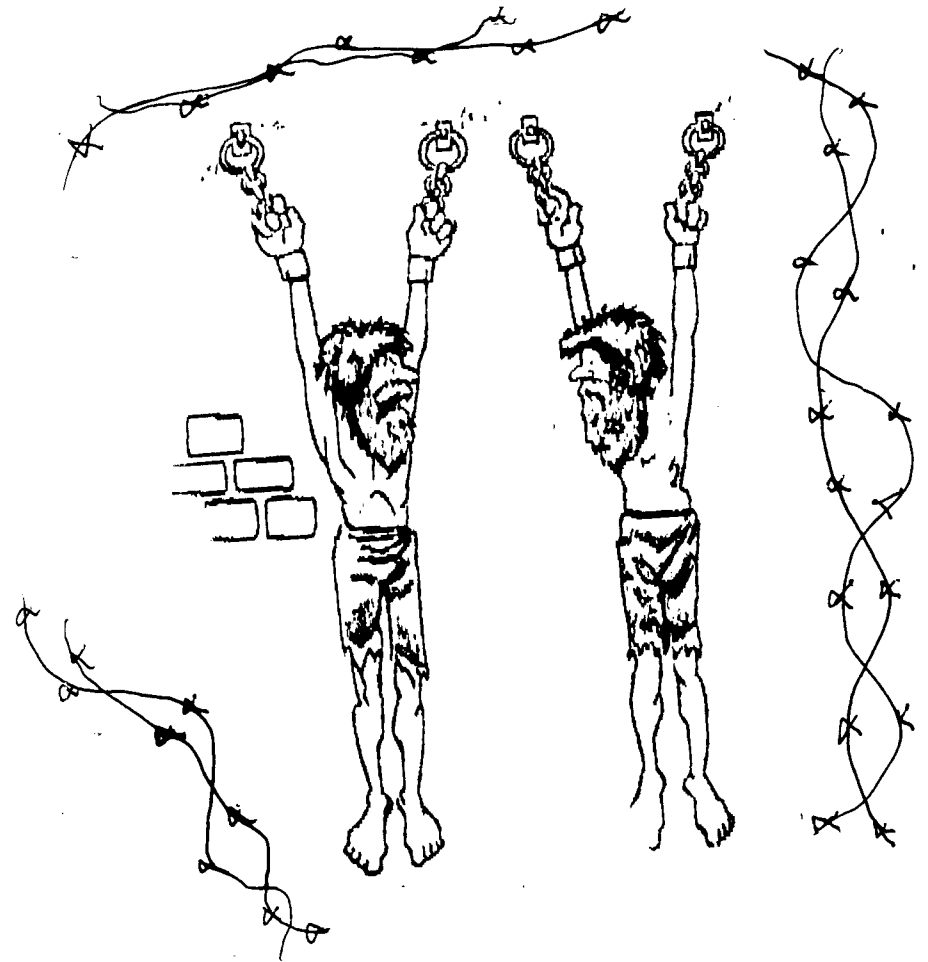
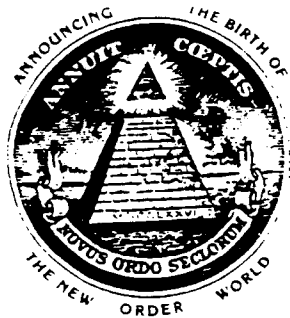
However, this presidential power has been abused in the form of executive orders that impinge across legislative concerns which are properly the province of Congress.

The validity of executive orders (EOs) has been questioned many times dating at least to the Civil War. However, a ruling as to the extent or limit to which they may be used has never been determined by the courts or by Congress.

The Federal Register contains the text of EOs issued by the presidents. There is no congressional authorization required, nor is there any review by the judiciary. All EOs are "laws" made by a single man—the president of the United States. (1)

POLICE STATE

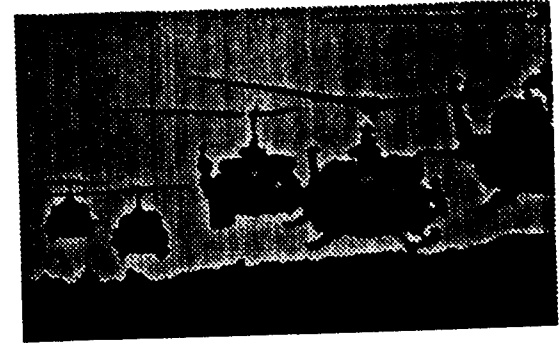
A country or other political unit in which the government exercises rigid and repressive controls over social, economic, and political life, especially by means of a secret police force.

Black helicopters and foreign troops have been reported in various parts of the United States by Patriots, large daily papers and even television. Who are they? Where do they come from? Why are they here? Who give them permission to train on american and canadian soil?

Some rumours highlight the scary nightmare of a "Coup d'Etat" which is believed to be underway to overthrow the democracy in order to give full powers to the United Nations' One World Order.

It is also believed that those troops are mixing up with others Agencies and organizations such FINCEN, FEMA, M.J.T.F. and B.A.T.F. Police Forces, Rex-84 and Operation DRAGNET, etc...

For months and months since 1993, our Press Agency: The International Free Press Agency and Network, in Canada, is in close contact with somebody in Michigan who is himself a personal friend of Mark, a former U.S. Army Intelligence and Counter-Intelligence Analyst. In a two hours video we received along with others documents, Mark delivers a frightening message concerning the tools the United Nations Military and Police Forces will be using to put an end to the Age of Democracy in United States and Canada before mid-summer of 1999.

The transcription of the video-tape called AMERICA IN PERIL has been reproduced in CONTACT Newspaper, Vol.4, No.2 (Jan.4, 1994), and in Vol.4, No.3 (Jan.11, 1994), and also in "THE NEW WORLD ORDER IN NORTH AMERICA", a 1993 book wrote by Dr. Robert O'Driscoll, who also owns the copyright for this material. We are using here the transcripts reproduced by the Contact's Newspaper: (2)

We will be covering everything we can concerning the New World Order operations inside the United States. We will be discussing the MJTF (Multi-Jurisdictional Task Force) Police, FINCEN United Nations combat forces inside the United States, and the conversion of the United States as an asset for the United Nations.

To begin with I originally worked as an Intelligence Analyst in 1975 through 1981 first with USEC Company D of USEC Fort Huachuca, Arizona. From there I moved on to 5th US Army Intelligence Center where I worked both as an Intelligence Analyst and as a Counter Intelligence Coordinator. Later through the 80's up until present time I command two, both second and third, outdoor brigades which are special warfare units that train US military forces in foreign warfare and tactics.

MJTF POLICE:

We are going to start with the MJTF Police and where it came from, what its original mission was, and what its mission is now. Through a series of political actions that started around approximately March of 1989, the Federal Government extorted resources from most of the states, sometimes all 50 states simultaneously over a two week period, passing laws in every state authorizing the use of Federal Funding to convert local and state forces into national police forces. The MJTF Task Force is in virtually every state of the union of the United States at this time. Its primary mission is "house-to-house search and seizure", "separation and categorization of men, women and children" in large numbers to transfer to detention facilities and the use of those facilities for interrogation purposes.

The MJTF are regular National Guard, local law enforcement, and street gangs converted to National Police Services. Remember this was originally organized under George Herbert Bush. We all know, of course, that President Clinton has purposed a National Police Force. This is simply another name, in fact an over-name for the MJTF Police. Now the model for the MJTF Police is that they are the velvet glove on the iron fist. Anybody who is familiar with some of the speeches that have taken place, ex-President Reagan spoke in England by phone approximately two months ago and commented that the United Nations Forces would be the velvet glove on the street fist. This is a very popular phrase. It has been used extensively by these people who are within the New World Order operation. I don't know how you feel about this but anytime I've been hit with an iron fist, I usually don't feel too good and a velvet glove doesn't make much difference. It should be noted that most of the resources are being drawn from again, Federal Funding to our regional governments.

The State of Michigan converted part of their forces over on February 11 of 1989 when Senator Carl Levin, the State

Adjutant Generals of the states of Michigan, Ohio, and Indiana met in Lansing and at 6:35 in the evening, an agreement was struck in which elements of the Michigan National Guard would be deployed in Indiana and Ohio in the event of--in fact it was stated that when firearms are confiscated in the Midwest, that these forces would be deployed both in Indiana and Ohio. Indiana and Ohio would then provide 50per cent of their Guard forces to police the Michigan under the MJTF guidelines.

Approximately 3 months after the arrangement was made through the Department of Defense (DOD) in conjunction with other agencies, some of them unknown at this time, the State of Indiana backed out of the agreement. When this took place the Federal Government through a series of funding coordinations withdrew resources from the State of Indiana. They had to restructure part of their Guard mechanism and in the process were able to maintain a good portion of their original integrity concerning their preparedness strength for Guard forces. Three battalions had to be restructured at that time.

Now the MJTF Police are supplied and supported through strategic reserve aircraft that have been transferred to their resource. They will convert almost all of the existing local police agencies to National Police forces after they have rifled personnel they do not consider trustworthy (see our chapter concerning the "New Age Police Ideology") and they will also incorporate street gangs.

Now if anybody has seen the guidelines, and we have copies of both, the original stated that "house-to-house search and seizures" would be performed by military, law enforcement, and civilian personel. Now we all know who the military are. That is anybody in a green uniform or a blue uniform with the Army, Navy, Air Force, Marines, Coast Guard. We understand that those will be people in the National Guard Reserve and our active military forces. We know who law enforcement is. These are the constables, individuals that you have at your local level all the way up to and including

our secret police in the United States such as the FBI, Central Intelligence Agency (CIA), and other agencies that might be at their disposal--Defense Intelligence Agency, etc.

Who are the civilians that are going to come into your home? I don't recall there being any guidelines for that in the Constitution. If anybody has listened to National Public Radio you will note that on several different occasions, specifically the 10th month of 1992 it was announced, in fact, it was a one hour special program, on National Public Radio about converting the street gangs to law enforcement agencies. We have been talking about this for years prior to its action. We knew that there were preparatory activities taking place, but through these activities a truce was signed by most of the large gangs in the city of Los Angeles. At the time there were negociations in process in Chicago and this was also taking place in New York. Since the initial action, a full agreement has been signed in Los Angeles and both the Crips and the Bloods are now been trained, equipped, and uniformed with Federal Funding through California. Chicago has finalized this agreement last week. New York is in the process of doing so sometime in the next few weeks and we can assume that they will do this very quickly. These forces will be the cannon fodder. Their mission is to be the forefront for the master forces to come through the door. Remember that the average Federal Agent makes anywhere from \$47,000 to \$57,000 a year. He is more or less looking at his pension. He is not concernend with risking his life, especially if he can find someone to throw in front of him as a sandbag. That is the mission of these group forces that are being organized.

Since last I spoke, probably the best example I'm sure that everybody listening here has heard about is Waco, Texas. These forces that were on the ground, to give you the best example, were not effective fighting forces. When you retreat and leave wounded and dead lying on the ground, that is called a rout. That's not a retreat and this is symptomatic of professional forces that ar there for the

money. On the other hand, if you use the old medieval pillage principle and you have a profit mechanism set up in which you are allowed to confiscate properties, cars, jewelry, furniture, the neighbor's wife, whatever, then you are highly motivated to go through that door, and especially if you have been doing it illegally for an extensive period of time and all of a sudden you are given the opportunity to be legitimized. Remember, why let the the street gang situation foster or floutish the way it did? We had more than the capability to restrict the street gangs at the time when they came about and most assuredly we had: we had the capacity to restrict them in any way that we wished to. However, by allowing the street gangs to flourish, you create regimentation. Then the strong come to the top. These are your NCOs and leaders and when you are finished, you simply put them in uniform and you have an organized military force at your disposal. They are thugs but they are expendable thugs! Remember that.

Now, MJTF police operations are, there are several actions that have taken place within the last two years starting in 1991, they participated or were part of Operation "Achilles", which was a sweep from the southern Ohio Valley up through to Michigan at ATF (Bureau of Alcohol, Tobacco and Firearms) and MJTF forces to harass and eliminate FFL holders who were manufacturers and producers of components and arms. Their primary concern was not to confiscate or to charge somebody with illegal arms but rather to acquire records and resources that were available and in the hands of the people who held the FFL. In every case where they went into these businesses the only thing that they took were the records of who purchased products and where they lived. Very important to understand.

There are a series of other activities that took place after this. MJTF was deployed in Los angeles during the LA riots, though there was only a slight mention of it, that's the authority they were under along with FINCEN. All of these agencies are overlapping and under the general authority of the United Nations. Remember, we are now an

International Organization, not the Unites States. We are a small corporate part of a big company, a larger company.

In 1992 through early 1993, reorganization was taking place to try to give the MJTF greater credibility. However, it was understood that the mercenary forces will not function as originally anticipated so the Guard has been restructured. That, for many people who are familiar with the way the Guard operates, will be able to understand why the Guard is being riffed of experienced personnel. "Desert Dust" or in other words what we call "Desert Storm", its primary mission (it was threefold), but its primary mission was to see whether or not the American people would eat the New World Order... U.S. soldiers were sent overseas, American flags were taken off their uniforms, flags were taken down by officers in the field, the flag was not to be flown. Most every other nationality was allowed to fly their flag and other than for publicity purposes for public consumption, the general position was that the flag was to be brodden at every opportunity. However, if any of you were watching the news you will notice a lot of Marines were jumping up and showing their patch, which they just pulled out of their pocket, and laying it on their arm and going "see this, this is what I'm fighting for". These people have to be done away with. You can't have these people in the military and so, they decided they would have to riff these people out, transfer them to Guard. If they are already in Guard unit, restructure, reestablish, guidelines that would allow them to extract these people from the mechanism. They are trying to go to the next generation of educated idiots. They are looking for people who are going to be more pliable, as Mr. Rockefeller said many years ago, clay that could be molded more efficiently. And since the first or latest crop didn't work, we are now going to restructure the entire mechanism and see what we can get from the next batch. This is where we are going with this.

Now it should be noted that before they can perform any of the actions that are pending, they are going to have to take weapons that we have inside the United States. I will say

again that the meeting that took place in 1989, the Federal Government and the representatives that were there stated unconditionally WHEN we take the weapons but WHEN! Under that premise everything else was constructed.

GUN CONTROL LAWS AND GERMANY:

Now, there is one that I like here and I'm going to have it put up on the board as we are speaking. A little poster everyone should remember. All those in favor of gun control raise your right hand. There is an interesting piece that just came out that I was most fascinated with in regards to firearms laws. It is a book concerning the gun control act of 1968, in which it has been demonstrated that the gun control act of 1968 was simply an American creation. It was taken from Nazi Germany's gun control laws of 1938, word for word. Now that's very important when you consider this. We are not talking a few paragraphs here and there. The entire document is taken from Nazi Germany's gun control laws of 1938. If they are already at that level in 1968, then where are you going to go with our gun laws now? If you have listened to the people who are talking about this they say that the Brady Bill, for instance, (I'm hoping that everybody understand what that is. That is one of the pending firearms legislation, that's at the Senate and House level right now). It is a good first step. Follow through on this. I don't think anybody likes that idea. If that's a first step then where are we headed?

MJTF & FINCEN:

It should be understood that the MJTF Police is not trusted by the Federal agencies and eventually will be done away with. Again, the MJTF are useful cannon fodder that eventually will be swept to the side.

Moving on beyond the MJTF Police. We are going to back up into them a little bit--there are FINCEN Forces. FINCEN are Financial Crimes Enforcement Network personnel.

FINCEN has as much to do with finances as the SAS had to do with airplanes. The SAS (Special Air Service) was a cover name for an entity which existed in England and was the equivalent to the OSS of World War II 1941 through 1945. FINCEN Forces: their mission is "house-to-house search and seizure", "separation and categorization of women and children", "transfer to detention facilities", securing properties acquired, but not the maintaining of detention camps. That will be the mission of the MJTF Police.

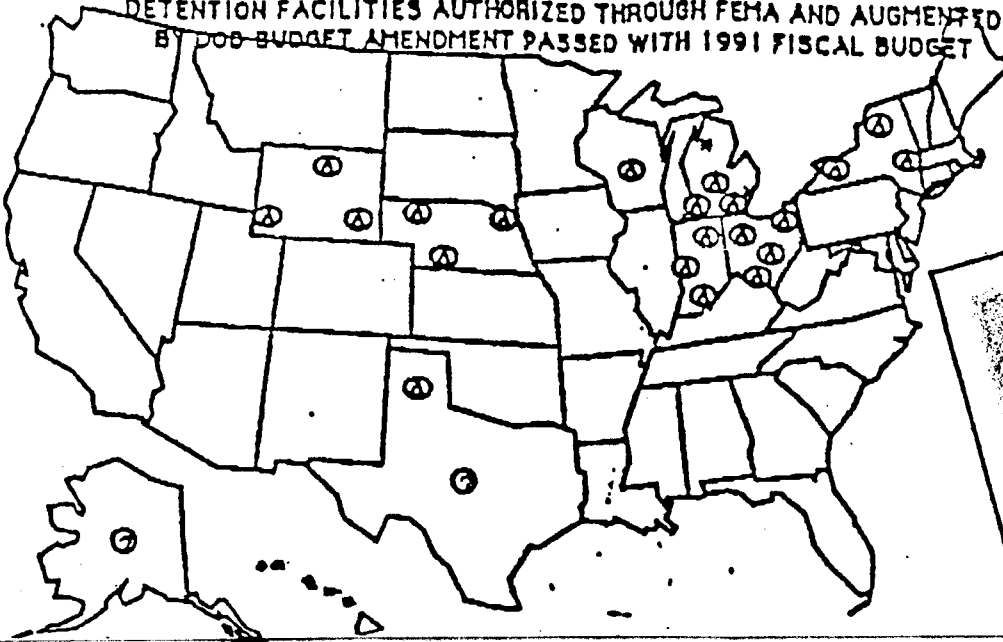
FEMA AND DETENTION CAMPS:

I should mention very quickly the detention camps themselves. Originally under FEMA, 23 detention camps were authorized. These detention camps were spread out across the United States. In addition to that, there are 20 supplemental camps that were authorized with 1990-1991 Military Fiscal Budget. Carl Levin's DOD Budget Amendment 656 authorized the implementation of these 20 camps to supplement the 23 that were already authorized. There are now 43 total camps that are predeployed inside the continental United States. In addition to that there are supplemental camps or auxiliary camps through each state and each region, an example of this would be the Nike-Hercules site located near Monroe, Michigan. That is pre-designated detention facility. The 3 sites that are located in Michigan: (1) Located due north of Pickney, Michigan, due west of Brighton. (2) Earmarked near Lansing, Michigan to be north-northeast. (3) Fort Custer Military Reservation which has been upgraded from a D facility to a B facility. This is very important because a D facility is State authorized and State controlled. A B facility, on the other hand, has been upgraded to Federal status and is comparable to any of our prime military facilities such as Ft. Benning, Georgia. Wright Patterson AFB, any facility that we are presently using for active military forces. However, if you get a chance to tour the highways and byways and back roads of Fort Custer you will find that there is a new urban warfare center there. The new urban warfare center

doesn't look like Bad Hersfeld (base), Germany. It looks like downtown Monroe. It looks like downtown Saline. It has 3 bedroom ranch style houses, crackerbox farm houses, small living areas inside downtown areas. At this particular site MJTF Police forces were training from the first week of January of 1989 on. They were training every second and third week of the month from Monday through Thursday. They were paying with non-DOD funds, in other words, these were GSA funds other than regular military budget allocations. It is important to understand how they pay because that's how you can find out who it is that's playing.

These forces operated secretly for a number of months and we identified them as they were training and they changed facilities. We understand after approximately 1 1/2 year cooling time they are using Custer and they are using Grayling again, extensively bringing forces together from other parts of the state, training them on site and sending them back out to be prepared for whatever is going to happen in the future.

FINCEN FORCES:

We'll get back to FINCEN now. FINCEN was organized utilizing four military forces as secret police forces here in the United States. They are drawn from military and secret police forces overseas. They are predominantly European. We have Belgian, Dutch, German. We are looking at French. We also have a variety of Asian military personnel. It is known at this time, for instance, that FINCEN has an element in Montana that is made up of Gurkhas (warlike Hindus from Nepal). The 197th Mechanized as of one week ago has deployed for a training operation that may last as long as two months in northern Montana through to the Canadian frontier. It is the 197th Mechanized Infantry combined with 2 brigades of British Mechanized Infantry, the First Canadian Armored Division, Gurkha Mercenary Forces, 1 Belgian brigade, 1 EEC Mixed Security brigade and an undetermined number of other forces all foreign. They origin-

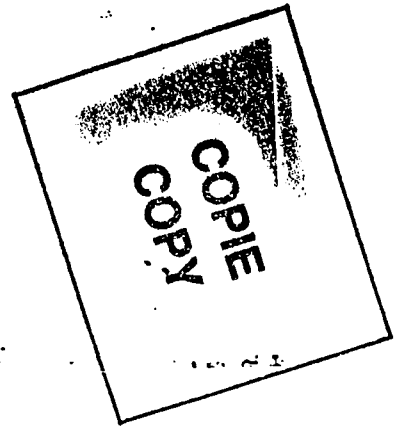
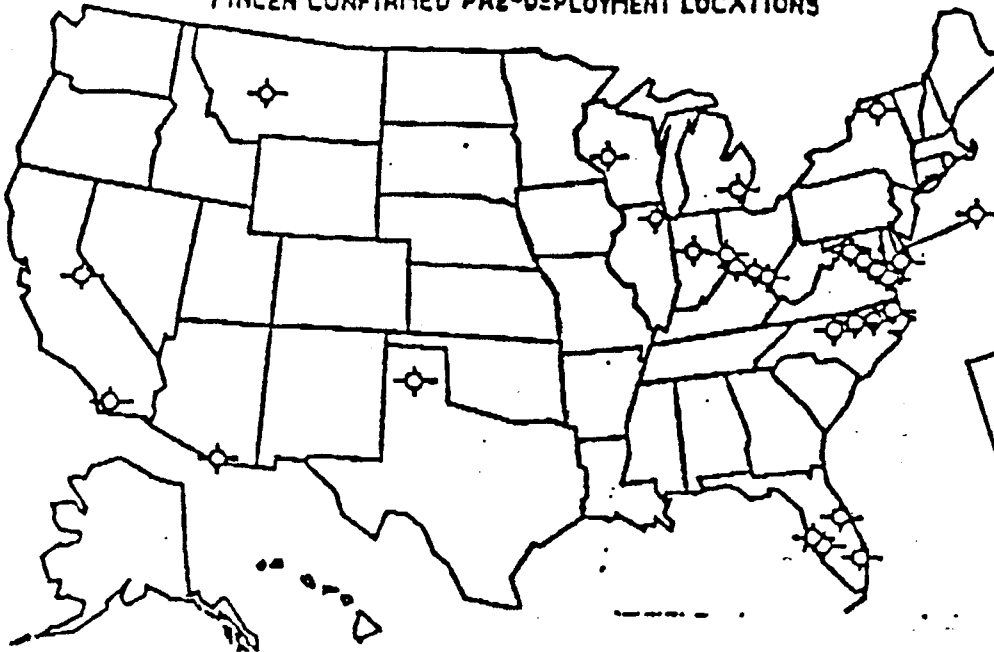
ally were scheduled to work for approximately 3 weeks in the area but if this is similar to the last mobilization that took place, you will find that they will be there for up to 2 1/2 to 3 months.

During the LA crisis that took place there were a series of actions that took place both in Montana and we also saw activities in California, and there were activities in northern Texas in the panhandle. (Late last month, March 1992, a second caller on the short wave talk show confirmed that machine guns are being mounted on boxcars in San Bernardino, California. S.B. Co. is the largest County. The black population in S.B. Co. "rivals" that of LA.) (3)

FINCEN forces are ruthless. For example, the Gurkhas are professional mercenary forces from Nepal. They rotate these forces for a period of time out of Nepal and were originally hired by the British military force for a number of years. Now that they are under UN authority of course, they have to find a use for them and they have. Remember the Gurkhas were being paid by the British and probably still are to be used against us. Kind of like the Hessians of 1775, isn't it? I think you will find a lot of other forces with similar perspective there.

There are, and I will use the regional map here, there are a number of forces spread throughout the 10 regions. For those of you who are not familiar with regionalism: Regionalism is a form of government that we are about to experience if the New World Order people have their way. Under regionalism, Michigan becomes not Michigan but area 5. As area 5 our capitol will be in Chicago. Under the New States Constitution this particular type of government comes into power and we are going to find that all of a sudden we are going to be part of this warm fuzzy New World Order real quick. Unfortunately, we never vote for a Governor again. The Governor will be directly assigned by the President, kind of like in Star Wars. (We call that "Dictature" folks; nothing else than a ruthless Dictature implemented against the Free Will of the People.) (4)

...Terror shall reign. And most assuredly, terror shall reign! The regional Governor will not have the same authority over his military forces but the most assuredly will have full authority over his security forces. Unlike the Governors of old he will not have a pocket army, he will simply have police. The centralized military force will be completely under the authority of the United Nations.

Now, how did we get here? Well, that's an interesting story when you think about it because there are a lot of problems that are involved. It's an ongoing escalation of resources pitted against the American people and the Republic. We are a Constitutional Republic, by the way. We are not a democracy. I think that everybody had better remember that right now. This is a problem you run into even with Republican Presidents. How many times did you hear George Bush say "this democracy"? This is a man who calls himself a Republican. I'm not necessarily a Democrat or a Republican. I'm one of those independent American kind of guys.

Here's an example of FINCEN and some of the effects that overlap into United Nations operations. This was on the cover of Airman magazine which is the US Air Force publication, July 1992. It should be very evident that the forces that are displayed here on the cover are very impressive. Unfortunately, of the 5 aircraft on the cover only one of them is American. The rest are all Soviet bombers or Soviet heavy-lift aircraft. It should be noted that these types of assets have been reported on by a lot of people in the military who people didn't want to listen to or believe. These are documents that more than verify the validity of comments that were made in the past. The forces involved that we are going to see in FINCEN will be very well educated. They are professional military forces. They are for all practical purposes mercenaries of course. You are going to find that they normally serve an 8-year tour unlike the old American mechanism which was a 6-year tour mixed time of active and reserve component with IRR (Independent Ready Reserve) options. Instead

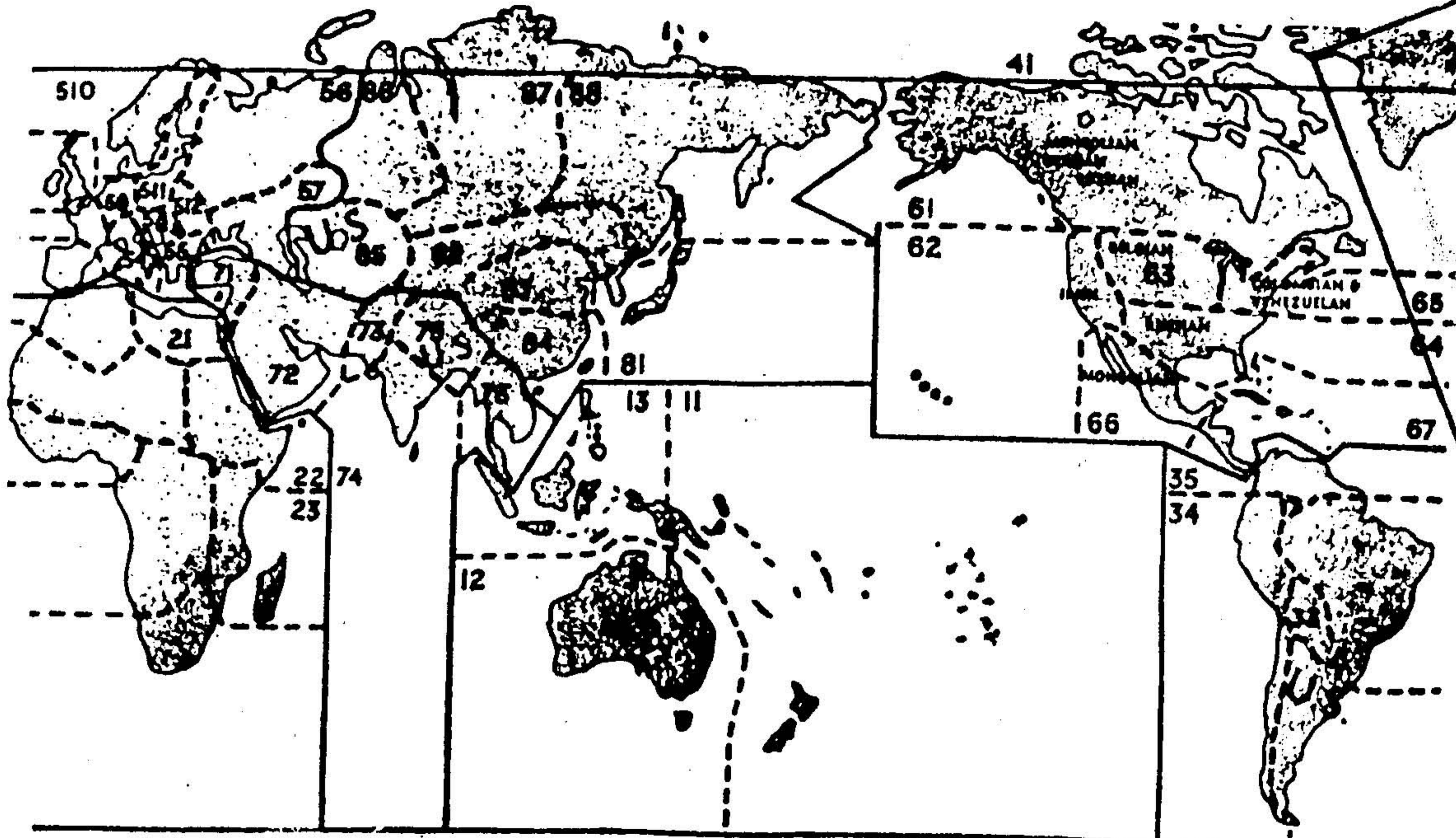
we have now gone to an 8-year mechanism, the same as all foreign professional forces overseas, very characteristic of the same mechanism that the British used against us in 1775. Conscription through pressing was normally done with an 8-year tour.

...what we are looking at right now is an action which is quite sophisticated and has taken probably 50 years to develop, and the enemy has almost reached that point where he can touch the golden ring.

FINCEN AND OVERSEAS MILITARY FORCES:

There are a lot of military forces that are being sent overseas. Does anybody wonder why in this time of peace we are sending more and more of our military strength to Bosnia-Herzegovina, Somalia, Thailand? And has anybody heard about our forces in Peru? I imagine not. Well, I'll give you a good example. We have 20,000 to 21,000 personnel right now sitting off Yugoslavia's coast or in Yugoslavia at this time. We have approximately 20,000 mixed personnel functioning in Somalia. That's 40,000 combat personnel. In addition to that we have 22,000 to 23,000 in Cambodia. Now we've got 60,000 people overseas and most of them are combat troops. Let's go one step further back during Desert Dust, one of those little actions that was missed by everybody is that during the executive orders that were signed, 18,000 US military personnel were sent to Peru for policing operations there under UN authority. Now this is documented. We've got people who are down there right now. There are families and there are Mothers who are highly concerned about the people that are in place. They have lost people there. People have been killed. This receives no publicity and yet it is going on. It is a prime example of "Watch my right hand". "Hey, you didn't see what was going on over here, did you? That's what we have to worry about.

These people control the Media completely. What I do a

lot of times...is video tape what is going on television but ignore what they say. Pay attention to the photographs. If they are really concerned with something they won't feed you much, but in many cases they feel the general population is not observant and there is more in a picture than in all the gobblygoopen words that they have fabricated. You have to ask yourself when you look at pieces of equipment and activities, why is this taking place? Where is this taking place? Is this actually what is going on? If you look at the expressions of the individuals, the activities, the attitudes, you know that something doesn't taste right. A lot of military people coming back are tickled pink to leave Somalia as fast as they can throw their feet on a 747 Or 737 air bus. There is a reason for that. It is an untenable situation but it is typical of the type that the United Nations has put us into. Of course, by the way, we are paying the bill too...

It should be noted that a lot of personnel who are and we have personal contacts that are experiencing this right now, are having difficulties bringing family members back or sending family members back from Europe to the United States. We have three families in particular that are experiencing this right now. They are attempting to send their wives and children out of Europe back into the continental United States and the military will not do it, will not send them...This is interesting considering we are not at war and we have no threat of war on the horizon that anybody could pick out short of a few policing actions that are supposed to be fairly minor...

(Beware that Lusitania-type contrived incident or incited internal strife does not put you in a real-life re-run of the TV mini-series "Amerika"! Based on research of the National Economic Council, the Map shown on other page was adopted in London in 1952 by the World Association of Parliamentarians for World Government. Alien troops would occupy and police the regionalized earth under a World Parliament of APPOINTED members headed by a dictator. No native Americans would enforce the New Order in the USA, only Russians, Colombians, Venezuelans,

Belgians, Irish, and Mongolians. State Department 7277 for totally disarming the USA presented similar plans.) (5)

(So why US and Canada are sending so much troops overseas? Why do we accept it? It is because we are so disillusioned, disenchanting about everything, and feel so powerless that we have already closed our doors to the outside world choosing instead to be captivated by a TV screen? Or...Or what exactly?) (6)

FINCEN AND UN COMBAT FORCES:

...United Nations combat forces include those that are cooperating with FINCEN at this time in Montana, the elements that are in California. There were 25,000 of them identified south of Los Angeles and are probably deployed north-northeast of Los Angeles in the Sacramento Basin. The elements that were located in Texas have shifted by all indications and are probably spread out through a series of garrisons. The Ohio Valley starting in the Cincinnati area and moving north-northwest have forces deployed there. We know that these elements are also located at Ft. Huachuca, Arizona; there are some at Ft. Benning, Georgia. We know that an element was also located at Ft. Drum, N.Y.

...our processing center for detainees in the western half of the United States is Oklahoma City. We do not know what the location is for the Eastern Seaboard at this time, however, by all indications Ft. Drum will be the control point for processing individuals to detention facilities on the eastern half of the United States, east of the Mississippi. If there are any problems, what I would recommend for a lot of people that are concerned about this is that we observe the air, not the ground.

What I would like to get into next are the activities and future proposed actions inside the United States by a variety of organizations including the MJTF Police, FINCEN, and UN battle groups that will be deployed against the

American people. First of all we'll go back to early 1989 when originally in smoke filled rooms, behind closed doors, some committee of political monkeys decided that it was time to go after the weapons inside the United States. In doing so, what they did is decide to come up with a program called guns/drugs drugs/guns. If you have a gun you must be a drug dealer. This is everybody, private arms owners, skeet shooters, whoever. Our response as law abiding American citizens was supposed to be, "Oh, take my guns, I'm not a drug dealer, oh please". Unfortunately, what happened as far as the government is concerned is that the American people started to rearm themselves very quickly.

We surveyed a lot of different shows throughout the United States, Midwest, specifically, in fact in some cases we covered three different cities and two different states within a 10 hour period. What we saw weren't people trying to get rid of their weapons, in fact, that wasn't the case at all. You'd notice that people weren't selling anything and were buying more. It was shoulder to shoulder, elbow to elbow, rear end to front and heel to toe and everybody was bringing everybody's uncle in to buy weapons, munitions equipment and we saw this from Kentucky and Tennessee to Pennsylvania, to New Jersey to Michigan, Indiana, Illinois. The effect that their guns/drugs drugs/guns program had is that the patriots out there started to talk to people and said, "see this is what we told you was going to happen". And after surveying a few shows, I'm sure that the intelligence information coming back to the Alcohol, Tobacco and Firearms people and also from other agencies that were monitoring the gun shows was the result was not exactly what they wanted either.

...When in 1990 it was realized that they weren't exactly accomplishing their original mission they had to change their time table a little, we think. By the third month it was realized that the militia forces civilian arms were burgeoning at a massive proportion. The structured forces inside that were deployed included operation "Achilles".

FINCEN, MJTF AND "OPERATION CLEAN-SWEEP":

They began to reduce their actions because of notoriety and the fact that they were seeing more aggressive stances on the civilian population that they were attacking. Unfortunately, like cockroaches, you can spray and they keep coming back. So by late 1992 the latest guns/drugs drugs/guns campaign escalated with a variety of other actions overlapping. It's a threat to your children....It's a threat to society. Well, this society isn't monarchical England, it isn't Pharaonic Egypt, and we most certainly aren't the Union of Soviet Socialist Republics. ...

Now during this time from late 1992 to the early part of 1993 we have seen a series of other actions take place in which firearms confiscations house-to-house, door-to-door have taken place. Operation "Clean-Sweep" in Chicago, Operation "Achilles 2" in Cleveland, and a series of actions that took place after the Los Angeles riots, not against the street gangs but against the citizens who defended their homes and their businesses. ...

During the earlier phases, for instance in Chicago, the black helicopter missions that we were talking about in the earlier hours were taking place extensively. We have individuals who were in high-rises who were actually above helicopters flying between the high-rises in Chicago, in the windy city. These operations culminated in a final activity which lasted approximately one week in which they coordoned off neighborhoods, went building to building and house to house, entered forcibly if necessary, and prosecuted the owners of any firearms, ammunition, or gun parts found. This was operation "Clean Sweep".

In Cleveland an activity which was covered only by National Public Radio involved elements of the MJTF police and probable FINCEN forces. The Ohio Guard was mobilized from several different areas of the state, transferred to an area outside the Cleveland airport where a moulnt area, an urban warfare training area was set up with three neigh-

borhoods. The units that were brought in were trained in house to house search and seizure and securing a neighborhood. They then went into the first training neighborhood, went house to house, secured the neighborhood and then attacked the second neighborhood. Once they had secured the second neighborhood they had to hold the first two and went to get a third neighborhood. After these elements were trained and passed through this mechanism, they were transferred to different parts of Cleveland where they were actually deployed against the population.

This happened about the same time that the Weaver incident took place in Idaho. It was almost simultaneously. In fact a series of actions both in Cleveland and one in Michigan took place either during or shortly after the Weaver incident. Now in Cleveland this received media coverage. In some part of Ohio this received media coverage but it received no national media attention except for one place, National Public Radio, who thought that this was the next best thing to sliced white bread, that they violated people's homes, that they had gone into different parts of the city and that they had done this.

...when the Alcohol, Tobacco and Firearms forces came into Detroit to search house-to-house in specific neighborhoods, it should be noted that National Public Radio on the 11th of March broadcasted another one hour program in which they specifically mentioned that if we can do it in Cleveland, why can't we do it in Michigan.

WACO: REHEARSAL FOR A RELIGIOUS BLAST BLUE-PRINT:

The Waco situation which is typical of a lot of what we are going to be seeing in the future, although, I think you are going to see more ham-handedness, involved a 100 to 130-man assault company of the Alcohol, Tobacco and Firearms, probably under MJTF authority again.

It should be understood that as of March 1989, the ATF, Alcohol, Tobacco and Firearms forces were divided up into these assault companies.

Each platoon consists of 40 men armored with the M16-A2 rifle, the AR15-9 millimeter conversion, or the M79 grenade launcher. It is now known that these forces also include the M60 machine gun, which is an infantry battle weapon now being deployed with policing agencies, you know, like they have in Russia. It was interesting to note that this assault company in Texas was identical to the type of forces that were used during Operation "Achilles" in the Ohio Valley coming up into Michigan.

The forces are in all black BDU uniform. They wear the black pasgan armor with the black pasgan helmet which looks quite a bit like the German colscuttle. They are armed, equipped and maintained through DOD resources. So, many of the weapons that they are provided with are actually provided by our military. In many cases, Alcohol, Tobacco and Firearms, the FBI, DEA are now receiving training by Quantico Marines and many of them have gone through the US Army Ranger School. That is rather exotic training for people who are supposed to be police officers in the United States. On the other hand if you again need thugs, you've got to send them some place where they can learn to be fairly efficient thugs.

Many of the people that we've had that went through Ranger School in the last one year said that up to 50 per cent of their company were made up of Federal Bureau of Investigation people and individual who were involved with Alcohol, Tobacco and Firearms or Drug Enforcement Agency.

Now, DEA, by the way, has what we call CLET units. CLET units are directly under the control of the Treasury and/or can be accessed by the MJTF police or FINCEN. CLET units are armed identically to the ATF combat elements and

are deployed throughout the United States and can be used overseas. DEA is now using extensive resources from outside the United States in terms of manpower, but they will not identify what the name of the organization is that's being used. Now, remember, we know what FINCEN is but nobody else is supposed to, so it can be assumed that FINCEN is the element that is involved.

How are they deploying equipment here? Well, its kind of strange. A lot of people say, where are they? Well, they are in all parts of the United States but we've had at least one face to face confrontation with some of their people right here in Michigan.

BLACK LIST: A STRANGE CASE...

...though I can't mention names, on a given date one of our people was attempting to use a space-available flight through US Army Tactical Lift Command. Upon arriving at the site they gave him his military ID card. Somebody punched in his name, look at him very briefly and went and punched it in again. In a minute and a half there were two MPs behind him. Now this site is Selfridge Air National Guard. The individual was then taken and put in a car, driven around to the southwest quadrant of the Post. When he arrived there, the MPs took him out of the vehicle and as he entered the structure the first person at the table, at the entrance desk was in all-black uniform with no identification or markings at all. He was then taken to an interrogation room. Now at first he's going, "oh my goodness, what did I do?"

"My ID card must be messed up or something." Upon seeing the black uniforms he understood exactly who he was dealing with. He was sat down. The first thing he was asked was how many cars do you own? How much food do you have? How many weapons do you own? What are the names of your children? What does 762X39 millimeters mean? He really didn't know. Well, he really did but he

thinks in inch not in metric. Then there was a little conference and they left the room. Well, they left the room and they left a file sitting on the table. Anybody that is involved with military knows that you don't do that. Your career rests on security but it should be understood that in this file --he dragged it across the table, opens it up very quickly and there is a big rap sheet about 2 1/2 ft. by 1 1/2 ft. tall. On this sheet was a spiderweb of names of people to be arrested. My name was at the top for the State of Michigan; so I can be proud I'm no.1 in trying. I don't have to try harder. Number 2 was another individual that was with us. Number 7 was the individual who was being questioned. All of the other lists had virtually dozens and dozens of names. It should be understood that it was meant for him to see this and it was a direct threat to anybody else who is prying into the affairs of these little goosesteppers.

The gentleman made a little rattling noise at the door and came back in, sat down, and basically told him, we have nothing to hold you on. We are going to let you go. Walking back out two MPs appeared, picked him up, walked him back over the vehicle, drove him around to his vehicle and he left the Post.

Now anybody that understands military documentation will understand that if you have a classified records jacket, you take a classified record sheet and put it on the top, first of all. ...The next thing you don't do is take a classified document and leave it where somebody you really don't want to see it can see it. This was meant as a direct threat. This was just before we were involved with other meetings that we've participated in that we were illuminating people to this subject. If I keep this up, they are going to do something to me. Well, I'll tell you what, I'm not stupid. If I'm already on the list as many other people are, look at this way, you are never going to come off that list.

CONCLUSION:

They are scared snotless of the possibility of the American

people waking up. Any possibility, anybody trying to bring forth what we are talking about puts such a wrench in their plans that they can't afford to see this exist. They will do everything in their power if need be probably eliminate people but I think that's down the road. Right now, they are rather concerned we are rather public but they will do everything in their power to squash this movement in its infancy. (2)

Since 1985, the IRS has been computerizing all Americans and that project is now virtually complete—in 1991—. A computer profile now exists on virtually every American family and individual, which will enable the government by computers to monitor virtually all of your activities, trace, track, and perhaps eventually directly assess your taxes based on your computerized financial profile—electronically debiting your bank account for the tax due.

The computerization of the American people will enable the government to watch and control you from the cradle to the grave. If this sounds a lot like George Orwell's 1984, Nicolai Ceausescu's Romania, Hitler's Third Reich or Gorbachev's or Deng Xiaoping's communist "paradises"—it is because it is! The New World Order/New Age government of the future will be able to watch and control its subjects more completely and efficiently than any totalitarian power in the past. The computer will help them to do so!

As a sample of the kind of people-tracking information which is now being amassed on computers by the US government, the following government memo was sent to employees of one large government agency charged with tracking and monitoring Americans and their finances:

"We now have available to us a new source of background information called METRONET which provides information on over 111 million people in 80 million households across the country. Not only does it eliminate the need for since ATLAS was originally purchased from METRONET by the credit bureau, but it also allows for the following variety of searches:

"PHONE SEARCH—provides a complete name and address report which is provided in accordance with US Postal Service standards. As mentioned above, it is the same as ATLAS except that the record search can continue further once the name and address of the subject have been determined.

"ADDRESS SEARCH—requires that the Zip Code, street

address and last name be entered in order to verify an address and receive the subject's current phone number. If it is a single family dwelling and your subject has moved, METRONET lists the current resident.

"HOUSEHOLD PROFILES—provides the time at current residence, type of dwelling, the subject's age and year of birth. It also provides the names, ages and year of birth of up to four additional family members.

"NEIGHBOR SEARCH—requires only the address to obtain details on up to 30 neighbors at new or old addresses. These details include names, addresses, phone numbers, dwelling types and length of residence. It also provides the current resident at the subject's last-known address.

"CHANGE OF ADDRESS ALERT—automatically searches the US Postal Service's National Change of Address files which is updated every two weeks. With 20 per cent of the population moving to a new residence annually and the fact that 30 per cent of these people never notify the postal service of their new address, METRONET also checks for any change of address that a subject has provided to a publisher or marketing company to make sure that their magazines or other products will be forwarded.

"STREET NAME SCANNING—helps obtain the correct street name abbreviations by checking an alphabetical table of all street names in any given Zip Code that begins with a specified letter.

"SURNAME SEARCH—allows the investigator to search an entire geographic region (i.e., state, county, city, zip code, etc.) when the only information known is the last name of the subject." (McAlvany Intelligence Advisor). (8)

In 1934 the Supreme Court stated: "Emergency does not create power. Emergency does not increase granted power or remove or diminish the restrictions imposed upon power granted or reserved. WHAT IS FinCEN?

The Financial Crimes Enforcement Network (FinCEN) is an organization established by the U.S. Department of Treasury to collect, analyze, and disseminate intelligence on financial crimes.

Secretary of Treasury Nicholas F. Brady officially established FinCEN by an Executive Order dated, April 25, 1990. This order set forth the FinCEN mission to provide a government-wide, multi-source intelligence and analytical network to support law enforcement and regulatory agencies in the detection, investigation, and prosecution of financial crimes.

WHY WAS FinCEN CREATED?

In order to fully comprehend the important role FinCEN plays in law enforcement, it is first necessary to understand the significance of financial crimes and, in particular, the process by which illicit proceeds are laundered. With the possible exception of crimes of passion and certain violent crimes, all criminal acts are committed for one reason - profit.

Since the profit motive is the driving force behind most criminal activity, the identification, seizure, and forfeiture of the profits or proceeds generated by the criminal activity is one of the keys to the disruption and ultimate cessation of a particular criminal activity.

Normally, the greater the profit, the more sophisticated are the financial manipulations necessary to conceal the criminal roots of the profit. Therefore, the profit, usually in the form of currency, becomes a vulnerable point for law enforcement agencies to focus upon.

FinCEN also provides for the coordination and collection of financial crimes intelligence information. The investigation of the financial side of a criminal organization may also assist in proving substantive criminal or civil offenses.

WHO IS FinCEN?

FinCEN was created to bring together, in one location, the information and expertise possessed by various agencies involved in the investigation of financial crimes and the regulation of financial institutions. By creating this synergy of people and information, FinCEN's intelligence analysis reports will reflect a more insightful work product. FinCEN is currently staffed by criminal investigators and/or analysts from Customs, IRS, DEA, Secret Service, Postal Inspection Service, FBI and BATE. In addition to the agents and analysts who are on long-term detail from their agencies, FinCEN also has a permanent staff of intelligence research specialists and automated data processing experts. FinCEN is in the process of establishing a working relationship with state, local, and foreign law enforcement agencies as well.

WHAT TYPE OF INFORMATION DOES FinCEN USE?

FinCEN uses many data bases in its analytical work, although one of the more important ones is the Financial Data Base. The data in the Financial Data Base is gleaned from reports that are required to be filed pursuant to the Bank Secrecy Act and include the Currency Transaction Report (CTR); Report of International Transportation of Currency or Monetary Instruments (CMIR); Currency Transaction Report by Casinos (CTRC); and Reports of Foreign Bank and Financial Accounts (FBAR). In addition, FinCEN accesses data from the Reports of Cash Payments Over \$10,000 Received in a Trade or Business (IRS Form 8300) which is required to be filed by the Internal Revenue Code.

Additionally, FinCEN is in the process of obtaining agreements for access to various Federal law enforcement data bases as well as other data bases maintained by the Federal sector which contain information useful in financial investigations. FinCEN also procures access to a variety of commercially maintained data banks which are valuable in locating individuals, determining asset ownership and establishing links between entities. These commercial sources of information, along with the data from the Federal agencies and the financial data base, form the foundation of information sources for FinCEN analysis.

FinCEN also maintains its own data base which logs and tracks inquiries made to FinCEN; it includes the results of intelligence analysis by FinCEN agents/analysts; and contains data processed during the analytical process.

We will utilize our data base in the sharing of information developed by FinCEN received a request from two different agencies on the same criminal entity, we will provide, in a secure manner, the catalyst for both agencies to cooperate and share data. This type of cooperation has already been orchestrated by FinCEN in more than one major narcotics money laundering investigation.

WHAT CAN I EXPECT FROM FinCEN?

FinCEN currently produces two types of analytical work products for use by its client agencies.

The Office of Tactical Support work product is tailored to providing information and leads on criminal organizations and activities which are presently under investigation by law enforcement agencies. Additionally, it provides analytical

cal assistance to regulatory agencies and proactively identifies previously undetected criminal organizations and activities so that criminal investigations can be initiated. FinCEN's work product will also assist agencies in the identification of assets for seizure and forfeiture purposes and to support ongoing investigations. The tactical work product will range from a search of data bases not readily accessible to the officer/agent on a single subject to assisting in the initiation of cases through a detailed analysis of a major criminal organization.

The initial contact point for participating agencies seeking tactical assistance is the Operations Center. The Center is staffed weekdays from 7 AM to midnight, Eastern time. We will continually evaluate the need to expand the operating hours of the Center. The methods of transmitting requests to the Center, besides the mail, will be by telephone, facsimile, or electronic mail depending on the procedures that are established with the particular agency.

FinCEN also studies financial crimes and money laundering with a bent toward the future. The Office of Strategic Analysis (OSA) is responsible for collecting, processing, analyzing, and developing intelligence on the emerging trends, patterns, and issues related to the proceeds of illicit activities. Some of the areas of study include: the analysis of the flow of currency to and from the Federal Reserve Banks; the examination of the CTR exemption procedure to determine if it is being exploited by the criminal element; and a review of the extent and ways money transmitters and currency exchange businesses are being utilized for money laundering.

The OSA has a Branch responsible for staying informed of international events and their potential effect on money laundering. Client agencies will also be kept abreast of current trends in the money laundering area through FinCEN's publication of "Money Laundering Updates."

DOES FinCEN ONLY DO NARCOTICS-RELATED INTELLIGENCE WORK?

No. Although the President's War on Drugs calls on FinCEN to place greater emphasis upon narcotics-related matters, FinCEN also routinely develops intelligence relating to the financial side of all criminal activity (i.e., financial institutions fraud, commercial crimes, tax evasion, etc.).

FinCEN's analytical work product will greatly assist law enforcement agencies in identifying potential criminal violations and violators within their respective jurisdictions. In addition, FinCEN can assist law enforcement agencies in the location of fugitives by attempting to locate their whereabouts through commercial systems and other data. FinCEN has been structured so as to be flexible and responsive to law enforcement, and intends to be on the cutting edge of financial crimes intelligence.

FinCEN does not have unlimited resources, so it will continue to determine how it will prioritize its work. Some of the prioritizing criteria we are considering using are as follows:

- Is the matter a national and/or requesting agency's priority?
- Is it focused on a criminal organization versus an individual?
- Is the scope of the organization - national/international versus local?
- Are the organizational assets subject to forfeiture due to the criminal activity?

Therefore, if you are conducting an investigation and some or all of the above listed attributes are present, you may want to contact FinCEN for assistance.

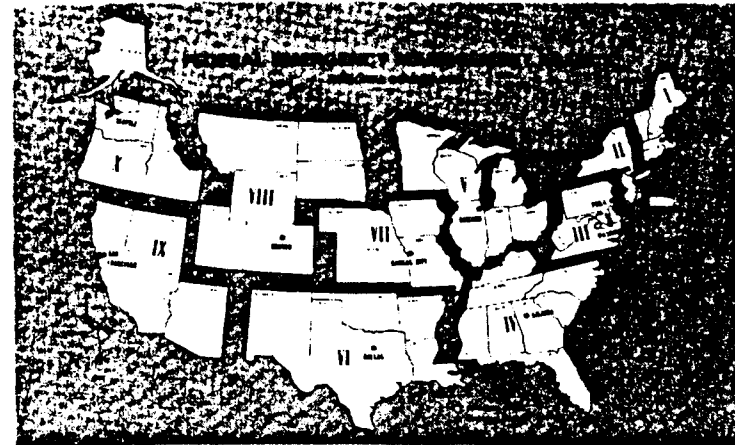

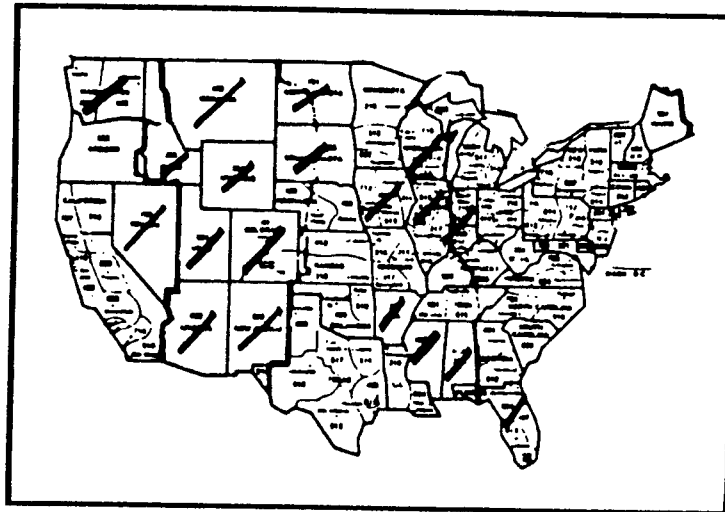

Executive Order 12148 of July 20, 1979
Federal Emergency Management

By the authority vested in me as President by the Constitution of the United States of America, including the Federal Civil Defense Act of 1951, as amended, and in order to provide for the most efficient and economical use of the Executive agencies, and to provide for the most efficient use of the Federal Emergency Management Agency, I hereby order as follows:

2-203. For purposes of this Order, the terms "natural, man-caused, or war-caused" shall mean any event which may cause substantial damage to or loss of property.

2-204. Executive Order No. 10952, as amended, entitled "Assigning Civil Defense Functions to the Secretary of Defense and Others", is revoked.

2-205. Executive Order No. 11051, as amended, relating to responsibilities of the Office of Emergency Preparedness, is revoked.

2-210. Executive Order No. 11415, as amended, relating to the Health Resources Advisory Committee, is revoked.

2-211. Executive Order No. 11795, as amended, entitled "Delegating Disaster Relief Functions Pursuant to the Disaster Relief Act of 1974", is revoked, except for Section 3 thereof.

2-212. Executive Order No. 11725, as amended, entitled "Transfer of Certain Functions of the Office of Emergency Preparedness", is revoked.

2-213. Executive Order No. 11749, as amended, entitled "Consolidating Disaster Relief Functions Assigned to the Secretary of Housing and Urban Development", is revoked.

2-2. Amendments.

2-201. Executive Order No. 10421, as amended, relating to physical security of defense facilities is further amended by (a) substituting the "Director of the Federal Emergency Management Agency" for "Director of the Office of Emergency Preparedness"; and (b) substituting the "Director of the Office of Emergency Management Agency" for "Director of the Office of Emergency Preparedness".

(1) Executive Order No. 11639, as amended, establishing the Upper Mississippi River Basin Commission.

2-214. Executive Order No. 11490, as amended, is further amended as follows:

(a) Delete the last sentence of Section 102(a) and substitute therefor the following: "The activities undertaken by the departments and agencies pursuant to this Order, except as provided in Section 3023, shall be in accordance with guidance provided by, and subject to, evaluation by the Director of the Federal Emergency Management Agency."

(b) Delete the first sentence of Section 3022, and Sections 3023(1) and 3024 and substitute therefor "Director of the Federal Emergency Management Agency."

Section 6. This Order is effective July 15, 1979.

WHAT IS FEMA ?

FEMA is the acronym for the Federal Emergency Management Agency. It was established by Executive Order 12148 and signed into existence by Jimmy Carter in 1979.

It was originally planned as an umbrella administration consisting of the disaster and emergency response arms of nearly a dozen scattered federal agencies. (11)

FEMA is the successor to the various cover agencies for bogus "national emergency" activity perpetrated since 1933, e.g., the Office of Emergency Preparedness, the Office of Defense Mobilization, the Office of Emergency Planning the Economic Stabilization Agency and the Civil Defense Administration... FEMA's major functions were, unconstitutionally and in violation of the Compact, delegated under sham and pretense of a series of so-called Executive Orders, but without actual authority. ... (12)

...While some national security planners applauded the 1979 creation of FEMA under Presidential Review Memorandum 32 as an effort to integrate all nine federal agencies with responsibilities for civil defense emergency planning and implementation, the authors of the plan had other things in mind.

The FEMA plan was written by Carter White House NSC advisor Zbigniew Brzezinski and NSC staffer Samuel Huntington. Four years earlier Brzezinski and Huntington had been together at the "Trilateral Commission's annual 1975 conference in Kyoto, Japan", where Huntington delivered a blood-curdlin paper advocating the end of democracy and the imposition of crisis-management forms of government. A Trilateral Commission-linked magazine, Challenge, had earlier described the concept as "fascism with a democratic face". NSC advisor Brzezinski called it the

“technetronic age”.

It was Brzezinski and Huntington’s vision of a technocratic fascist structure that came into being with the cration of FEMA—not a legitimate and long overdue serious attempt at civil defense...(To quote) Huntington’s 1975 book,Crisis of Democracy...

“We have to come to recognize that there are potentially desirable limits to economic growth. There are also potentially desirable limits to the indefinite extension of political democracy.”

Within months after he had written this analysis, Huntington entered the Old Executive Office building as an NSC staffer under the Trilateral Commission executive director Brzezinski. FEMA was cast in the “crisis of democracy” vision of the commission’s zero-growth agenda. The transition from Carter to Reagan tended to accelerate, rather than slow, the buildup of the FEMA parallel government within the government program of Trilateralist Brzezinski and Huntington. By 1984, FEMA’s “continuity of government” structure was well oiled. Over 1,000 executive orders allocating extensive powers to FEMA in the event of a string of national emergencies sat in a safe in the Oval Office, waiting only for the signature of the President.

And in April 1984, FEMA, in conjunction with the Department of Defense, held extensive secret maneuvers throughout the United States. If there was any doubt that Huntington’s “crisis of democracy” vision was foremost in the minds of its planners, a declassified section of the exercise plan, dubbed REX-84 BRAVO spelled out the scenario on which the operation was based:

“...The sudden withdrawal of cheap incremental loans to heavily indebted countries generated a number of consequences to both borrowers and lenders alike. The first was to throw the entire world into the worst recession since the

great depression of the 1930...

“The response of commercial banks...was predictable...both the multinational banks and the IMF...emphasized three actions: a) lower imports; b) raise exports; and c) reduce the government sector debt by cutting subsidies and, in effect, cutting real wages.

“The outcome of this advice, on a worldwide basis, was primarily social unrest. It occurred in the Warsaw Pact nations as well as free world countries. The major impact of a high and rising dollar with the interest rate of most loans tied to the London Interbank Offer Rate (LIBOR) was to shift almost all import earnings from being used to pay for imports, to being used to service debt...Bankruptcies and defaults on a massive scale developed, and doomsayers began to publish apocalyptic scenarios”...

This so-called “scenario” was the basis of secret government contingency planning for installing crisis-management at the very moment that President Reagan was delivering false assurances to the American people and the nation’s allies that great economic recovery—The “Reagan Revolution”—was under way—Railroad! by the Commission to Investigate Human Rights Violations, Appendix B. (13)

AMERICANS “COMPUTERIZED” BY F E M A:

Fort Meade, Maryland is the government’s most tightly guarded installation (it houses, among others, the secret National Security Agency). In an unmarked, windowless office building on the grounds of Fort Meade, hundreds of thousands of American citizens are being “computerized” by technicians on the payroll of the Federal Emergency Management Agency (FEMA).

“Administratively, this place is the equivalent of an unlisted telephone”, explained a former senior official of FEMA

who agreed to an interview on condition that his identity be protected. "It has no official existence. There is no listing for it, no traceable designation. But it's there, idling quietly, like a doomsday bomb waiting for its moment in history."

The task of FEMA's secret data control annex at Fort Meade is to develop so-called CAP's--the term stands for "crisis action programs"--to be implemented in national emergencies. The term was originally used to denote disaster relief plans at the Federal Preparedness Agency, once a department of the General Services Administration, now merged into FEMA.

But the computerized action plans instrumented at Fort Meade have nothing to do with aiding victims of hurricanes or other natural disasters. They are blueprints for taking over the U.S. government and converting it into a command system under the "emergency management" of federal bureaucrats.

Privately, congressional investigators, intelligence analysts and veteran Washington newsmen familiar with the inner machinery of the vast federal bureaucracy have long expressed concern and anxiety about FEMA. An "umbrella administration" born in 1978 when President Jimmy Carter combined the disaster and emergency response functions of nearly a dozen scattered federal outposts into a single agency, FEMA has always been known as an "activist" and secretive fraternity.

Under Louis Giuffrida, appointed FEMA director by President Ronald Reagan in 1981, the agency developed a top-secret project for arresting tens of thousands of "suspects aliens" along with troublesome critics and dissenters whom the White House found annoying enough to be labeled "potentially subversive."

Tagged Operation Rex 84, these un-Constitutional plans were first discovered and revealed by this populist newspaper (The Spotlight) in a series of exclusive investigative reports

in the April 23 and May 14, 1984 issues.

But although "The Spotlight's" expose wrecked FEMA's plans for setting up mass "emergency detention centers"--and cost Giuffrida his post as director--secret preparations for "(ensuring) the continuity of the federal government" in ill-defined "emergencies" remained the major concern of FEMA's senior officials.

"Those words, enunciated by President Gerald Ford in Executive Order 11921, were understood by FEMA to mean that one day they would be in charge of the country," explained Dr. Henry Kliemann, a political scientist at Boston University. "As these bureaucrats saw it, FEMA's real mission was to wait, prepare and then take over when some 'situation' seemed serious enough to turn the United States into a police state."

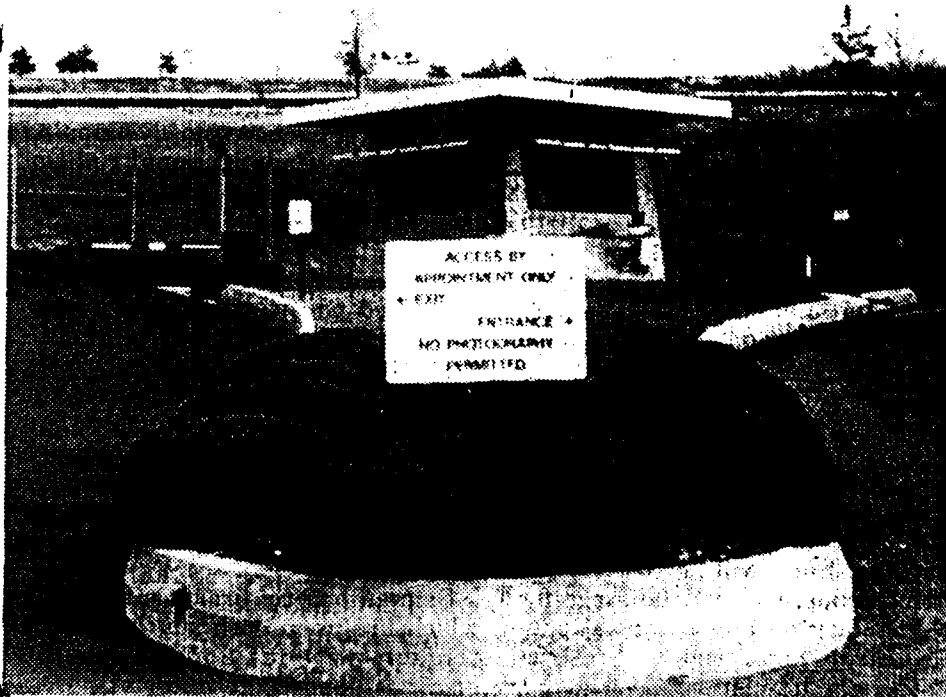
To illustrate FEMA's conspiratorial core, knowledgeable Washington intelligence sources cited the instance of the 1989 visit by President George Bush to Cartagena, Colombia, to attend a so-called regional drug summit with three Latin American presidents.

"There were rumors of a terrorist threat against Bush by Colombian drug hit squads", recounted Monroe H. Brown, a former federal security officer with long years of service in Miami. "Teams of Secret Services, FBI and CIA agents were mobilized to find out how serious the threat was, while back in Washington FEMA went to work on an emergency program in case the presidential plane was hit by a Stinger missile somewhere over Colombia."

FEMA's emergency measures included preparations to round up more than 10,000 Americans "redlined" in the agency's computers as "activists, supporters or sympathizers of terrorism in the United States," explained Brown.

In August 1990, after Iraq invaded Kuwait, FEMA got

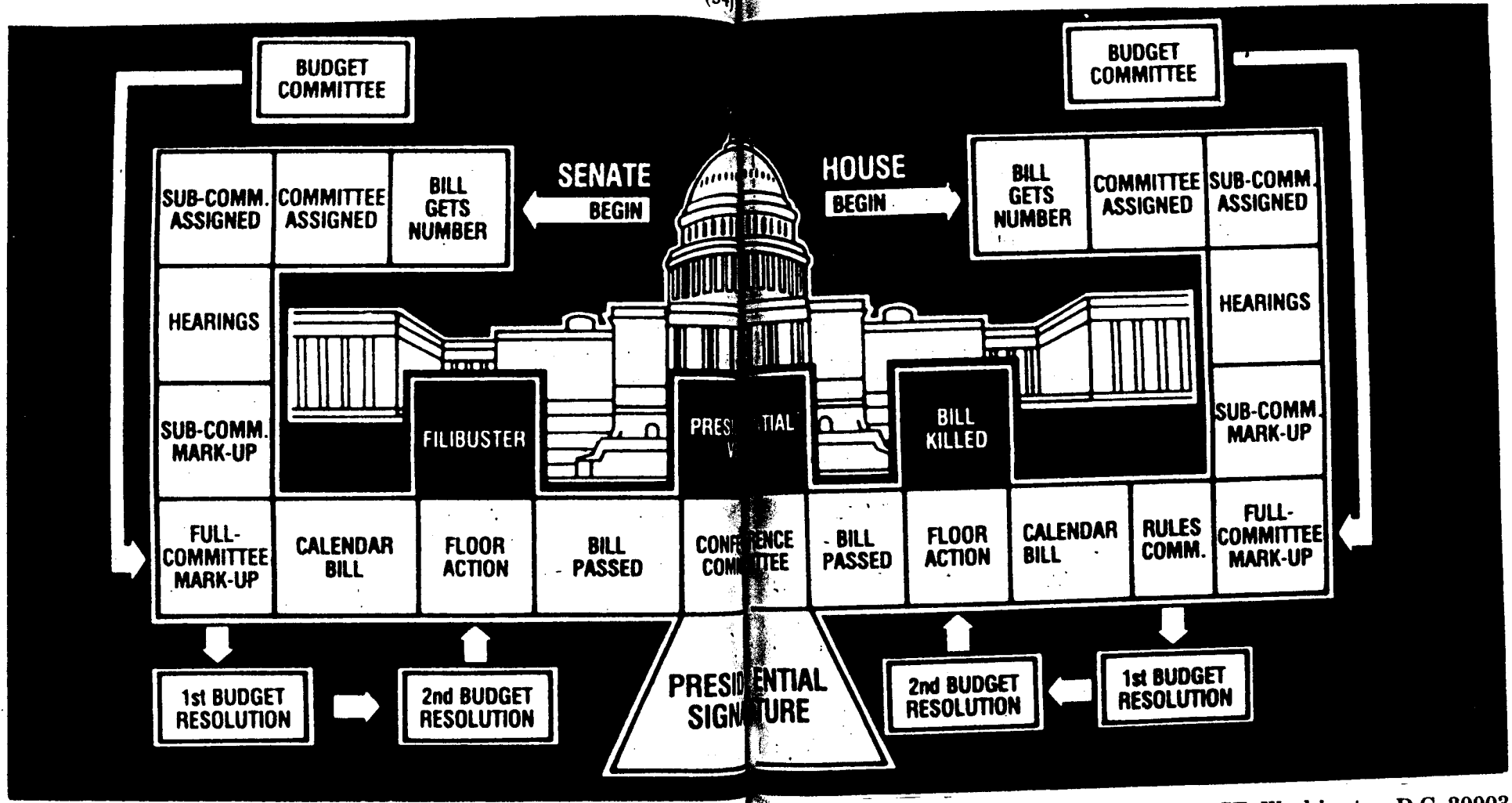

e.g., shanghaied or blackmailed into service! ...

6. Seize and/or control every major national asset.

7. Provide for National Security and consolidate the assignment of emergency preparedness functions with various departments and agencies.

8. 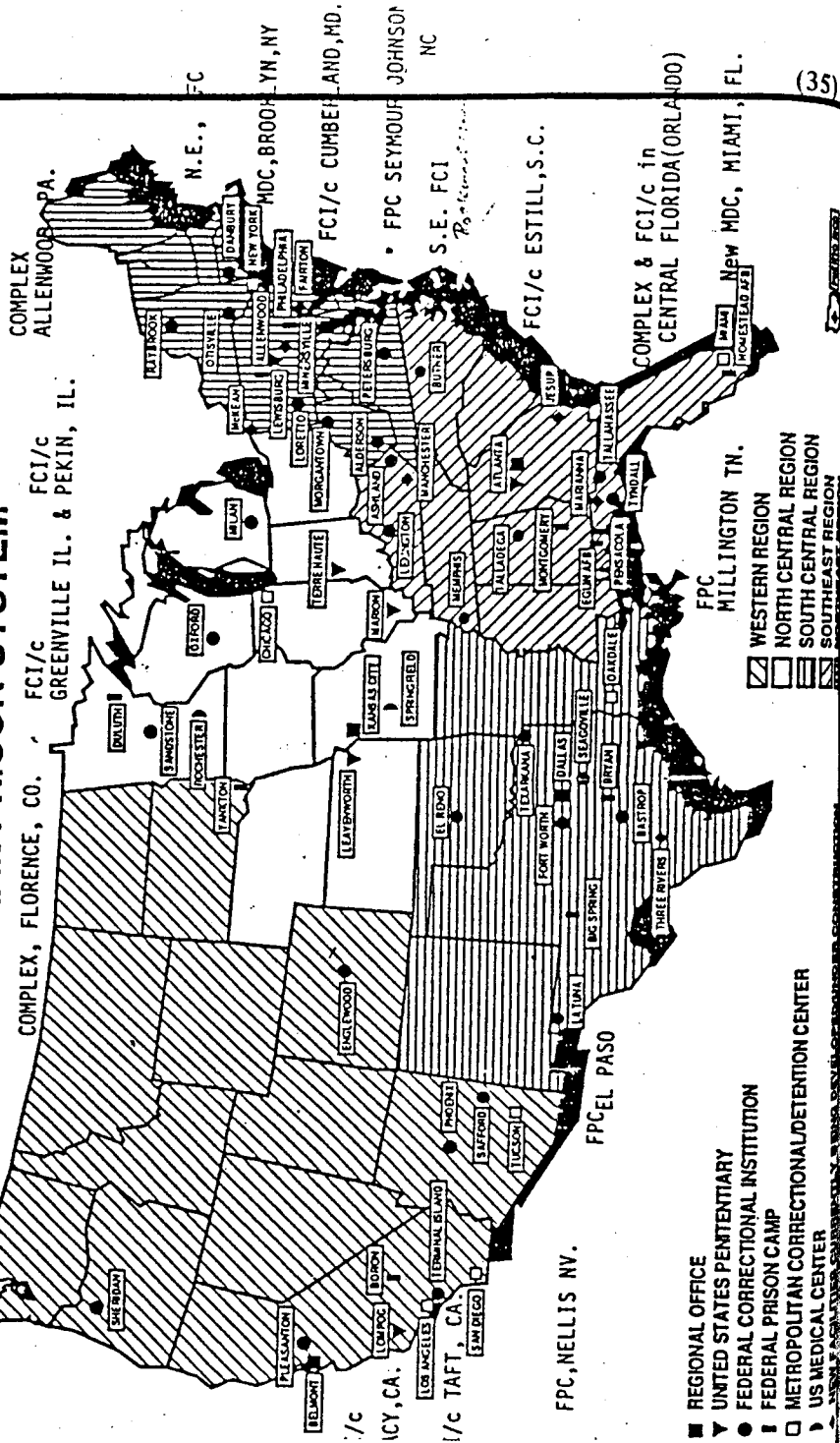

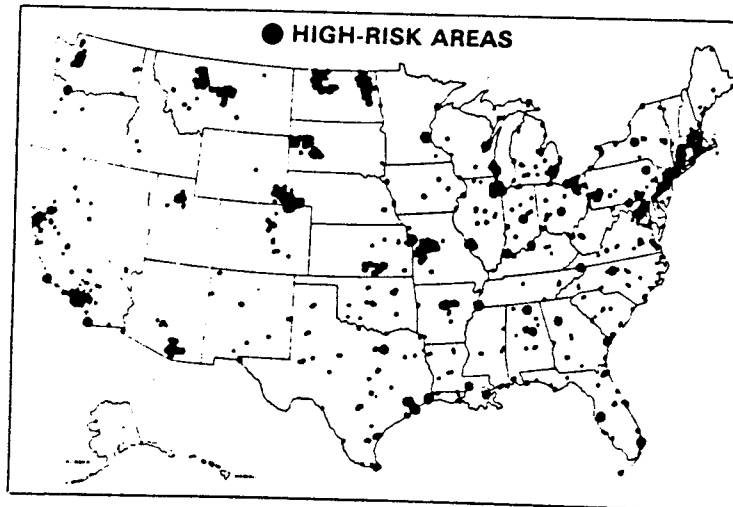
President Nixon on 3-27-69 through the Government Reorganization Act divided the United States into ten Regions. To further implement this Regional Governance over the U.S.A., President Nixon signed Executive Order 11649 and entered it in the Federal Register Feb. 12, 1972. (Vol. 37, No. 30)

Through the authority vested in him as President of the U.S., he established a Federal Regional Council for each of the ten standard regions. special—and extra-Constitutional—powers to impose their will on the nation.”

...FEMA's bureaucrats can then proceed to:

*Take over all farms, ranches or timberland in order to utilize them more effectively as decreed in Executive Order (EO) 11490, the so-called omnibus emergency preparedness decree promulgated by President Richard Nixon on October 28, 1969.

*Seize all sources of public power: electric, nuclear, petroleum, etc.

*Freeze all wages, prices and bank accounts.

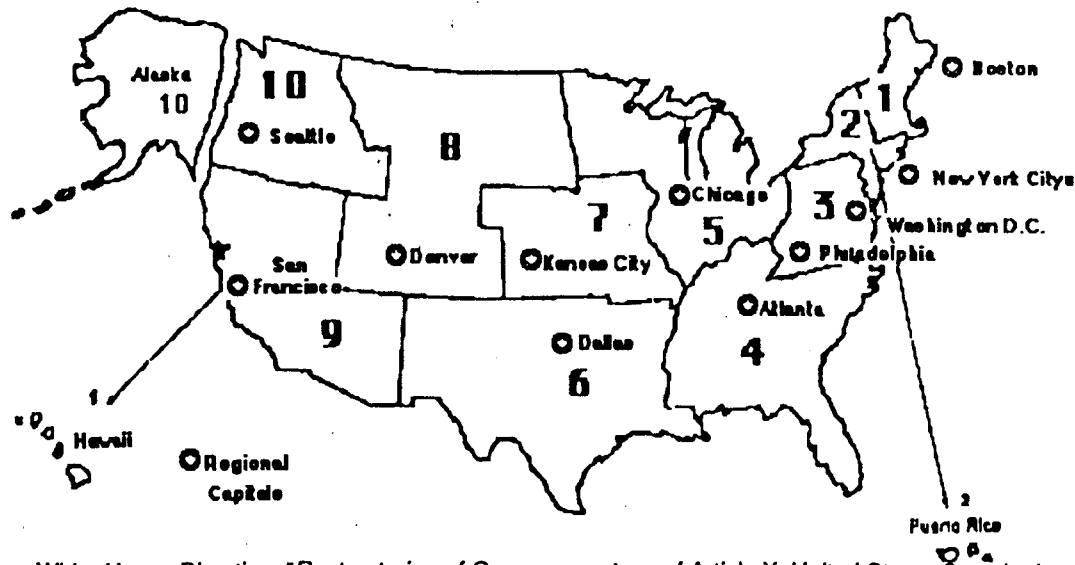
The American Convention consolidated the 13 original states, sovereign under the Articles of Confederation, into a giant free trade zone. REGIONAL GOVERNMENT STRUCTURE



White House Directive, "Restructuring of Government Service Systems", dated 27 March 1969, merged the fifty sovereign states into ten federal regions in violation of the prohibitions of Article IV, **United States Constitution**.

The Christian Roots of Freedom

by Eric D. Butler

C.H. Douglas commented that so far from being merely a piece of sloppy sentimentalism, the Law of Love enunciated by Christ was a political truth of far-reaching implications. Christ shattered the collectivist and legalistic philosophy of the Pharisees. Every individual was unique and of value in the eyes of God the Father. Systems and institutions like the Sabbath existed to serve the individual, not to control him. The individual was born to be free, and Truth was the way to that freedom. Knowing the Truth was the first requisite for achieving freedom. ...

The Christian concept of freedom is not a type of free-for-all, which leads to anarchy and the inevitable use of arbitrary external compulsion in an attempt to hold societies together. And yet life itself requires acceptance, even if unconsciously, of some forms of compulsion. We must breathe air in order to stay alive.

What then is the Christian concept of freedom? ...

The rules of God's universe transcend human thinking, said Douglas, and cannot be changed. They are absolutes. But by searching for Truth, the individual can come to have a greater understanding of those Truths. And if he works in harmony with those Truths, he can expand his freedom, as witnessed by the fact that the discoveries of true science have made it possible to progressively free men from limitations imposed by their environment.

The discovery of God's Truths has made it physically possible for the individual in all developed countries to live in comfort and security. To the extent that this objective is not being reached is a measure of the enslavement of human minds to the dictates of that Black Magic known as Sound Finance. The answer to Black Magic is to stop believing in it. This requires freeing the mind from the worship of a form of unreality. "We are attempting to release reality", said Douglas. The Kingdom of God is within every individual, said Christ, and can be sought by the individual.

What happens in the metaphysical world dictates what happens in the material world. Over countless ages the battles of the physical world have been decided by the battles for the mind. The value system accepted by individuals dictates their behaviour. When Western man started to accept and apply the Christian values it resulted in a completely new type of civilization. The Christian concept of the value of

the individual gave him a status completely unknown previously. Coupled with the Law of Love, this concept resulted in a type of creative drama in which the individual could play a meaningful role. Christianity was a religion of hope. Relations between individuals were progressively ennobled by a type of creative love which even modified military conflict between men. The winners of military conflicts came to accept the view that Christian love should be extended to the vanquished. The term "gentleman" is derived from the Christian value system. The status of women was elevated. Justice should be tempered with mercy towards all, as witnessed by the development of English Common Law, with every individual being of such value in the eyes of God that he must always be assumed to be innocent until found guilty in a court of law.

Love and service are closely related. "Love your neighbour as yourself" means exactly what the words imply. Shakespeare put it slightly differently. "To thine own self be true, and thou canst not then be false to any man." ...The plight of the world today is a reflection of the erosion of the Christian concept of love. There was a time not so long ago when people did not need to lock their houses, when their wives and children could walk the streets in complete safety, when a man's word was his bond and business dealings could be transacted with a handshake. There was more real freedom than there is today because there was more real love.

One cannot know complete freedom unless one ensures that others also have freedom.

One must have complete faith that in a free society based on the Law of Love, every individual must be trusted to exercise that freedom to the full — with the provision that this does not in any way interfere with the freedom of others. "Perfect love casteth out fear." Fear is a lack of faith, which can lead to despair. Despair is a type of sin against the Holy Ghost, and is the very opposite of faith. The faith of individuals is undermined as they are organized into bigger and more highly centralized mobs in which the individual is driven down the scale of existence. Douglas said that the true purpose of man is self-development, the releasing of man's most spiritual attribute, creative initiative. The Law of Love generates inducement and voluntary association and rejects compulsion. ...

But the Second World War saw a major retreat from Christian influence, with the victim being used by the advocates of vengeance to stage "war crime trials". The law of love was replaced with hatred, a most destructive force.

The future of Christian Civilization requires a return to the application of the Law of Love in the widest possible sense. Only in this way can real freedom for the future be assured. — *The New Times*, Melbourne, Australia

HISTORY OF EXECUTIVE ORDERS:

Under the Constitution of the United States, the president is vested with the executive power of the government (Article II, Section I, clause I), the power to “preserve, protect and defend the Constitution” (Article II, Section I, clause 7) and the power to see that the laws are faithfully executed (Article II, Section 3).

From these powers is implied the authority to issue “executive orders” (EOs).

AN “EXECUTIVE ORDER” HAS NEVER BEEN DEFINED BY CONGRESS.

In use from the earliest days of the republic, the executive order was at first employed mainly for the disposition of the public domain, the withdrawal of lands from federal reservations and for other similar purposes.

During World War I the use of the executive order was widened, as executive authority and power increased.

In the early years executive orders were not numbered, and since there was no uniform system for recording them the total of the unnumbered orders is unknown.

The validity of executive orders has been questioned many times, but a ruling as to the extent or limit to which they may be used has never been determined by the courts or by Congress (Library of Congress, Legislative Research service No.398/117-9).

The “Federal Register” contains the text of directives issued under the authority of the president. No congressional authorization is required. There is no review by the judiciary.

All EOs are laws made by one man: the president of the

United States.

Through existing EOs, it is possible for one man to ignore the Constitution, Congress and the will of the people. A complete DICTATORSHIP can be imposed, "under color of law," on the American people.

On March 9, 1933 President Franklin Roosevelt declared a state of "National Emergency" to deal with the banking crisis. Later, he declared two other national emergencies as he led the United States into World War II.

Another state of emergency was declared by President Harry Truman in 1950 after Red China's intervention in the Korean War. Truman formally ended both the World War II emergencies in April of 1952, but expressly reaffirmed the 1950 declaration.

Presidents Dwight Eisenhower, John Kennedy, Lyndon Johnson and Richard Nixon also reaffirmed it as each took office. Nixon declared other national emergencies on March 23, 1970 and August 15, 1971.

A declaration by the president indicating a national emergency exists has always stopped short of Martial Law, although the president has that prerogative. Undoubtedly it would be exercised in the event of a major or nuclear attack on the United States.

The last use of Martial Law was in Hawai a few hours after the attack on Pearl Harbour in 1941.

It is interesting to note that the tendency of martial law to perpetuate itself was demonstrated in that case. The military retained basic control of Hawai until the Supreme Court in 1944 ruled that the continued use of martial law, long after the disaster conditions had ended, was un-Constitutional. (19)

THE FRIGHTENING SIGHT OF DICTATORIAL

POWERS:

It is a frightening thought, but there are Executive Orders (EOs) on the books that made it possible for a president to ignore the Constitution and its cherished Bill of Rights, Congress, the judiciary and the very will of the American people.

It is a fact that a complete dictatorship can be imposed upon the people at any time, simply by the president declaring a national emergency.

During the 1950s and 1960s, it was believed that the best way to bring about one-world government was by disarming the United States. Those who feared for America's Constitutionally guaranteed liberties, and rightfully so, warned that America would be disarmed and would become easy prey for the ever-expanding military power of the Soviet Union and Red China.

They particularly opposed the powers of the Arms Control and Disarmament Agency, established to disarm America.

Now, however, with Eastern Europe shaking itself free from the shackles of communism and those peoples exercising their nationalistic yearnings, disarmament by both sides has become a necessity to cure social ills plaguing the U.S. and former Soviet bloc countries. With the apparent failure of the Red military machine, the general movement has been toward easing of the arms race.

From the newfound "friendship" with Eastern Europe and in particular from the so-called multinational effort against Iraq in the Persian Gulf, President George Bush rarely gives a speech or holds a press conference in which he fails to mention his thoughts about a "New World Order."

Now, however, a new method is needed to nullify America's treasured Constitution, and the insidious EOs have gained a new and even more dangerous part to play in the plotting

of the one worlders of the Trilateralist-Bilderberger ilk.

The biggest danger of such schemes as those proposed by Rep. Newt Gingrich (R-Ga.) and Sen. Phil Gramm (R-Texas) is that any declared "national emergencies" would allow the president to activate repressive EOs signed by presidents going back to World War II.

Here are some of the EOs involved:

*EO 10995, which provides for the takeover of the communications media. In other words, forget about freedom of the press.

*EO10997, which provides for the takeover of all electric power, petroleum, gas and other fuels and minerals.

*EO 10998, which provides for the takeover of all food resources and the nation's farms.

*EO 10999, which provides for the takeover of all modes of transportation, control of highways, seaports, etc.

*EO 11000, which provides for mobilization of all civilians into work brigades under government supervision. In other words, slave labor.

*EO 11001, which provides for government takeover of all health, education and welfare functions.

*EO 11002, designates the postmaster general to operate a national registration of all persons.

*EO 11003, which provides for the government to take over airports and aircraft.

*EO 11004, which provides for the Housing and Finance Authority to relocate communities, designate areas to be abandoned and establish new locations for populations.

*EO 11005, which provides for the government to take over railroads, inland waterways and public storage facilities.

All of the above orders were combined by President Richard Nixon into the notorious EO 11490...which allows all of these insidious things to take place if a national emergency is declared.

Here are some direct quotes from the 40-page Nixon EO: "Develop plans and procedures for the Department of Defense utilization of non-industrial facilities in the event of an emergency in order to reduce requirements for new construction and to provide facilities in a minimum period of time..." In other words, The Confiscation of Private Property.

"Develop plans and procedures for the provision of logistical support to members of foreign forces, their employees and dependents as may be present in the United States under terms of bilateral or multilateral agreements which authorize such support in the event of a national

In other words, prepare for the billeting of foreign troops in your home contrary to the Third Amendment.

"Develop emergency plans for the control of alien enemies and other aliens within the United States...The location, restraint or custody of aliens..."

"The Secretary of Labor shall have primary responsibility for preparing national emergency plans and developing preparedness programs covering civilian manpower resources."

Preparation can be undertaken for forced labor.

"Provision for regulation of money and credit in accordance with the needs of the economy, including the acquisition, decentralization and distribution of emergency supplies of currency; the collection of cash items and non-

cash items; and the conduct of fiscal agency and foreign operations.

“Provision for the continued or resumed operation of banking, savings and loan, and farm credit institutions, including measures for the recreation of evidence of assets or liabilities destroyed or inaccessible.

“Regulation of the withdrawal of currency and the transfer of credits including deposit and share account balances.”

Then along come President Jimmy Carter and EO 12148, titled the Federal Emergency Management Act. All prior EOs having anything to do with emergency planning were incorporated into it. This EO gives the president absolute power during any “emergency” so declared by him.

From Carter’s machinations emerged a totally new bureaucracy, the Federal Emergency Management Agency (FEMA) which assumed control of a chain of older “emergency agencies”, including the Federal Disaster Assistance Administration, the National Weather Service, the Federal Emergency Broadcast System and about a dozen others.

In an “emergency”, FEMA was, through EO 12148, to virtually take over the key functions of the national government by means of “senior representatives” and “liaison agents” now positioned in every major government agency.

Incredibly, FEMA even has the power to assume the duties of the president himself.

...Those who want to know the complete truth about its not-so-innocent nature only need to peruse Carter’s EO 12148, as it appeared on July 24, 1979, in the Federal Register, and as it was reprinted in the May 26, 1980 issue of The SPOTLIGHT.

Finally, President Ronald Reagan updated this EO in his

last full year in office on November 18, 1988, leaving his successor, Bush, the tools to create a dictatorship, his “New World Order”. (20)

Then came up to the top of the top, the EO 11051:

“The Director of the Office of Emergency Planning authorized to put Executive Orders into effect in ‘times of increased international tension or financial crisis’. He is also to perform such additional functions as the President may direct.” (21)

The Director...: It is not specified civilian or elected; may concern anybody, even a close political friend...

...times of increased international tension or financial crisis: may be related to absolutely anything outside to continental United States, like a major crisis in the Middle East or in Yugoslavia or even in Russia.... May also concern a “Crash” created by a sudden “Coups” in Russia...

Finally, has been created the most unknown HR 4079:

“Forty-eight of your taxpaid congressmen sponsored the Newspeak-named ‘National Drug and Crime Emergency Act’ which could cost you more than \$30 TRILLION and imprison 30 MILLION Americans. ...here’s what that Constitution-scuttling measure could do:

*Declare a five year “Emergency” imposing martial rule.

*Impose testing for drug and alcohol use.

*Authorize mass expulsion of drug and alcohol users from public and private high schools and college and fire any workers using drugs.

*Accelerate confiscation of cars, boats, planes, other property of casual drug users.

*Set much higher mandatory sentences for drug and alcohol use. Previous maximum sentences would become minimum sentences.

*Allow revocation of probation, parole and suspended sentences.

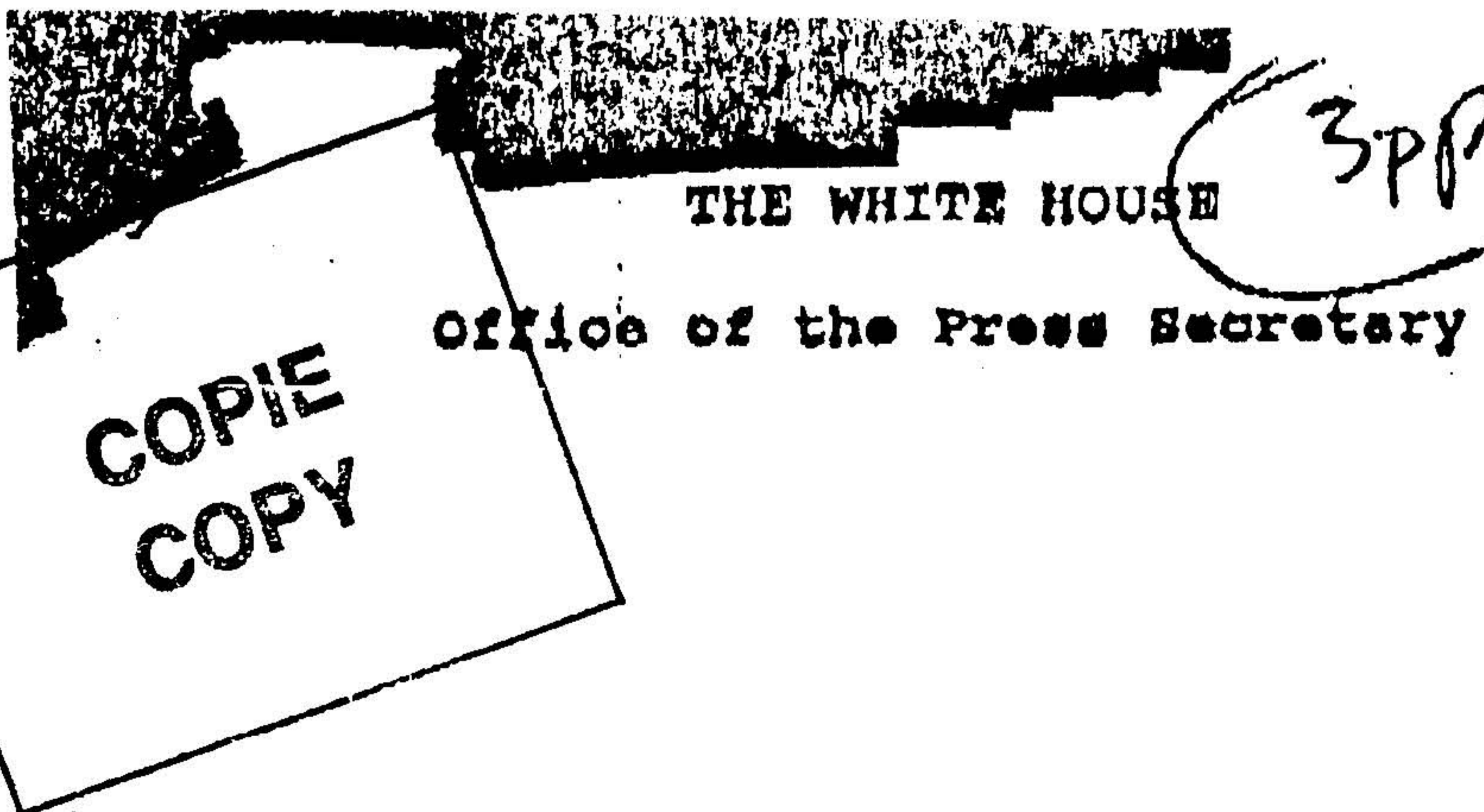
*Reopen World War II Japanese 'Relocation Centers' as concentration camps.

NATIONAL SECURITY INDUSTRIAL RESPONSIVENESS

By the authority vested in me as President by the Constitution and the laws of the United States of America, including 50 U.S.C. App. 468, 10 U.S.C. 4501 and 9501, and 50 U.S.C. 82, it is hereby ordered as follows:

Section 101. Policy. The United States must have the capability to rapidly mobilize its resources in the interest of national security. Therefore, to achieve prompt delivery of articles, products, and materials to meet national security requirements, the Government may place orders and require priority performance of these orders.

Sec. 102. Delegation of Authority under 50 U.S.C.
App. 468.

(a) Subject to paragraph (b) of this section, the authorities vested in the President, under 50 U.S.C. App. 468, with respect to the placing of orders for prompt delivery of articles or materials, except for the taking authority under 50 U.S.C. App. 468(c), are hereby delegated to:

- (1) the Secretary of Agriculture with respect to all food resources;
- (2) the Secretary of Energy with respect to all forms of energy;
- (3) the Secretary of Transportation with respect to all forms of civil transportation; and
- (4) the Secretary of Commerce with respect to all other articles and materials, including construction materials.

(b) The authorities delegated by paragraph (a) of this section shall be exercised only after:

- (1) a determination by the Secretary of Defense that prompt delivery of the articles or materials for the exclusive use of the armed forces of the United States is in the interest of national security; or
- (2) a determination by the Secretary of Energy that the prompt delivery of the articles or materials for the Department of Energy's atomic energy programs is in the interest of national security.

(c) All determinations of the type described in paragraph (b) of this section and all delegations -- made prior to the effective date of this order under the Defense Production Act of 1950, as amended, and under its implementing rules and regulations -- shall be continued in effect, including but not limited to approved programs listed under the Defense Priorities and Allocations System (15 CFR Part 700).

Sec. 103. Delegation of Authority under 10 U.S.C. 4501 and 9501, and 50 U.S.C. 82.

(a) Subject to paragraph (b) of this section, the authorities vested in the President under 10 U.S.C. 4501 and 9501 with respect to the placing of orders for necessary products or materials, and under 50 U.S.C. 82 with respect to the placing of orders for ships or war materials, except for the taking authority vested in the President by these acts, are hereby delegated to:

- (1) the Secretary of Agriculture with respect to all food resources;
- (2) the Secretary of Energy with respect to all forms of energy;
- (3) the Secretary of Transportation with respect to all forms of civil transportation; and
- (4) the Secretary of Commerce with respect to all other products and materials, including construction materials.

(b) The authorities delegated in paragraph (a) of this section may be exercised only after the President has made the statutorily required determination.

Sec. 104. Implementation. (a) The authorities delegated under sections 102 and 103 of this order shall include the power to redelegate such authorities, and the power of successive redelegation of such authorities, to departments and agencies, officers, and employees of the Government. The authorities delegated in this order may be implemented by regulations promulgated and administered by the Secretaries of Agriculture, Defense, Energy, Transportation, and Commerce, and the Director of the Federal Emergency Management Agency, as appropriate.

(b) All departments and agencies delegated authority under this order are hereby directed to amend their rules and regulations as necessary to reflect the new authorities delegated herein that are to be relied upon to carry out their functions. To the extent authorized by law, including 50 U.S.C. App. 486, 10 U.S.C. 4501 and 9501, and 50 U.S.C. 82, all rules and regulations issued under the Defense Production Act of 1950, as amended, with respect to the placing of priority orders for articles, products, ships, and materials, including war materials, shall be deemed, where appropriate, to implement

the authorities delegated by sections 102 and 103 of this order, and shall remain in effect until amended or revoked by the respective Secretary. All orders, regulations, and other forms of administrative actions purported to have been issued, taken, or continued in effect pursuant to the Defense Production Act of 1950, as amended, shall, until amended or revoked by the respective Secretaries or the Director of the Federal Emergency Management Agency, as appropriate, remain in full force and effect, to the extent supported by any law or any authority delegated to the respective Secretary or the Director pursuant to this order.

(c) Upon the request of the Secretary of Defense with respect to particular articles, products, or materials that are determined to be needed to meet national security requirements, any other official receiving a delegation of authority under this Executive order to place orders or to enforce precedence of

such orders, shall exercise such authority within 10 calendar days of the receipt of the request; provided, that if the head of any department or agency having delegated responsibilities hereunder disagrees with a request of the Secretary of Defense, such department or agency head shall, within 10 calendar days from the receipt of the request, refer the issue to the Assistant to the President for National Security Affairs, who shall ensure expeditious resolution of the issue.

(d) Proposed department and agency regulations and procedures to implement the delegated authority under this order, and any new determinations made under sections 102(b)(1) or (2), shall be coordinated by the Director of the Federal Emergency Management Agency with all appropriate departments and agencies.

Sec. 105. Judicial Review. This order is intended only to improve the internal management of the executive branch and is not intended to create any right or benefit, substantive or procedural, enforceable at law by a party against the United States, its agencies, its officers, or any person.

“The establishment and effective operation of an international Disarmament Organization within the framework of the United Nations, to assure compliance at all times, with all disarmament obligations.”

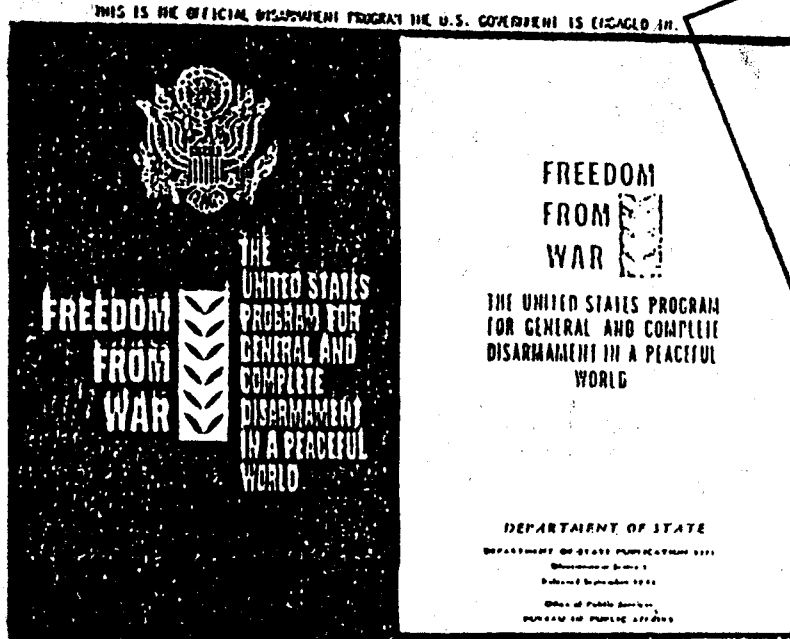

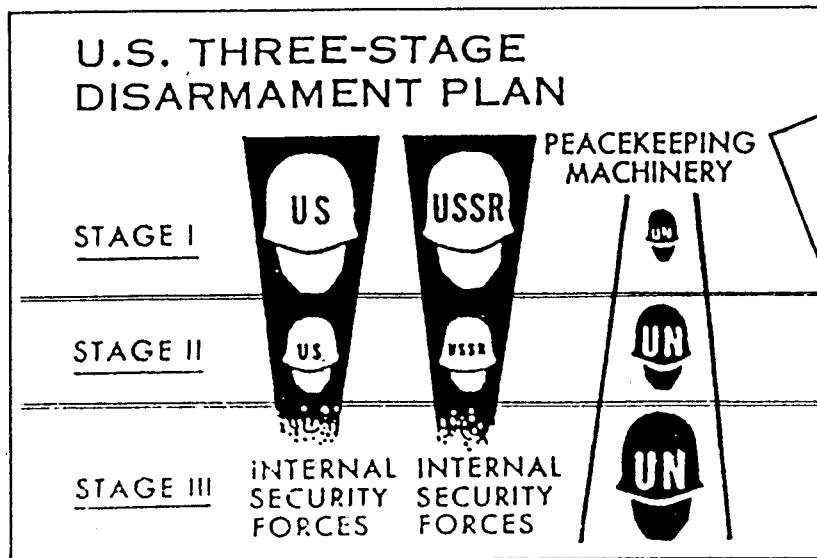

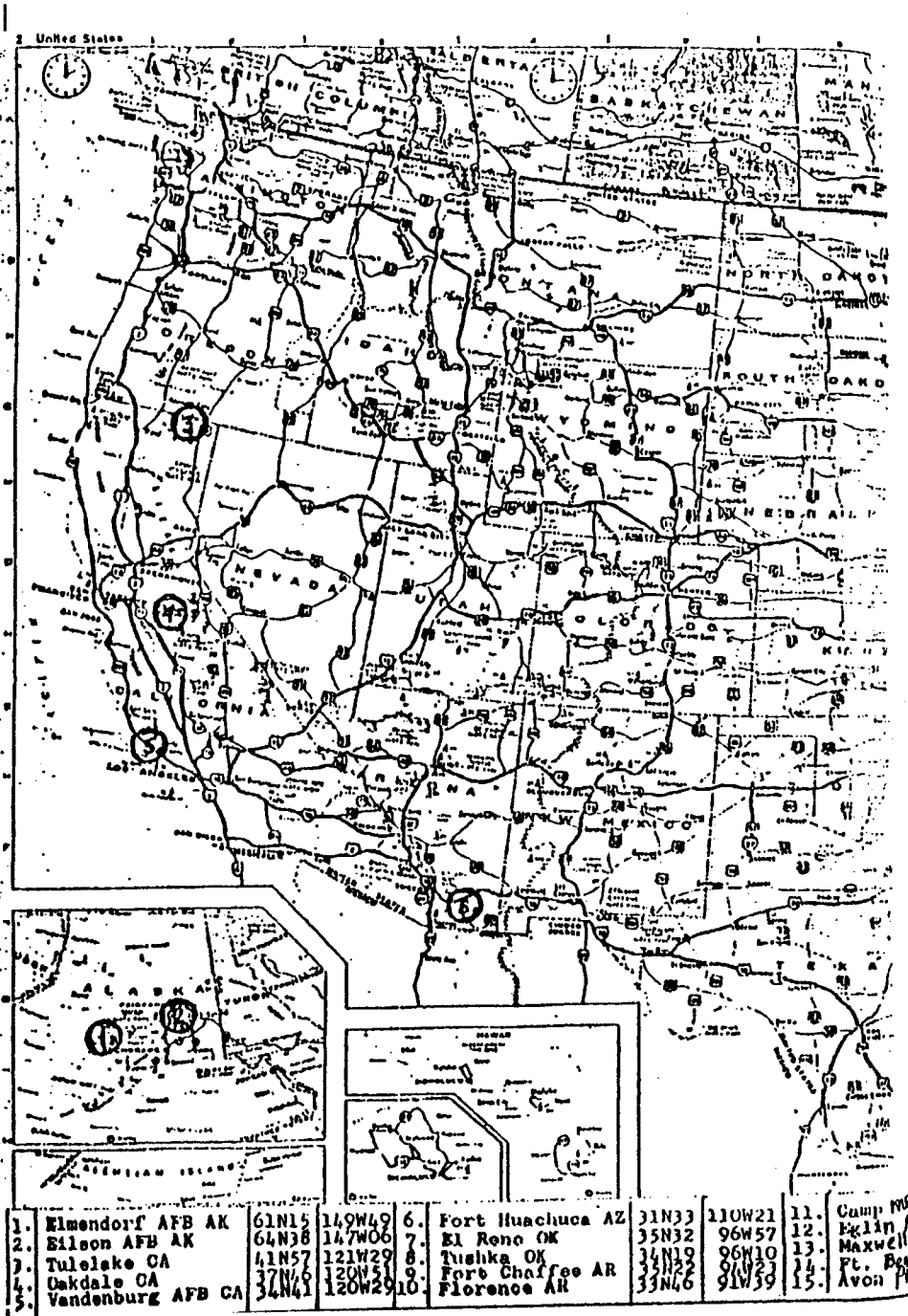
...A world in which adjustment to change takes place in accordance with the principles of the United Nations.

In order to make possible the achievement of that goal, the program sets forth the following specific objectives toward which nations should direct their efforts:

- The disbanding of all national armed forces and the prohibition of their reestablishment in any form whatsoever

other than those required to preserve internal order and for contributions to a United Nations Peace Force;

- The elimination from national arsenals of all armaments, including all weapons of mass destruction and the means for their delivery, other than those required for a United Nations Peace Force and for maintaining internal order;
- The manufacturer of armaments would be prohibited except for those of agreed types and quantities to be used by the U.N. Peace Force and those required to maintain internal order. All other armaments would be destroyed or converted to peaceful purposes.



REX '84: CONCENTRATION CAMPS-UNITED NATIONS RE-EDUCATION FACILITIES:

Mass detention facilities—otherwise known as concentration camps—have been set up at a number of major U.S. military installations on the secret orders of Ex-President Reagan. The Executive orders which established these camps have been canceled because the camps are now in place. The White House issued a highly classified NATIONAL SECURITY DECISION DIRECTIVE (NSDD) which set forth urgent instructions which 'activated' ten huge prison camps at key defense command locations across America.

McCoy, Wisconsin; Ft. Benning, Georgia; Ft. Huachuca, Arizona; and finally at the southern Justice Department detention and interrogation center known as Camp Krome near Miami, Florida.

A major national task force of federal intelligence and law enforcement agencies—including the FBI, the CIA, U.S. Marshals, INS, Customs, Coast Guard, National Guard, and so forth—will join with local and state police in massive roundups to haul in lists of suspects who will fill these improvised stockades.

“The first roundup—and the publicly announced one—will be of illegal aliens and refugees”, according to a military source. “But under the secret provisions of “REX-84” there will be also broad arrests of security suspects who can be held in these centers under this emergency order, whether they’re U.S. citizens or not.”

Americans whom the administration suspects of belonging to so-called “violence-prone” groups, or of “supporting” such groups—which may mean only that a citizen subscribes to an anti-government/pro-freedom newsletter—may find themselves hauled off with hordes of illegal immigrants.

Another category of anti-bureaucratic activists which may be bound for administrative detention under this directive is that “major, organized tax resisters”, one source close to the program said.

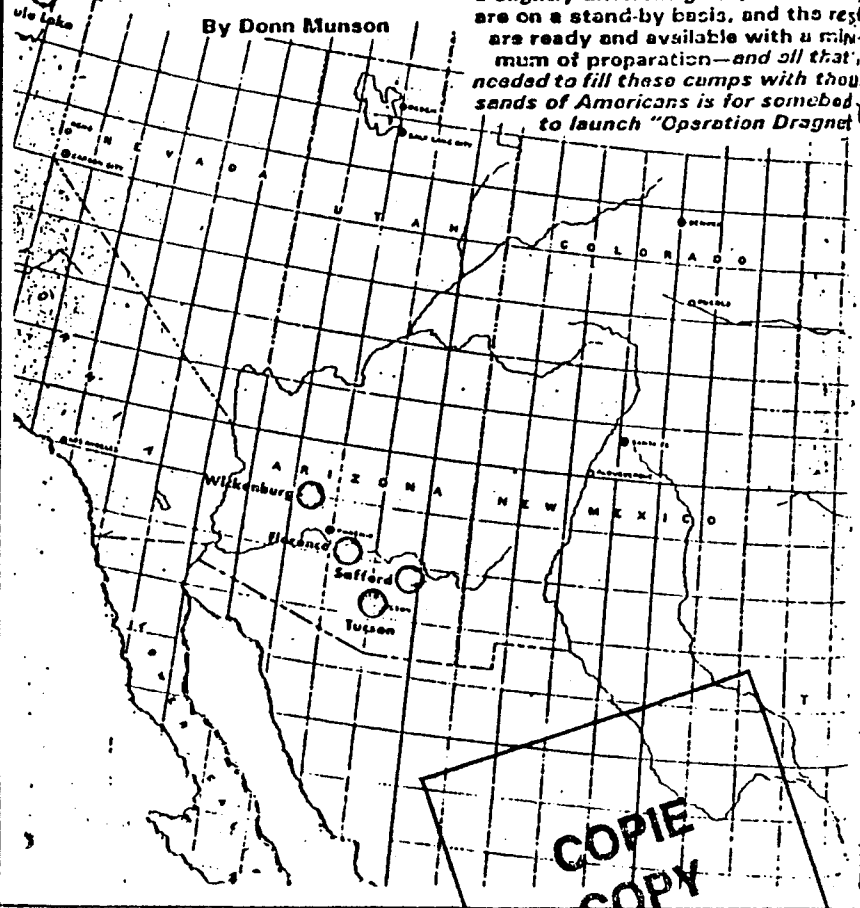

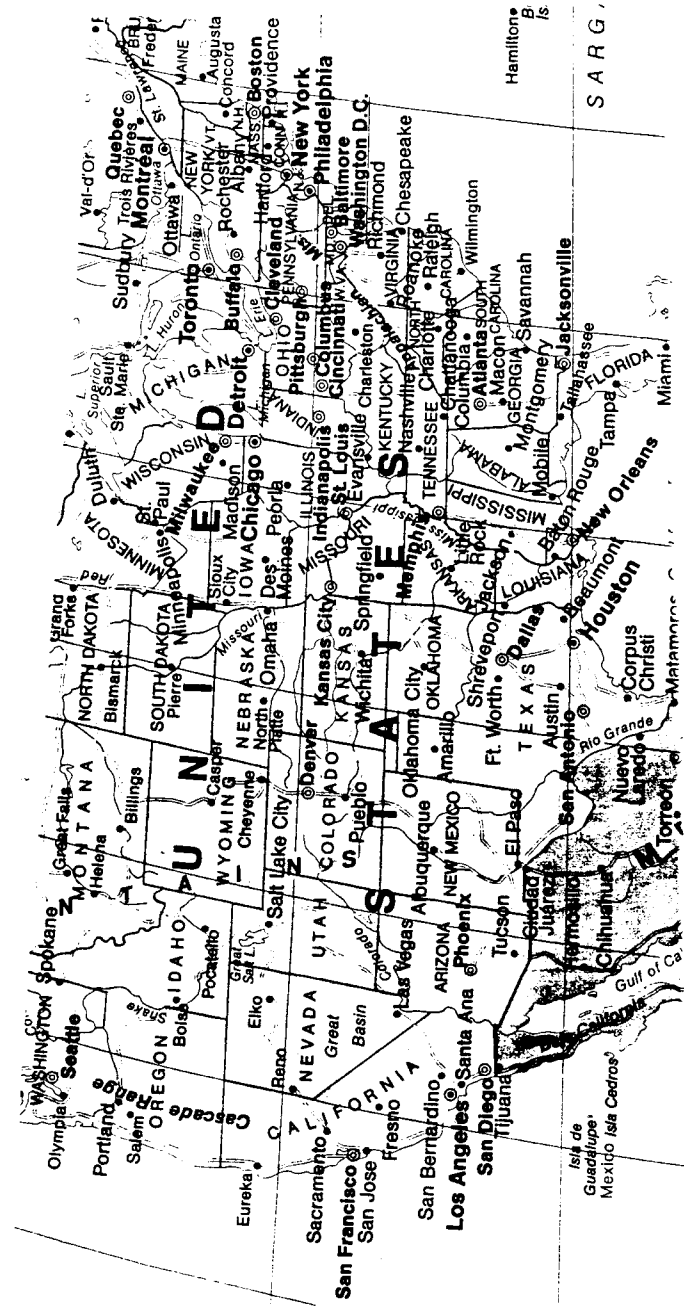

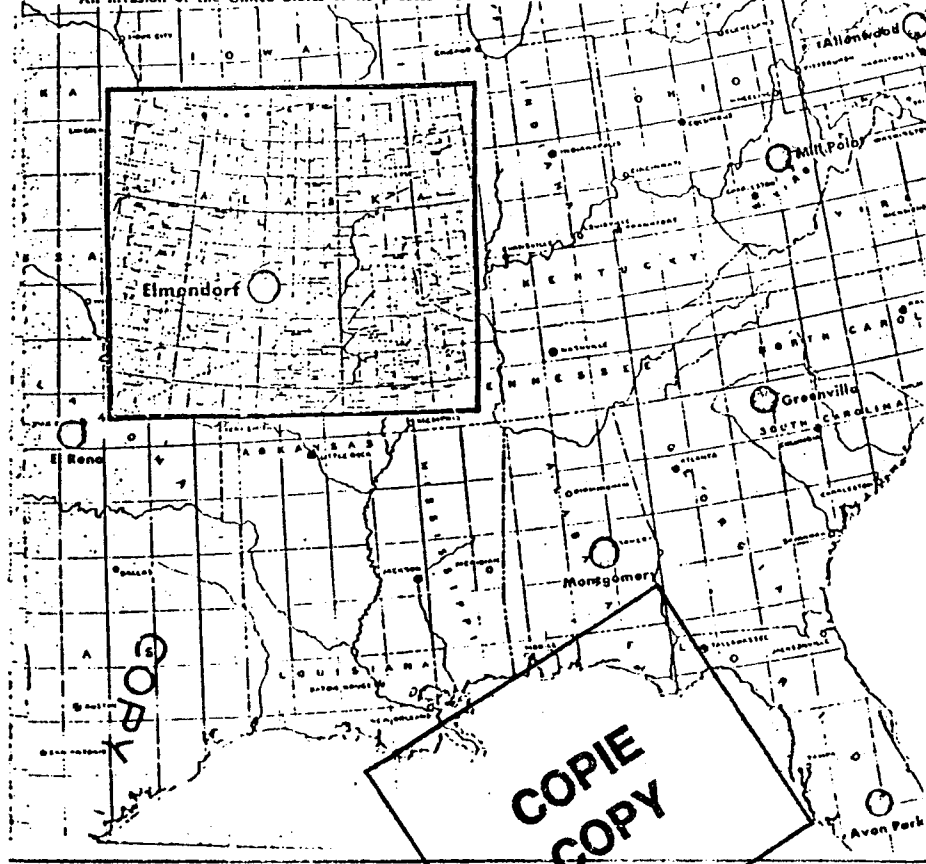
