The TRUTH-Moul VACCINES 2020.

Ty Bollinger:	Welcome to The Truth About Vaccines 2020, episode eight. We're your hosts, Ty and Charlene Bollinger. Since we initially released Truth About Vaccines in 2017, there's been some monumental events that have happened in the vaccine realm, so we've produced two bonus episodes to bring you up to speed on the current state of vaccine freedom. Our health freedom literally is hanging in the balance, and vaccines are at the forefront of this issue.
Charlene Bollinger:	Every July 4, since our nation declared independent in 1776, Americans have celebrated this truth: All men are created equal, that they are endowed by their creator with certain unalienable rights, that among them, life, liberty, and the pursuit of happiness.
Ty Bollinger:	The legal right to dissent has been a hallmark of freedom in America. Unlike in author- itarian dictatorships, in our country citizens have the right and responsibility to partici- pate in the lawmaking process.
Charlene Bollinger:	We have, or should have, the freedom to openly debate government policy, law, and ethics in the public forums and dissent from the majority without fear of intimidation or punishment.
Ty Bollinger:	But two and a half centuries after the Declaration was signed, that is changing. The right to autonomy and protection of bodily integrity is the first human right. If you cannot vol- untarily decide when and for what reason you are willing to risk your life or the life of your child, your unalienable right to life and liberty has been taken from you.
Charlene Bollinger:	No matter what your position on vaccines may be, you should take a hard look at recent actions by government officials and corporations to censor and repeal civil liberties that safeguard your human right to autonomy and protection of bodily integrity.
Ty Bollinger:	Dismantling free speech seems to be the standard operating procedure of big pharma, big tech, and the government itself. Yellow journalism is the policy of the day, where parents, doctors, scientists, researchers, journalists, and politicians are called anti-vaxxers and relentlessly targeted if they dare to even ask a question about the safety of vaccines, the quality of the studies, or the ethics of laws requiring use of a liability-free pharmaceutical product that can harm or kill.
Charlene Bollinger:	Despite Congress officially acknowledging the fact that vaccines can injure and kill in the 1986 Vaccine Act, and even though the United States Supreme Court ruled in 2011 that government licensed vaccines are unavoidably unsafe, today anyone who publicly questions vaccine safety or advocates for voluntarily vaccination is treated like a criminal and called names.
Ty Bollinger:	Benjamin Franklin, the coauthor of the Declaration of Independence, he warned us this: Freedom of speech is a principal pillar of a free government. When this support is taken away, the constitution of a free society is dissolved, and tyranny is erected on its ruins.
Charlene Bollinger:	Here's Del Bigtree discussing what's been going on the past few years.

The TRUTH About VACCINES 2020.

- *Del Bigtree:* Back in 2017, I gave the talk about the Vaccine Safety Project, something that we had created, Bobby Kennedy and I, in working for meeting at the National Institute of Health that had been set up by Donald Trump. It's two years later now. My nonprofit, Informed Consent Action Network, we have been suing government agencies. We've won lawsuits against the National Institute of Health, Health and Human Services, the FDA.
- *Del Bigtree:* This was not really an issue that was on the radar. Not many people were talking about vaccines. No one in the news was really talking about it. In the last two years, really, since l've presented, I would say that this vaccine discussion and anti-vaxxers and how the World Health Organization has come out since then and said that vaccine hesitancy is one of the 10 greatest threats to global health in the world. That's a massive statement, a terrifying statement. But what we've seen is this issue of forced vaccinations, I would say is now the second biggest discussion in major news around the world, whereas nobody was talking about it before. Before, they were just going to push forward with their agenda, and no one was going to say anything.
- *Del Bigtree:* What we've proven now is that we are becoming a movement, and we are becoming a threat to the pharmaceutical idea of world health. That is, I think, epitomized by media coverage. So, we're there. We're where we want to be. They are now having to talk about us. Even though it's negative, more and more people every day are waking up, opening their newspapers, and saying, "You mean there's people that actually don't believe in vaccines? Why? Who's this Del Bigtree guy? Who are Ty and Charlene Bollinger? Who's Robert Kennedy Jr.? Who's this Andy Wakefield guy?" They're going and starting to do research.
- *Ty Bollinger:* Del mentioned the term vaccine hesitancy. Did you know that the USA has been operating under a defacto state of emergency since January 2019? That happened after the World Health Organization announced that, "The reluctance or refusal to vaccinate," which is termed vaccine hesitancy, "is one of the top 10 threats to global health."

Charlene

- *Bollinger:* Here's a June 2019 PDF document from Infoguard, which asserts that the anti-vax movement poses a threat to our national security. The word threat is often used during wartime to elicit fear and hatred of an enemy. In any war, real or perceived, rational thinking is the first casualty of fear, which makes it easier for people to agree to give up freedoms in exchange for the promise of safety.
- *Ty Bollinger:* For the past year and a half, there have been calls for public identification, criminal prosecution, and imprisonment of unvaccinated people and parents who don't vaccinate their children.

Charlene

- *Bollinger:* Wow. Shockingly, in December 2019, neocon Republican Rick Wilson posted that the anti-vaxxers are a scourge and a strong argument for reeducation camps, the immediate seizure of their property, and putting their children into protective custody.
- *Ty Bollinger:* This demand sums up the medical police state tyranny and antihuman authoritarianism that characterizes vaccine advocates. They quite literally seek to throw parents in concentration camps if they refuse to have their children injected with nearly 100 toxic vaccines that contain neurotoxic substances like aluminum, squalene, mercury, aborted fetal tissue, formaldehyde, and even complete DNA sequences of aborted human babies.

- *Dr. Tenpenny:* Things have really ratcheted up on the pro-vaccine side. I believe that what was happening is that more and more people were becoming aware of problems associated with vaccines through all the work that I've done for the last 19 years, through The Truth About Vaccines. More and more people were saying, "What? Should I be questioning this?" Then they were doing their own research. Once you know what you know, you can't un-know it. People were saying, "No thank you. I think I'll take my risk with a fever, a cough, and a rash rather than ... and maybe having a short-term infection rather than a lifetime of chronic illness."
- *Dr. Tenpenny:* I think that the powers that be were seeing that the jig was up, and that more and more people were going to say no, and their only last tool in the toolbox to hammer people, to make them be injected with their liability-free toxic products ... We've seen that in multiple states across the country, and we've also started to see whispers now that they're going to ratchet that up to the federal level. The pharmaceutical industry's going to pay off Congress and say, "We're really tired of fighting this in all 50 states. Let's just bring this up to federal level and mandate it like vaccinations for all and shut down all of this noise."
- *Dr. Tenpenny:* I believe on the one hand, that's kind of the bad news. The good news is that people are waking up and fighting back. They are getting educated. They are getting informed. They're setting their fear aside of being called a name, an anti-vaxxer. They're not caring anymore if they get unfriended on Facebook or Instagram. They're stepping forward and saying, "This is my body, my choice, my child, and we're just going to have to say no." I believe the activism in the last two years has really accelerated, but it's been met with a lot of other powerful voices from the top down.

Charlene

- *Bollinger:* People are really waking up to this issue, and one of the main reasons is censorship from those powerful political voices that Dr. Tenpenny just mentioned.
- *Ty Bollinger:* In March 2019, Representative Adam Schiff, Democrat out of California, sent a letter to Jeff Bezos, the CEO of Amazon, to express concern that Amazon was recommending products and content that discouraged parents from vaccinating their children. He requested that Amazon censor any anti-vaccine sentiment, and he stated that, "The dissemination of unfounded and debunked theories about the dangers of vaccination is a great risk to public health."

Charlene

- *Bollinger:* In June 2019, New Jersey Senator Bob Menendez, a senior member of the Senate finance committee that sets national health policy, sent a letter to Facebook CEO Mark Zuckerberg requesting that Facebook remove all anti-vaccine "misinformation" and replace it with "medically accurate information."
- *Ty Bollinger:* During the summer of 2019, in one devastating algorithmic stroke, Google removed many of the top natural health and health freedom websites from their organic search results, with some of them losing as much as 99% of their traffic. "The censorship that is being applied to alternative health is nothing less than demonic," said Zach Vorhies, who worked at Google as a software engineer for eight and a half years before he came out as a whistleblower. He then said, "That may seem extreme, but I've been following the happenings and the new cures that are being suppressed."

Charlene

- *Bollinger:* According to Vorhies, in the past three years, Google has rolled out changes that purposely down-rank independent health websites, even extremely high-quality and independent medical articles that are written by credentialed healthcare professionals. Here at The Truth About Cancer and The Truth About Vaccines, we lost 90% of our organic traffic once Google implemented this anti-natural health algorithm during the summer of 2019. In the first quarter, our Pinterest account was deleted completely based on their assertion that we violated the policy against self-harm.
- *Ty Bollinger:* In April, "anti-vaxxers were banned from raising money on GoFundMe." Then in June, digital marketer Mailchimp banned anti-vax content. In early July, Vimeo announced that it would no longer publish sites that were critical of vaccines or sites that even questioned vaccine safety. In July, Facebook shut down the largest anti-vaccine group on its platform. Facebook, whose committee members include former big pharma employees, has also censored legitimate scientific inquiry and debate regarding vaccine safety. Also in July, a Canadian chiropractor was fined \$100,000 for criticizing vaccines on social media.

Charlene

- *Bollinger:* It's clear that anyone who stands for health freedom and criticizes big pharma, big agri, or pretty much big anything are losing posting privileges, finding themselves de-ranked, and eventually shadow banned, or outright banned.
- *Ty Bollinger:* No matter what your view is on vaccines, the point we are illustrating now is that big pharma's tentacles extend to big tech and that prohibiting the sharing of health information, a tenent of the interest, is immoral and just plain wrong. The fact that you cannot even question vaccines without being censored or called names should alarm everyone that's watching this.
- *Del Bigtree:* So, what do people need to do? I think recognize that that's your future. And it may be two to three years away. If you know that and you've studied your history ... We all asked ourselves the same question when we look at Nazi Germany. Why didn't the people leave? Didn't they see it coming? Didn't they recognize that slowly but surely they weren't allowed in this store or weren't allowed in this town or weren't allowed in this state, or there's a train now that they're forcing you to get on? At what point do we recognize that we're back in that position?
- *Del Bigtree:* We live in a country where we still get to vote for our elected officials. We need to start to demanding that our elected officials speak to this issue, speak to body autonomy, and stand up for parental rights, human rights, physical rights, body autonomy, and if you don't, you're fired. I'm not going to be afraid to talk about it with anybody. We were called the Republicans and Democrats, but it looks like third graders all screaming and yelling and pulling each other's hair.

Robert F.

Kennedy Jr.: The reason they call you anti-vaxxer [inaudible 00:13:11] anti-vaxxer is it's a way of shutting us up so they don't have to debate these very, very serious issues about vaccine safety, so they don't have to debate the science. They're telling us [inaudible 00:13:25] going to censor Facebook because they want to get rid of misinformation about vaccines. We're just talking about science. We're giving them peer review. Charlene Bollinger:	Have you ever wondered if the TV news anchors were given the same talking points? Here's a humorous montage initially from Conan O'Brien that demonstrates the way that the mainstream media seem to all be on the same script.

Dr. Soumya

Swaminathan: Vaccines are very safe. If someone gets sick after vaccination, it is usually either a coincidence, an error in administering the vaccine, or very rarely, a problem with the vaccine itself. That's why we have vaccine safety systems. Robust vaccine safety systems allow health workers and experts to react immediately to any problems that may arise. They can examine the problem, rigorously and scientifically look at the data, and then promptly address the problem.

Dr. Soumya

Swaminathan: WHO works closely with countries to make sure that vaccines can do what they do best, prevent disease without risks.

Swaminathan: New vaccines against malaria, meningitis, and encephalitis in Asia and Africa are now being thoroughly monitored with support from WHO.

Swaminathan: Vaccines are one of the safest tools we have to prevent disease and ensure a healthy future for all children.

Charlene

Bollinger: As you can clearly see, the media has been told that vaccines are safe and effective, but have you ever wondered what the World Health Organization scientists and pediatricians say when they discuss vaccines behind closed doors?

Ty Bollinger:	Well, you can quit wondering. Closed door videos from the Global Vaccine Safety Summit and the World Health Organization were uncovered by Del Bigtree's nonprofit organiza- tion, the Informed Consent Action Network.
Charlene Bollinger:	These videos show key officials and doctors at the December 3, 2019 Vaccine Safety Summit in Geneva, Switzerland, directly contradicting their public claims of vaccine safety and research that proves the science is settled.
Ty Bollinger:	Hold on to your seats as you get to see for yourself what they tell us is vastly different than what they tell each other in secret meetings. Remember, in the video that we just watched, the chief scientist who is the face of the World Health Organization vaccine policy, Dr. Soumya Swaminathan, tells us multiple times that vaccines are safe and robust vaccine safety systems are in place.
Dr. Soumya Swaminathan:	I think we cannot overemphasize the fact that we really don't have very good safety monitoring systems in many countries, and this adds to the miscommunication and the misapprehensions because we're not able to give clearcut answers when people ask questions about the deaths that have occurred due to particular vaccine. This always gets blown up in the media. One should be able to give a very factual account of what exactly has happened and what the cause of deaths are, but in most cases, there's some obfuscation at that level. Therefore, there's less and less trust in the system.
Charlene Bollinger:	Wow. Did you hear what we just heard? The World Health Organization's number one pe- diatrician and chief scientist just said behind closed doors, in a private meeting that they do not have very good safety monitoring systems in place, and then she said something that blew us away.
Ty Bollinger:	Yeah. She said, "We're not able to give clearcut answers when people ask questions about the deaths that have occurred due to the vaccines," and that, "in most cases, there's some obfuscation at that level." FYI, the term obfuscation means the action of making something obscure, unclear, or unintelligible. In other words, she's saying that when doctors get confronted with legitimate safety questions from their parents, they have no idea how to answer the question, so they just muddy the waters.
Charlene Bollinger:	Wow. Remember, this meeting was filmed just four days after the World Health Organization released their propaganda video where she told us over and over that vac- cines are safe and that robust vaccine safety systems are in place.
Ty Bollinger:	We're going to break down the entire meeting in the next episode, episode nine, and we're going to break out the multiple lies that they are telling you right now about vac- cines. It's going to rock your world. You don't want to miss the final episode, episode nine.
Ty Bollinger:	Based on catching them lying to us, more and more people are posting about the lies, more and more people are basing their arguments on the actual words of the World Health Organization that you just saw.

From the networks, it's misinformation.
Robert F. Kennedy Jr.:	Any of you watch NBC the other night and saw Lester Holt, and they're all All of these news shows have become advertisements, and they're all part of this orchestrated frenzy. "We're terrified of measles. You've got to get the vaccines. We've got to pass the mandate." Lester Holt is sponsored by Merck, which makes a vaccine. Lester Holt showed a frightening picture on his show of a baby that was afflicted with these terrible measles bumps. It turns out it was fake. He had to fake it. He's never apologized, NBC has never apologized. That is misinformation, and Lester Holt is sitting there saying we've got to shut down this misinformation about vaccines while he is the primary promoter of that information.
Charlene Bollinger:	That's right, they are spreading misinformation. The photo on the top is the royalty-free stock photo that you can purchase on Dreamstime.
Ty Bollinger:	Here's the same photo, but it's been edited and photoshopped to add the measles splotches. Check it out. There's no doubt, is there? With splotches, without splotches. With splotches, without splotches.
Charlene Bollinger:	Here's a screenshot of the purchase page where NBC apparently found the photo before they decided to doctor it up. How dishonest.
Ty Bollinger:	As mathematicians used to say when they proved the theorem, Q.E.D., quod erat demonstrandum. In other words, we caught you, NBC. You are fake news.
Charlene Bollinger:	lsn't it ironic? NBC was circulating a fake photo in a story aimed at busting anti-vaccine myths. Does anyone else find this to be as disgusting as we do?

Robert F. Kennedy Jr.:	I had 11 brothers and sisters. I had over 50 cousins. I didn't know a single person with a peanut allergy. Why do my kids all have food allergies? Because they were born after 1989. If you were born prior to 1989, your chance of having a chronic disease, according to HHS, is 12.8%. If you were born after 1989, your chance of having a chronic disease is 54%. And the FDA has said to the vaccine companies, "You need to take [inaudible 00:25:50]."

Kennedy Jr.:	We're not saying all of those things, all of those illnesses came from vaccines, but there is no intervention that is so exquisitely and precisely timed as what happened when we went in 1989 and changed that vaccine schedule and raised the levels of aluminum and mercury, tripled and quintupled them, and went from three vaccines that I had to the 72 that my kids had and the 75 that the kids are going to have next year. There are 273 new vaccines in the pipeline.
Robert F. Kennedy Jr.:	I was talking to I went in and met with Adam Schiff. I've been a Democrat all my life. What's happening in the Democratic Party disturbed me greatly, but I was astonished when one of the leading Democrats in our country, Adam Schiff, went to the internet titans, to Facebook, to Google, Pinterest, Instagram, and Amazon, and told them, "You need to start censoring information about complaints and information about pharmaceu- tical products."

- *Kennedy Jr.*: I said to Adam Schiff, "What in the world? What kind of cognitive dissonance does it require to understand that this company is lying and cheating and killing with every other medical product and pharmaceutical product that it makes, but it has found Jesus when it comes to vaccines? And it's not going to lie about that?"
- *Ty Bollinger:* Bobby makes a great point. Cognitive dissonance is defined as the state of having inconsistent thoughts and beliefs, so this is the perfect word to describe someone who trusts big pharma to manufacture safe vaccines which are not regulated or double-blind, placebo-control tested in light of the fact that they have been fined \$35 billion in damages caused by the prescription drugs they manufactured that were regulated and double-blind, placebo-control tested.
- *Ty Bollinger:* Check out this graphic. You can see the childhood vaccines from birth to six months and then the vaccines from six months to 18 months, including DTaP, Hib, hep B, pneumo-coccal, polio, hep A, MMR, chickenpox, flu, and multiple combo vaccines. Not a single one of them had a placebo-controlled trial.

Charlene

- *Bollinger:* Let's listen to Del Bigtree as he dives deeper into this cognitive dissidence regarding vaccines, especially with politicians, and links it to the big pharma lobby and highlights the lack of randomized, double-blind, placebo-controlled studies.
- *Del Bigtree:* The pharma lobby's the most powerful in Washington. It's true. It's the number one most powerful lobby. What's it doing there? Yet, Bernie Sanders or Elizabeth Warren will say, "I'm anti-pharma lobby. I am pro-vaccine mandate and removing exemptions."
- *Del Bigtree:* I don't understand why they don't see that the fastest-growing sector of pharma is vaccines. The future of that industry is vaccines for many reasons. One, you cannot sue them if they injure you because of the 1986 Vaccine Injury Compensation Act that took all liability away from the industry and anyone that gives you a vaccine. Two, it's never been through a safety study at all. We've not seen [inaudible 00:31:27]. This is one of the things that my nonprofit, in working with Bobby Kennedy, we've proven even with lawsuits that unlike every other drug that goes through a double-blind placebo study to establish safety, no vaccine ever has, at least certainly the ones on our childhood schedule. That's problematic.
- *Del Bigtree:* Now you have the pharmaceutical industry who loses billion-dollar lawsuits almost every week now. It feels like we're seeing these lies being upturned in courtrooms around America and the world. They make a product, we can't get into a courtroom, a product that's given to our children and the only product of all those being sued that have never been through a safety study.

Charlene

Bollinger: Aren't you amazed at the fact that vaccines are touted as safe when there are zero double-blind, placebo-controlled studies? Del mentioned that he and Bobby sued and won.

The TRUTH About VACCINES 2020.

Ty Bollinger:	One of those cases dealt with maternal vaccinations. Have you ever gone to CVS or Walmart and you see the get your flu vaccine signs? Protection during pregnancy. CDC says, WHO says safe effective, get those vaccines.
Charlene Bollinger:	Surely, since there is such a huge push for pregnant moms to get vaccinated, at least they've done adequate studies to make sure those vaccines are safe, right?
Ty Bollinger:	Here's one more clip of the World Health Organization Vaccine Safety Summit from December 3, 2019. Listen to Dr. David Kaslow discussing maternal vaccinations, which he calls "the new target population for vaccines."
Dr. David Kaslow:	Coming down the pike maybe relatively quickly is a new target population for us in vac- cines, and that's maternal immunization. These are women who are pregnant, who will have all kinds of adverse events associated with their pregnancy. Part of the problem is, is that we don't have a strong enough pharmacoepidemiologic baseline in the target populations that we're studying to be able to say, "Is this an expected adverse event due to pregnancy, or is this related to the vaccine?" So, I do think an investment in that kind of epidemiologic baseline is going to be critically important if we don't want to derail some of our maternal immunization vaccines as they go into low-resource settings.
Ty Bollinger:	I do think an investment in adequate safety studies would be helpful for us so that we don't derail this money train, but this is not a laughing matter. Dr. Kaslow just insinuated that safety studies have not been done with maternal vaccines.
Charlene Bollinger:	The next video is of the ACIP meeting in October 2017. Dr. Wellington Sun is the guy at the ACIP meetings that actually deals with a lawsuit against vaccines, which is an HRSA program under DHHS. Listen to what he says about the vaccines in pregnancy. It will blow your mind.
Speaker 40:	Dr. Sun.
Dr. Wellington Sun:	Yeah. I just want to make a clarification on use of vaccines in pregnancy. Unless there is a study of that vaccine in pregnant women, even though that age indication [inaudible 00:34:35] may fall in within that age indication, it is still not considered use in pregnant women would still be considered off label.
Ty Bollinger:	Did you hear that? He said that for pregnant moms, the use of vaccines should be con- sidered off label. Off label is defined as relating to the prescription of a drug for a condi- tion other than that for which it has been officially approved.
Charlene Bollinger:	In other words, Dr. Sun just admitted that for pregnant mothers, vaccines, all vaccines have never been approved or tested. This is when Del Bigtree, who was sitting right behind Dr. Sun, got the idea to sue the FDA.
Ty Bollinger:	He sent Freedom of Information requests and told the FDA that he wanted to see the trials of the flu vaccine and Tdap vaccine in pregnant women to show that those vaccines are safe for the fetus. They settled because they got the FDA to admit that they have "no records responsive to your requests."

Charlene

Bollinger: In other words, they admitted that there had been zero clinical trials with pregnant women.

Charlene

Bollinger: Here's Dr. Judy Mikovits discussing some of the cases she's been involved with in vaccine court.

Dr. Judy

Mikovits: We've worked on maybe 10 to 15 cases in vaccine court, and we found that court to be, as I've said, beyond corruption to just pure evil. Most of the cases we do right now are Gardasil injury, and they're things including cancers, leukemias, lymphomas, death, seizures, ME/ CFS. The Gardasil vaccine is so, so toxic. And then flu vaccines for the elderly, where the elderly are literally dropping dead or dying within months of the flu in Prevnar shots.

Dr. Judy

- *Mikovits:* What's happened for me and Dr. Ruscetti, my colleague, is we've delved down in maybe 10 or 15, 20 cases that we've been working and seeing at the molecular level and scientific level how the fetal tissue in the vaccines, how the aluminum contaminants, how they're literally destroying not only our children's brains but every organ system, bladder cancer, kidney cancer, leukemia. Just incredible, and the government is covering it all up. The advisory committee on immunization practices has accelerated recommending vaccines across the board. There are almost 270 vaccines in the pipeline as they mandate across the board and force vulnerable children and populations to be vaccinated and killed.
- *Ty Bollinger:* One such child who was killed by vaccines is Colton Berrett, whose story was included at the end of episode five. Colton was a healthy, active, perfectly normal young boy. That is, until he received the HPV vaccine. It was agreed by doctors that Colton suffered a severe adverse reaction and vaccination injury to the Gardasil vaccine, and they reported his vaccine injury to the Vaccine Adverse Events Reporting System, VAERS. His left arm eventually lost function, and he became paralyzed. He also had issues breathing, so intubation and ventilator were needed. Eventually, Colton lost his ability to speak as paralysis continued spreading throughout his body. He never complained. He smiled a lot, all the time. He wore a headband that read caught you staring.

Charlene

- Bollinger: The vaccine changed the life of his family forever, and now Colton is gone. Colton Berrett was injured by the HPV vaccine, paralyzed and permanently intubated. He had to learn to walk a second time, had to cart around a 15-pound breathing apparatus wherever he went. Colton took his own life because he did not want to be a burden to his family. Just let that sink in for a while. Several weeks shy of his 18th birthday, he took his own life so as not to be a burden to those he loves. Our hearts go out to the Berrett family. Children are dying all for the sake of profit. It's shameful and dehumanizing and criminal.
- *Del Bigtree:* What I'm saying is that it is about money. You're not the number one most powerful lobby in Washington, you're not going to get that money back because you got 2% more children vaccinating, couple million more. What happens when they get every adult mandated into a vaccine program? Now think about an industry where there's 16 vaccines already on an adult's schedule at the CDC and 340 million people are forced to use them. How about 270 vaccines in the approval stage that every adult, 340 million, have to use? And once America goes, the rest of the world will follow. We are the scientific minds of the world. "America said it was okay. They forced their citizens into it. So should we."

Del Bigtree:	America alone, if we have an adult mandate, that industry overnight goes from being a \$50 billion industry to a multi-trillion-dollar industry, overnight in America alone. I think that that's all the motivation you have to look at. The pharmaceutical industry is one the verge of being the world power industry of the planet.
Ty Bollinger:	This is why they're trying to mandate vaccines, this is why the tech giants are censoring anyone who questions vaccines: Money. But people are waking up in droves. Here's Dr. Andrew Wakefield explaining why this incredible awakening is happening.
Dr. Andrew Wakefield:	They have witnessed the extraordinarily oppressive approach of the government and the industry to forcing us into mandatory vaccination policy, or they've witnessed the censorship of any debate in the mainstream media and now in social media about vaccine safety. They're saying, "Hang on. I don't necessarily believe vaccines cause autism, but I know that when you have to throw the Constitution out the window, when you have to rip up the First Amendment to protect your narrative from people merely expressing their opinions that these vaccines are unsafe, then I know in my heart there's something wrong."
Charlene Bollinger:	And there's definitely something wrong when states begin to eliminate medical exemp- tions for people whose doctors have told them that a vaccine might kill them.
Dr. Andrew Wakefield:	California has now passed bills which mandate vaccination according to the CDC's rec- ommended schedule for all public and private school attendance. You have to be vacci- nated to [inaudible 00:41:26]. The next policy they enacted was to pass SB 276, which went after doctors who were writing medical exemptions.
Robert F. Kennedy Jr.:	There's 4,000 children in this state who were told by their doctors, who were familiar with their medical records, their medical history, their families, and knew that child in a context, those doctors have told those 4,000 children, "You should not be vaccinated because it could kill you or it could permanently injure you."
Robert F. Kennedy Jr.:	Now the state of California has stepped in and said, "We're going to force those kids to get vaccinated anyway."
Robert F. Kennedy Jr.:	Physicians have now become, instead of the confidant of a patient who are focused on healing that particular patient, they've now become agents of the state who are treating that patient not for their own good but for the good of the public at large. That's a very, very dangerous place because where do you end up with that? We've crossed a boundary, where doctors are no longer the confidants of their patients but now are the agents of state policy. That's dangerous. Kennedy Jr.:

Dr. Andrew

Wakefield: Now they've taken that right away from the children's doctor, the person who knows these children, and put it in the hands of a state official who's never met them, doesn't know them, and, frankly, doesn't care. There is a dramatic limitation of medical exemptions in order to exert control over vaccination policy. It's catastrophic. Firstly, there is no place whatsoever in medicine for any mandated procedure, none, zero. Nazi Germany taught us that. Experimental medical programs in people who did not have informed consent is abhorrent, is totally unacceptable to the conduct of ethical medicine. You can't do it. You must never do it.

Dr. Andrew

- *Wakefield:* But that's what's happening here in California. People are being forced into a medical procedure with known risks, with quantifiable risks, where they have to pick up the consequences of a permanently damaged child. No one cares. There's nothing there for them, no infrastructure in place to protect that family. They bear all the liability. When that child, that parent hands their baby over to the doctor to be vaccinated, then the least informed person in that relationship, because you can't sue the doctor, you can't sue the pharmaceutical companies, the least informed person bears all the liability and all the risk: the mother. That's atrocious. So, there is no place whatsoever for mandated medical procedures in any civilized country in the world, and that is what is happening here and what they intend for the world. It's got to stop.
- *Ty Bollinger:* Yes, this Draconian style of forced medicine, which violates the Nuremberg Code, must stop. - *Ty Bollinger:* California set a precedent by ramming through Senate bill 276 in 2019, despite massive protests by thousands of people who were truly concerned about the loss of vaccine freedom. Unbelievably, they even arrested some of the peaceful protestors. Let's check out what happened in New York and then in New Jersey over the past couple of years.

Charlene

- *Bollinger:* In early 2019, the bureaucrats of New York state decided that it was time to eliminate the right of parents to opt their children out of mandatory vaccinations for religious reasons, so they rammed a bill to repeal the religious exemption to vaccination through both the assembly and Senate in one day with no public hearings. This legislative coup completely cut the citizens of New York out of participating in the new lawmaking process. Within hours, the governor of New York signed a bill into law.
- *Ty Bollinger:* Then New York City began to target the Hasidic Jews since this ultra-Orthodox community is openly opposed to vaccination due to religious beliefs. Unbelievably, New York City sent 15 to 20 "disease detectives" into the Jewish community, some with Yiddish interpreters, some of them going house to house to levy \$1,000 fines and misdemeanor charges for the Jews that weren't vaccinated.

Charlene

- *Bollinger:* New York City mayor Bill de Blasio was quick to regurgitate the don't wait, vaccinate propaganda. You would think that the churches would have been appalled, but in October, right after The Truth About Cancer live in Anaheim, Bobby Kennedy called us and told us that he was speaking about vaccines at a church in Harlem when they cut his mic. He was forced to go outside into the streets to finish.
- *Ty Bollinger:* Unbelievable.
- *Ty Bollinger:* A couple of months later, right across the Hudson River, New Jersey followed suit and attempted to pass a bill that would eliminate the religious exemption for vaccines, just like California and New York had done. But due to the efforts of over a dozen grassroots organizations in the state of New Jersey as well as thousands of citizens who responded by descending on Trenton and stood in the cold, and later freezing rain, for nearly 12 hours to ensure that their voices were heard, the bill was pulled from the Senate floor.

Charlene

- *Bollinger:* Thank God for these peaceful protestors who were exercising their First Amendment rights, which includes not only freedom of speech but religious freedom, which is the last remaining legal shield against forced vaccination in this country.
- *Ty Bollinger:* Interestingly, in order to get the bill to the Senate floor, it had to pass general assembly, but there were seven out of the 10 members that were going to vote no. So, New Jersey state Senate president Stephen Sweeney replaced three of the no votes with three replacement people who voted yes. Thus, the bill passed assembly by a vote of six to four. Here's a brief clip of Senator Sweeney showing just how ignorant he is about vaccines and the religious exemption.

Senator Ste-

- *phen Sweeney:* Every single medical association in this state, every doctors group in this state, all the medical professionals are on the side of vaccination. The reason for a religious exemption was, back in the '50s and '60s, they used fetal tissue [inaudible 00:48:59] to make the vaccines. That was the reason why. They don't do that now. They don't.
 - Speaker 46: Yes, they do.

Senator Ste-

phen Sweeney: No, they don't.

Charlene

- *Bollinger:* Senator Sweeney? Yes, they do. You need to quit talking out of ignorance, sir. Here are just a few of the current CDC vaccines that have aborted fetal tissue lines listed in their package inserts.

Dr. Stanley Plotkin:	76.
Speaker 47:	76.

Dr. Stanley Plotkin:	Mm-hmm (affirmative).
Speaker 47:	And these fetuses were all three months or older when aborted, correct?
Dr. Stanley Plotkin:	Yes.
Speaker 47:	And these were all normally developed fetuses, correct?
Dr. Stanley Plotkin:	Yes.
Speaker 47:	What organs did you harvest from these fetuses?
Dr. Stanley Plotkin:	Well, I didn't personally harvest any, but a whole range of tissues were harvested by coworkers.
Speaker 47:	Okay.
Speaker 47:	These pieces were then cut up into little pieces, right?
Dr. Stanley Plotkin:	Yes.
Speaker 47:	And they were cultured?
Dr. Stanley Plotkin:	Yes.
Speaker 47:	Okay.
Speaker 47:	Some of the pieces of the fetuses were pituitary gland that were chopped up into pieces [crosstalk 00:52:09]-
Dr. Stanley Plotkin:	Mm-hmm (affirmative).
Speaker 47:	Included the lung of the fetuses?
Dr. Stanley Plotkin:	Yes.
Speaker 47:	Included the skin?
Dr. Stanley Plotkin:	Yes.
Speaker 47:	Kidney?
Dr. Stanley Plotkin:	Yes.

Speaker 47:	Spleen?
Dr. Stanley Plotkin:	Yes.
Speaker 47:	Heart?
Dr. Stanley Plotkin:	Yes.
Speaker 47:	And tongue?
Dr. Stanley Plotkin:	I don't recall, but probably, yes.
Speaker 47:	I just want to make sure I understand. In your entire career This was just one study. I'm going to ask you again. In your entire career, how many fetuses have you worked with? Approximately.
Dr. Stanley Plotkin:	Well, I don't remember the exact number, but quite a few when we were studying them originally, before we decided to use them to make vaccines.
Speaker 47:	Do you have any sense? This one study had 76. How many other studies did you have that used aborted fetuses [crosstalk 00:53:02]-
Dr. Stanley Plotkin:	Oh, I don't remember how many.
Speaker 47:	Are you aware that one of the objections to vaccination by the plaintiff in this case is the inclusion of aborted fetal tissue in the development of vaccines and the fact that it's actually part of the ingredients of vaccines?
Dr. Stanley Plotkin:	Yeah, I'm aware of those objections. The Catholic Church has actually issued a docu- ment on that which says that individuals who need the vaccines should receive the vac- cines regardless of the fact, and that I think it implies that I am the individual who will go to Hell because of the use of aborted tissues, which I am glad to do.
Speaker 47:	Okay.
Speaker 47:	Do you know if the mother is Catholic?
Dr. Stanley Plotkin:	l have no idea.
Speaker 47:	Okay.

Speaker 47:	You have said that, "Vaccination is always under attack by religious zealots who believe that the will of God includes death and disease."
Dr. Stanley Plotkin:	Yes.
Speaker 47:	You stand by that statement?
Dr. Stanley Plotkin:	l absolutely do.
Speaker 47:	0kay.
Speaker 47:	Are you an atheist?
Dr. Stanley Plotkin:	Yes.
Ty Bollinger:	Hmm. It looks like it won't be long until Dr. Plotkin learns firsthand that God does exist.
Charlene Bollinger:	That's the truth, Ty.
Charlene Bollinger:	Hey, someone should send that interview to Senator Stephen Sweeney.
Ty Bollinger:	Yeah. It's truly amazing the outright lies that are regurgitated, like the whopper that Senator Sweeney just told.
Charlene Bollinger:	Another boldfaced lie is right on the CDC's website, where they state, as a matter of fact, that vaccines do not cause autism.
Ty Bollinger:	But then the first study that they cite actually concludes "the evidence is inadequate to accept or reject a causal relationship between diphtheria, tetanus, or pertussis vaccines and autism."
Charlene Bollinger:	In other words, their primary reference study was inconclusive, but the headline reads emphatically, "Vaccines do not cause autism." How dishonest.
Charlene Bollinger:	Back to New Jersey. The New Jersey Senate tried to push through the bill in early January 2020, but they were met with even more protestors. Here's Del Bigtree and Jeffrey Jaxen discussing the amazing turnout.
Del Bigtree:	How do you think this affects the politicians? Because I know when we were there at the end of last year, the police force there and the gentleman that ran security for the last 20 years said to me, "We have never seen this many people at the capital in my entire time at this capital on any issue there is." And now you're saying there's twice as many people.
Jeffrey Jaxen:	Yes.

- *Del Bigtree:* What is this all coming down to? Why are they there? How many votes are hanging in the balance? What is the discussion right now?
- *Jeffrey Jaxen:* Well, I hear there's five people that are still in limbo. I know there's some of the health freedom movement ... Leaders met with them on Monday to try to change their minds or try to get them to see the other side, understand the science that's not quite there, understand the safety studies that aren't quite there. I have to think that the politicians within that building, they definitely can hear this. We have about 10 times as many bullhorns, chanting, drums, you name it. They can't ignore this, and the fact that if it was ... If they thought this was the biggest crowd they ever saw last month, this one's bigger, and it doesn't look like they're going away. So, I have to think this influences the tide. Starting 2020 right now with this kind of momentum, all the other states in America have to be looking at this and saying, "Do we really want this in our backyard if we try to take religious freedom, if we try to take away medical exemptions and put them in a bureaucratic bubble?"

Charlene

Bollinger: Jeffrey Jaxen put it brilliantly. We cannot allow the states to take all the medical and religious exemptions away from us. We must continue to stand up and make our voices heard like they did in New Jersey. Millions of people suffer from diseases caused by vaccines. That's just a fact. It shouldn't be that way in a free country.

Dr. Judy

- *Mikovits:* 25 million Americans suffer chronic diseases. One in two American children is sick in ways that we were never chronically ill before, with asthma, allergies, cancer. The cancer rates are skyrocketing. We're literally bankrupting our country with these dangerous biologicals, these vaccines being forced upon our children and our families. It's got to be the number one thing in the election because we won't have a country if we continue to remove religious freedom, freedom of choice. This is the foundation upon which our country was built.
- *Del Bigtree:* I think vaccines is the frontier, I think it is the battleground as we speak. They're going to attempt to force vaccinate every adult and child not only in America but around the world. It's already on Health and Human Services' website. If pharma gets control of us at that level where they can forcibly inject us with products we have no control over by buying our politicians and passing laws and then force these products upon us, there will be no alternative medicine. There will be no chiropractors, there will be no acupuncturists, there will be no alternative way. We will see more and more medical kidnapping, like we're seeing. This is the moment.
- *Del Bigtree:* I believe this vaccine discussion is the attempt by the pharmaceutical industry to take over our lives once and for all, so today I'll be calling for everybody to stand up, because the war has begun. We are in, I believe, a spiritual war. We are up against an idea that our bodies are not sounds and only the pharmaceutical industry can keep us alive. If we believe that our bodies want to heal and that nature has the answers or, for many of us, God, then we have to stand up just as our Founding Fathers did and make a difference now.
- *Del Bigtree:* I just moved from Los Angeles, where I developed my film and television career, where my children were born, and moved to Texas because I believe I'm a refugee now from California. I'm a refugee in my own country. People from New York are also finding themselves in the same situation. Child Protective Services being called into hospitals, where somebody's child fell out of a tree, broke their arm. They just want to take them in to get the arm fixed, and then it's, "Well, you need a Tdap vaccine now."

Del Bigtree: "Oh, I don't need that."

Del Bigtree: Then, "Well, why? Why are you not getting it?" Then they look into your vaccine record, and now because you're not vaccinated, they're talking about taking your child away from you.

- *Del Bigtree:* People want to make me worry about the border between Mexico and America. I'm not happy with what I'm seeing there, but I'm watching citizens have their children taken away from them because they don't vaccinate, because they don't want to give their child chemotherapy and things like that. This is a terrifying, scary time that the pharmaceutical industry is making decisions, political decisions, police decisions, and legislative decisions about our lives.
- *Del Bigtree:* What do people need to do? People better wake up. We have to wake up right now. This is not something that is going to be, "Oh, I'm worried what's going to happen to my grandchildren." This future, where is it going to be? In our lifetime. In fact, I believe in the next three to five years, we have either won this battle against the pharmaceutical takeover of our bodies ...
- *Del Bigtree:* We are talking about the idea, when you look at California and New York, they just removed every exemption there is. California took it a step further to remove, essentially, the medical exemption. A doctor cannot even use your family history, knowing you, and say, "I'm writing an exemption. This child shouldn't be vaccinated."
- *Del Bigtree:* There's a kid up in New York right now, in a wheelchair with cerebral palsy who developed seizures from vaccinations. The leading neurologist at the children's hospital said, "You cannot vaccinate this child," yet the school will not let him go to school because a school board is overriding a neurologist? That is terrifying.

Charlene

Bollinger: Welcome to The Truth About Vaccines 2020, episode nine, the final episode. We're your hosts, Ty and Charlene Bollinger.

Ty Bollinger: In the last episode we analyzed what's been happening across the USA with draconian mandatory vaccine laws, and removal of religious and medical exemptions. We also covered the blatant censorship and suppression of any and all anti vaccine sentiments, by big tech giants.

Charlene

Bollinger: Here's Bobby Kennedy, recapping what's been happening over the past few years in the vaccine world and the censorship of any and all information that doesn't conform to the religious dogma that vaccines are safe and effective.

Robert Ken-

nedy: Oh you know there's been a huge global drive by the vaccine industry to mandate facts and public debate. So, we've had a long term censorship on network television which receives, and the press, which receives about almost \$10 billion a year from the vaccine companies and for advertising et cetera and that allows them also to dictate content so we've never been able to debate or discuss this issue on the mainstream press, but we were able to go to the social media. But in the last year, we've been completely shut down in social media. Google has become a vaccine company, Google now has a partnership with Glaxo. Google is making vaccines and they're partner with Merck, and they've completely shut down all discussion, what they call vaccine misinformation that is not misinformation.

Robert F.

- *Kennedy Jr.:* It's information that is critical of a medical product, of a pharmaceutical product. Facebook has shut us down, Pinterest, MailChimp, all of the major social media platforms have shut us down. And there's also been a push to mandate vaccines. This is a broad, they know they cannot sell in a marketplace, so they have to mandate them, and they know that they can't win the debate, so they have to censor it.
- *Ty Bollinger:* And they're not even hiding the censorship. Big tech is openly admitting that they are going to censor anyone who questions the safety of vaccines, or even hints that we should have better safety monitoring systems. So, based on those criteria, it looks like they're going to want to start censoring the World Health Organization soon.

Charlene

- *Bollinger:* Why you might ask. There was a meeting which took place at the World Vaccine Safety Summit on December 3rd 2019 in Geneva, Switzerland. Have you ever worked wondered what the World Health Organization's scientists and pediatricians say when they discuss vaccines behind closed doors?
- *Ty Bollinger:* Hold on to your seats as you're going to get to see for yourself that what they tell us is vastly different than what they discuss in secret meetings. Interestingly, in attendance at this meeting was the World Health Organization's number one chief scientist, who is the face of the WHO Dr. Soumya Swaminathan, does that name sound familiar? If you watched episode eight, you saw her telling you this about vaccines.



Dr. Soumya Swaminathan:	Vaccines are very safe, that's why we have vaccine safety systems, robust vaccine safety systems. WHO works closely with countries to make sure that vaccines can do what they do best, prevent disease without risks.
Charlene Bollinger:	Now, here's what she said less than a week after the World Health Organization ran that vaccines are very safe propaganda commercial. Thanks to Del Bigtree and HighWire for this shocking footage.
Dr. Soumya Swaminathan:	I think we cannot overemphasize the fact that we really don't have very good safety monitoring systems in many countries, and this adds to the MIS communication and the misapprehensions, because we're not able to give clear cut answers when people ask questions about the deaths that have occurred due to a particular vaccine, and this always gets blown up in the media. One should be able to give a very factual account of what exactly is happened and what the cause of deaths are. But in most cases there are some obfuscation at that level, and therefore there's less and less trust then in the system.
Ty Bollinger:	Wow, I thought vaccines were safe. I thought they had robust safety monitoring systems. I thought vaccines prevented disease without risks. That's what Dr. Swaminathan and often told us in the commercial, but then she said the exact opposite in closed door meetings.
Charlene Bollinger:	Here's Dr. Heidi Larson, the founding director of the vaccine confidence project. And former head of global immunization communication at UNICEF describing safety science in the current vaccine program.
Dr. Heidi Larson:	There's a lot of safety science that's needed. And, without the good science, we can't have good communication. So, although I'm talking about all these other contextual issues and communication issues, it absolutely needs the science as the backbone, you can't repurpose the same old science to make it sound better if you don't have the science that's relevant to the new problem. So, we need much more investment in safety science
Ty Bollinger:	Wait a minute, Dr. Larson, do you mean that science is lacking? We thought the science was settled. We thought that anyone who suggested that we needed more safety science was a conspiracy theorist, a nut job, an anti-vaxxer.
Charlene Bollinger:	If Dr. Larson has a Facebook page, she better watch out because she just violated their

30

no anti-vaxxer policy by stating that we need more safety science. Next up is Dr. Marion Gruber, the Director of the Office of Vaccines Research and Review at the FDA.

Dr. Marion

- *Gruber:* One of the additional issues that complicates safety evaluation is if you look at and you struggle with the length of follow up that should be adequate in a, let's say, a pre licensure or even post marketing study, if that's even possible. And again, as you mentioned, pre licensure clinical trials may not be powered enough. It's also the subject population that you administer the adjuvant to, because we've seen data presented to us where, an adjuvant, a particular adjuvant added to a vaccine antigen did really nothing when administered to a certain population, and simply the elderly compared to administering the same formulation to younger age strata. So these are things which need to be considered as well, and further complicate safety and effectiveness evaluation of adjuvants combined with vaccine antigens.
- *Ty Bollinger:* Did you get what Dr. Gruber just said? One of those pesky little things that complicates safety evaluations is the fact that the "clinical trials" may not be powered enough. And that fact really needs to be considered when evaluating safety. Let me translate, we don't have enough clinical trials to determine if vaccines are really safe or not, especially with the combination of antigens and adjuvants.

Charlene

Bollinger: Here's Dr. Martin Howell Freide, coordinator of the World Health Organization initiative for vaccine research, describing the association of adjuvants with vaccine injury and the need to build confidence in the vaccine program. You won't hear this on 60 Minutes.

Dr. Martin

Howell Freide: Every time that there is an association, be it a temporal or not temporal, the first accusation is it is the adjuvant. And yet without adjuvants, we are not going to have the next generation of vaccines. And many of the vaccines that we do have, ranging from tetanus through to HPV, require adjuvants in order for them to work. So the challenge that we have in front of us is, how do we build confidence in this? And the confidence first of all comes from the regulatory agencies, I look to Marion. When we add an adjuvant, it's because it is essential. We do not add adjuvants to vaccines because we want to do so. But when we add them, it adds to the complexity. And I give courses every year on how do you develop vaccines? How do you make vaccines? And the first lesson is, why are you making your vaccine if you can avoid using an adjuvant, please do so.

Dr. Martin

- *Howell Freide:* Lesson two is, if you're going to use an adjuvant, use one that has a history of safety. And lesson three is, if you're not going to do that think very carefully.
- *Ty Bollinger:* It almost seems like he was insinuating that adjuvants were increasing the frequency of adverse reactions from vaccines.

Dr. Martin

Howell Freide: It seems to me that adjuvants multiply the immunogenicity of the antigens that they are added to, and that is their intention. It seems to me they multiply the reactogenicity in many instances. And therefore it seems to me that it is not unexpected if they multiply the incidence of adverse reactions, that are associated with the antigen, but may not have been detected through lack of statistical power in the original study.

Charlene

Bollinger: Did he just say that adjuvants multiply the incidence of adverse reactions? Let's see how Dr. Martin Howell Freide responds.

Dr. Martin	
Howell Freide:	You are correct. As we add adjuvants, especially some of the more recent adjuvants, such as the ASO1 saponin derived adjuvants, we do see increased local reactogenic- ity. The primary concern though usually, is systemic adverse events rather than local adverse events. And we tend to get in the phase two, in the phase three studies quite good data on the local reactogenicity. Those of us in this room that are beyond the age of 50 who've had the pleasure of having the recent shingles vaccine, will know that this does have quite significant local reactogenicity. If you got the vaccine, you know that you've got the vaccine. But this is not the major health concerns.
Dr. Martin Howell Freide:	The major health concern, which we are seeing are accusations of long term effects. So, to come back to this I'm going to once again, point to the regulators, comes down to ensuring that we conduct the phase two and the phase three studies with adequate size, and with appropriate measurement.
Ty Bollinger:	Let me translate what he just said. When it comes to adjuvants and vaccines, we know when there are local reactions. Like when you get a shot like in the shoulder, you get swelling at the point where you got the injection. But, we have no freaking clue about systemic adverse events, and we really do need to design some phase two and phase three studies with adequate size and appropriate measurement, to help us figure out if vaccines cause long term adverse events.
Charlene Bollinger:	Wait, wait, wait, is this the same organization that one week before this summit had released a commercial stating vaccines are safe and they prevent disease without risk? Wow.
Ty Bollinger:	Yeah. So here's a response from Dr. David Kaslow about this small, in other words, inad- equate sample sizes, and the "tyranny of small numbers." Listen to this.
Dr. David	
Kaslow:	So in our clinical trials we are actually Using relatively small sample sizes, and when we do that we're at risk of tyranny of small numbers. Which is, you just need a single case of Wegener's Granulomatosis, and your vaccine has to solve Walt's, how do you prove a null hypothesis? And it takes you years and years to try to figure that out. So, it's a real conundrum, right? Getting the right size, dealing with the tyranny of small numbers, making sure that you can really do it. And so, I think one of the things that we really need to invest in, are kind of better biomarkers, better mechanistic understanding of how these things work, so we can better understand adverse events as they come up.
Ty Bollinger:	Did you get that? Dr. Kaslow mentioned that since their sample size is so small when monitoring adverse events, that if one person is seriously injured, it takes a while to massage the numbers to make it appear that the vaccine is safe, and that's a real co- nundrum. And one of the needed investments is better biomarkers, and a better under- standing of adverse events.
Charlene Bollinger:	I thought they had already invested in the safety monitoring system but, here we have the third or fourth person at this summit admitting they actually do not have safety systems in place

systems in place.

Ty Bollinger:	And those are the people, and they're not just people, these are the doctors and scien- tists who create vaccine policy for the world at the World Health Organization. Some of the doctors in attendance appeared truly concerned about these admissions. Here's a very good question from Dr. Bassey Okposen from Nigeria.
Dr. Bassey Okposen:	I cast back my mind to our situation in Nigeria where a six weeks, 10 weeks, 14 weeks, a child is being given different antigens from different companies, and these vaccines have different adjuvant, different preservatives and so on. Something crosses my mind is there a possibility of these adjuvants, preservatives cross reacting amongst themselves? Have there ever been a study on the possibility of cross reactions on the [inaudible 00:14:10], that you can share the experience with us?
Charlene	
Bollinger:	Wow, great question. Dr. Okposen is truly concerned about his people in Nigeria, and the adverse cross reactions that can occur from injecting them with multiple vaccines, with multiple adjuvants and multiple antigens.
Ty Bollinger:	Have studies ever been done on using multiple vaccines in combination? One of the doctors had that exact same question at the ACIP meeting in February of 2018. FYI, ACIP is the acronym for Advisory Committee on Immunization Practices, which is an arm of the CDC.
Speaker 10:	Is there any comment on using this vaccine the same time with other adjuvanted vaccines?
Dr. Sarah Schillie:	We have no data to make a recommendation one way or the other.
Amanda Cohn:	So, just to sort of put this in context of other vaccines, whilst pre-clinical studies were not done using these vaccines simultaneously, our general approach to immunizations is that, they should be given They can be given at the same time in different limbs.
Charlene Bollinger:	When asked if there had ever been safety studies using multiple vaccines in combina- tion, Dr. Sarah Schillie, member of the CDC's ACIP committee said, "We have no data." In other words, no. Hearing her say that totally blew me away, I was literally speech- less, and apparently so was the crowd at the ACIP meeting. Because, right after her comment, there's a long awkward silence.
Ty Bollinger:	Yep. And then Amanda Cohn says, "Although we've never done studies on multiple vac- cines given at the same time," which is most vaccines today, "their general approach is that multiple vaccines with multiple adjuvants and multiple antigens can be given at the same time, as long as they're given in separate limbs." Seriously, that's about as stupid as saying that taking crystal meth, and cocaine, and heroin is safe, as long as you inject the heroin, you smoke the crystal meth, and you snort the cocaine. Do other countries subscribe to the CDC nonsense?
Speaker 13:	Are adjuvanted, multiple adjuvanted vaccines used in Europe or other markets?
Speaker 15:	Dr. Ward do you want to comment?
Dr. Ward:	Not to my knowledge.

Charlene Bollinger:	So, Europe and other countries don't use multiple adjuvanted vaccines, we have no data to determine if they are safe, but we believe they are safe as long as you inject the kid in the bottom, the shoulder, the leg.
Ty Bollinger:	You'd think that someone would have spoken up at the CDC meeting where they are about to vote on adding yet another vaccine to the CDC mandatory schedule. And they should have said something like, "Let's not vote on this until we're sure." You would think that would have happened.
Speaker 15:	Okay. I think unless there's any further discussion, we will take a vote on this recommendation.
Amanda Cohn:	I want to remind everyone to please check your voting, whatever, machine thingy, and voting is open.
Speaker 15:	Thank you very much. So the voting is completed, and it is unanimous to support this recommendation. Thank you all.
Charlene Bollinger:	Are you serious? Despite the admitted lack of safety studies, 100% of the CDC's ACIP committee voted to add this Hep B vaccine, or the dynavax, to vaccine list.

Ty Bollinger:	What did he mean by the myocardial infarction issue? That's doctor speak for heart attack by the way. There had been 14 heart attacks and the first trial group. Dr. Heidi Larson:	The other thing that's a trend and an issue is not just confidence in providers, but con- fidence of health care providers. We have a very wobbly health professional frontline that is starting to question vaccines and the safety of vaccines. Kennedy Jr.: Well they said if we call it a medicine, all medicines under the law, have to be safety tested as [inaudible 00:22:25], even a randomized test, usually for five years. We can't do that. Or we're going to call them something different. We're going to call them biologics, and we're going to make it so they don't have to be tested at all. And, the industry when it exploded in 1989, took advantage of that loophole, and they brought all of these new products to market, none of them have been tested, not one of the 72 vaccines currently on the schedule, mandated for our children has ever been tested against a placebo. That means, that nobody can scientifically tell you what the risk profile of that product is.

Robert F.

Kennedy Jr.: Nobody can tell you that that product is going to save more lives than it can take, with any scientific basis whatsoever. And how can we as a society, as a government, as a Democratic Party, be mandating products for our children, when we cannot tell them what the risk is of that product. Now, all of the vaccines on the schedule, and every medical product are required with their, whatever safety test they do, and many of them say not one has ever used a placebo, but some of them do safety testing anyway. Maybe, like the polio vaccine for 48 hours, the hepatitis B vaccine has been given to every child in this country the day they're born five days. That means if that baby dies on day six, it never happened. If the baby gets a seizure on day six, it never happened. If the baby gets food allergies and it's diagnosed three years later, or autism, or autoimmune disease, it never happened.

Robert F.

Kennedy Jr.: That way they can say that they're safe. The weird thing was, was there was one vaccine, the MMR, the vaccine that all of this hoopla is about, it was the only vaccine that has no safety testing listed on its insert. And for many years, Dell and I have been saying, that's weird. Did they not do any? Or, what happened? So we sued HHS. And we said, where is it? Is there any safety testing for the MMR [inaudible 00:25:13]? Three weeks ago, they gave us the safety testing. It were 800 kids, normally you have 20,000 kids in one of these, 20,000 subjects. There's 800 and eight separate tests for 100 each, for a drug that they are going to give to billions of people. And the testing lasted only 42 days. 50% of the kids who were involved in that study had gastrointestinal illnesses, serious ones, some of them for the full 42 days.

Robert F.

- *Kennedy Jr.:* And 50% person had respiratory illnesses, some of them are 42. This is a product that is worse according to its own records, and the illness that it's pretending to prevent.
- *Del Bigtree:* They're already studies they're showing all around the world that, people who have measles has children ... Let me say this the right way. People who did not have measles as children and were vaccinated for measles, they have a 67% increased risk of developing non Hodgkin's lymphoma, they have a 333% increase risk of developing Hodgkin's lymphoma. And if a woman had measles and mumps as a child, her risk of ovarian cancer is cut in half. We're talking right there, right there simply by having these natural infections as children, we just saved tens of thousands of lives, if not hundreds of thousand lives in America alone. Yet they want to talk about some immune suppressed child, the one child out there that may get the measles, by the way no deaths, measles has killed no one in any of the outbreaks over the last decade, even though there's this heightened stress yet, hundreds of thousands of people are dying of these cancers that science is showing, if you just had the childhood measles infection, and mumps, your body was actually being primed to protect you from cancers.

Del Bigtree: Heart disease. Most of the studies show that at the very minimum, you would cut down heart disease by 10% if people had measles and mumps as children. That right there that kills I think 650,000 people a year. You just save 65,000 people by simply letting a child get the measles? Those are the discussions we should be having. And so when we talk about trivial childhood illness, it's not only taking vaccines that are toxic, incredibly toxic for a trivial childhood illness like measles or chicken pox, or rotavirus, or things like this that really don't kill people living in a modern country like we live in. It's worse than that. Not only are we adding toxins to our body, we're stopping our body from being designed to protect us from much more serious issues in our future.

Charlene

- *Bollinger:* Del is absolutely correct. Studies are showing that natural exposure to measles and mumps, and other childhood diseases like chickenpox, confers protection from much more serious conditions like cancer and heart disease. Were you aware that Del's Informed Consent Action Network, and Bobby Kennedy teamed up to take on the DHHS for vaccine safety violations?
- *Ty Bollinger:* The lawsuit brought forth evidence that vaccine safety has been neglected for over 30 years. Here's the scoop. The National Childhood Vaccine Injury Act of 1986 requires DHHS to take responsibility for improving the efficacy and safety of vaccines. And it charged them with continuous monitoring and improving of adverse event reporting. The DHHS is also tasked with providing a report on improvements by the mandate for safer childhood vaccine clause to Congress, at least every two years. Guess what Del and Bobby found out, DHHS has not even met one time in 30 years. Just to reiterate, the 1986 Act required them to meet every two years to continuously work on vaccine safety improvements, and report to Congress, and they've never met a single time. This is mind boggling.

Charlene

Bollinger: They sued the government and won. But the US government isn't the only one getting sued, and losing.

Robert F.

Kennedy Jr.: It's four companies that make all 72 of our vaccines, Merck, [inaudible 00:29:36], and Pfizer are four of the most corrupt companies in the world. Those four companies collectively, they're serial felons. They've paid \$35 billion the last 10 years, for falsifying science, for auditing regulators, lying to doctors, selling drugs that they knew were poisonous and know were going to kill people. Why does anybody believe it? It requires a kind of cognitive dissonance, this is a, yeah, they're doing that with all their other products but they're not doing with vaccines.

Dr. Judy

Mikovits: We've written a second book called Plague of Corruption, and Plague of Corruption essentially centers on the the corruption in vaccine court, and the idea in the science, in the media, in the news media, our journals are literally fake news. So what we've done is, we've covered it up at every level, and yes, it's trillions of dollars, but it's everything else. It reveals decades, four decades, maybe five or six of corruption. Where, for instance we know the polio vaccine has always caused polio, and that, there was another woman scientists whose career and life were destroyed by her refusing to give up that information and make that public. So this has been going on for 40 or 50 years.

Dr. Judy

Mikovits: So it's trillions of dollars, and it's our entire medical public health machine would simply break down from lack of trust. Because one can't even imagine the evil of inoculating these known carcinogens, and known viruses into vulnerable children. Well, there's nothing about any of this that has anything to do with public health, it's simply the wealth of public officials.

Dr. Andrew

Wakefield: The underlying reason for people to react in the way they react from the pro vaccine lobby is many fold. I mean some people just ideologically believe in vaccination. Some people are part of a bureaucracy like the CDC, and the collective responsibility is to protect vaccination policy. Not necessarily protect children, but to protect vaccination policy, and they will do everything they can to justify that. "Well, he told me to do that and he's doing it as well, and my boss told me, so I'm just a functionary here, I just do what I'm told," any number of excuses for doing what they do. From the pharmaceutical companies perspective, it's a lot of money, a huge amount of money, a massive market, and they don't want to lose that by the truth coming out. So that's really their reason.

Dr. Andrew

Wakefield: So people operate in this way for different reasons, and it's really a question that I would love to put to them as a filmmaker, why did you do this? Why do the CDC pursue this program of intensifying the vaccination program when they've never done the proper safety studies or never demanded the proper safety studies of the industry? It's a very good question, and I don't have an answer. It seems to me utter madness. They know that they committed fraud in the setting of the MMR vaccine study, they know they did that. So, beyond a certain point, when you have knowledge then it becomes deliberate, if you continue with a policy beyond the point of knowledge that there's a problem, that you could address and prevent, then it is deliberate.

Dr. Andrew

Wakefield: So they are deliberately harming children right now. Why they would want to intensify that by adding more vaccines to the schedule that are untested, I have absolutely no idea. It is utter madness. But I'm afraid that government bureaucracies, particularly when they're driven by links to very, very powerful corporate institutions like the pharmaceutical companies, tend to behave in that way. Who knows what they have on them? Who knows? I don't know. And I again, this is a question that as a filmmaker I would love to pose to them, what madness possesses you to want to go on doing this without first saying, "Hang on, let's just pause. Let's just stop. Let's just go back and reevaluate what we're doing, to see if it's safe." Why continue, Helter Skelter down this path? I don't know.

Robert F.

Kennedy Jr.:

Jr.: Do you know what the ultimate authority is? The Institute of Medicine. That is what Congress named the Institute of Medicine to be the ultimate authority on vaccine safety. And you know what the Institute of Medicines says? It says there are 150 diseases that we think are caused by vaccines, CDC you have to study them, they said that in 1994, CDC refused. They said it again in 1998, CDC refused. They said it again in 2011, they said it every year. The Institute of Medicine says we have no idea whether these vaccines are causing this huge chronic disease epidemic, that is the ultimate authority. Not WHO, not CDC. Charlene

- *Bollinger:* The Institute of Medicine says they do not know whether vaccines are safe, but then again, so did the World Health Organization at the December 2nd 2019 Vaccine Safety Summit.
- *Ty Bollinger:* But despite their admissions that they do not have good safety studies, and they do not know whether vaccines are actually safe, which you would think would be a good reason to continue discussing vaccine safety, the push to censor truthful vaccine debate online accelerated into high gear in 2019.
- *Del Bigtree:* We're seeing on the other side, censorship and book burning, we're returning to a dark age. Adam Schiff, I'm going to talk about this in my talk. Adam Schiff reached out and said, "I want Instagram, Facebook, Twitter to start censoring anyone that's questioned the safety of vaccines." He wrote a letter to Amazon saying, "You need to remove all books and movies that question the safety of vaccines, or that say that there's other ways to heal your kids with autism." And so my film Vaxxed, which is what started this whole thing for me, has been removed from Amazon. You can't find my film anywhere except at vaxxedthemovie.com, which is the distributors website, whereas it used to be free with Amazon Prime.
- *Del Bigtree:* So, for the first time in a really long time, certainly in America, censorship and book burning is now their approach. And what that says to me is that, this agenda, and this mindset, this government and the way it's working now, is on its way out the door. There's never been a regime that's decided that burning literature, and burning ideas, was the way to win. Every time that's ever happened in the world, that marked the end of that paradigm. So I believe we're coming to the end of that paradigm. But boy, it's going to be intense.

- *Bollinger:* It is going to be intense but, we will win. Ironically Schiff's letter calling for censorship contained to the exact misinformation he was asking Facebook to censor. - *Ty Bollinger:* Schiff was quickly blasted by Congressman Bill Posey in a letter to Facebook boss Mark Zuckerberg. Dr. Judy

- *Mikovits:* I believe that vaccine freedom, and the vaccine injury, and everything we've talked about today, should be at the front of every single candidate in the 2020 election for any race in any city, any state, and certainly at the presidential level.
- *Del Bigtree:* I think vaccinations is the most important discussion, period. I was a progressive liberal my whole life, I grew up in Boulder, Colorado, I'm an environmentalist. I think that we are polluting our air, and our water, and our food supply, and the earth, and I think we should care about that, our children have to grow up in it. Wakefield: Right see vaccines, if we have one in 32 children, sorry, one in two children by 2032, which is the predicted numbers based upon the CDC own data, one in two children with autism, then you have an environment where you either have autism, or you look after someone with autism. There is no economy, the environment's irrelevant. Public policy, foreign policy, everything is irrelevant. There's nothing, there's no standing army, there's no police force, there's no economy, there's nothing. And so that's what we face. And people, it's so enormous that people really can't even conceptualize where we are. But I've watched this emerge over the last 20, 30 years, and I know it to be true, that this is what we face. Charlene Bollinger:	But are we sure that everyone who dies with Coronavirus actually died from the virus? The CDC has given guidance on how to report a Coronavirus death. Check this out.
Ty Bollinger:	From the CDC's official guidance, "It is important to emphasize that Coronavirus disease 2019, or COVID-19, should be reported on the death certificate for all decedents, where the disease caused or is assumed to have caused, or contributed to the death."
Charlene Bollinger:	Did you get that? The CDC is instructing hospital workers to assume that COVID-19 was the cause of death.
Ty Bollinger:	Then listen to this. "If the decedent had other chronic conditions, such as COPD or asthma that may have also contributed, these conditions are supposed to be reported in part two."
Charlene Bollinger:	Hmm.
Ty Bollinger:	Hmm, that's interesting, isn't it?
Charlene Bollinger:	Yeah. Well, we're not suggesting there is no virus or no deaths, we're just thinking logi- cally and exploring all possibilities here. What if the pandemic isn't really as bad as the media is telling us?

Ty Bollinger:	The good news is that, as of today, mid April 2020, Surgeon General Jerome Adams explained that the Coronavirus Task Force has effectively dumped the Gates, CDC, WHO predictive contagion model, and they're now working with what he calls, the real data. And he believes that based on this data, that businesses will begin to reopen as early as May, and others in June, and by the time you watch this video, you're going to know a lot more than we do today. This runs contrary to the fear mongering that's going on right now with Fauci and Gates, who have threatened that businesses may not reopen for a year, or at least until they're conveniently patent vaccination is available for everyone.
Ty Bollinger:	In Episode Six, we heard from Dr. Judy Mikovits, who discovered that a mouse retro- virus XMRV, had contaminated the MMR, and the polio encephalitis vaccines given to American children and soldiers, and was causing a national health crisis.
Charlene Bollinger:	She wanted to sound the alarm but she was silenced by the powers that be, and in- structed to sign a paper stating that her studies finding retroviruses in vaccines were fraudulent, even though the studies were legitimate.

Ty Bollinger:	Due to her ethics and convictions, she refused. And as a result of refusing to lie, she had all of her research illegally confiscated, she went to jail and lost her position as a government researcher and scientist, and has been blackballed from receiving any more National Institutes of Health grants, effectively ending her career as a scientist.
Charlene Bollinger:	Thanks to Robert F. Kennedy Jr. and Children's Health Defense, we just found out who it was that pressured Dr. Mikovits to lie to the American public.
Dr. Judy Mikovits:	What Tony Fauci, Ian Lipkin, and Harold Varmus did was pressure me to be silent, and withdraw our manuscript. I refused again.
Dr. Judy Mikovits:	(silence)
Dr. Judy Mikovits:	When I refused to be silent, Dr. Fauci stepped in and ordered that my computers and notebooks be confiscated, and orchestrated the retraction of our science paper.
Dr. Judy Mikovits:	(silence)
Dr. Judy Mikovits:	He then removed all of my funding, and prevented me from getting a job in government research from 2012 forward.
Ty Bollinger:	So that's how Dr. Mikovits, a woman of integrity and honesty was repaid for trying to help us. Fauci made her pay for not lying about XMRV, which remains in American vaccines. It's likely that hundreds of millions have been injected with these contaminated vaccines. And hundreds of millions have also been exposed to COVID-19. Did you know that in 2015, under the Obama administration, \$3.7 million was transferred from National Institutes of Health to the Wuhan Institute of Virology to study the Coronavirus? President Trump just announced that this is under investigation. Let's listen to Dr. Buttar discussing this topic.
Dr. Rashid Buttar:	It goes back to 2014. The US government decided based upon certain virologists at that time saying that look, "There's no justification for this kind of research, there's a potential for it to cause harm, cause a pandemic, so there is no justification for us to do this type of research. So the government passed a moratorium in 2014. Fauci approved budgets to be, monies to be sectioned for this type of research. So basically, and I'm getting really, every time I think about this, it gets me really flustered because I'm so angry that he basically broke the law. He more than broke the law, he created this entire cascade that we're seeing with the world shutdown, was created by this initial aspect back in 2015.

- *Buttar:* He broke the law, he went against government moratoriums, he took taxpayer money, and he funded research that is now led to the COVID-19. In 2017, he was documented at Georgetown University saying, that there will be a pandemic that this presidency will face, that this term will face. How did he know that in 2017, that something was going to happen in 2018, '19 and 2020? There's no ... You can't predict the market from three days from today, what's going to happen? How did he know that there was going to be a pandemic? He stated the President of this ... This president will face a pandemic, the exact quotes, I don't want to just say the exact words, you guys have the video footage-
- Anthony Fauci: There is no question that there will be a challenge the coming administration in the arena of infectious diseases, both chronic infectious diseases, in the sense of already ongoing disease, and we have certainly a large burden of that. But, also there will be a surprise outbreak. There will be a surprise outbreak.

Dr. Rashid

Buttar: He's a criminal, he's broken the law, he's gone against the government, I mean, to me that seems like it's a traitorous thing to do when the government has passed a regulation, and he's one of the highest levels in the NIH, and he's got a directorship at the NIH, and then he breaks the law, he breaks the moratorium, and then funds research against something that could potentially cause harm throughout the entire world, and he's in collusion with a foreign government.

- *Bollinger:* Tony Fauci failed us. He has proven that he is not trustworthy. Are you now prepared to trust When it comes to the Coronavirus vaccine? Do you remember a few years ago when President Trump was going to appoint our good friend, Bobby Kennedy, as the head of the Commission on vaccinations safety and scientific integrity? Eventually Bobby said that the Trump administration never contacted him after the initial meetings. We always wondered why President Trump seemingly dropped the ball on this issue. Here's one of the reasons why.
- *Bill Gates:* Then the second time I saw him was March the after that, so March 2017, in the White House. In both of those two meetings, he asked me if vaccines weren't a bad thing, because he was considering a commission to look into ill effects of vaccines and somebody, his name is Robert Kennedy Jr. was advising him that vaccines were causing bad things. Dr. Michael

- *Ryan:* In most parts of the world, due to lockdown, most of the transmission that's actually happening in many countries now, is happening in the household, at family level. In some senses, transmission has been taken off the streets, and pushed back into family units. Now, we need to go and look in families, to find those people who may be sick and remove them, and isolate them in a safe and dignified manner.
- *Ty Bollinger:* Just so you know, we're coming to your house, seizing your children, removing them from the house by force, and isolating them in a safe and dignified manner. I don't think so Dr. Ryan. That may work in the UK, but you try that in the USA, and you're going to find out that the majority of us still believe wholeheartedly, in all the amendments listed in the Bill of Rights.

- *Bollinger:* Sadly, the United States Constitution really doesn't seem to matter anymore. According to Dr. Ron Paul, what is most dangerous throughout this Coronavirus pandemic is that, although this virus will eventually disappear, the assault on our civil liberties is not likely to be reversed. From this point on, whenever local officials, county officials, state governors or federal bureaucrats decide there is sufficient reason to suspend the Constitution, they will not hesitate to do so. Anyone who challenges the suspension of the Constitution for their own good, will be labeled unpatriotic and perhaps even reported to the authorities.
- *Ty Bollinger:* Dr. Paul continues, he says, "The government is justified in canceling the Constitution," we are told. Because we are in an emergency situation caused by the COVID-19 virus. But do people forget that the United States Constitution itself was written and adopted while we were in an emergency situation? Did the framers of the Constitution fail to add an 11th amendment to the Bill of Rights saying, "Oh, by the way, none of this really counts if we get sick?" Of course not. Those who wrote our Constitution understood that these rights are not granted by the government, but rather by our Creator. Thus, it was never a question as to when or under what conditions they could be suspended. The government had no authority to suspend them at all, because it did not grant them in the first place.

Charlene

- *Bollinger:* Wake up people, don't go radio silent on this issue. It's time to stand up to the medical tyranny. It's time to draw the line in the sand.
- *Ty Bollinger:* I'm so proud of the people in my home state of Texas for drawing their line in the sand, as they recently came out in droves to protest the loss of liberty, and the draconian quarantine laws that are violating our Constitutional rights. Will you stand up and defend vaccine freedom here in America and across the globe? It's your health, your family, your choice, and our mission continues. No forced vaccination, not in America, not on our watch. We conclude with this telling quote from Bobby Kennedy, which he made during his acceptance speech, when we gave him a Lifetime Achievement Award in December 2019 here in Nashville.

Robert F.

Kennedy Jr.: People talk about big government, and how it's a threat to democracy. And it is, and government can spy on you, like our government is doing to us today, when they can torture people, which is something America never allowed. When they can read our mail and store our emails, and do all this stuff, when, you know everybody knows it's a danger. The biggest danger from the beginning of our country's history, perception under our most visionary beloved political leaders, was that the bigger threat to American democracy was, out sized corporate power. Thomas Jefferson fought like hell to make sure corporations could not get charters because he said, "They are eternal, they have no soul, and they will grow and they will overwhelm democracy. And if you left them form with these limited liability charters, we will regret it and our democracy will not survive."

Robert F.

Kennedy Jr.: Andrew Jackson said the same thing, that it's bones fighting the banks, to try to make sure that the bank could not get their charters. Teddy Roosevelt, a Republican said that, "American democracy never been a foreign power. We're too big or too powerful." But he said, "It would be subverted I malefactors of great wealth, who would undermine it from within." Dwight Eisenhower, a Republican, of his important and famous speech ever. On my birthday in 1960, as he was leaving off and my uncle was coming in, he gave a speech in which he warned America against a domination by a military corporate industrial complex, the unity of corporate and government power.

Robert F.

Kennedy Jr.: Abraham Lincoln founder of the Republican Party, and the greatest president probably in our history, at the height of the Civil War said, "I have the South in front of me and I have the corporation's behind me, and for my nation, I fear the corporations more." And Franklin Roosevelt said during World War II, that the domination of government, a corporate power is, "the essence of fascism." And Benito Mussolini, an insider with that process, said essentially the same thing. He complained that fascism should not be called fascism, it should be called corporatism, because it was the merger of state and corporate power. And Today, we are living at what they warned us about. There's a seamless unity between CDC, EPA, HHS, or FDA, HHS, the regulatory agencies and the vaccine companies. And they have turned Americans into commodities.

Robert F.

Kennedy Jr.: And we have to understand as a nation that, domination of business by government is called communism. The domination of government by business is called fascism. Now our job is to walk that narrow trail in between, and keep big government at bay with our left, with our right hand, keep big business at bay with our left. And walk down that road of free market capitalism and democracy. And in order to do that, we need a public that is educated, and understands the science, and understands all, and appreciates all the milestones of tyranny, and that is willing and ready to stand up, and defend the values of our country, and our culture, and our children's health, at what the individual cost of our selves is. And I know it, everybody in this room is already in that category.

Robert F.

Kennedy Jr.: Our challenge now is to go out and find all the other people. A people, men and women of goodwill in this country, who if they understood, we know would be with us 100%. And we need to take back our country, and our children's health, and our democracy. Thank you.
